# **B-Engrossed** Senate Bill 519

Ordered by the House June 8 Including Senate Amendments dated April 18 and House Amendments dated June 8

Sponsored by Senator DINGFELDER; Senator BONAMICI, Representative FREDERICK (Presession filed.)

## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

[Provides that if property that is subject to trustee's sale or judgment of foreclosure and sale is also subject to affordable housing covenant, sale is subject to right of eligible covenant holder to purchase property for total sum of obligations secured by trust deed or mortgage on property or highest bid re-ceived for the property other than bid from eligible covenant holder.] [Requires notice of sale and judgment of foreclosure and sale to give notice as to rights of eligible

covenant holders.]

[Declares emergency, effective on passage.] Provides, in sale or judgment of foreclosure proceeding, that if trustee sells property upon which single residential unit that is subject to affordable housing covenant is situated, eligible covenant holder may purchase property from trustee for lesser of total sum of obli-gations secured by trust deed or mortgage on property or highest bid received for property other than bid from eligible covenant holder.

86.755. (1)(a) [The] A trustee shall hold [the] a trustee's sale on the date and at the time and 5 place designated in the notice of sale given under ORS 86.740, which must be at a designated time 6 after 9 a.m. and before 4 p.m., based on the standard of time set forth in ORS 187.110 and at a des-7 ignated place in the county or one of the counties where the property is situated. Except as pro-8 9 vided in paragraph (b) of this subsection, the trustee may sell the property in one parcel or in 10 separate parcels and shall sell the parcel or parcels at auction to the highest bidder for cash. Any person, including the beneficiary under the trust deed, but excluding the trustee, may bid at the 11 12 trustee's sale. [The] An attorney for the trustee, or an agent that the trustee or the attorney des-13 ignates, may conduct the sale and act in the sale as the trustee's auctioneer.

(b) If the trustee sells property upon which a single residential unit that is subject to an affordable housing covenant is situated, the eligible covenant holder may purchase the property from the trustee at the trustee's sale for cash or cash equivalent in an amount that is the lesser of:

(A) The sum of the amounts payable under ORS 86.765 (1) and (2); or

(B) The highest bid received for the property other than a bid from the eligible covenant
 holder.

(c)(A) Except as provided in subparagraph (B) of this paragraph, if an eligible covenant
 holder purchases the property in accordance with paragraph (b) of this subsection, the sale
 forecloses and terminates all other interests in the property as provided in ORS 86.770 (1).

(B) If an interest in the property exists that is prior to the eligible covenant holder's interest, other than the interest set forth in the trust deed that was the subject of the foreclosure proceeding under ORS 86.735, notwithstanding the provisions of ORS 86.770 (1) the sale does not foreclose and terminate the prior interest and the eligible covenant holder's title to the property is subject to the prior interest.

(2) The trustee or the attorney for the trustee, or an agent that the trustee or the attorney conducting the sale designates, may postpone the sale for one or more periods [*totaling*] **that total** not more than 180 days from the original sale date, giving notice of each adjournment by public proclamation made at the time and place set for sale. The trustee, the attorney or an agent that the trustee or the attorney designates may make the proclamation.

(3) The purchaser shall pay at the time of sale the price bid or the price determined in ac cordance with subsection (1)(b) of this section, and, within 10 days following payment, the trus tee shall execute and deliver the trustee's deed to the purchaser.

(4) The trustee's deed shall convey to the purchaser the interest in the property that the grantor had, or had the power to convey, at the time the grantor executed the trust deed, together with any interest the grantor or the grantor's successors in interest acquire after the execution of the trust deed.

(5)(a) The purchaser at the trustee's sale is entitled to possession of the property on the 10th day after the sale. A person that remains in possession after the 10th day under any interest, except an interest prior to the trust deed, or an interest the grantor or a successor of the grantor created voluntarily, is a tenant at sufferance. The purchaser may obtain possession of the property from a tenant at sufferance by following the procedures set forth in ORS 105.105 to 105.168 or other appli1 cable judicial procedure.

(b) Except as provided in paragraph (c) of this subsection, at any time after the trustee's sale the purchaser may follow the procedures set forth in ORS 105.105 to 105.168 or other applicable judicial procedure to obtain possession of the property from a person that holds possession under an interest that the grantor or a successor of the grantor created voluntarily if, not earlier than 30 days before the date first set for the sale, the person was served with not less than 30 days' written notice of the requirement to surrender or deliver possession of the property.

8 (c) If the property purchased at the trustee's sale is a dwelling unit, as defined in ORS 90.100 9 (9), that the person holds under a tenancy that the grantor or a successor of the grantor created 10 voluntarily and in good faith, the purchaser may follow the procedures set forth in ORS 105.105 to 11 105.168 or other applicable judicial procedure to obtain possession if after the sale the purchaser 12 terminates the tenancy in a written notice given to the person:

(A) At least 60 days before the termination date specified in the notice, if the tenancy is a fixed term tenancy, as defined in ORS 90.100, and at least 30 days before the date first set for the trustee's sale the person provided the trustee with a copy of the rental agreement that established the fixed term tenancy. The provisions of this subparagraph do not apply to a purchaser that does not intend to terminate a fixed term tenancy before the date on which the fixed term tenancy ends.

(B) At least 30 days before the termination date specified in the notice, if:

(i) The tenancy is a month-to-month tenancy or week-to-week tenancy, as those terms are defined
in ORS 90.100, and at least 30 days before the date first set for the trustee's sale the person provided
the trustee with a copy of the rental agreement that established the tenancy or with other written
evidence of the existence of a rental agreement, if the person cannot provide the rental agreement;
or

(ii) The tenancy is a fixed term tenancy for which the person has provided notice to the trustee
as provided in subparagraph (A) of this paragraph and the purchaser intends to occupy the property
that is subject to the fixed term tenancy as the purchaser's primary residence.

(d) A purchaser may not commence a proceeding under ORS 105.105 to 105.168 that is authorized
 under this subsection before the later of:

8 (9) An affordable housing covenant holder may assign a third-party right of enforcement, by a 9 written instrument executed by the covenant holder and recorded in the deed and mortgage records 10 of the county in which the real property is located, to a person that qualifies [to be] **as** an eligible 11 covenant holder but that is not the holder of that covenant.

12 (10) An affordable housing covenant is automatically terminated if:

(a) The only holder of the covenant is a corporation, as defined in ORS 65.001, that is dissolved
 without conveying or assigning the covenant; and

(b) No person is entitled to exercise a third-party right of enforcement pursuant to subsection(9) of this section.

SECTION 5. (1) The amendments to ORS 86.705 and 86.755 by sections 1 and 2 of this 2011
 Act apply to trustee's sales for which notice was sent on or after the effective date of this
 2011 Act.

(2) The amendments to ORS 456.280 by section 4 of this 2011 Act apply to affordable
 housing covenants that are created on or after the effective date of this 2011 Act.
