

Senate Bill 5511

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Budget and Management Division, Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by State Department of Energy.

Limits biennial expenditures by department from lottery moneys.

Limits biennial expenditures by department from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2011.

A BILL FOR AN ACT

2 Relating to the financial administration of the State Department of Energy; limiting expenditures;
3 and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Notwithstanding any other law limiting expenditures, the amount of**
6 **\$30,531,027 is established for the biennium beginning July 1, 2011, as the maximum limit for**
7 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**
8 **but excluding lottery funds and federal funds, collected or received by the State Department**
9 **of Energy.**

10 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**
11 **\$2,164,185 is established for the biennium beginning July 1, 2011, as the maximum limit for**
12 **payment of expenses from lottery moneys allocated from the Administrative Services Eco-**
13 **nomic Development Fund to the State Department of Energy for debt service for the energy**
14 **efficiency and sustainable technology loan program.**

15 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of**
16 **\$30,830,849 is established for the biennium beginning July 1, 2011, as the maximum limit for**
17 **payment of expenses from federal funds collected or received by the State Department of**
18 **Energy.**

19 **SECTION 4. For the biennium beginning July 1, 2011, expenditures by the State Depart-**
20 **ment of Energy for loans for small scale energy loan projects and expenditures by the de-**
21 **partment for debt service are not limited.**

22 **SECTION 5. This 2011 Act being necessary for the immediate preservation of the public**
23 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
24 **July 1, 2011.**
