SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Designates Governor as Superintendent of Public Instruction. Requires Governor to appoint Deputy Superintendent of Public Instruction, and specifies required qualification of deputy superintendent. Allows current Superintendent of Public Instruction to complete term of office.

Declares emergency, effective on passage.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1. ORS 326.330 is repealed and section 2 of this 2011 Act is enacted in lieu**
8 **thereof.**

9 **SECTION 2. (1) As provided by section 1, Article VIII of the Oregon Constitution, the**
10 **Governor is the Superintendent of Public Instruction.**

11 **(2)(a) The Governor, acting as Superintendent of Public Instruction, shall appoint a**
12 **Deputy Superintendent of Public Instruction. The deputy superintendent must have at least**
13 **five years of experience in the administration of an elementary school or a secondary school.**
14 **The appointment of the deputy superintendent shall be subject to confirmation by the Senate**
15 **as provided by ORS 171.562 and 171.565.**

16 **(b) The deputy superintendent shall perform any act or duty of the office of Superinten-**
17 **dent of Public Instruction that is designated by the Governor, and the Governor is respon-**
18 **sible for any acts of the deputy superintendent.**

19 **(3) The deputy superintendent may be removed from office by the Governor following**
20 **consultation with the State Board of Education.**

21 **(4) The deputy superintendent shall receive a salary set by the Governor, and shall be**
22 **reimbursed for all expenses actually and necessarily incurred by the deputy superintendent**
23 **in the performance of official duties.**

24 **SECTION 3. (1) Notwithstanding section 2 of this 2011 Act, the Governor shall become**
25 **the Superintendent of Public Instruction when one of the following first occurs:**

26 **(a) The expiration of the term of the Superintendent of Public Instruction holding office**

1 on the effective date of this 2011 Act; or

2 (b) The vacancy for any cause in the office of Superintendent of Public Instruction that
3 occurs on or after the effective date of this 2011 Act.

4 (2) The Superintendent of Public Instruction holding office on the effective date of this
5 2011 Act shall continue to serve as superintendent until the date on which the Governor be-
6 comes Superintendent of Public Instruction as provided by subsection (1) of this section. A
7 superintendent so continuing to serve shall have the authority, powers, functions and duties
8 of, and be subject to other provisions of law applicable to, the superintendent.

9 (3) The Governor may appoint a Deputy Superintendent of Public Instruction pursuant
10 to section 2 of this 2011 Act to take office on or after the date on which the Governor be-
11 comes Superintendent of Public Instruction as provided in subsection (1) of this section.

12 **SECTION 4.** ORS 171.130 is amended to read:

13 171.130. (1) At any time in advance of any regular or special session of the Legislative Assembly
14 fixed by the Legislative Counsel Committee, or at any time in advance of a special session as may
15 be fixed by joint rules of both houses of the Legislative Assembly, the following may file a proposed
16 legislative measure with the Legislative Counsel:

17 (a) Members who will serve in the session and members-elect.

18 (b) Interim and statutory committees of the Legislative Assembly.

19 (2) On or before December 15 of the year preceding a regular legislative session, or at any time
20 in advance of a special session as may be fixed by joint rules of both houses of the Legislative As-
21 sembly, the following may file a proposed legislative measure with the Legislative Counsel:

22 (a) The Oregon Department of Administrative Services, to implement the fiscal recommendations
23 of the Governor contained in the budget report of the Governor.

24 (b) The person who will serve as Governor during the session.

25 (c) The Secretary of State, the State Treasurer, the Attorney General[,] **and** the Commissioner
26 of the Bureau of Labor and Industries [*and the Superintendent of Public Instruction*].

27 (d) The Judicial Department.

28 (3) Notwithstanding subsection (2) of this section, a statewide elected official who initially as-
29 sumes office in January of an odd-numbered year may submit proposed measures for introduction
30 by members or committees of the Legislative Assembly until the calendar day designated by rules
31 of either house of the Legislative Assembly. The exemption granted by this subsection to a newly
32 elected Governor does not apply to state agencies in the executive branch.

33 (4) On or before December 15 of the year preceding a regular legislative session, a state agency
34 may file a proposed legislative measure with the Legislative Counsel through a member or commit-
35 tee of the Legislative Assembly.

36 (5) The Legislative Counsel shall order each measure filed pursuant to subsections (1) to (4) of
37 this section prepared for printing and may order the measure printed. If the person filing a measure
38 specifically requests in writing that the measure be made available for distribution, the Legislative
39 Counsel shall order the measure printed and shall make copies of the printed measure available for
40 distribution before the beginning of the session to members and members-elect and to others upon
41 request.

42 (6) Copies of all measures filed and prepared for printing or printed pursuant to this section
43 shall be forwarded by the Legislative Counsel to the chief clerk of the house designated by the
44 person filing the measure for introduction.

45 (7) The costs of carrying out this section shall be paid out of the money appropriated for the

1 expenses of that session of the Legislative Assembly for which the measure is to be printed.

2 (8) The Legislative Counsel Committee may adopt rules or policies to accomplish the purpose
3 of this section.

4 (9) This section does not affect any law or any rule of the Legislative Assembly or either house
5 thereof relating to the introduction of legislative measures.

6 **SECTION 5.** ORS 171.133 is amended to read:

7 171.133. (1) A state agency shall not cause a bill or measure to be introduced before the Legis-
8 lative Assembly if the bill or measure has not been approved by the Governor.

9 (2) As used in ORS 171.130 and this section, "state agency" means every state agency whose
10 costs are paid wholly or in part from funds held in the State Treasury, except:

11 (a) The Legislative Assembly, the courts and their officers and committees;

12 (b) The Public Defense Services Commission; and

13 (c) The Secretary of State, the State Treasurer, the Attorney General[,] **and** the Commissioner
14 of the Bureau of Labor and Industries [*and the Superintendent of Public Instruction*].

15 **SECTION 6.** ORS 171.735 is amended to read:

16 171.735. ORS 171.740 and 171.745 do not apply to the following persons:

17 (1) News media, or their employees or agents, that in the ordinary course of business directly
18 or indirectly urge legislative action but that engage in no other activities in connection with the
19 legislative action.

20 (2) Any legislative official acting in an official capacity.

21 (3) Any individual who does not receive compensation or reimbursement of expenses for lobby-
22 ing, who limits lobbying activities solely to formal appearances to give testimony before public ses-
23 sions of committees of the Legislative Assembly, or public hearings of state agencies, and who, when
24 testifying, registers an appearance in the records of the committees or agencies.

25 (4) A person who does not spend more than an aggregate amount of 24 hours during any cal-
26 endar quarter lobbying and who does not spend an aggregate amount in excess of \$100 lobbying
27 during any calendar quarter.

28 (5) The Governor, chief of staff for the Governor, deputy chief of staff for the Governor, legal
29 counsel to the Governor, deputy legal counsel to the Governor, Secretary of State, Deputy Secretary
30 of State appointed pursuant to ORS 177.040, State Treasurer, Chief Deputy State Treasurer ap-
31 pointed pursuant to ORS 178.060, chief of staff for the office of the State Treasurer, Attorney Gen-
32 eral, Deputy Attorney General appointed pursuant to ORS 180.130, [*Superintendent of Public*
33 *Instruction*,] Deputy Superintendent of Public Instruction appointed pursuant to [ORS 326.330] **sec-**
34 **tion 2 of this 2011 Act**, Commissioner of the Bureau of Labor and Industries, deputy commissioner
35 of the Bureau of Labor and Industries appointed pursuant to ORS 651.060, members and staff of the
36 Oregon Law Commission who conduct the law revision program of the commission or any judge.

37 **SECTION 7.** ORS 173.130 is amended to read:

38 173.130. (1) The Legislative Counsel shall prepare or assist in the preparation of legislative
39 measures when requested to do so by a member or committee of the Legislative Assembly.

40 (2) Upon the written request of a state agency, the Legislative Counsel may prepare or assist
41 in the preparation of legislative measures that have been approved for preparation in writing by the
42 Governor or the Governor's designated representative. The Legislative Counsel may also prepare
43 or assist in the preparation of legislative measures that are requested in writing by the Judicial
44 Department, the Governor, the Secretary of State, the State Treasurer, the Attorney General[,] **or**
45 the Commissioner of the Bureau of Labor and Industries [*or the Superintendent of Public*

1 *Instruction*]. In accordance with ORS 283.110, the Legislative Counsel may charge the agency or
2 officer for the services performed.

3 (3) The Legislative Counsel shall give such consideration to and service concerning any measure
4 or other legislative matter before the Legislative Assembly as is requested by the House of Repre-
5 sentatives, the Senate or any committee of the Legislative Assembly that has the measure or other
6 matter under consideration.

7 (4) The Legislative Counsel, pursuant to the policies and directions of the Legislative Counsel
8 Committee and in conformity with any applicable rules of the House of Representatives or Senate,
9 shall perform or cause to be performed research service requested by any member or committee of
10 the Legislative Assembly in connection with the performance of legislative functions. Research as-
11 signments made by joint or concurrent resolution of the Legislative Assembly shall be given priority
12 over other research requests received by the Legislative Counsel. The research service to be per-
13 formed includes the administrative services incident to the accomplishment of the research requests
14 or assignments.

15 (5) The Legislative Counsel shall give an opinion in writing upon any question of law in which
16 the Legislative Assembly or any member or committee of the Legislative Assembly may have an
17 interest when the Legislative Assembly or any member or committee of the Legislative Assembly
18 requests the opinion. Except as provided in subsection (2) of this section and ORS 173.135, the
19 Legislative Counsel shall not give opinions or provide other legal services to persons or agencies
20 other than the Legislative Assembly and members and committees of the Legislative Assembly.

21 (6) The Legislative Counsel may enter into contracts to carry out the functions of the Legisla-
22 tive Counsel.

23 **SECTION 8.** ORS 240.205 is amended to read:

24 240.205. The unclassified service shall comprise:

25 (1) One executive officer and one secretary for each board or commission, the members of which
26 are elected officers or are appointed by the Governor.

27 (2) The director of each department of state government, each full-time salaried head of a state
28 agency required by law to be appointed by the Governor and each full-time salaried member of a
29 board or commission required by law to be appointed by the Governor.

30 (3) The administrator of each division within a department of state government required by law
31 to be appointed by the director of the department with the approval of the Governor.

32 (4) Principal assistants and deputies and one private secretary for each executive or adminis-
33 trative officer specified in ORS 240.200 (1) and in subsections (1) to (3) of this section. "Deputy"
34 means the deputy or deputies to an executive or administrative officer listed in subsections (1) to
35 (3) of this section who is authorized to exercise that officer's authority upon absence of the officer.
36 "Principal assistant" means a manager of a major agency organizational component who reports
37 directly to an executive or administrative officer listed in subsections (1) to (3) of this section or
38 deputy and who is designated as such by that executive or administrative officer with the approval
39 of the Director of the Oregon Department of Administrative Services.

40 (5) Employees in the Governor's office and the principal assistant and private secretary in the
41 Secretary of State's division.

42 (6) The director, principals, instructors and teachers in the school operated under ORS 346.010.

43 (7) Apprentice trainees only during the prescribed length of their course of training.

44 (8) Licensed physicians and dentists employed in their professional capacities and student
45 nurses, interns, and patient or inmate help in state institutions.

1 (9) Lawyers employed in their professional capacities.

2 (10) All members of the Oregon State Police appointed under ORS 181.250 and 181.265.

3 (11) **The Deputy [superintendents] Superintendent of Public Instruction appointed under**
4 **section 2 of this 2011 Act** and associate superintendents in the Department of Education.

5 (12) Temporary seasonal farm laborers engaged in single phases of agricultural production or
6 harvesting.

7 (13) Any individual employed and paid from federal funds received under the Emergency Job and
8 Unemployment Assistance Act of 1974 (United States Public Law 93-567) or any other federal pro-
9 gram intended primarily to alleviate unemployment. However, persons employed under this sub-
10 section shall be treated as classified employees for purposes of ORS 243.650 to 243.782.

11 (14) Managers, department heads, directors, producers and announcers of the state radio and
12 television network.

13 (15) Employees, including managers, of the foreign trade offices of the Oregon Business Devel-
14 opment Department located outside the country.

15 (16) Any other position designated by law as unclassified.

16 **SECTION 9.** ORS 244.050 is amended to read:

17 244.050. (1) On or before April 15 of each year the following persons shall file with the Oregon
18 Government Ethics Commission a verified statement of economic interest as required under this
19 chapter:

20 (a) The Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the
21 Bureau of Labor and Industries, [*Superintendent of Public Instruction,*] district attorneys and mem-
22 bers of the Legislative Assembly.

23 (b) Any judicial officer, including justices of the peace and municipal judges, except any pro tem
24 judicial officer who does not otherwise serve as a judicial officer.

25 (c) Any candidate for a public office designated in paragraph (a) or (b) of this subsection.

26 (d) The Deputy Attorney General.

27 (e) The Legislative Administrator, the Legislative Counsel, the Legislative Fiscal Officer, the
28 Secretary of the Senate and the Chief Clerk of the House of Representatives.

29 (f) The Chancellor and Vice Chancellors of the Oregon University System and the president and
30 vice presidents, or their administrative equivalents, in each institution under the jurisdiction of the

1 subsection (1) of this section who was not a candidate in the preceding primary election, or who

3 election by write-in votes, shall file with the commission a statement of economic interest as re-

5 (5) Subsections (1) to (4) of this section apply only to persons who are incumbent, elected or
6 appointed public officials as of April 15 and to persons who are candidates on April 15. Subsections

8 filing deadline for the statewide general election.

9 (6) If a statement required to be filed under this section has not been received by the commis-
10 sion within five days after the date the statement is due, the commission shall notify the public of-
11 ficial or candidate and give the public official or candidate not less than 15 days to comply with the
12 requirements of this section. If the public official or candidate fails to comply by the date set by the
13 commission, the commission may impose a civil penalty as provided in ORS 244.350.

14 **SECTION 10.** ORS 249.002, as amended by section 2, chapter 18, Oregon Laws 2010, is amended
15 to read:

16 249.002. As used in this chapter:

17 (1) "Candidate" means an individual whose name is or is expected to be printed on the official
18 ballot.

19 (2) "County clerk" means the county clerk or the county official in charge of elections.

20 (3) "Elector" means an individual qualified to vote under section 2, Article II, Oregon Consti-
21 tution.

22 (4) "Judge" means judge of the Supreme Court, Court of Appeals, circuit court or the Oregon
23 Tax Court, or any county judge who exercises judicial functions.

24 (5) "Member" means an individual who is registered as being affiliated with the political party.

25 (6) "Minor political party" means a political party that has qualified as a minor political party
26 under ORS 248.008.

27 (7) "Nonpartisan office" means the office of judge, [*Superintendent of Public Instruction*,] Com-
28 missioner of the Bureau of Labor and Industries, any elected office of a metropolitan service district
29 under ORS chapter 268, justice of the peace, county clerk, county assessor, county surveyor, county
30 treasurer, sheriff, district attorney or any office designated nonpartisan by a home rule charter.

31 (8) "Prospective petition" means the information, except signatures and other identification of
32 petition signers, required to be contained in a completed petition.

33 (9) "Public office" means any national, state, county, city or district office or position, except
34 a political party office, filled by the electors.

35 (10) "State office" means Governor, Secretary of State, State Treasurer, Attorney General,
36 Commissioner of the Bureau of Labor and Industries, [*Superintendent of Public Instruction*,] judge,
37 state Senator, state Representative or district attorney.

38 **SECTION 11.** ORS 249.056 is amended to read:

39 249.056. (1) At the time of filing a declaration of candidacy a candidate for the following offices
40 shall pay to the officer with whom the declaration is filed the following fee:

41 (a) United States Senator, \$150.

42 (b) Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the Bu-
43 reau of Labor and Industries, [*Superintendent of Public Instruction*,] Representative in Congress,
44 judge of the Supreme Court, Court of Appeals or Oregon Tax Court, or executive officer or auditor
45 of a metropolitan service district, \$100.

1 (c) County officer, district attorney, county judge who exercises judicial functions or circuit
2 court judge, \$50.

3 (d) State Senator or Representative or councilor of a metropolitan service district under ORS
4 chapter 268, \$25.

5 (2) No filing fee shall be required of persons filing a declaration of candidacy for precinct com-
6 mitteeperson or justice of the peace.

7 **SECTION 12.** ORS 249.215 is amended to read:

8 249.215. (1) If a vacancy occurs in a state office before the 61st day before the first general
9 election to be held during that term of office, the remaining two years of the term of the state office
10 shall be filled by the electors at that general election.

11 (2) The remaining two years of the term of the state office shall commence on the second
12 Monday in January following the general election. Any appointment made to fill the vacancy shall
13 expire when a successor to the office is elected and qualified.

14 (3) Candidates for the remaining two years of the term of the state office under this section shall
15 be nominated as provided in this chapter except as follows:

16 (a) A major political party or a minor political party, by party rule, or an assembly of electors
17 or individual electors, may select a nominee; and

18 (b) The Secretary of State shall accept certificates of nomination and notifications of nominees

28 case of a recall election, "ballot" includes material posted in a voting compartment or delivered to

30 (2) "Chief elections officer" means the:

31 (a) Secretary of State, regarding a candidate for a state office or an office to be voted on in the
32 state at large or in a congressional district, or a measure to be voted on in the state at large.

33 (b) County clerk, regarding a candidate for a county office, or a measure to be voted on in a
34 county only.

35 (c) City clerk, auditor or recorder, regarding a candidate for a city office, or a measure to be
36 voted on in a city only.

37 (3) "County clerk" means the county clerk or the county official in charge of elections.

38 (4) "Elector" means an individual qualified to vote under section 2, Article II, Oregon Consti-
39 tution.

40 (5) "Major political party" means a political party that has qualified as a major political party
41 under ORS 248.006.

42 (6) "Measure" includes any of the following submitted to the people for their approval or re-
43 jection at an election:

44 (a) A proposed law.

45 (b) An Act or part of an Act of the Legislative Assembly.

1 (c) A revision of or amendment to the Oregon Constitution.

2 (d) Local, special or municipal legislation.

3 (e) A proposition or question.

4 (7) "Minor political party" means a political party that has qualified as a minor political party
5 under ORS 248.008.

6 (8) "Nonpartisan office" means the office of judge of the Supreme Court, Court of Appeals, cir-
7 cuit court or the Oregon Tax Court, [*Superintendent of Public Instruction*,] Commissioner of the
8 Bureau of Labor and Industries, any elected office of a metropolitan service district under ORS
9 chapter 268, justice of the peace, county clerk, county assessor, county surveyor, county treasurer,
10 county judge who exercises judicial functions, sheriff, district attorney or any office designated
11 nonpartisan by a home rule charter.

10 (f) Insures that all children and their families, regardless of disability, risk factors or cultural
11 or linguistic differences, are able to utilize services for which they would otherwise be qualified.

12 (g) Encourages services and supports for preschool children with disabilities and their families
13 in their home communities and in settings with children without disabilities.

14 (h) Recognizes the importance of developing and supporting well-trained and competent person-
15 nel to provide services to preschool children with disabilities, and their families.

16 (i) Evaluates the system's impact on the child and family, including child progress, service
17 quality, family satisfaction, transition into public schooling, longitudinal and cumulative reporting
18 over several biennia and interagency coordination at both the state and local level.

19 (j) Reports information described in paragraph (i) of this subsection to the State Interagency
20 Coordinating Council, the Governor, [*the Superintendent of Public Instruction,*] the State Board of
21 Education and the Legislative Assembly each biennium.

22 (2) In carrying out the provisions of subsection (1) of this section, the Department of Education,
23 the Department of Human Services and the Oregon University System shall coordinate services to
24 preschool children with disabilities, or who are at risk of developing disabling conditions, and their
25 families. All program planning, standards for service, policies regarding services delivery and budget
26 development for services for preschool children with disabilities, and their families shall reflect the
27 policy outlined in subsection (1) of this section and elaborated through rules and agreements.

28 **SECTION 23.** Section 1, chapter 856, Oregon Laws 2009, as amended by section 31, chapter 856,
29 Oregon Laws 2009, is amended to read:

30 **Sec. 1.** (1) There is created the Alcohol and Drug Policy Commission, which is charged with
31 producing a plan for the funding and effective delivery of alcohol and drug treatment and prevention
32 services. The commission shall recommend:

33 (a) A strategy for delivering state-funded treatment and prevention services;

34 (b) The priority of funding for treatment and prevention services;

35 (c) Strategies to maximize accountability for performance of treatment and prevention services;

36 (d) Methods to standardize data collection and reporting; and

37 (e) A strategy to consolidate treatment and prevention services and reduce the fragmentation
38 in the delivery of services.

39 (2) The membership of the commission consists of:

40 (a) Sixteen members appointed by the Governor, subject to confirmation by the Senate in the
41 manner prescribed in ORS 171.562 and 171.565, including:

42 (A) An elected district attorney;

43 (B) An elected county sheriff;

44 (C) A county commissioner;

45 (D) A representative of an Indian tribe;

- 1 (E) An alcohol or drug treatment provider;
- 2 (F) A chief of police;
- 3 (G) An alcohol or drug treatment researcher or epidemiologist;
- 4 (H) A criminal defense attorney;
- 5 (I) A judge of a circuit court, who shall be a nonvoting member;
- 6 (J) A representative of the health insurance industry;
- 7 (K) A representative of hospitals;
- 8 (L) An alcohol or treatment professional who is highly experienced in the treatment of persons
9 with a dual diagnosis of mental illness and substance abuse;
- 10 (M) An alcohol or drug abuse prevention representative;
- 11 (N) A consumer of alcohol or drug treatment who is in recovery;
- 12 (O) A representative of the business community; and
- 13 (P) An alcohol or drug prevention representative who specializes in youth.
- 14 (b) Two members of the Legislative Assembly appointed to the commission as nonvoting mem-
15 bers of the commission, acting in an advisory capacity only and including:
- 16 (A) One member from among members of the Senate appointed by the President of the Senate;
17 and
- 18 (B) One member from among members of the House of Representatives appointed by the Speaker
19 of the House of Representatives.
- 20 (c) The following voting ex officio members:
- 21 (A) The Governor or the Governor's designee;
- 22 (B) The Attorney General;
- 23 (C) The Director of the Oregon Health Authority;
- 24 (D) The Director of the Department of Corrections; and
- 25 (E) The **Deputy** Superintendent of Public Instruction **or the deputy superintendent's**
26 **designee.**
- 27 (3) The Alcohol and Drug Policy Commission shall select one of its members as chairperson and
28 another as vice chairperson, for such terms and with duties and powers necessary for the perform-
29 ance of the functions of such offices as the commission determines.
- 30 (4) A majority of the voting members of the commission constitutes a quorum for the transaction
31 of business.
- 32 (5) Official action of the commission requires the approval of a majority of the voting members
33 on the commission.
- 34 (6) The commission may establish a steering committee and subcommittees. These committees
35 may be continuing or temporary.
- 36 (7) Each commission member appointed by the Governor serves at the pleasure of the Governor.
37 If there is a vacancy for any cause, the Governor shall make an appointment to become immediately
38 effective.
- 39 (8) The Oregon Health Authority shall provide staff support to the commission. Subject to
40 available funding, the commission may contract with a public or private entity to provide staff sup-
41 port.
- 42 (9) Members of the commission who are not members of the Legislative Assembly are entitled
43 to compensation and expenses incurred by them in the performance of their official duties in the
44 manner and amounts provided for in ORS 292.495. Claims for compensation and expenses shall be
45 paid out of funds appropriated to the Oregon Health Authority or funds appropriated to the com-

1 mission for purposes of the commission.

2 **SECTION 24.** ORS 458.558 is amended to read:

3 458.558. (1) The members of the Oregon Volunteers Commission for Voluntary Action and Ser-
4 vice must be citizens of this state who have a proven commitment to community service and who
5 have a demonstrated interest in fostering and nurturing citizen involvement as a strategy for
6 strengthening communities and promoting the ethic of service in all sectors of this state.

7 (2) The Governor shall appoint as members of the commission at least one of each of the fol-
8 lowing:

9 (a) An individual with experience in educational, training and development needs of youth, par-
10 ticularly disadvantaged youth.

11 (b) An individual with experience in promoting involvement of older adults in service and
12 volunteerism.

13 (c) A representative of community-based agencies or organizations within this state.

14 (d) The **Deputy** Superintendent of Public Instruction or designee.

15 (e) A representative of local governments in this state.

16 (f) A representative of local labor unions in this state.

17 (g) A representative of business.

18 (h) A person at least 16, but not more than 25, years of age who is a participant or supervisor
19 in a national service program.

20 (i) A representative of a national service program described in 42 U.S.C. 12572(a).

21 (3) In addition to appointing members under subsection (2) of this section, the Governor may
22 appoint as members individuals from the following groups:

23 (a) Educators.

24 (b) Experts in the delivery of human, educational, environmental or public safety services to
25 communities and individuals.

26 (c) Members of Native American tribes.

27 (d) At-risk youths who are out of school.

28 (e) Entities that receive assistance under the Domestic Volunteer Service Act of 1973 (42 U.S.C.
29 4950 et seq.).

30 (4) In making appointments of members described in subsections (2) and (3) of this section, the
31 Governor shall ensure that:

32 (a) No more than 50 percent of the appointed members are from the same political party; and

33 (b) No more than 25 percent of the appointed members are state employees.

34 **SECTION 25.** ORS 326.305 is repealed.

35 **SECTION 26.** Section 2 of this 2011 Act and the amendments to ORS 171.130, 171.133,
36 171.735, 173.130, 240.205, 244.050, 249.002, 249.056, 249.215, 254.005, 258.036, 258.055, 260.005,
37 260.076, 292.311, 292.430, 292.930, 329.837, 343.465 and 458.558 and section 1, chapter 856, Oregon
38 Laws 2009, by sections 4 to 24 of this 2011 Act and the repeal of ORS 326.305 and 326.330 by
39 sections 1 and 25 of this 2011 Act do not apply to:

40 (1) A Superintendent of Public Instruction who is holding office on the effective date of
41 this 2011 Act; or

42 (2) A Deputy Superintendent of Public Instruction who is appointed under the authority
43 of a Superintendent of Public Instruction who is holding office on the effective date of this
44 2011 Act.

45 **SECTION 27.** This 2011 Act being necessary for the immediate preservation of the public

1 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
2 **on its passage.**
