

Senate Bill 5523

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Budget and Management Division, Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Allocates moneys from Administrative Services Economic Development Fund to Oregon Department of Administrative Services for biennium beginning July 1, 2009.

Limits biennial expenditures by Oregon Department of Administrative Services from certain lottery moneys for biennium beginning July 1, 2009.

Modifies limit on biennial expenditures by Oregon Department of Administrative Services for debt service on projects funded with certificates of participation for biennium beginning July 1, 2009.

Modifies appropriation to Department of Community Colleges and Workforce Development for debt service on certain general obligation bonds for biennium beginning July 1, 2009.

Modifies limit on biennial expenditures by Department of Community Colleges and Workforce Development for debt service for biennium beginning July 1, 2009.

Modifies limit on biennial expenditures by Department of Community Colleges and Workforce Development for debt service on lottery bonds for biennium beginning July 1, 2009.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to state financial administration; creating new provisions; amending sections 1, 2 and 7,
3 chapter 727, Oregon Laws 2009, and section 87, chapter 95, Oregon Laws 2010; limiting expen-
4 ditures; and declaring an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. There is allocated for the biennium beginning July 1, 2009, from the Admin-**
7 **istrative Services Economic Development Fund, to the Oregon Department of Administrative**
8 **Services, the amount of \$323,068 for the purposes of paying, when due, the principal and in-**
9 **terest on outstanding certificates of participation for projects authorized under chapter 2,**
10 **Oregon Laws 2009.**

11 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of \$323,068**
12 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
13 **expenses by the Oregon Department of Administrative Services from lottery moneys allo-**
14 **cated from the Administrative Services Economic Development Fund for debt service and**
15 **related costs on certificates of participation for projects authorized under chapter 2, Oregon**
16 **Laws 2009.**

17 **SECTION 3. Section 87, chapter 95, Oregon Laws 2010, is amended to read:**

18 **Sec. 87. (1) Notwithstanding any other law limiting expenditures, the amount of [~~\$2,694,971~~]**
19 **\$2,285,775 is established for the biennium beginning July 1, 2009, as the maximum limit for payment**
20 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding**
21 **lottery funds and federal funds, collected or received by the Oregon Department of Administrative**
22 **Services, for debt service on projects funded with certificates of participation sold under chapter 2,**
23 **Oregon Laws 2009.**

3 **SECTION 4.** Section 1, chapter 727, Oregon Laws 2009, is amended to read:

19 **SECTION 5.** Section 2, chapter 727, Oregon Laws 2009, is amended to read:

20 **Sec. 2.** Notwithstanding any other law limiting expenditures, the following amounts are estab-
 21 lished for the biennium beginning July 1, 2009, as the maximum limits for payment of expenses from
 22 fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds, fed-
 23 eral funds and those funds described in section 6 of this 2009 Act, collected or received by the De-
 24 partment of Community Colleges and Workforce Development, for the following purposes:

 27 Development..... \$ 3,267,956
- 28 (2) Oregon Youth Conservation
 29 Corps..... \$ 2,744,510
- 30 [(3) *Debt service*..... \$ 2,764,688]
- 31 **(3) Debt service \$ 3,173,844**

32 **SECTION 6.** Section 7, chapter 727, Oregon Laws 2009, is amended to read:

33 **Sec. 7.** Notwithstanding any other law limiting expenditures, the amount of [~~\$7,911,324~~]
 34 **\$7,588,256** is established for the biennium beginning July 1, 2009, as the maximum limit for payment
 35 of expenses by the Department of Community Colleges and Workforce Development from lottery
 36 moneys allocated from the Administrative Services Economic Development Fund to the department
 37 for debt service on lottery bonds.

38 **SECTION 7. This 2011 Act being necessary for the immediate preservation of the public**
 39 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
 40 **on its passage.**
