

# Senate Bill 609

Sponsored by COMMITTEE ON JUDICIARY

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Eliminates sunset of provision authorizing supervisory authority to place certain offenders on inactive post-prison supervision.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

1  
2 Relating to crime; amending sections 47 and 49, chapter 660, Oregon Laws 2009; and declaring an  
3 emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** Section 49, chapter 660, Oregon Laws 2009, as amended by section 6, chapter 2,  
6 Oregon Laws 2010, is amended to read:

7 **Sec. 49.** (1) ORS 144.285 applies to prisoners convicted of aggravated murder or murder that  
8 was committed before, on or after July 1, 2009, and whose petition for a change in the terms of  
9 confinement is denied on or after January 1, 2010.

10 (2) ORS 144.280 applies to prisoners sentenced for a crime committed prior to November 1, 1989,  
11 and who are denied parole on or after January 1, 2010.

12 (3) The amendments to ORS 144.125, 144.228 and 144.232 by sections 3 to 5, chapter 660, Oregon  
13 Laws 2009, apply to prisoners:

14 (a) Whose release date is postponed under ORS 144.125 on or after January 1, 2010.

15 (b) For whom the State Board of Parole and Post-Prison Supervision is unable to set a release  
16 date under ORS 144.228 or 144.232 on or after January 1, 2010.

17 (4) The amendments to ORS 137.717, [*137.721 and*] 164.162 **and 475.935** by sections 8, 9 and 15,  
18 chapter 660, Oregon Laws 2009, apply to sentences imposed:

19 (a) On or after February 15, 2010; and

20 (b) For crimes committed on or after January 1, 2009, and before January 1, 2012.

21 (5) ORS 475.933 and the amendments to ORS 137.717, [*137.721 and*] 164.162 **and 475.935** by  
22 sections 11, 14 and 16, chapter 660, Oregon Laws 2009, apply to sentences imposed for crimes com-  
23 mitted on or after January 1, 2012.

24 (6) The amendments to ORS 421.121 by section 17, chapter 660, Oregon Laws 2009, apply to in-  
25 mates who:

26 (a) Are sentenced for a crime committed:

27 (A) On or after July 1, 2009; and

28 (B) Before [*the effective date of this 2010 Act*] **February 17, 2010**; and

29 (b) Are not prohibited by any other provision of law from obtaining a reduction in the term of  
30 incarceration under ORS 421.121.

31 (7) The amendments to ORS 421.121 by section 19, chapter 660, Oregon Laws 2009, apply to in-

2 (a) Are sentenced for a crime committed on or after [*the effective date of this 2010 Act*] **February**  
3 **17, 2010**, and before July 1, 2011; and

4 (b) Are not prohibited by any other provision of law from obtaining a reduction in the term of  
5 incarceration under ORS 421.121.

6 (8) The amendments to ORS 137.545 by section 20, chapter 660, Oregon Laws 2009, apply to  
7 crimes committed before July 1, 2011.

8 (9) Section 21, chapter 660, Oregon Laws 2009, applies to persons:

9 (a) Convicted of a crime committed before July 1, 2011; and

10 (b) Who are on probation on or after the effective date of the rules adopted by the Department  
11 of Corrections under section 21 (3), chapter 660, Oregon Laws 2009.

12 (10) Section 31, chapter 660, Oregon Laws 2009, applies to crimes committed:

13 (a) On or after February 15, 2010; and

14 (b) Before January 1, 2012.

15 (11) The amendments to ORS 137.545 by section 32, chapter 660, Oregon Laws 2009, apply to  
16 crimes committed on or after July 1, 2011.

17 (12) ORS 163.168 and the amendments to ORS 163.165 and 163.235 by sections 39 and 43, chapter  
18 660, Oregon Laws 2009, apply to conduct occurring on or after July 1, 2009.

19 (13) Except as provided in subsection (14) of this section, section 23, chapter 660, Oregon Laws  
20 2009, applies to persons:

21 (a) Convicted of a crime committed before, **on or after** July 1, 2011; and

22 (b) Sentenced to the legal and physical custody of the supervisory authority under ORS 137.124  
23 (2).

24 (14)(a) A person sentenced to the legal and physical custody of a supervisory authority under  
25 ORS 137.124 (2) shall serve an active period of post-prison supervision of at least two additional  
26 months if, on July 1, 2009, the person has served:

27 (A) Four months or more of active post-prison supervision for crimes in crime categories 1 to  
28 3; or

29 (B) Ten months or more of active post-prison supervision for crimes in crime categories 4 to 10.

30 (b) Except as provided in paragraph (c) of this subsection, the supervisory authority shall place  
31 an offender described in paragraph (a) of this subsection on inactive supervision status on the date  
32 that is two months after July 1, 2009.

33 (c) At any time before the date that is two months after July 1, 2009:

34 (A) The parole and probation officer responsible for supervising an offender described in para-  
35 graph (a) of this subsection may send a report described in section 23 (3), chapter 660, Oregon Laws  
36 2009, to the supervisory authority for review; and

37 (B) After reviewing the report, the supervisory authority may extend the active post-prison  
38 supervision period in accordance with section 23 (4), chapter 660, Oregon Laws 2009.

39 (d) Section 23, chapter 660, Oregon Laws 2009, and the provisions of this subsection and sub-  
40 section (13) of this section do not apply to a person sentenced to the legal and physical custody of  
41 a supervisory authority under ORS 137.124 (2) whose term of active post-prison supervision imposed  
42 by the sentencing court expires on or before the date that is two months after July 1, 2009.

43 **SECTION 2.** Section 47, chapter 660, Oregon Laws 2009, is amended to read:

44 **Sec. 47.** (1) Sections 1, 6, 8 and 9, chapter 14, Oregon Laws 2008, and sections 8, 9 and 10,  
45 chapter 35, Oregon Laws 2008, are repealed on February 15, 2010.

1           (2) Sections 21 [*to*] **and** 24 [*of this 2009 Act*], **chapter 660, Oregon Laws 2009**, are repealed on  
2 July 1, 2011.

3           (3) Section 31 [*of this 2009 Act*], **chapter 660, Oregon Laws 2009**, is repealed on January 1,  
4 2012.

5           (4) Section 18 [*of this 2009 Act*], **chapter 660, Oregon Laws 2009, as amended by section 7,**  
6 **chapter 2, Oregon Laws 2010**, is repealed on July 1, 2013.

7           **SECTION 3.** **This 2011 Act being necessary for the immediate preservation of the public**  
8 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**  
9 **on its passage.**
