SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires construction labor contractors to be licensed by Commissioner of Bureau of Labor and Industries. Establishes licensing requirements [*and fees*]. Provides exemptions.

Requires commissioner to administer and enforce licensing and regulatory requirements and adopt rules. Establishes grounds for denying, suspending or revoking license. Specifies duties of construction labor contractor. Permits commissioner to assess civil penalties for violations. Prohibits certain actions and discrimination against employees.

Creates cause of action against person acting as construction labor contractor without license and against person using unlicensed contractor.

Declares emergency, effective on passage.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 658.405 is amended to read:

8 658.405. As used in ORS 658.405 to 658.503 and 658.991 (2) and (3), unless the context requires
9 otherwise:

10 (1) "Agricultural association" means a nonprofit or cooperative association of farmers, growers
11 or ranchers that is incorporated under applicable state law and that acts as a farm labor contractor
12 solely on behalf of members of the association.

13 [(2) "*Commissioner*" means the Commissioner of the Bureau of Labor and Industries.]

14 (2)(a) "**Construction labor contractor**" includes any person that:

15 (A) **For an agreed remuneration or rate of pay, recruits, solicits, supplies or employs**
16 **workers to perform labor for another in construction;**

17 (B) **For an agreed remuneration or rate of pay, recruits, solicits, supplies or employs**
18 **workers on behalf of an employer engaged in construction; or**

19 (C) **Enters into a subcontract with another for any of the activities described in subpar-**
20 **agraph (A) or (B) of this paragraph.**

21 (b) "**Construction labor contractor**" does not include:

22 (A) **A person that has a construction contract with an owner of real property where the**
23 **construction work is performed;**

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (B) A person that has obtained building permits to perform construction work;

2 (C) A person that supplies building materials or machinery, other than manual tools or
3 hand-operated power tools, for a construction project;

4 (D) An owner of real property engaged in the solicitation or recruitment of persons to
5 perform construction work on the owner's property;

6 (E) The Employment Department;

7 (F) A crew leader;

8 (G) Individuals who perform labor pursuant to an agreement for exchanging their own
9 labor or services with each other, provided the work is performed on land owned or leased
10 by the individuals;

11 (H) An educational institution that is recognized as such by the Department of Educa-
12 tion;

13 (I) A labor union; or

14 (J) A local joint apprenticeship committee formed under ORS 660.135.

15 (3) "Crew leader" means the member of a group of workers who [(a)] acts as spokesman for the
16 group, [(b)] travels with the group from another state into Oregon and [(c)] performs the same work
17 along with other group members. A crew leader may transport workers from their local place of
18 residence to their place of employment so long as the crew leader does not perform this service for
19 a profit.

20 (4)(a) "Farm labor contractor" [means any person who,] **includes any person that:**

21 (A) For an agreed remuneration or rate of pay, recruits, solicits, supplies or employs workers
22 to perform labor for another **person** to work in forestation or reforestation of lands, including but
23 not limited to the planting, transplanting, tubing, precommercial thinning and thinning of trees and
24 seedlings, the clearing, piling and disposal of brush and slash and other related activities [or];

25 (B) **For an agreed remuneration or rate of pay, recruits, solicits, supplies or employs**
26 **workers to perform labor for another person** in the production or harvesting of farm products;
27 [or who]

28 (C) Recruits, solicits, supplies or employs workers to gather evergreen boughs, yew bark, bear
29 grass, salal or ferns from public lands for sale or market prior to processing or manufacture; [or
30 who]

31 (D) Recruits, solicits, supplies or employs workers on behalf of an employer engaged in these
32 activities; [or who,]

33 (E) In connection with the recruitment or employment of workers to work in these activities,
34 furnishes board or lodging for such workers; [or who]

35 (F) Bids or submits prices on contract offers for those activities; or [who]

36 (G) Enters into a subcontract with another for any of those activities. [However,]

37 (b) "Farm labor contractor" does not include:

38 [(a)] (A) Farmers, including owners or lessees of land intended to be used for the production of
39 timber, their permanent employees, advertising media, platoon leaders or individuals engaged in the
40 solicitation or recruitment of persons for dayhaul work in connection with the growing, production
41 or harvesting of farm products;

42 [(b)] (B) The Employment Department;

43 [(c)] (C) A crew leader;

44 [(d)] (D) An individual who performs work, other than recruiting, supplying, soliciting or em-
45 ploying workers to perform labor for another, alone or only with the assistance of the individual's

1 spouse, son, daughter, brother, sister, mother or father;

2 [(e)] (E) Individuals who perform labor pursuant to an agreement for exchanging their own labor
3 or services with each other, provided the work is performed on land owned or leased by the indi-
4 viduals;

5 [(f)] (F) An educational institution that is recognized as such by the Department of Education;
6 [or]

7 [(g)] (G) A farmer who operates a farmworker camp, regulated under ORS 658.750, who recruits,
8 supplies, solicits or employs workers only for the farmer's own operations, and has farmworkers
9 living in the camp who are employed by another on no more than an incidental basis, and the farmer
10 receives no remuneration by virtue of such incidental employment[.]; **or**

11 **(H) A labor union.**

12 **(5) "Labor contractor" means a construction labor contractor or a farm labor contractor.**

13 **SECTION 2.** ORS 658.015 is amended to read:

14 658.015. (1) ORS 658.005 to 658.245 do not apply to [farm] labor contractors subject to ORS
15 658.405 to 658.503.

16 (2) ORS 658.005 to 658.245 do not apply to any nonprofit organization or corporation organized
17 for the purpose of economic adjustment, civic betterment and the giving of professional guidance and
18 placement to its members, when all of the following requirements are met:

19 (a) None of its directors, officers or employees are deriving any profit beyond a nominal salary
20 for services performed on its behalf.

21 (b) Membership dues and fees are used solely for the maintenance of the organization or cor-
22 poration.

23 (c) No fee is charged for employment services.

24 (d) On request of the Commissioner of the Bureau of Labor and Industries, the organization or
25 corporation files with the commissioner, on or before the first day of April of each year, a copy of
26 its constitution or articles of incorporation and its bylaws, together with a sworn statement setting
27 forth its place of business; the names and addresses of its officers, directors and employees, the
28 salaries they receive and the services they actually perform; and the various benefits furnished to
29 its members.

30 (3) As used in subsection (2) of this section:

31 (a) "Civic betterment" means the promotion of the common good and general welfare of the
32 people of this state or any political subdivision therein.

33 (b) "Economic adjustment" means the promotion of a program by which individuals are helped
34 to acquire new professional skills, add to their existing professional skills or change their type of
35 profession.

36 (4) ORS 658.005 to 658.245 do not apply to a bona fide labor organization of workers or a
37 nonprofit organization or corporation that has been formed in good faith for the regulation, pro-
38 motion and advancement of the general professional interests of its members and that incidentally
39 maintains a placement service principally engaged in securing employment for such members.

40 **SECTION 3.** ORS 658.407 is amended to read:

41 658.407. The Commissioner of the Bureau of Labor and Industries shall administer and enforce
42 ORS 658.405 to 658.503, and in so doing shall:

43 (1) Investigate and attempt to adjust equitably controversies between [farm] labor contractors
44 and their workers with respect to claims arising under ORS 658.415 (3) or 658.419.

45 (2) Take appropriate action to establish the liability or lack thereof of the [farm] labor con-

1 tractor for wages of the employees of the [farm] labor contractor and if appropriate proof exists of
2 liability for wages the commissioner shall pay the same or such part thereof as the commissioner
3 has funds on deposit or cause the surety company to forthwith pay the entire liability or such part
4 thereof as the sums due under the bond will permit.

5 (3) Adopt appropriate rules to administer ORS 658.405 to 658.503.

6 **SECTION 4.** ORS 658.410 is amended to read:

7 658.410. (1) Except as provided by ORS 658.425 and subsection (3) of this section, a person may
8 not act as a [farm] labor contractor without a valid license in the person's possession issued to the
9 person by the Commissioner of the Bureau of Labor and Industries. Except as provided in subsection
10 (3) of this section, a person may not act as a farm labor contractor with regard to the forestation
11 or reforestation of lands unless the person possesses a valid farm labor contractor's license with the
12 indorsement required by ORS 658.417 (1). The Bureau of Labor and Industries shall make rules for
13 the issuance of duplicate licenses in the event of the loss or destruction of original licenses.

14 (2) [Farm] Labor contractor licenses may be issued by the commissioner only as follows:

15 (a) To a natural person operating as a sole proprietor under the person's own name or under
16 an assumed business name registered with the Office of Secretary of State.

17 (b) To two or more natural persons operating as a partnership or as a limited liability partner-
18 ship under their own names or under an assumed business name registered with the Office of Sec-
19 retary of State.

20 (c) Except as provided in subsection (3) of this section, to the majority shareholder or majority
21 shareholders of a corporation or a limited liability company that is licensed to operate as a [farm]
22 labor contractor.

23 (d) Except as provided in subsection (3) of this section, to a corporation or a limited liability
24 company whose majority shareholder or majority shareholders are also licensed to operate as a
25 [farm] labor contractor and that is authorized to do business in Oregon by the Office of Secretary
26 of State.

27 (e) To a cooperative corporation authorized to do business in Oregon by the Office of Secretary
28 of State.

29 (f) To a private nonprofit corporation authorized to do business in Oregon by the Office of Sec-
30 retary of State and designated by the Internal Revenue Service as exempt under section 501(c)(3)
31 of the Internal Revenue Code, provided:

32 (A)(i) The purpose of the corporation is to provide education or training; and

33 (ii) Workers recruited, solicited, supplied or employed by the corporation are recruited, solicited,
34 supplied or employed only for the purpose of educating or training the workers **in construction**, in
35 the forestation or reforestation of lands or in the production or harvesting of farm products; or

36 (B) For at least five years before the corporation files an application for a [farm] labor con-
37 tractor license, the corporation has been:

38 (i) Authorized to do business in Oregon by the Office of Secretary of State;

39 (ii) Primarily engaged in recruiting, soliciting, supplying or employing workers; and

40 (iii) Designated by the Internal Revenue Service as exempt under section 501(c)(3) of the Inter-
41 nal Revenue Code.

42 (g) **For a farm labor contractor license only**, to an agricultural association that is authorized
43 to do business in Oregon by the Office of Secretary of State.

44 (3) The majority shareholder or majority shareholders of a corporation or limited liability com-
45 pany are not required to be licensed under this section if the corporation or limited liability com-

pany:

(a)(A) Publicly trades its shares of stock on a stock exchange regulated by the United States Securities and Exchange Commission; or

(B) Has 10 or more shareholders and demonstrates to the satisfaction of the commissioner that the corporation or limited liability company is adequately capitalized; and

(b) Is authorized to do business in Oregon by the Office of Secretary of State.

SECTION 5. ORS 658.411 is amended to read:

658.411. (1) *[The]* **An** employee of a *[farm]* labor contractor who is licensed under ORS 658.405 to 658.503 may be licensed as a *[farm]* labor contractor subject to an employee indorsement if the employee continuously meets all of the following conditions:

(a) The employee's employer has filed with the Commissioner of the Bureau of Labor and Industries a signed statement, in a form required by the commissioner, agreeing to sponsor the application and to notify the commissioner promptly upon termination of the employment of the employee;

(b) The employee engages in activities that would require licensing as a *[farm]* labor contractor solely on behalf of the employer;

(c) The employee does not personally employ any workers and is not responsible for paying any workers;

(d) The employer maintains proof of financial responsibility;

(e) The employer's license remains in good standing; and

(f) The employee meets all of the conditions for licensing as a *[farm]* labor contractor, except as provided in this section.

(2) A *[farm]* labor contractor subject to an employee indorsement acting in compliance with subsection (1) of this section need not:

(a) Provide proof of financial responsibility under ORS 658.415 (3).

(b) Comply with ORS 658.440 (1)(j).

(3) The license of a *[farm]* labor contractor subject to an employee indorsement shall state the conditions contained in subsection (1) of this section on its face and shall state that a *[farm]* labor contractor subject to an employee indorsement who operates out of compliance with these restrictions is an unlicensed *[farm]* labor contractor.

(4) A *[farm]* labor contractor who employs another *[farm]* labor contractor is personally, jointly and severally liable for any damages, attorney fees or costs awarded against the employee for the actions of the *[farm]* labor contractor employee undertaken within the scope of employment, or for actions of the employee that the employee takes under color of an employee's license subject to an employee indorsement that are known, or reasonably should have been known, by the employer. In the case of a *[farm]* labor contractor that is a corporation, both the corporation and the licensed majority shareholder or shareholders are so liable.

SECTION 6. ORS 658.412 is amended to read:

658.412. **The Commissioner of the Bureau of Labor and Industries may not issue a** *[No]* license to operate as a *[farm]* labor contractor *[shall be issued]* until an applicant for a license has successfully passed a qualifying examination designed to test the applicant's ability, knowledge and proficiency to conduct and manage the business of a *[farm]* labor contractor. The commissioner *[of the Bureau of Labor and Industries, by rule,]* shall prescribe **by rule** the requirements for and the manner of testing the competency of license applicants.

NOTE: Section 7 was deleted by amendment. Subsequent sections were not renumbered.

SECTION 8. ORS 658.415 is amended to read:

1 658.415. (1) A person may not act as a *[farm]* labor contractor unless the person has first been
2 licensed by the Commissioner of the Bureau of Labor and Industries under ORS 658.405 to 658.503.
3 Any person may file an application for a license to act as a *[farm]* labor contractor at any office
4 of the Bureau of Labor and Industries. The application shall be sworn to by the applicant and shall
5 be written on a form prescribed by the commissioner. The form shall include, but not be limited to,
6 questions asking:

7 (a) The applicant's name, Oregon address and all other temporary and permanent addresses the
8 applicant uses or knows will be used in the future.

9 (b) Information on all motor vehicles to be used by the applicant in operations as a *[farm]* labor
10 contractor, including license number and state of licensure, vehicle number and the name and ad-
11 dress of vehicle owner for all vehicles used.

12 (c) Whether or not the applicant was ever denied a license under ORS 658.405 to 658.503 within
13 the preceding three years, or in this or any other jurisdiction had *[such]* a **labor contractor** license
14 denied, revoked or suspended within the preceding three years.

15 (d) The names and addresses of all persons financially interested, whether as partners, share-
16 holders, associates or profit-sharers, in the applicant's proposed operations as a *[farm]* labor con-
17 tractor, together with the amount of their respective interests, and whether or not, to the best of
18 the applicant's knowledge, any of these persons was ever denied a license under ORS 658.405 to
19 658.503 within the preceding three years, or had *[such]* a **labor contractor** license denied, revoked
20 or suspended within the preceding three years in this or any other jurisdiction.

21 (2) Each applicant shall furnish satisfactory proof with the application:

22 (a) Of the existence of a policy of insurance in an amount adequate under rules issued by the
23 commissioner for vehicles to be used to transport workers. For the purpose of this paragraph, the
24 certificate of an insurance producer licensed in Oregon is satisfactory proof of adequate insurance.

25 (b) Of the existence of workers' compensation insurance as provided in ORS 658.440 (1)(j). The
26 commissioner may adopt rules concerning satisfactory proof of adequate workers' compensation in-
27 surance.

28 (3) Each applicant shall submit with the application and shall continually maintain thereafter,
29 until excused, proof of financial ability to promptly pay the wages of employees and other obli-
30 gations specified in this section. The proof required in this subsection shall be in the form of a
31 corporate surety bond of a company licensed to do such business in Oregon, a cash deposit or a
32 deposit the equivalent of cash. For the purposes of this subsection, it shall be deemed sufficient
33 compliance if the *[farm]* labor contractor procures a savings account at a bank or savings and loan
34 institution in the name of the commissioner as trustee for the employees of the *[farm]* labor con-
35 tractor and others as their interests may appear and delivers proof of the account and the ability
36 to withdraw the funds to the commissioner under the terms of a bond approved by the commissioner.
37 The amount of the bond and the security behind the bond, or the cash deposit, shall be based on the
38 maximum number of employees the **labor** contractor employs at any time during the year. The bond
39 or cash deposit shall be:

40 (a) \$10,000 if the **labor** contractor employs no more than 20 employees; or

41 (b) \$30,000, or such lesser sum as may be authorized by the commissioner under ORS 658.416,
42 if the **labor** contractor employs 21 or more employees.

43 (4) In the event that a single business entity licensed as a *[farm]* labor contractor has more than
44 one natural person who, as an owner or employee of the business entity, engages in activities that
45 require the persons to be licensed individually as *[farm]* labor contractors, and each *[such]* person

1 engages in [*such*] **those** activities solely for that business entity, the commissioner may provide by
2 rule for lower aggregate bonding requirements for the business entity and its owners and employees.
3 If there is an unsatisfied judgment of a court or final decision of an administrative agency against
4 a license applicant, the subject of which is any matter that would be covered by the bond or deposit
5 referred to in subsection (3) of this section, the commissioner may not issue a license to the appli-
6 cant until the judgment or decision is satisfied. As a condition of licensing any such applicant, the
7 commissioner may require the applicant to submit proof of financial ability required by subsection
8 (3) of this section in an amount up to three times that ordinarily required of a license applicant.

9 (5) All corporate surety bonds filed under this section or ORS 658.419 shall be executed to cover
10 liability for the period for which the license is issued. During the period for which it is executed,
11 the bond may not be canceled or otherwise terminated.

12 (6) Each application must be accompanied by the fee established under ORS 658.413.

13 (7) Any person who uses the services of a [*farm*] labor contractor who has failed to comply with
14 any of the provisions of this section or ORS 658.419 shall:

15 (a) Be personally and jointly and severally liable to any employee as far as the employee has
16 not been paid wages in full for the work done for that person.

17 (b) Be personally liable for all penalty wages that have occurred under ORS 652.150 for the
18 wages due under this section.

19 (8) Any person who suffers any loss of wages from the employer of the person or any other loss
20 specified in subsection (16) of this section shall have a right of action in the name of the person
21 against the surety upon the bond or against the deposit with the commissioner. The right of action:

22 (a) Is assignable and must be included with an assignment of a wage claim, of any other appro-
23 priate claim or of a judgment thereon.

24 (b) May not be included in any [*suit or*] action against the [*farm*] labor contractor but must be
25 exercised independently after first procuring a judgment or other form of adequate proof of liability
26 established by rule and procedure under subsection (14) of this section establishing the [*farm*] labor
27 contractor's liability for the claim.

28 (9)(a) The surety company or the commissioner shall make prompt and periodic payments on the
29 [*farm*] labor contractor's liability up to the extent of the total sum of the bond or deposit.

30 (b) Payment shall be made based upon priority of wage claims over advances made by **the**
31 **construction property owner**, the grower or producer of agricultural commodities or the owner
32 or lessee of land intended to be used for the production of timber, for advances made to or on behalf
33 of the [*farm*] labor contractor.

34 (c) Payment shall be made in full of all sums due to each person who presents adequate proof
35 of the claim.

36 (d) Payment shall be made in part if there are insufficient funds to pay in full the person next
37 entitled to payment in full.

38 (10) A person may not bring any [*suit or*] action against the surety company or the commissioner
39 on the bond or against the commissioner as the trustee for the beneficiaries of the [*farm*] labor
40 contractor under any deposit made pursuant to this section or ORS 658.419 unless the person has
41 first exhausted the procedures contained in subsections (8) and (12) of this section or in ORS 658.419
42 and contends that the surety company or the commissioner still has funds that are applicable to the
43 person's judgment or acknowledgment.

44 (11) The commissioner may not be prevented from accepting assignments of wage claims and
45 enforcing liability against the surety on the bond or from applying the deposit to just wage claims

1 filed with the commissioner.

2 (12) All claims against the bond or deposit shall be unenforceable unless request for payment
3 of a judgment or other form of adequate proof of liability or a notice of the claim has been made
4 by certified mail to the surety or the commissioner within six months from the end of the period for
5 which the bond or deposit was executed and made.

6 (13) If the commissioner has received no notice as provided in subsection (12) of this section
7 within six months after a [farm] labor contractor is no longer required to provide and maintain a
8 surety bond or deposit, the commissioner shall terminate and surrender any bond or any deposit
9 under the control of the commissioner to the person who is entitled thereto upon receiving appro-
10 priate proof of such entitlement.

11 (14) The commissioner shall adopt rules reasonably necessary for administration and enforce-
12 ment of the provisions of this section and ORS 658.419.

13 (15) Every [farm] labor contractor required by this section or ORS 658.419 to furnish a surety
14 bond or make a deposit in lieu [thereof] **of a surety bond** shall keep conspicuously posted upon the
15 premises where employees working under the contractor are employed a notice, in both English and
16 any other language used by the [farm] labor contractor to communicate with workers, specifying the
17 contractor's compliance with the requirements of this section and ORS 658.419 and specifying the
18 name and Oregon address of the surety on the bond or a notice that a deposit in lieu of the bond
19 has been made with the commissioner together with the address of the commissioner.

20 (16) The bond or deposit referred to in subsection (3) of this section shall be payable to the
21 commissioner and shall be conditioned upon:

22 (a) Payment in full of all sums due on wage claims of employees.

23 (b) Payment by the [farm] labor contractor of all sums due to **the construction property**
24 **owner**, the grower or producer of agricultural commodities or the owner or lessee of land intended
25 to be used for the production of timber for advances made to or on behalf of the [farm] labor con-
26 tractor.

27 (17) The commissioner may not issue a license until the applicant executes a written statement
28 that shall be subscribed and sworn to and that shall contain the following declaration:

31 With regards to any action filed against me concerning my activities as a [farm] labor contrac-
32 tor, I appoint the Commissioner of the Bureau of Labor and Industries as my lawful agent to accept
33 service of summons when I am not present in the jurisdiction in which such action is commenced
34 or have in any other way become unavailable to accept service.
35 _____

36
37 (18) A person who cosigns with a [farm] labor contractor for a bond required by subsection (3)
38 of this section or by ORS 658.419 is not personally or jointly and severally liable for unpaid wages
39 above the amount of the bond solely because the person cosigned for the bond.

40 (19) The court may award reasonable attorney fees to the prevailing party in any action to en-
41 force the provisions of this section or ORS 658.419.

42 **SECTION 9.** ORS 658.416 is amended to read:

43 658.416. If the Commissioner of the Bureau of Labor and Industries finds that an applicant has
44 operated as an Oregon licensed [farm] labor contractor without an employee indorsement for at least
45 two years in compliance with ORS 658.405 to 658.503 and with any other laws pertaining to the

1 conduct of [*farm*] labor contractors, and that no valid claims for unpaid wages have been made
2 against the applicant, then the commissioner may reduce the amount of the bond or deposit that
3 would otherwise be required pursuant to ORS 658.415 (3) to an amount determined by the commis-
4 sioner, but in no event less than the following:

5 (1) If the commissioner finds that the **labor** contractor has so operated for a period of at least
6 five years, \$20,000;

7 (2) If the commissioner finds that the **labor** contractor has so operated for at least four years,
8 \$22,500;

9 (3) If the commissioner finds that the **labor** contractor has so operated for at least three years,
10 \$25,000; or

11 (4) If the commissioner finds that the **labor** contractor has so operated for at least two years,
12 \$27,500.

13 **SECTION 10.** ORS 658.417 is amended to read:

14 658.417. In addition to the regulation otherwise imposed upon [*farm*] labor contractors pursuant
15 to ORS 658.405 to 658.503, a person who acts as a farm labor contractor with regard to the fore-
16 station or reforestation of lands shall:

17 (1) Obtain a special indorsement from the Commissioner of the Bureau of Labor and Industries
18 on the license required by ORS 658.410 that authorizes the person to act as a farm labor contractor
19 with regard to the forestation or reforestation of lands.

20 (2) Pay the fee established under ORS 658.413.

17 **SECTION 30. Notwithstanding section 29 of this 2011 Act, the Commissioner of the Bu-**
18 **reau of Labor and Industries may take any action before the operative date established by**
19 **section 29 of this 2011 Act that is necessary to enable the commissioner to exercise, on and**
20 **after the operative date, all the duties, functions and powers conferred on the commissioner**
21 **by this 2011 Act.**

22 **SECTION 31. This 2011 Act being necessary for the immediate preservation of the public**
23 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
24 **on its passage.**
