## SENATE AMENDMENTS TO SENATE BILL 727

1	On page 1 of the printed bill, line 3, after "701.109," insert "701.139,".
2	Delete lines 5 through 22 and delete pages 2 through 8 and insert:
3	"SECTION 1. Sections 2 and 3 of this 2011 Act are added to and made a part of ORS
4	chapter 701.
5	"SECTION 2. (1) The Construction Contractors Board shall accept for processing any
6	complaint against a contractor for unpaid wages that:
7	"(a) Is timely filed;
8	"(b) States the amount of unpaid wages alleged to be owed to the complainant; and
9	"(c) Identifies each contractor being complained against.
10	"(2) The board may not reject a complaint described in subsection (1) of this section if
11	the rejection is based upon the complainant:
12	"(a) Being unable to specify the exact days, hours or locations of the employment;
13	"(b) Being unable to provide documentation of the employment by a contractor alleged
14	to be potentially responsible in whole or in part for payment of the wages claimed;
15	"(c) Being unable to provide witnesses to the employment who are unrelated to the
16	complainant; or
17	"(d) Alleging that the complainant was jointly employed by a contractor that did not have
18	a direct contractual relationship with the complainant.
19	"(3) The board shall dismiss a complaint described in subsection (1) of this section 120
20	days after filing if the complainant has not informed the board that the complainant has filed
21	a civil action or filed a wage claim with the Bureau of Labor and Industries to collect the
22	unpaid wages. If the complainant timely notifies the board that the complainant has filed a
23	civil action or wage claim to collect the unpaid wages, the board shall suspend processing
24	of the complaint filed with the board during the pendency of the civil action or wage claim.
25	"(4) If a civil action or wage claim results in a finding that the contractor is not liable
26	for the unpaid wages described in subsection (1) of this section, the board shall dismiss the
27	complaint filed with the board.
28	"(5) If a civil action or wage claim to collect unpaid wages results in a court judgment
29	or in a final order by the Commissioner of the Bureau of Labor and Industries finding the
30	contractor liable for the unpaid wages described in subsection (1) of this section, the
31	complainant must deliver a certified copy of the judgment or final order to the board and to
32	the bond surety no later than the 30th day after the judgment or final order is entered to
33	be able to maintain the complaint and possibly receive payment from the bond of the con-
34	tractor.
35	"(6)(a) Upon receipt of a timely delivered certified copy of a judgment or final order as

described in subsection (5) of this section, subject to paragraphs (b) to (d) of this subsection 1 2 the board shall issue a proposed order on the complaint in the amount of the judgment or order together with any costs, interest and attorney fees awarded under the judgment, to 3 4 the extent that the judgment or order amount, costs, interest and fees are within the jurisdiction of the board. 5

6 "(b) The board shall issue a proposed order as described in paragraph (a) of this sub-7 section if the judgment or final order includes determinations:

"(A) That wages are owing to the complainant;

"(B) That the complainant earned the wages while employed by a construction contrac-9 10 tor;

11

"(C) That the wages were earned within one year prior to the date on which a complaint for the wages was filed with the board under subsection (1) of this section; and

"(D) Whether the complaint arises from work described in ORS 701.139 (4), work de-13scribed in ORS 701.139 (5) or work that is not described in ORS 701.139 (4) or (5). 14

15(c) If a judgment or final order omits any of the determinations described in paragraph (b) of this subsection, the board shall make the determinations that were omitted from the 16 judgment or final order. 17

18 "(d) If a judgment or final order is issued as described in this subsection, the board is 19 limited to determining whether a complaint comes within the jurisdiction of the board and 20 is subject to payment by the surety.

21"(7) The board shall issue any proposed order in a form that indicates the surety's max-22imum liability to the complainant. If a hearing is not requested within the time set forth in 23the proposed order, the proposed order becomes final without any further action by the board. If a hearing is requested, unless review of an issue is precluded under subsection (6) 24 25of this section, the board may determine:

26"(a) Whether the complaint was timely filed with the board as provided in ORS 701.143.

27"(b) Whether the complaint is for work subject to this chapter.

"(c) The extent of the surety's liability to the complainant. 28

"SECTION 3. (1) If the Construction Contractors Board learns that a judgment against 29 30 a contractor for unpaid wages remains unsatisfied more than 30 days after becoming final by operation of law or on appeal, no later than 15 days after learning that the judgment is 31unsatisfied the board shall: 32

"(a) Suspend the license of the contractor; and

(b) Post a summary of the judgment information on a website maintained by the board.

35 "(2) The board shall keep a license suspended and information posted as provided in subsection (1) of this section until the board learns that the judgment for unpaid wages has 36 been satisfied. 37

"SECTION 4. ORS 701.005, as amended by section 4, chapter 77, Oregon Laws 2010, is amended 38 39 to read:

40 "701.005. As used in this chapter:

41 "(1) 'Board' means the Construction Contractors Board.

"(2) 'Commercial contractor' means a licensed contractor that holds an endorsement as a: 42

"(a) A person that, for compensation or with the intent to sell, arranges or undertakes or offers 13to undertake or submits a bid to construct, alter, repair, add to, subtract from, improve, inspect, 14 15move, wreck or demolish, for another, a building, highway, road, railroad, excavation or other 16 structure, project, development or improvement attached to real estate, or to do any part thereof.

17"(b) A person that purchases or owns property and constructs or for compensation arranges for 18 the construction of one or more residential structures or small commercial structures with the in-19 tent of selling the structures.

"(c) A school district, as defined in ORS 332.002, that permits students to construct a residential 2021structure or small commercial structure as an educational experience to learn building techniques 22and sells the completed structure.

23"(d) A community college district, as defined in ORS 341.005, that permits students to construct a residential structure or small commercial structure as an educational experience to learn building 24 25techniques and sells the completed structure.

26 "(e) A person except a landscape contracting business, nurseryman, gardener or person engaged in the commercial harvest of forest products, that is engaged as an independent contractor to re-2728 move trees, prune trees, remove tree limbs or stumps or to engage in tree or limb guying.

29 "(f) A business that supplies the services of a home inspector certified under ORS 701.350 or a 30 cross-connection inspector and backflow assembly tester certified under ORS 448.279.

"(g) A person that for compensation arranges, undertakes, offers to undertake or submits a bid 3132to clean or service chimneys.

33 "(6) 'Developer' means a contractor that owns property or an interest in property and engages 34in the business of arranging for construction work or performing other activities associated with the 35 improvement of real property, with the intent to sell the property.

"(7) 'Employed' means permitted or suffered to perform work.

37 "[(7)(a)] (8)(a) 'General contractor' means a contractor whose business operations require the 38 use of more than two unrelated building trades or crafts that the contractor supervises or performs 39 in whole or part, whenever the sum of all contracts on any single property, including materials and 40 labor, exceeds an amount established by rule by the board.

41 "(b) 'General contractor' does not mean a specialty contractor or a residential limited contrac-42tor.

"(2) Upon receipt, the clerk shall record the order in the County Clerk Lien Record. In addition 2021to any other remedy provided by law, recording an order in the County Clerk Lien Record pursuant 22to the provisions of this section has the effect provided for in ORS 205.125 and 205.126, and the or-23der may be enforced as provided in ORS 205.125 and 205.126.

4 "<u>SECTION 11.</u> Section 3 of this 2011 Act applies to judgments that become final by oper-5 ation of law before, on or after the effective date of this 2011 Act.

6 "<u>SECTION 12.</u> The amendments to ORS 701.106 by section 5 of this 2011 Act apply to vi-7 olations or failures to comply with ORS 652.140 or 653.010 to 653.261 that occur before, on or 8 after the effective date of this 2011 Act.

9 "<u>SECTION 13.</u> The amendments to ORS 701.109 by section 6 of this 2011 Act apply to 10 judgments recorded on or after the effective date of this 2011 Act.

SECTION 14. The amendments to ORS 701.153 by section 9 of this 2011 Act do not apply for the purpose of increasing the amount payable from a bond for nonowner complaints or for costs, interest and attorney fees pursuant to a notice and order issued by the Construction Contractors Board before the effective date of this 2011 Act.".
