**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Permits Oregon Health Authority to approve one or more pilot projects relating to dental health. Allows person not licensed to practice dentistry or dental hygiene to practice dentistry or dental hygiene in approved pilot project.

Changes title of limited access permit dental hygienist to expanded practice dental hygienist. Modifies requirements for permit and scope of practice of permit holder. Makes changes operative on January 1, 2012.

Requires insurance policy covering dental health that provides coverage for services performed by dentist to cover services when performed by expanded practice dental hygienist under certain circumstances.

Directs Oregon Board of Dentistry to compile data relating to expanded practice dental hygienists.

Permits Oregon Health Authority to approve pilot projects for training and certifying community dental health coordinators. Sunsets pilot project January 2, 2018.

Establishes Dental Pilot Projects Fund. Continuously appropriates moneys in fund to authority for purposes of pilot projects.

Declares emergency, effective on passage.

**A BILL FOR AN ACT**

2 Relating to dental health; creating new provisions; amending ORS 679.010, 679.020, 679.025, 680.150,  
3 680.200, 680.205, 750.055 and 750.333; appropriating money; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5  
6 **DENTAL PILOT PROJECTS**

7  
8 **SECTION 1. (1) The Oregon Health Authority may approve pilot projects to encourage**  
9 **the development of innovative practices in oral health care delivery systems with a focus on**  
10 **providing care to populations that evidence-based studies have shown have the highest dis-**  
11 **ease rates and the least access to dental care. The authority may approve a pilot project that**  
12 **is designed to:**

13 (a) **Operate for three to five years or a sufficient amount of time to evaluate the validity**  
14 **of the pilot project;**

15 (b) **Evaluate quality of care, access, cost, workforce and efficacy; and**

16 (c) **Achieve at least one of the following:**

17 (A) **Teach new skills to existing categories of dental personnel;**

18 (B) **Develop new categories of dental personnel;**

19 (C) **Accelerate the training of existing categories of dental personnel; or**

20 (D) **Teach new oral health care roles to previously untrained persons.**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (2) The authority shall adopt rules:

2 (a) Establishing an application process for pilot projects;

3 (b) Establishing minimum standards, guidelines and instructions for pilot projects; and

4 (c) Requiring an approved pilot project to report to the authority on the progress and  
5 outcomes of the pilot project, including:

6 (A) The process used to evaluate the progress and outcomes of the pilot project;

7 (B) The baseline data and information to be collected;

8 (C) The nature of program data that will be collected and the methods for collecting and  
9 analyzing the data;

10 (D) The provisions for protecting the safety of patients seen or treated in the project;  
11 and

12 (E) A statement of previous experience in providing related health care services.

13 (3) The authority shall seek the advice of appropriate professional societies and licensing  
14 boards before adopting rules under subsection (2) of this section.

15 (4)(a) Notwithstanding ORS 679.020 and 680.020, a person may practice dentistry or dental  
16 hygiene without a license as part of a pilot project approved under this section under the  
17 general supervision of a dentist licensed under ORS chapter 679 and in accordance with rules  
18 adopted by the authority.

19 (b) A person practicing dentistry or dental hygiene without a license under this section  
20 is subject to the same standard of care and is entitled to the same immunities as a person  
21 performing the services with a license.

22 (5) The authority may accept gifts, grants or contributions from any public or private  
23 source for the purpose of carrying out this section. Funds received under this subsection  
24 shall be deposited in the Dental Pilot Projects Fund established under section 17 of this 2011  
25 Act.

26 SECTION 2. Section 1 of this 2011 Act is repealed on January 2, 2018.

28 **EXPANDED PRACTICE DENTAL HYGIENISTS**

29  
30 SECTION 3. ORS 679.010 is amended to read:

31 679.010. As used in this chapter and ORS 680.010 to 680.205, unless the context requires other-  
32 wise:

33 [(1) "Board" means the Oregon Board of Dentistry.]

34 [(2)] (1) "Dental assistant" means a person who, under the supervision of a dentist, renders as-  
35 sistance to a dentist, dental hygienist, dental technician or another dental assistant or renders as-  
36 sistance under the supervision of a dental hygienist providing dental hygiene.

37 [(3)] (2) "Dental hygiene" means that portion of dentistry that includes the rendering of educa-  
38 tional, preventive and therapeutic dental services and diagnosis and treatment planning for such  
39 services. "Dental hygiene" includes, but is not limited to, scaling, root planing, curettage, the ap-  
40 plication of sealants and fluoride and any related intraoral or extraoral procedure required in the  
41 performance of such services.

42 [(4)] (3) "Dental hygienist" means a person who, under the supervision of a dentist, practices  
43 dental hygiene.

44 [(5)] (4) "Dental technician" means that person who, at the authorization of a dentist, makes,  
45 provides, repairs or alters oral prosthetic appliances and other artificial materials and devices which

1 are returned to a dentist and inserted into the human oral cavity or which come in contact with its  
2 adjacent structures and tissues.

3 [(6)] (5) "Dentist" means a person who may perform any intraoral or extraoral procedure re-  
4 quired in the practice of dentistry.

5 [(7)] (6) "Dentistry" means the healing art which is concerned with the examination, diagnosis,  
6 treatment planning, treatment, care and prevention of conditions within the human oral cavity and  
7 maxillofacial region and conditions of adjacent or related tissues and structures. The practice of  
8 dentistry includes but is not limited to the cutting, altering, repairing, removing, replacing or repo-  
9 sitioning of hard or soft tissues and other acts or procedures as determined by the **Oregon Board**  
10 **of Dentistry** and included in the curricula of dental schools accredited by the Commission on  
11 Dental Accreditation of the American Dental Association, post-graduate training programs or con-  
12 tinuing education courses.

13 [(8)] (7) "Direct supervision" means supervision requiring that a dentist diagnose the condition  
14 to be treated, that a dentist authorize the procedure to be performed, and that a dentist remain in  
15 the dental treatment room while the procedures are performed.

16 (8) "**Expanded practice dental hygienist**" means a dental hygienist who performs dental  
17 **hygiene services in accordance with ORS 680.205 as authorized by an expanded practice**  
18 **dental hygienist permit issued by the board under ORS 680.200.**

19 (9) "General supervision" means supervision requiring that a dentist authorize the procedures  
20 **by standing orders, practice agreements or collaboration agreements**, but not requiring that  
21 a dentist be present when the authorized procedures are performed. The authorized procedures may  
22 also be performed at a place other than the usual place of practice of the dentist.

23 (10) "Indirect supervision" means supervision requiring that a dentist authorize the procedures  
24 and that a dentist be on the premises while the procedures are performed.

25 [(11) "*Limited access permit dental hygienist*" means a dental hygienist who renders dental hygiene  
26 *services in accordance with ORS 680.205 as authorized by a limited access permit issued by the board*  
27 *pursuant to ORS 680.200.*]

28 [(12) "*State*" means any state or territory of the United States and the District of Columbia.]

29 **SECTION 4.** ORS 679.020 is amended to read:

30 679.020. (1) A person may not practice dentistry without a license.

31 (2) Only a person licensed as a dentist by the Oregon Board of Dentistry may own, operate,  
32 conduct or maintain a dental practice, office or clinic in this state.

33 (3) The restrictions of subsection (2) of this section, as they relate to owning and operating a  
34 dental office or clinic, do not apply to a dental office or clinic owned or operated by any of the  
35 following:

36 (a) A labor organization as defined in ORS 243.650 and 663.005 (6), or to any nonprofit organ-  
37 ization formed by or on behalf of such labor organization for the purpose of providing dental ser-  
38 vices. Such labor organization must have had an active existence for at least three years, have a  
39 constitution and bylaws, and be maintained in good faith for purposes other than providing dental  
40 services.

41 (b) The School of Dentistry of the Oregon Health and Science University.

42 (c) Institutions of higher education listed in ORS 352.002.

43 (d) Local governments.

44 (e) Institutions or programs accredited by the Commission on Dental Accreditation of the  
45 American Dental Association to provide education and training.

1 (f) Nonprofit corporations organized under Oregon law to provide dental services to rural areas  
2 and medically underserved populations of migrant, rural community or homeless individuals under  
3 42 U.S.C. 254b or 254c or health centers qualified under 42 U.S.C. 1396d(1)(2)(B) operating in com-  
4 pliance with other applicable state and federal law.

5 (g) Nonprofit charitable corporations as described in section 501(c)(3) of the Internal Revenue  
6 Code and determined by the Oregon Board of Dentistry as providing dental services by volunteer  
7 licensed dentists to populations with limited access to dental care at no charge or a substantially  
8 reduced charge.

9 (4) For the purpose of owning or operating a dental office or clinic, an entity described in sub-  
10 section (3) of this section must:

11 (a) Name an actively licensed dentist as its dental director, who shall be subject to the pro-  
12 visions of ORS 679.140 in the capacity as dental director. The dental director, or an actively licensed  
13 dentist designated by the director, shall have responsibility for the clinical practice of dentistry,  
14 which includes, but is not limited to:

15 (A) Diagnosis of conditions within the human oral cavity and its adjacent tissues and structures.

16 (B) Prescribing drugs that are administered to patients in the practice of dentistry.

17 (C) The treatment plan of any dental patient.

18 (D) Overall quality of patient care that is rendered or performed in the practice of dentistry.

19 (E) Supervision of dental hygienists, dental assistants or other personnel involved in direct pa-  
20 tient care and the authorization for procedures performed by them in accordance with the standards  
21 of supervision established by statute or by the rules of the board.

22 (F) Other specific services within the scope of clinical dental practice.

23 (G) Retention of patient dental records as required by statute or by rule of the board.

24 (H) Ensuring that each patient receiving services from the dental office or clinic has a dentist  
25 of record.

26 (b) Maintain current records of the names of licensed dentists who supervise the clinical activ-  
27 ities of dental hygienists, dental assistants or other personnel involved in direct patient care utilized  
28 by the entity. The records must be available to the board upon written request.

29 (5) Subsections (1) and (2) of this section do not apply to [*a limited access permit*] **an expanded**  
30 **practice** dental hygienist who renders services authorized by a [*limited access*] permit issued by the  
31 board pursuant to ORS 680.200.

32 (6) Nothing in this chapter precludes a person or entity not licensed by the board from:

33 (a) Ownership or leasehold of any tangible or intangible assets used in a dental office or clinic.  
34 These assets include real property, furnishings, equipment and inventory but do not include dental  
35 records of patients related to clinical care.

36 (b) Employing or contracting for the services of personnel other than licensed dentists.

37 (c) Management of the business aspects of a dental office or clinic that do not include the clin-  
38 ical practice of dentistry.

39 (7) If all of the ownership interests of a dentist or dentists in a dental office or clinic are held  
40 by an administrator, executor, personal representative, guardian, conservator or receiver of the es-  
41 tate of a former shareholder, member or partner, the administrator, executor, personal represen-  
42 tative, guardian, conservator or receiver may retain the ownership interest for a period of 12 months  
43 following the creation of the ownership interest. The board shall extend the ownership period for  
44 an additional 12 months upon 30 days' notice and may grant additional extensions upon reasonable  
45 request.

1       **SECTION 5.** ORS 679.025 is amended to read:

2       679.025. (1) *[It shall be unlawful for any]* **A** person *[not otherwise authorized by law to]* **may not**  
3 practice dentistry or purport to be a dentist without a valid license to practice dentistry issued by  
4 the Oregon Board of Dentistry.

5       (2) The requirements of this section *[shall]* **do** not apply to:

6       (a) Dentists licensed in another state making a clinical presentation sponsored by a bona fide  
7 dental society or association or an accredited dental educational institution approved by the board.

8       (b) Bona fide full-time students of dentistry who, during the period of their enrollment and as a  
9 part of the course of study in an Oregon accredited dental education program, engage in clinical  
10 studies on the premises of such institution or in a clinical setting located off the premises of the  
11 institution if the facility, the instructional staff and the course of study to be pursued at the off-  
12 premises location meet minimum requirements prescribed by the rules of the board and the clinical  
13 study is performed under the direct supervision of a member of the faculty.

14       (c) Bona fide full-time students of dentistry who, during the period of their enrollment and as a  
15 part of the course of study in a dental education program located outside of Oregon that is accred-  
16 ited by the Commission on Dental Accreditation of the American Dental Association or its successor  
17 agency, engage in community-based or clinical studies as an elective or required rotation in a clin-  
18 ical setting located in Oregon if the community-based or clinical studies meet minimum requirements  
19 prescribed by the rules of the board and are performed under the direct supervision of a member  
20 of the faculty of the Oregon Health and Science University School of Dentistry.

21       (d) Candidates who are preparing for a licensure examination to practice dentistry and whose  
22 application has been accepted by the board or its agent, if such clinical preparation is conducted in  
23 a clinic located on premises approved for that purpose by the board and if the procedures are lim-  
24 ited to examination only. This exception shall exist for a period not to exceed two weeks imme-  
25 diately prior to a regularly scheduled licensure examination.

26       (e) Dentists practicing in the discharge of official duties as employees of the United States  
27 Government and any of its agencies.

28       (f) Instructors of dentistry, whether full- or part-time, while exclusively engaged in teaching ac-  
29 tivities and while employed in accredited dental educational institutions.

30       (g) Dentists employed by public health agencies who are not engaged in the direct delivery of  
31 clinical dental services to patients.

32       (h) Persons licensed to practice medicine in the State of Oregon in the regular discharge of their  
33 duties.

34       (i) Persons qualified to perform services relating to general anesthesia or sedation under the  
35 direct supervision of a licensed dentist.

36       (j) Persons practicing dentistry upon themselves as the patient.

37       (k) Dental hygienists, dental assistants or dental technicians performing services under the  
38 supervision of a licensed dentist in accordance with the rules adopted by the board.

39       (L) A person licensed as a denturist under ORS 680.500 to 680.565 engaged in the practice of  
40 denture technology.

41       (m) *[A limited access permit]* **An expanded practice** dental hygienist who renders services au-  
42 thorized by a *[limited access]* permit issued by the board pursuant to ORS 680.200.

43       **SECTION 6.** ORS 680.150 is amended to read:

44       680.150. (1) Any dentist may employ a dental hygienist who may engage in the practice of dental  
45 hygiene in the office of such dentist under the general supervision of a dentist.

1 (2) Any public institution, health care facility or health maintenance organization, as those  
2 terms are defined in ORS 442.015, may employ a dental hygienist who may engage in the practice  
3 of dental hygiene under the general supervision of a dentist.

4 (3) A dental hygienist under the general supervision of a dentist may engage in the practice of  
5 dental hygiene in any place where limited access patients are located.

6 (4) The Oregon Board of Dentistry may adopt rules specifying other locations where dental  
7 hygienists may work and shall specify in its rules the degree of supervision a dentist must exercise  
8 over the procedures the hygienist performs.

9 (5) Notwithstanding ORS 679.010 [(4)] (3), supervision by a dentist is not required when a dental  
10 hygienist determines the need for and appropriateness of sealants or fluoride, and applies sealants  
11 or fluoride at the locations and for persons described in ORS 680.205 (1) [and (2)].

12 **SECTION 7.** ORS 680.200 is amended to read:

13 680.200. (1) Upon application accompanied by the fee established by the Oregon Board of  
14 Dentistry, the board shall grant a permit to practice as [a *limited access permit*] **an expanded**  
15 **practice** dental hygienist to [any] **an** applicant who:

16 (a) Holds a valid, unrestricted Oregon dental hygiene license;

17 (b) Presents proof of current professional liability insurance coverage;

18 (c) Presents documentation satisfactory to the board of successful completion of an emergency  
19 life support course for health professionals, including cardiopulmonary resuscitation, from an agency  
20 or educational institution approved by the board; and

21 (d) Presents documentation satisfactory to the board that the [person] **applicant** has:

22 (A)(i) Completed 2,500 hours of supervised dental hygiene practice; and

23 (ii) **After licensure as a dental hygienist**, completed 40 hours of courses, **chosen by the ap-**  
24 **plicant**, in [a *formal, post-secondary educational program accredited by the Commission on Dental*  
25 *Accreditation of the American Dental Association or its successor agency and*] **clinical dental hygiene**  
26 **or public health sponsored by continuing education providers** approved by the board; or

27 (B) Completed a course of study approved by the board that includes at least 500 hours of dental  
28 hygiene practice, **completed before or after graduation from a dental hygiene program**, on pa-  
29 tients described in ORS 680.205 while under the direct supervision of a member of the faculty of a  
30 dental program or dental hygiene program accredited by the Commission on Dental Accreditation  
31 of the American Dental Association or its successor agency. [*Practice hours from before and after*  
32 *graduation from the dental hygiene program may be combined to meet the requirement of this subpar-*  
33 *agraph.*]

34 (2) [All permits] **A permit** issued pursuant to subsection (1) of this section [expire] **expires** two  
35 years following the date of issuance unless renewed on or before that date by:

36 (a) Payment of the renewal fee as set by the board;

37 (b) Submission to the board of satisfactory evidence of completion of at least 36 hours of con-  
38 tinuing education; [and]

39 (c) Presentation to the board of proof of professional liability insurance coverage; **and**

40 (d) **Completion of a survey developed by the board that measures the success of the ex-**  
41 **panded practice dental hygienist program against baseline data.**

42 (3) The board may refuse to issue or renew [a *limited access*] **an expanded practice dental**  
43 **hygienist** permit or may suspend or revoke the permit of [a *limited access permit*] **an expanded**  
44 **practice** dental hygienist who has been convicted of an offense or been disciplined by a dental li-  
45 censing body in a manner that bears, in the judgment of the board, a demonstrable relationship to

1 the ability of the applicant to practice [*limited access permit*] **expanded practice** dental hygiene in  
2 accordance with the provisions of this chapter or ORS chapter 679, or who has falsified an appli-  
3 cation for permit, or any person for any cause described under ORS 679.140 or 679.170.

4 **SECTION 8.** ORS 680.205 is amended to read:

5 680.205. (1) [*A dental hygienist issued a permit to act as a limited access permit*] **An expanded**  
6 **practice** dental hygienist [*under ORS 680.200 shall be authorized to*] **may** render all services within  
7 the scope of practice of dental hygiene, as defined in ORS 679.010, without the supervision of a  
8 dentist and as authorized by the [*limited access*] **expanded practice dental hygienist** permit to:

9 (a) Patients or residents of the following facilities or programs who, due to age, infirmity or  
10 disability, are unable to receive regular dental hygiene treatment:

11 (A) Nursing homes as defined in ORS 678.710;

12 (B) Adult foster homes as defined in ORS 443.705;

13 (C) Residential care facilities as defined in ORS 443.400;

14 (D) Adult congregate living facilities as defined in ORS 441.525;

15 (E) Mental health residential programs administered by the Oregon Health Authority;

16 (F) Facilities for mentally ill persons, as those terms are defined in ORS 426.005;

17 (G) Facilities for persons with mental retardation, as those terms are defined in ORS 427.005;

18 (H) Local correctional facilities and juvenile detention facilities as those terms are defined in  
19 ORS 169.005, regional correctional facilities as defined in ORS 169.620, youth correction facilities  
20 as defined in ORS 420.005, youth care centers as defined in ORS 420.855, and Department of Cor-  
21 rections institutions as defined in ORS 421.005; or

22 (I) Public and nonprofit community health clinics.

23 (b) Adults who are homebound.

24 (c) Students or enrollees of nursery schools and day care programs and their siblings under 18  
25 years of age, Job Corps and [*other*] similar employment training facilities, primary and secondary  
26 schools, including private schools and public charter schools, and persons entitled to benefits under  
27 the Women, Infants and Children Program.

28 (d) Patients in hospitals, medical clinics, medical offices or offices operated or staffed by nurse  
29 practitioners, physician assistants or midwives.

30 (e) **Patients whose income is less than the federal poverty level.**

31 (f) **Other populations that the Oregon Board of Dentistry determines are underserved or**  
32 **lack access to dental hygiene services.**

33 [*(2) The Oregon Board of Dentistry may authorize the provision of dental hygiene services by a*  
34 *limited access permit dental hygienist at locations or to populations that are underserved or lack access*  
35 *to dental hygiene services.*]

36 [*(3)*] (2) At least once each calendar year, [*a dental hygienist issued a permit to act as a limited*  
37 *access permit*] **an expanded practice** dental hygienist shall refer each patient or resident to a den-  
38 tist who is available to treat the patient or resident.

39 (3) **An expanded practice dental hygienist may render the services described in para-**  
40 **graphs (a) to (d) of this subsection to the patients described in subsection (1) of this section**  
41 **if the expanded practice dental hygienist has entered into an agreement in a format approved**  
42 **by the board with a dentist licensed under ORS chapter 679. The agreement must set forth**  
43 **the agreed-upon scope of the dental hygienist's practice with regard to:**

44 (a) **Administering local anesthesia;**

45 (b) **Administering temporary restorations without excavation;**

1 (c) **Prescribing prophylactic antibiotics and nonsteroidal anti-inflammatory drugs speci-**  
2 **fied in the agreement; and**

3 (d) **Overall dental risk assessment and referral parameters.**

4 (4) This section does not authorize [*a limited access permit*] **an expanded practice** dental  
5 hygienist [*to administer local anesthesia or temporary restorations except under the general supervision*  
6 *of a dentist licensed under ORS chapter 679, or*] to administer nitrous oxide except under the indirect  
7 supervision of a dentist licensed under ORS chapter 679.

8 (5) [*A limited access permit*] **An expanded practice** dental hygienist may assess the need for and  
9 appropriateness of sealants, apply sealants and write prescriptions for all applications of fluoride in  
10 which fluoride is applied or supplied to patients.

11 (6) [*A person granted a limited access permit under ORS 680.200 shall*] **An expanded practice**  
12 **dental hygienist must** also procure all other permits or certificates required by the board under  
13 ORS 679.250.

14 **SECTION 9.** The Oregon Board of Dentistry shall issue an expanded practice dental  
15 hygienist permit under ORS 680.200 to each person holding a limited access permit under  
16 ORS 680.200 as in effect immediately before the operative date specified in section 19 of this  
17 2011 Act.

18 **SECTION 10.** Section 11 of this 2011 Act is added to and made a part of the Insurance  
19 Code.

20 **SECTION 11.** (1) If a policy of insurance covering dental health provides for coverage for  
21 services performed by a dentist licensed under ORS chapter 679, the policy must also cover  
22 the services when they are performed by an expanded practice dental hygienist, as defined  
23 in ORS 679.010, who has entered into a provider contract with the insurer.

24 (2) The provisions of ORS 743A.001 do not apply to this section.

25 **SECTION 12.** (1) The Oregon Board of Dentistry shall compile data, including baseline  
26 data, in every odd-numbered year on the use of expanded practice dental hygienists, as de-  
27 fined in ORS 679.010, in this state.

28 (2)(a) The Department of Consumer and Business Services shall adopt rules requiring  
29 health insurers to report to the department on the reimbursement of services provided by  
30 expanded practice dental hygienists.

31 (b) The department shall provide the information collected under paragraph (a) of this  
32 subsection to the board.

33 (3) The board shall report to an interim legislative committee related to dental health  
34 on the reimbursement of services provided by expanded practice dental hygienists on or be-  
35 fore October 1 of each even-numbered year.

36 **SECTION 13.** ORS 750.055 is amended to read:

37 750.055. (1) The following provisions of the Insurance Code apply to health care service con-  
38 tractors to the extent not inconsistent with the express provisions of ORS 750.005 to 750.095:

39 (a) ORS 705.137, 705.139, 731.004 to 731.150, 731.162, 731.216 to 731.362, 731.382, 731.385, 731.386,  
40 731.390, 731.398 to 731.430, 731.428, 731.450, 731.454, 731.488, 731.504, 731.508, 731.509, 731.510,  
41 731.511, 731.512, 731.574 to 731.620, 731.592, 731.594, 731.640 to 731.652, 731.730, 731.731, 731.735,

20 **COMMUNITY DENTAL HEALTH COORDINATOR PILOT PROJECTS**

22 **SECTION 15. (1) The Oregon Health Authority may approve pilot projects for training**  
23 **and certifying community dental health coordinators to educate the community on dental**  
24 **health.**

25 **(2) The authority shall consult with appropriate professional organizations, educational**  
26 **institutions and the Oregon Board of Dentistry before approving pilot projects under this**

5       **SECTION 17.** The Dental Pilot Projects Fund is established in the State Treasury, separate and distinct from the General Fund. Interest earned by the Dental Pilot Projects Fund shall be credited to the fund. Moneys in the fund are continuously appropriated to the Oregon Health Authority for the purposes of carrying out the provisions of sections 1 and 15 of this 2011 Act.
