

Senate Bill 76

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor John A. Kitzhaber for Department of Corrections)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Expands definition of "corrections officer" to include officers who supervise other corrections officers.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to certification of corrections officers; amending ORS 181.610 and 181.665; and declaring
3 an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 181.610 is amended to read:

6 181.610. In ORS 181.610 to 181.712, unless the context requires otherwise:

7 (1) "Abuse" has the meaning given the term in ORS 107.705.

8 (2) "Board" means the Board on Public Safety Standards and Training appointed pursuant to
9 ORS 181.620.

10 (3) "Certified reserve officer" means a reserve officer who has been designated by a local law
11 enforcement unit, has received training necessary for certification and has met the minimum stan-
12 dards and training requirements established under ORS 181.640.

13 (4) "Commissioned" means [*an authorization granting the power*] **being authorized** to perform
14 various acts or duties of a police officer or certified reserve officer and acting under the supervision
15 and responsibility of a county sheriff or as otherwise provided by law.

16 (5) "Corrections officer" means an officer or member [*of*] **employed full-time by** a law
17 enforcement unit who [*is employed full-time thereby and*]:

18 (a) Is charged with and primarily performs the duty of custody, control or supervision of indi-
19 viduals convicted of or arrested for a criminal offense and confined in a place of incarceration or
20 detention other than a place used exclusively for incarceration or detention of juveniles[.]; **or**

21 (b) **Has been certified as a corrections officer described in paragraph (a) of this sub-**
22 **section and has supervisory or management responsibility for corrections officers described**
23 **in paragraph (a) of this subsection.**

24 (6) "Department" means the Department of Public Safety Standards and Training.

25 (7) "Director" means the Director of the Department of Public Safety Standards and Training.

26 (8) "Domestic violence" means abuse between family or household members.

27 (9) "Emergency medical dispatcher" means a person who has responsibility to process requests
28 for medical assistance from the public or to dispatch medical care providers.

29 (10) "Family or household members" has the meaning given that term in ORS 107.705.

30 (11) "Fire service professional" means a paid or volunteer firefighter, an officer or a member

1 of a public or private fire protection agency that is engaged primarily in fire investigation, fire
 2 prevention, fire safety, fire control or fire suppression or providing emergency medical services, light
 3 and heavy rescue services, search and rescue services or hazardous materials incident response.
 4 “Fire service professional” does not *[include]* **mean** forest fire protection agency personnel.

5 [(12)(a)] **(12)** “Law enforcement unit” means:

6 (a) A police force or organization of the state, a city, port, school district, mass transit district,
 7 county, county service district authorized to provide law enforcement services under ORS 451.010,
 8 Indian reservation, Criminal Justice Division of the Department of Justice, the Department of Cor-
 9 rections, the Oregon State Lottery Commission or common carrier railroad *[whose]* **the** primary duty
 10 **of which**, as prescribed by law, ordinance or directive, is *[any]* one or more of the following:

11 (A) Detecting crime and enforcing the criminal laws of this state or laws or ordinances relating
 12 to airport security;

13 (B) The custody, control or supervision of individuals convicted of or arrested for a criminal
 14 offense and confined to a place of incarceration or detention other than a place used exclusively for
 15 incarceration or detention of juveniles; or

16 (C) The control, supervision and reformation of adult offenders placed on parole or sentenced
 17 to probation and investigation of adult offenders on parole or probation or being considered for
 18 parole or probation[.];

19 *[(b) “Law enforcement unit” also means:]*

20 [(A)] (b) A police force or organization of a private entity with a population of more than 1,000
 21 residents in an unincorporated area *[whose]* **the** employees **of which** are commissioned by a county
 22 sheriff;

23 [(B)] (c) A district attorney’s office; *[and]* **or**

24 [(C)] (d) A private, nonprofit animal care agency that has maintained an animal welfare inves-
 25 tigation department for at least five years and has had officers commissioned as special agents by
 26 the Governor.

27 (13) “Parole and probation officer” means:

28 (a) *[Any]* **An** officer who is employed full-time by the Department of Corrections, a county or a
 29 court and who is charged with and performs the duty of:

30 (A) Community protection by controlling, investigating, supervising and providing or making
 31 referrals to reformative services for adult parolees or probationers or offenders on post-prison
 32 supervision; or

33 (B) Investigating adult offenders on parole or probation or being considered for parole or pro-
 34 bation; or

35 (b) *[Any]* **An** officer who:

36 (A) Is certified and has been employed as a full-time parole and probation officer for more than
 37 one year;

38 (B) Is employed part-time by the Department of Corrections, a county or a court; and

39 (C) Is charged with and performs the duty of:

40 (i) Community protection by controlling, investigating, supervising and providing or making re-
 41 ferrals to reformative services for adult parolees or probationers or offenders on post-prison super-
 42 vision; or

43 (ii) Investigating adult offenders on parole or probation or being considered for parole or pro-
 44 bation.

45 (14) “Police officer” means an officer, member or employee of a law enforcement unit *[who is]*

1 employed full-time as a peace officer **who is:**

2 (a)(A) Commissioned by a city, port, school district, mass transit district, county, county service
 3 district authorized to provide law enforcement services under ORS 451.010, Indian reservation, the
 4 Criminal Justice Division of the Department of Justice, the Oregon State Lottery Commission[*or*],
 5 the Governor or [*who is a member of*] the Department of State Police [*and who is*]; **and**

6 (B) Responsible for enforcing the criminal laws of this state or laws or ordinances relating to
 7 airport security [*or is*]; **or**

8 (b) An investigator of a district attorney’s office if the investigator is or has been certified as
 9 a peace officer in this or [*any other*] **another** state.

10 (15) “Public or private safety agency” means [*any*] **a** unit of state or local government, a special
 11 purpose district or a private firm [*which*] **that** provides, or has authority to provide, fire fighting,
 12 police, ambulance or emergency medical services.

13 (16) “Public safety personnel” and “public safety officer” include corrections officers, youth
 14 correction officers, emergency medical dispatchers, parole and probation officers, police officers,
 15 certified reserve officers, telecommunicators and fire service professionals.

16 (17) “Reserve officer” means an officer or member of a law enforcement unit **who is:**

17 (a) [*Who is*] A volunteer or [*who is*] employed less than full-time as a peace officer commissioned
 18 by a city, port, school district, mass transit district, county, county service district authorized to
 19 provide law enforcement services under ORS 451.010, Indian reservation, the Criminal Justice Divi-
 20 sion of the Department of Justice, the Oregon State Lottery Commission[*or*], the Governor or [*who*
 21 *is a member of*] the Department of State Police;

22 (b) [*Who is*] Armed with a firearm; and

23 (c) [*Who is*] Responsible for enforcing the criminal laws and traffic laws of this state or laws
 24 or ordinances relating to airport security.

25 (18) “Telecommunicator” means [*any*] **a** person employed as an emergency telephone worker as
 26 defined in ORS 243.736 or a public safety dispatcher whose primary duties are receiving, processing
 27 and transmitting public safety information received through a 9-1-1 emergency reporting system as
 28 defined in ORS 403.105.

29 (19) “Youth correction officer” means an employee of the Oregon Youth Authority who is
 30 charged with and primarily performs the duty of custody, control or supervision of youth offenders
 31 confined in a youth correction facility.

32 **SECTION 2.** ORS 181.665 is amended to read:

33 181.665. (1) Except for a person who has requested and obtained an extension from the Depart-
 34 ment of Public Safety Standards and Training pursuant to subsection (2) of this section, a person
 35 may not be employed as a police officer, or utilized as a certified reserve officer, by any law
 36 enforcement unit for more than 18 months unless:

37 (a) The person is a citizen of the United States; and

38 (b) The person has been certified as being qualified as a police officer or certified reserve officer
 39 under the provisions of ORS 181.610 to 181.712 and the certification has neither lapsed nor been
 40 revoked pursuant to ORS 181.661, 181.662 and 181.664 (1) and not been reissued under ORS 181.664
 41 (2).

42 (2) The department, upon the facts contained in an affidavit accompanying the request for an
 43 extension, may find good cause for failure to obtain certification within the time period described
 44 in subsection (1) of this section. If the department finds that there is good cause for such failure,
 45 the department may extend for up to one year the period that a person may serve as a police officer

1 or reserve officer without certification. The grant or denial of such an extension is within the sole
2 discretion of the department.

3 (3) Except as provided in subsection (4) of this section, a person employed as a police officer
4 by any law enforcement unit shall commence the training necessary for certification under ORS
5 181.610 to 181.712 at an academy operated by the department not later than the 90th day after the
6 date of the officer's employment by the law enforcement unit.

7 (4) A law enforcement unit may delay the commencement of training of a police officer for up
8 to 120 days from the date of the officer's employment when it considers the delay necessary. When
9 a law enforcement unit delays commencement of a police officer's training under this subsection, it
10 shall file a written statement of its reasons with the department.

11 (5) When a delay in the commencement of training necessary for certification under ORS 181.610
12 to 181.712 at an academy operated by the department is caused by the inability of the department,
13 for any reason, to provide that training, the period of such delay shall not be counted as part of the
14 periods set forth in subsections (3) and (4) of this section within which the training must be com-
15 menced.

16 (6) A person utilized as a certified reserve officer by a law enforcement unit must complete the
17 training necessary for certification under ORS 181.610 to 181.712 at a site approved by the depart-
18 ment.

19 (7) Notwithstanding any other provision of law, the law enforcement unit described in ORS
20 181.610 [(12)(b)(C)] (12)(d) shall bear the expense of training necessary for certification under ORS
21 181.610 to 181.712.

22 **SECTION 3. This 2011 Act being necessary for the immediate preservation of the public**
23 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
24 **on its passage.**
