76th OREGON LEGISLATIVE ASSEMBLY--2011 Regular Session

Senate Bill 815

Sponsored by COMMITTEE ON JUDICIARY (at the request of Oregon Law Commission)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes owner of real property to use transfer on death deed to pass real property outside of probate at owner's death.

6	UNIFORM REAL PROPERTY TRANSFER ON DEATH ACT
7	
8	SECTION 1. Sec. 1 - Short title. Sections 1 to 18 of this 2011 Act may be cited as the
9	Uniform Real Property Transfer on Death Act.
10	SECTION 2. Sec. 2 - Definitions. As used in sections 1 to 18 of this 2011 Act:
11	(1) "Beneficiary" means a person that receives property under a transfer on death deed.
12	(2) "Designated beneficiary" means a person designated to receive property in a transfer
13	on death deed.
14	(3) "Joint owner" means a joint tenant, a tenant by the entirety and any other co-owner
15	of property that is held in a manner that entitles one or more of the owners to ownership
16	of the whole of the property upon the death of one or more of the other owners.
17	(4) "Person" means an individual, corporation, business trust, personal representative,
18	trustee, partnership, limited liability company, association, joint venture, public corporation,
19	government or governmental subdivision, agency or instrumentality or any other legal or
20	commercial entity.
21	(5) "Property" means an interest in real property located in this state.
22	(6) "Transfer on death deed" means a deed that conveys property to a designated bene-
23	ficiary at the transferor's death.
24	(7) "Transferor" means an individual who makes a transfer on death deed.
25	SECTION 3. Sec. 3 - Applicability. Sections 1 to 18 of this 2011 Act apply to a transfer
26	on death deed made before, on or after the effective date of this 2011 Act by a transferor
27	dying on or after the effective date of this 2011 Act.
28	SECTION 4. Sec. 4 - Nonexclusivity. Sections 1 to 18 of this 2011 Act do not affect any
29	method of transferring property otherwise permitted by the law of this state.
30	SECTION 5. Sec. 5 - Authority for transfer on death deed. (1) An individual may transfer
31	property to one or more designated beneficiaries effective at the transferor's death by a

1	transfer on death deed.
2	(2) The individual may designate one or more:
3	(a) Primary beneficiaries; and
4	(b) Alternate beneficiaries who take the property only if none of the primary beneficiaries
5	is qualified or survives the transferor.
6	SECTION 6. Sec. 6 - Revocability of transfer on death deed. A transfer on death deed is
7	revocable even if the deed or another instrument contains a contrary provision.
8	SECTION 7. Sec. 7 - Nontestamentary nature of transfer on death deed. A transfer on
9	death deed is nontestamentary.
10	SECTION 8. Sec. 8 - Capacity of transferor; fraud, duress or undue influence. (1) The
11	capacity required to make or revoke a transfer on death deed is the same as the capacity
12	required to make a will.
13	(2) A transfer on death deed or an instrument revoking a transfer on death deed that is
14	procured by fraud, duress or undue influence is void.
15	(3) A proceeding must be commenced not later than 18 months after the transferor's
16	death to:
17	(a) Contest the capacity of the transferor; or
18	(b) Determine whether a transfer on death deed or an instrument revoking a transfer
19	on death deed is void because it was procured by fraud, duress or undue influence.
20	SECTION 9. Sec. 9 - Requirements. (1) A transfer on death deed:
21	(a) Except as provided otherwise in paragraph (b) of this subsection, must contain the
22	essential elements and formalities of a properly recordable inter vivos deed;
23	(b) Must state that the transfer to the designated beneficiary is to occur at the
24	transferor's death;
25	(c) Must identify the designated beneficiary by name; and
26	(d) Must be recorded before the transferor's death in the deed records in the office of the
27	county clerk for the county in which the property is located.
28	(2) A beneficiary designation that identifies beneficiaries only as members of a class is
29	void.
30	SECTION 10. Sec. 10 - Notice; delivery; acceptance; consideration. A transfer on death
31	deed is effective without:
32	(1) Notice or delivery to, or acceptance by, the designated beneficiary during the
33	transferor's life; or
34	(2) Consideration.
35	SECTION 11. Sec. 11 - Revocation by instrument; revocation by act. (1) An instrument
36	is effective to revoke a recorded transfer on death deed, or any part of it, only if the in-
37	strument:
38	(a) Is acknowledged by the transferor after the transferor acknowledges the deed to be
39	revoked;
40	(b) Is recorded before the transferor's death in the deed records of the county in which
41	the property is located; and
42	(c) Is one of the following:
43	(A) A transfer on death deed that revokes the deed, or part of the deed, expressly or by
44	inconsistency;

45 (B) An instrument of revocation that expressly revokes the deed, or part of the deed; or

of the transferor may revoke the transfer on death deed as provided in this section.
(3) If a transfer on death deed is made by more than one transferor, revocation by one
transferor does not affect the transfer of another transferor's interest in property by the
transfer on death deed.
(4) After a transfer on death deed is recorded, the deed may not be revoked by a
revocatory act on the deed.
(5) This section does not limit the effect of an inter vivos transfer of the property.
SECTION 12. Sec. 12 - Effect of transfer on death deed during transferor's life. During
a transferor's life, a transfer on death deed does not:
(1) Affect an interest or right of the transferor or any other owner, including the right
to transfer or encumber the property;
(2) Affect an interest or right of a designated beneficiary, even if the designated benefi-
ciary has actual or constructive notice of the deed;
(3) Affect an interest or right of a secured, unsecured or future creditor of the transferor
even if the creditor has actual or constructive notice of the deed;
(4) Affect the eligibility of the transferor or a designated beneficiary for any form of
public assistance;
(5) Create a legal or equitable interest in favor of the designated beneficiary; or
(6) Subject the property to claims or process of a secured, unsecured or future creditor
of the designated beneficiary.
SECTION 13. Sec. 13 - Effect of transfer on death deed at transferor's death. (1) Except
as provided otherwise in the transfer on death deed and subject to ORS 107.115, 112.455 to
112.555 or 112.570 to 112.590 and sections 19, 20 and 21 of this 2011 Act, when a transferor
dies, the following rules apply to property that is subject to a transfer on death deed and
owned by the transferor at death:
(a) A designated beneficiary's interest in the property:
(A) Is transferred to the designated beneficiary in accordance with the deed if the des-
ignated beneficiary survives the transferor; or
(B) Lapses if the designated beneficiary does not survive the transferor.
(b) If the transferor has identified multiple designated beneficiaries to receive concurrent
interests in the property:
(A) Concurrent interests are transferred to the designated beneficiaries in equal and
undivided shares with no right of survivorship; and
(B) The share of a designated beneficiary that lapses or fails for any reason is transferred
to the remaining designated beneficiaries in proportion to the interest of each designated

7	SECTION 14. Sec. 14 - Disclaimer. A beneficiary may disclaim all or part of the
8	beneficiary's interest as provided by ORS 105.623 to 105.649.
9	SECTION 15. Sec. 15 - Liability for creditor claims and statutory allowances. (1) A
10	transferor's estate may enforce a liability against property transferred at the death of the
11	transferor by a transfer on death deed to the extent that the probate estate of the transferor
12	is insufficient to satisfy:
13	(a) A claim allowed or established by summary determination or separate action under
14	ORS 114.505 to 114.560 or under ORS chapter 115 against the probate estate; or
15	(b) A statutory allowance to a surviving spouse or child under ORS 114.015.
16	(2) If the same transferor transfers multiple properties by one or more transfer on death
17	deeds, the liability under this section is apportioned among the transferred properties in
18	proportion to the net value of each transferred property at the transferor's death.
19	(3) A proceeding must be commenced not later than 18 months after the transferor's
20	death to enforce the liability under this section.
