**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Removes sunset on Alcohol and Drug Policy Commission [*and adds members and advisory committee*]. **Modifies membership of commission. Adds budget advisory committee to commission.** Modifies and adds additional duties of commission. Requires commission **to establish priorities and policies related to alcohol and drug prevention and treatment services, to adopt budget policy priorities for alcohol and drug prevention and treatment services and** to establish [*or approve*] minimum standards for alcohol and drug prevention and treatment programs financed with state funds or with other funds administered by state.

**Requires commission to develop and implement plan for structuring Oregon's data collection and reporting systems for alcohol and drug prevention and treatment programs.**

9 Whereas almost 70 percent of inmates in Oregon prisons need treatment for drug and alcohol  
10 problems; and

11 Whereas the number of Oregon eighth graders who have had an alcoholic drink in the past 30  
12 days is nearly twice the national average; and

13 Whereas health care expenditures in Oregon associated with alcohol and drug abuse were \$813  
14 million in 2006; and

15 Whereas there were 229 overdose deaths in Oregon in 2008; and

16 Whereas 56 percent of Oregon parents whose children are abused and neglected have issues  
17 with drug and alcohol addiction; and

18 Whereas in 2008, 33 percent of Oregon traffic fatalities involved alcohol-impaired drivers; and

19 Whereas alcohol abuse costs Oregon's economy \$3.2 billion per year, more than eight times the  
20 amount of tax revenue from alcohol sales; and

21 Whereas although prevention and recovery are very cost-effective, Oregon's programs have been  
22 consistently underfunded, leaving tens of thousands of Oregonians without assistance; and

23 Whereas Oregon does not have a consistent, rational data collection and accountability system  
24 to track funding and ensure that funds are invested wisely; and

1       Whereas many prevention programs in the state do not follow best practices established through  
2 scientifically sound randomized testing; and

3       Whereas the state lacks a clear long-term strategy for prevention and treatment backed by a  
4 coordinated budgeting process; and

5       Whereas addiction is a chronic disease and must be treated with a continuum of care; and

6       Whereas alcohol and drug recovery services should be founded on evidence-based and tribal-  
7 based practices that are administered with fidelity and also take into consideration the needs of  
8 disparate populations; and

9       Whereas a recovery-oriented system of care must include physical and mental health as well as  
10 addictions; and

11       Whereas policies must encourage collaboration across systems of care so that individuals and  
12 their families receive services that are necessary to recovery; now, therefore,

13 **Be It Enacted by the People of the State of Oregon:**

14       **SECTION 1.** Section 1, chapter 856, Oregon Laws 2009, as amended by section 31, chapter 856,  
15 Oregon Laws 2009, is amended to read:

16       **Sec. 1. (1) As used in this section and section 2 of this 2011 Act:**

17       **(a) “Local government” means a local government as defined in ORS 174.116 that receives**  
18 **state or federal funding for programs that provide alcohol or drug prevention or treatment**  
19 **services.**

20       **(b) “Participating state agency” means the State Commission on Children and Families,**  
21 **the Department of Corrections, the Department of Human Services, the Oregon Health Au-**  
22 **thority, the Department of Education, the Oregon Criminal Justice Commission, the Oregon**  
23 **State Police, the Oregon Youth Authority or any other state agency that is approved by the**  
24 **Alcohol and Drug Policy Commission to license, contract for, provide or coordinate alcohol**  
25 **or drug prevention or treatment services.**

26       **(c) “Provider” means any person that is licensed by the Oregon Health Authority to**  
27 **provide alcohol or drug prevention or treatment services.**

28       **[(1)] (2)** There is created the Alcohol and Drug Policy Commission, which is charged with  
29 **[producing a plan for] planning, evaluating and coordinating policies for** the funding and effective  
30 delivery of alcohol and drug **[treatment and] prevention and treatment** services. **[The commission**  
31 **shall recommend:]**

32       **[(a) A strategy for delivering state-funded treatment and prevention services;]**

33       **[(b) The priority of funding for treatment and prevention services;]**

34       **[(c) Strategies to maximize accountability for performance of treatment and prevention services;]**

35       **[(d) Methods to standardize data collection and reporting; and]**

36       **[(e) A strategy to consolidate treatment and prevention services and reduce the fragmentation in the**  
37 **delivery of services.]**

38       **[(2)] (3)** The membership of the commission consists of:

39       **(a)** Sixteen members appointed by the Governor, subject to confirmation by the Senate in the  
40 manner prescribed in ORS 171.562 and 171.565, including:

41       **(A)** An elected district attorney;

42       **(B)** An elected county sheriff;

43       **(C)** A county commissioner;

44       **(D)** A representative of an Indian tribe;

45       **(E) [An alcohol or drug treatment] A provider;**

- 1 (F) A chief of police;
- 2 (G) An alcohol or drug treatment researcher or epidemiologist;
- 3 (H) A criminal defense attorney;
- 4 [(I) A judge of a circuit court, who shall be a nonvoting member;]
- 5 [(J)] (I) A representative of the health insurance industry;
- 6 [(K)] (J) A representative of hospitals;
- 7 [(L)] (K) An alcohol or treatment professional who is highly experienced in the treatment of
- 8 persons with a dual diagnosis of mental illness and substance abuse;
- 9 [(M)] (L) An alcohol or drug abuse prevention representative;
- 10 [(N)] (M) A consumer of alcohol or drug treatment who is in recovery;
- 11 [(O)] (N) A representative of the business community;
- 12 [(P)] (O) An alcohol or drug prevention representative who specializes in youth; **and**
- 13 **(P) A person with expertise in and experience working with information technology sys-**
- 14 **tems used in complex intergovernmental or corporate settings.**
- 15 (b) Two members of the Legislative Assembly appointed to the commission as nonvoting mem-
- 16 bers of the commission, acting in an advisory capacity only and including:
- 17 (A) One member from among members of the Senate appointed by the President of the Senate;
- 18 and
- 19 (B) One member from among members of the House of Representatives appointed by the Speaker
- 20 of the House of Representatives.
- 21 (c) The following voting ex officio members:
- 22 (A) The Governor or the Governor's designee;
- 23 (B) The Attorney General;
- 24 (C) The Director of the Oregon Health Authority;
- 25 (D) The Director of the Department of Corrections; [and]
- 26 (E) The Superintendent of Public Instruction;
- 27 **(F) The Director of Human Services;**
- 28 **(G) The Director of the Oregon Youth Authority;**
- 29 **(H) The chairperson of the State Commission on Children and Families; and**
- 30 **(I) The administrator of the Oregon Liquor Control Commission.**
- 31 **(d) A judge of a circuit court appointed to the commission as a nonvoting member by the**
- 32 **Chief Justice of the Supreme Court.**
- 33 [(3)] (4) The Alcohol and Drug Policy Commission shall select one of its members as chairperson
- 34 and another as vice chairperson, for such terms and with duties and powers necessary for the per-
- 35 formance of the functions of such offices as the commission determines.
- 36 [(4)] (5) A majority of the voting members of the commission constitutes a quorum for the
- 37 transaction of business.
- 38 [(5)] (6) Official action of the commission requires the approval of a majority of [the voting
- 39 members on the commission] **a quorum.**
- 40 [(6)] (7) The commission may establish a steering committee and subcommittees. These commit-
- 41 tees may be continuing or temporary.
- 42 [(7)] (8) **The term of office of** each commission member appointed by the Governor **is four**
- 43 **years, but a member** serves at the pleasure of the Governor. If there is a vacancy for any cause,
- 44 the Governor shall make an appointment to become immediately effective.
- 45 [(8)] (9) The Oregon Health Authority shall provide staff support to the commission. Subject to

1 available funding, the commission may contract with a public or private entity to provide staff sup-  
2 port.

3 [(9)] (10) Members of the commission who are not members of the Legislative Assembly are en-  
4 titled to compensation and expenses incurred by them in the performance of their official duties in  
5 the manner and amounts provided for in ORS 292.495. Claims for compensation and expenses shall  
6 be paid out of funds appropriated to the Oregon Health Authority or funds appropriated to the  
7 commission for purposes of the commission.

8 (11) **The commission shall establish a budget advisory committee composed of the indi-  
9 viduals listed in subsection (3)(a)(C), (c)(B) to (I) and (d) of this section. The individual de-  
10 scribed in subsection (3)(d) of this section is a nonvoting member of the committee. The  
11 committee shall recommend budget policy priorities to the commission:**

12 (a) **Regarding the allocation of funding for alcohol and drug prevention and treatment  
13 services across state agencies and throughout this state;**

14 (b) **That identify additional funding from federal and private sources for alcohol and drug  
15 prevention and treatment services; and**

16 (c) **For authorizing a suspension of the payment of state funds, or funds administered  
17 by this state, to programs that do not comply with the commission's rules or the budget  
18 priority policy or that do not provide effective prevention or treatment services.**

19 (12)(a) **The Governor shall appoint a Director of the Alcohol and Drug Policy Commission  
20 who shall serve at the pleasure of the Governor and be responsible for the dissemination and  
21 implementation of the commission's policies and the performance of the duties, functions  
22 and powers of the commission that are delegated to the director by the commission.**

23 (b) **The director shall be paid a salary as provided by law or, if not so provided, as pre-  
24 scribed by the Governor.**

25 **SECTION 2. (1) The Alcohol and Drug Policy Commission established under section 1,  
26 chapter 856, Oregon Laws 2009, shall:**

27 (a) **Establish priorities and policies for alcohol and drug prevention and treatment ser-  
28 vices as part of a long-term strategic prevention and treatment plan for this state.**

29 (b) **In consultation with the budget advisory committee described in section 1, chapter  
30 856, Oregon Laws 2009, adopt budget policy priorities including recommendations for state  
31 agency budget allocations, in the Governor's proposed budget, for alcohol and drug pre-  
32 vention and treatment services.**

33 (c) **For alcohol and drug prevention and treatment services that use state funds or that  
34 use private or federal funds administered by this state, establish, as the commission deems  
35 appropriate, minimum standards for licensing, contracting for, providing and coordinating  
36 the services.**

37 (2) **To promote the effective and efficient use of resources and to reduce unnecessary  
38 administrative requirements, the commission, in consultation with participating state agen-  
39 cies, the Judicial Department, local governments, providers and the Oregon Department of  
40 Administrative Services, shall develop and implement a plan for structuring Oregon's data  
41 collection and reporting systems for alcohol and drug prevention and treatment programs  
42 to enable participating state agencies, the Judicial Department, local governments and pro-  
43 viders to share data to:**

44 (a) **Improve client care;**

45 (b) **Improve and ensure the fidelity of evidence-based treatment practices;**

- 1 (c) Improve alcohol and drug prevention and treatment programs;
- 2 (d) Ensure the accountability of publicly funded programs;
- 3 (e) Establish high-level, statewide performance measures for Oregon's alcohol and drug
- 4 prevention and treatment programs; and
- 5 (f) Advance the science of alcohol and drug prevention and treatment.
- 6 (3) The plan established under subsection (2) of this section must:
- 7 (a) Include protocols and procedures to improve data collection, sharing and analysis and
- 8 the interoperability of data and information systems;
- 9 (b) Include safeguards for protecting the confidentiality of information consistent with
- 10 state and federal privacy and security requirements;
- 11 (c) Include safeguards for protecting trade secret information of providers;
- 12 (d) Include a review of the data collection, sharing and analysis functions of participating
- 13 state agencies with respect to alcohol and drug prevention and treatment programs to iden-
- 14 tify duplicative, inefficient, wasteful or unnecessary functions and include recommendations
- 15 for improvements to the functions described in this paragraph; and
- 16 (e) Be published no later than six months after the appointment, under section 1, chapter
- 17 856, Oregon Laws 2009, of the first Director of the Alcohol and Drug Policy Commission and
- 18 shall be revised as frequently as the commission determines is appropriate.
- 19 (4) Consistent with the plan established under subsection (2) of this section, the com-
- 20 mission may:
- 21 (a) Designate a statewide data repository for data related to alcohol and drug prevention
- 22 and treatment services and require participating state agencies, local governments and pro-
- 23 viders to furnish data to the designated statewide data repository in the form and manner
- 24 prescribed by the commission.
- 25 (b) Direct participating state agencies, local governments and providers to furnish other
- 26 data, information and reports that the commission considers necessary to perform its duties.
- 27 (c) Furnish data to participating state agencies, local governments, providers and the
- 28 Judicial Department.
- 29 (d) Direct the unit within the Oregon Health Authority that conducts analyses and eval-
- 30 uations of alcohol and drug prevention and treatment programs to:
- 31 (A) Modify systems and business processes to conform to the plan established under
- 32 subsection (2) of this section; and
- 33 (B) Change or stop data collection, data sharing or data analysis functions that are
- 34 duplicative, inefficient, wasteful or unnecessary.
- 35 (5) All participating state agencies shall:
- 36 (a) Provide staff support and financial resources to assist the commission in the per-
- 37 formance of its duties, which may include making reasonable modifications to the informa-
- 38 tion systems of the state agencies to conform the systems to the plan established under
- 39 subsection (2) of this section.
- 40 (b) Furnish such information, assistance and advice as the commission considers neces-
- 41 sary to perform its duties.
- 42 (c) Coordinate grant applications that seek funding for alcohol or drug prevention or
- 43 treatment programs.
- 44 (d) Coordinate with research entities to obtain current information about issues related
- 45 to alcohol and drug use and to encourage research to evaluate and refine prevention and

1 **treatment efforts.**

2 (e) **Educate the general public about issues related to alcohol and drug use and the ef-**  
3 **fectiveness of evidence-based prevention and treatment services, to increase public aware-**  
4 **ness and the allocation of resources.**

5 (f) **Promote a treatment delivery infrastructure that will meet anticipated increases in**  
6 **demand for services, ensure a skilled addictions treatment workforce and provide effective**  
7 **treatment assessment mechanisms.**

8 (g) **Assess funding priorities and explore opportunities for additional federal resources for**  
9 **alcohol and drug prevention and treatment services.**

10 (h) **Solicit from agencies, associations, individuals and all political subdivisions of this**  
11 **state program proposals that address identified priorities.**

12 (i) **Evaluate and report to the commission, in the manner and at intervals prescribed by**  
13 **the commission, on the cost and effectiveness of the state agency's treatment programs.**

14 (6) **The commission may:**

15 (a) **Establish up to 10 pilot programs, located in diverse Oregon communities including**  
16 **at least one tribe, to:**

17 (A) **Phase in the long-term strategic prevention and treatment plan developed under**  
18 **subsection (1)(a) of this section; and**

19 (B) **Implement prevention programs developed under subsection (7) of this section.**

20 (b) **Delegate to the Director of the Alcohol and Drug Policy Commission the authority to**  
21 **carry out the provisions of this section.**

22 (c) **Apply for and receive gifts and grants from any public or private source. All moneys**  
23 **received by the commission under this paragraph are continuously appropriated to the com-**  
24 **mission for the purposes of carrying out the duties, functions and powers of the commission.**

25 (d) **Award grants from funds appropriated to the commission by the Legislative Assem-**  
26 **bly, or from funds otherwise available from any other source, for the purpose of carrying**  
27 **out the duties of the commission.**

28 (7) **No later than six months after the appointment of the first Director of the Alcohol**  
29 **and Drug Policy Commission, the director shall develop a science-based model alcohol and**  
30 **drug prevention program for use in conjunction with the pilot programs, if any, established**  
31 **under subsection (6) of this section and as otherwise directed by the commission. The di-**  
32 **rector shall develop the model program in consultation with:**

33 (a) **The Oregon Health Authority;**

34 (b) **The Department of Human Services;**

35 (c) **The Department of Education;**

36 (d) **The Oregon Liquor Control Commission;**

37 (e) **The State Commission on Children and Families;**

38 (f) **Organizations that represent or advocate on behalf of consumers of alcohol and drug**  
39 **prevention and treatment programs; and**

40 (g) **Behavioral scientists.**

41 (8) **The commission and participating state agencies shall enter into interagency agree-**  
42 **ments to:**

43 (a) **Provide staff and financial resources to assist the commission in carrying out its**  
44 **duties;**

45 (b) **Share computer systems and technologies between participating state agencies' staff;**

1 (c) Collect and analyze data related to the performance of alcohol and drug prevention  
2 and treatment programs; and

3 (d) Investigate the impacts of drug and alcohol abuse on Oregonians.

4 (9) The commission may adopt rules to carry out its duties under this section.

5 **SECTION 3.** ORS 3.450 is amended to read:

6 3.450. (1) As used in this section, “drug court program” means a program in which:

7 (a) Individuals who are before the court obtain treatment for substance abuse issues and report  
8 regularly to the court on the progress of their treatment; and

9 (b) A local drug court team, consisting of the court, agency personnel and treatment and service  
10 providers, monitors the individuals’ participation in treatment.

11 (2)(a) The governing body of a county or a treatment provider may establish fees that individuals  
12 participating in a drug court program may be required to pay for treatment and other services  
13 provided as part of the drug court program.

14 (b) A court may order an individual participating in a drug court program to pay fees to par-  
15 ticipate in the program. Fees imposed under this subsection may not be paid to the court.

16 (3) Records that are maintained by the circuit court specifically for the purpose of a drug court  
17 program must be maintained separately from other court records. Records maintained by a circuit  
18 court specifically for the purpose of a drug court program are confidential and may not be disclosed  
19 except in accordance with regulations adopted under 42 U.S.C. 290dd-2, including under the cir-  
20 cumstances described in subsections (4) to [(6)] (7) of this section.

21 (4) If the individual who is the subject of the record gives written consent, a record described  
22 in subsection (3) of this section may be disclosed to members of the local drug court team in order  
23 to develop treatment plans, monitor progress in treatment and determine outcomes of participation  
24 in the drug court program.

25 (5) A record described in subsection (3) of this section may not be introduced into evidence in  
26 any legal proceeding other than the drug court program unless:

27 (a) The individual who is the subject of the record gives written consent for introduction of the  
28 record; or

29 (b) The court finds good cause for introduction. In determining whether good cause exists for  
30 purposes of this paragraph, the court shall weigh the public interest and the need for disclosure  
31 against the potential injury caused by the disclosure to:

32 (A) The individual who is the subject of the record;

33 (B) The individual-physician relationship; and

34 (C) The treatment services being provided to the individual who is the subject of the record.

35 (6) A court, the State Court Administrator, **the Alcohol and Drug Policy Commission** or the  
36 Oregon Criminal Justice Commission:

37 (a) May use records described in subsection (3) of this section and other drug court program  
38 information to track and develop statistics about the effectiveness, costs and other areas of public  
39 interest concerning drug court programs.

40 (b) [A court, the State Court Administrator or the Oregon Criminal Justice Commission] May re-  
41 lease statistics developed under **paragraph (a) of** this subsection and analyses based on the statis-  
42 tics to the public.

43 (7) Statistics and analyses released under [*this*] subsection (6) of this section may not contain  
44 any information that identifies an individual participant in a drug court program.

45 **SECTION 4.** ORS 135.980 is amended to read:

1 135.980. (1) [By January 1, 1990,] The Director of the Department of Corrections shall [compile  
2 and thereafter] maintain a directory of public and private rehabilitative programs known and avail-  
3 able to corrections agencies of the state and of each county. For purposes of this subsection,  
4 “rehabilitative program” means a planned activity, in a custodial or noncustodial context, designed  
5 and implemented to treat drug or alcohol abuse, to prevent criminal sexual behavior, to modify a  
6 propensity to commit crimes against persons or property or to achieve restitution for losses caused  
7 by an offender and includes programs that employ the device of mediation between the victim and  
8 offender. **Rehabilitative programs included in the directory that are designed and implemented  
9 to treat drug or alcohol abuse must meet minimum standards adopted by the Oregon Health  
10 Authority under ORS 430.357.** The director shall include:

11 (a) The name, address and telephone number of the program and the identity of its director or  
12 other principal contact;

13 (b) The geographical jurisdiction of the program;

14 (c) The types of offenders that the program claims to be able to serve and the criteria that the  
15 program applies in selecting or soliciting cases;

16 (d) The claims of the program regarding its effectiveness in reducing recidivism, achieving  
17 restitution or otherwise serving correctional objectives;

18 (e) An assessment by the relevant corrections agency of the actual effectiveness of the program;  
19 and

20 (f) The capacity of the program for new cases.

21 (2) The Director of the Department of Corrections shall make the directory available to the  
22 Oregon Criminal Justice Commission and to judges in a form that will allow sentencing judges to  
23 determine what rehabilitative programs are appropriate and available to the offender during any  
24 period of probation, imprisonment or local incarceration and post-prison supervision. The Director  
25 of the Department of Corrections shall also make the directory available to its employees who pre-  
26 pare presentence reports and proposed release plans for submission to the State Board of Parole and  
27 Post-Prison Supervision.

28 (3) The directory shall be updated as frequently as is practical, but no less often than every six  
29 months.

30 [(4) *The Director of the Department of Corrections shall prepare a plan for monitoring the scope  
31 and measuring the effectiveness of existing rehabilitative programs and shall deliver that plan to the  
32 Oregon Criminal Justice Commission no later than January 1, 1990.*]

33 **SECTION 5.** ORS 137.229 is amended to read:

34 137.229. The Department of Corrections, to the extent that funds are available, shall expand  
35 existing and establish new treatment programs for alcohol and drug dependency **that meet mini-  
36 mum standards adopted by the Oregon Health Authority pursuant to ORS 430.357.**

37 **SECTION 6.** ORS 336.222 is amended to read:

38 336.222. In accordance with rules adopted by the State Board of Education in consultation with  
39 the Oregon Health Authority, each district school board shall adopt a comprehensive alcohol and  
40 drug abuse policy and implementation plan[, *including but*] **that conforms to the policies and  
41 priorities established by the Alcohol and Drug Policy Commission under section 2 of this 2011  
42 Act, and includes but is** not limited to:

43 (1) Alcohol and drug abuse prevention curriculum and public information programs addressing  
44 students, parents, teachers, administrators and school board members;

45 (2) The nature and extent of the district’s expectation of intervention with students who appear



1 to have drug or alcohol abuse problems;

2 (3) The extent of the district's alcohol and other drug prevention and intervention programs; and

3 (4) The district's strategy to gain access to federal funds available for drug abuse prevention  
4 programs.

5 **SECTION 7.** ORS 336.235 is amended to read:

6 336.235. In order to carry out the duties described in ORS 336.222 and 336.227, the State Board  
7 of Education, in consultation with the Oregon Health Authority **and the Alcohol and Drug Policy**  
8 **Commission**, shall adopt by rule, as a minimum, descriptions of the content of what shall be in-  
9 cluded in the policy and plan described in ORS 336.222 and 336.227.

10 **SECTION 8.** ORS 351.105 is amended to read:

11 351.105. In order to carry out the duties described in ORS 352.008, the State Board of Higher  
12 Education, in consultation with the Oregon Health Authority **and the Alcohol and Drug Policy**  
13 **Commission**, shall adopt by rule, as a minimum, descriptions of the content of what shall be in-  
14 cluded in the policy and plan described in ORS 352.008.

15 **SECTION 9.** ORS 352.008 is amended to read:

16 352.008. In consultation with the Oregon Health Authority **and the Alcohol and Drug Policy**  
17 **Commission**, each state institution of higher education shall adopt a comprehensive alcohol and  
18 drug abuse policy and implementation plan.

19 **SECTION 10.** ORS 353.120 is amended to read:

20 353.120. The Oregon Health and Science University, **in consultation with the Alcohol and**

24 409.410. (1) The Director of the Oregon Health Authority shall administer [*all*] alcohol and drug  
25 abuse programs, including but not limited to programs or components of programs described in ORS  
26 430.397 to 430.401, 475.225, 743.557 and 743.558 and ORS chapters 430 and 801 to 822.

27 (2) Subject to ORS 417.300 and 417.305, the director shall:

28 (a) Report to the [*Legislative Assembly*] **Alcohol and Drug Policy Commission** on accomplish-  
29 ments and issues occurring during each biennium, and report on a new biennial plan describing re-  
30 sources, needs and priorities for all alcohol and drug abuse programs.

31 (b) Develop within the Oregon Health Authority priorities for alcohol and drug abuse programs  
32 and activities.

33 [*(c) Monitor the priorities of approved alcohol and drug abuse related programs in all other state*  
34 *agencies.*]

35 [*(d)*] (c) Conduct statewide and special planning processes which provide for participation from  
36 state and local agencies, groups and individuals.

37 [*(e)*] (d) Identify the needs of special populations including minorities, elderly, youth, women and  
38 individuals with disabilities.

39 [*(f)*] (e) Subject to ORS chapter 183, adopt such rules as are necessary for the performance of  
40 the duties and functions specified by this section[, *ORS 430.255 to 430.630, or otherwise lawfully de-*  
41 *legated*].

42 (3) The director may apply for, receive and administer funds, including federal funds and grants,  
43 from sources other than the state. Subject to expenditure limitation set by the Legislative Assembly,  
44 funds received under this subsection may be expended by the director:

45 (a) For the study, prevention or treatment of alcohol and drug abuse and dependence in this

1 state.

2 (b) To provide training, both within this state and in other states, in the prevention and treat-  
3 ment of alcohol and drug abuse and dependence.

4 **(4) The director shall, in consultation with state agencies and counties, establish guide-**  
5 **lines to coordinate program review and audit activities by state agencies and counties that**  
6 **provide funds to alcohol and drug prevention and treatment programs. The purpose of the**  
7 **guidelines is to minimize duplication of auditing and program review requirements imposed**

30 (e) Education and consultation services for primary care physicians treating seniors and persons

32 (3) In carrying out the provisions of subsections (1) and (2) of this section, the department shall:

33 (a) Develop plans for service coordination within the department;

34 (b) Recommend budget provisions for the delivery of needed services offered by the department;

44 nities and develop policy and oversee the implementation of a local coordinated comprehensive plan

- 2 (b) Identify and map the range of resources in the community;
- 3 (c) Plan, advocate and fund research-based **and tribal-based** initiatives for children who are 18

- 5 (d) Develop local policies, priorities, outcomes and targets;
- 6 (e) Prioritize activities identified in the local plan and mobilize the community to take action;
- 7 (f) Prioritize the use of nondedicated resources;
- 8 (g) Monitor implementation of the local plan; and
- 9 (h) Monitor and evaluate the intermediate outcome targets identified in the local plan that are
- 10 reviewed under ORS 417.797, and report on the progress in addressing priorities and achieving out-
- 11 comes.

12 (2)(a) A local commission may not provide direct services for children and their families.

13 (b) Notwithstanding paragraph (a) of this subsection, a local commission may provide direct

14 services for children and their families for a period not to exceed six months if:

15 (A)(i) The local commission determines that there is an emergency;

16 (ii) A provider of services discontinues providing the services in the county or region; or

17 (iii) No provider is able to offer the services in the county or region; and

7 (A) A voluntary local early childhood system plan created pursuant to ORS 417.777;

10 (C) Local service plans, developed pursuant to ORS 430.630, for the delivery of mental health
