**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies provisions related to imposition of civil penalties by [*Water Resources Commission, Department of State Lands, State Department of Fish and Wildlife, State Department of Geology and Mineral Industries, Parks and Recreation Department, State Department of Energy and Department of Environmental Quality*] **Department of State Lands, State Parks and Recreation Department, Department of Environmental Quality, State Department of Energy, State Department of Fish and Wildlife, State Department of Geology and Mineral Industries, State Forestry Department, Water Resources Department and State Department of Agriculture**. Dedicates certain penalties to Department of Justice Protection and Education Revolving Account.

[*Repeals provision requiring notice of violation related to sewage.*]

[*Modifies definition of "generator" for purposes of laws related to hazardous waste.*]

Requires that fine imposed in certain environmental crimes cases be in form of [*compensatory fine*] **restitution**. Directs court to forward [*compensatory fine*] **restitution** payments to Department of Justice for deposit in Department of Justice Protection and Education Revolving Account. Modifies scope of phrase "state and federal environmental laws" for purposes of account.

Declares emergency, effective on passage.

8 **DEPARTMENT OF JUSTICE PROTECTION AND**  
9 **EDUCATION REVOLVING ACCOUNT, RESTITUTION,**  
10 **AND CATEGORIES OF MONETARY OBLIGATIONS**  
11

12 **SECTION 1.** ORS 180.095 is amended to read:

13 180.095. (1) The Department of Justice Protection and Education Revolving Account is created  
14 in the General Fund. All moneys in the account are continuously appropriated to the Department  
15 of Justice and may be used to pay for only the following activities:

16 (a) Restitution and refunds in proceedings described in paragraph (c) of this subsection;

17 (b) Consumer and business education relating to the laws governing antitrust, unlawful trade  
18 practices and the environment; and

19 (c) Personal services, travel, meals, lodging and all other costs and expenses incurred by the  
20 department in investigating, preparing, commencing and prosecuting the following actions and suits,

1 and enforcing judgments, settlements, compromises and assurances of voluntary compliance arising  
2 out of the following actions and suits:

3 (A) Actions and suits under the state and federal antitrust laws;

4 (B) Actions and suits under ORS 646.605 to 646.656;

5 (C) Criminal prosecutions under state *[and]* or federal environmental laws, **including but not**  
6 **limited to prosecutions for conduct made criminal under ORS 164.775, 164.785, 164.805,**  
7 **273.990, 274.990, 390.995, 448.992, 448.994, 453.990, 459.992, 466.995, 467.990, 468.922, 468.926,**  
8 **468.929, 468.931, 468.936, 468.939, 468.943, 468.946, 468.951, 468.953, 468.956, 468A.595, 468A.655,**  
9 **468A.990, 496.992, 498.222, 506.991, 517.990, 520.991, 522.990, 526.990, 527.990, 537.990, 540.990,**

11 (D) Actions commenced under ORS 59.331; *[and]*

12 (E) Actions and suits under ORS 180.750 to 180.785[.]; **and**

13 **(F) Civil actions under state or federal environmental laws, including but not limited to**  
14 **actions under ORS 196.870, 196.895, 390.663 (1)(f) and (6), 390.674, 390.925, 390.986, 390.992 (2),**  
15 **468.090, 468.100, 468.135, 469.085, 469.563, 506.995, 509.910, 517.880 (3), 517.992, 520.175, 522.810,**  
16 **561.191, 568.933 (8) and 634.905 and sections 20, 22, 28 and 30 of this 2011 Act and actions under**  
17 **ORS 561.280 that seek to enjoin the violation of ORS 634.372 or the violation of rules adopted**  
18 **pursuant to ORS 568.912.**

19 (2) Moneys in the Department of Justice Protection and Education Revolving Account are not  
20 subject to allotment. Upon request of the Attorney General, the State Treasurer shall create sub-  
21 accounts within the account for the purposes of managing moneys in the account and allocating  
22 those moneys to the activities described in subsection (1) of this section.

23 (3) Except as otherwise provided by law, all sums of money received by the Department of Jus-  
24 tice under a judgment, settlement, compromise or assurance of voluntary compliance, including  
25 damages, restitution, refunds, attorney fees, costs, disbursements, **penalties** and other recoveries,  
26 but excluding civil penalties under ORS 646.642, in proceedings described in subsection (1)(c) of this  
27 section shall, upon receipt, be deposited with the State Treasurer to the credit of the Department  
28 of Justice Protection and Education Revolving Account. However, if the action or suit was based  
29 on an expenditure or loss from a public body or a dedicated fund, the amount of such expenditure  
30 or loss, after deduction of attorney fees and expenses awarded to the department by the court or  
31 agreed to by the parties, if any, shall be credited to the public body or dedicated fund and the re-  
32 mainder thereof credited to the Department of Justice Protection and Education Revolving Account.

33 (4) If the Department of Justice recovers restitution or refunds in a proceeding described in  
34 subsection (1)(c) of this section, and the department cannot determine the persons to whom the  
35 restitution or refunds should be paid or the amount of the restitution or refund payable to individual  
36 claimants is de minimis, the restitution or refunds may not be deposited in the Department of Justice  
37 Protection and Education Revolving Account and shall be deposited in the General Fund.

38 (5) Before April 1 of each odd-numbered year, the Department of Justice shall report to the Joint  
39 Committee on Ways and Means:

40 (a) The department's projection of the balance in the Department of Justice Protection and Ed-  
41 ucation Revolving Account at the end of the biennium in which the report is made and at the end  
42 of the following biennium;

43 (b) The amount of the balance held for restitution and refunds; and

44 (c) An estimate of the department's anticipated costs and expenses under subsection (1)(b) and  
45 (c) of this section for the biennium in which the report is made and for the following biennium.

1 (6) The Joint Committee on Ways and Means, after consideration of recommendations made by  
2 the Department of Justice, shall use the information reported under subsection (5) of this section to  
3 determine an appropriate balance for the revolving account.

4 **SECTION 2.** ORS 137.103 is amended to read:

5 137.103. As used in ORS 137.101 to 137.109, 161.675 and 161.685:

6 (1) "Criminal activities" means any offense with respect to which the defendant is convicted or  
7 any other criminal conduct admitted by the defendant.

8 (2) "Economic damages":

9 (a) Has the meaning given that term in ORS 31.710, except that "economic damages" does not  
10 include future impairment of earning capacity; and

11 (b) In cases involving criminal activities described in ORS 163.263, 163.264 or 163.266, includes  
12 the greater of:

13 (A) The value to the defendant of the victim's services as defined in ORS 163.261; or

14 (B) The value of the victim's services, as defined in ORS 163.261, computed using the minimum  
15 wage established under ORS 653.025 and the overtime provisions of the federal Fair Labor Standards  
16 Act of 1938 (29 U.S.C. 201 et seq.).

17 (3) "Restitution" means:

18 (a) Full, partial or nominal payment of economic damages to a victim[. *Restitution is independent*  
19 *of and may be awarded in addition to a compensatory fine awarded under ORS 137.101.*]; **and**

20 **(b) In a criminal prosecution described in ORS 180.095 (1)(c)(C), any portion of the fine**  
21 **imposed by the court that is not ordered paid under ORS 137.101.**

22 (4) "Victim" means:

23 (a) The person against whom the defendant committed the criminal offense, if the court deter-  
24 mines that the person has suffered economic damages as a result of the offense.

25 (b) Any person not described in paragraph (a) of this subsection whom the court determines has  
26 suffered economic damages as a result of the defendant's criminal activities.

27 (c) The Criminal Injuries Compensation Account, if it has expended moneys on behalf of a victim  
28 described in paragraph (a) of this subsection.

29 (d) An insurance carrier, if it has expended moneys on behalf of a victim described in paragraph  
30 (a) of this subsection.

31 (5) "Victim" does not include any coparticipant in the defendant's criminal activities.

32 **SECTION 2a.** ORS 137.106 is amended to read:

33 137.106. (1) When a person is convicted of a crime, or a violation as described in ORS 153.008,  
34 that has resulted in economic damages, the district attorney shall investigate and present to the  
35 court, prior to the time of sentencing, evidence of the nature and amount of the damages. If the  
36 court finds from the evidence presented that a victim suffered economic damages, in addition to any  
37 other sanction it may impose, the court shall include one of the following in the judgment:

38 (a) A requirement that the defendant pay the victim restitution in a specific amount that equals  
39 the full amount of the victim's economic damages as determined by the court.

40 (b) A requirement that the defendant pay the victim restitution, and that the specific amount  
41 of restitution will be established by a supplemental judgment based upon a determination made by  
42 the court within 90 days of entry of the judgment. In the supplemental judgment, the court shall  
43 establish a specific amount of restitution that equals the full amount of the victim's economic dam-  
44 ages as determined by the court. The court may extend the time within which the determination and  
45 supplemental judgment may be completed for good cause. The lien, priority of the lien and ability

1 to enforce the specific amount of restitution established under this paragraph by a supplemental  
2 judgment relates back to the date of the original judgment that is supplemented.

3 (c)(A) A requirement that the defendant pay the victim restitution in a specific amount that is  
4 less than the full amount of the victim's economic damages, with the consent of the victim.

5 (B) If the defendant is convicted of a person felony, as that term is defined in the rules of the  
6 Oregon Criminal Justice Commission, a requirement that the defendant pay the victim restitution  
7 in a specific amount that is less than the full amount of the victim's economic damages, only with  
8 the written consent of the victim.

9 (2) After the district attorney makes a presentation described in subsection (1) of this section,  
10 if the court is unable to find from the evidence presented that a victim suffered economic damages,  
11 the court shall make a finding on the record to that effect.

12 (3) No finding made by the court or failure of the court to make a finding under this section  
13 limits or impairs the rights of a person injured to sue and recover damages in a civil action as  
14 provided in ORS 137.109.

15 **(4) When the court imposes a fine in a criminal prosecution described in ORS 180.095**  
16 **(1)(c)(C), the court shall include in the judgment a requirement that the defendant pay as**  
17 **restitution any portion of the fine not ordered paid under ORS 137.101.**

18 [(4)(a)] **(5)(a)** If a judgment or supplemental judgment described in [subsection (1) of] this section  
19 includes restitution, a court may delay the enforcement of the monetary sanctions, including  
20 restitution, only if the defendant alleges and establishes to the satisfaction of the court the  
21 defendant's inability to pay the judgment in full at the time the judgment is entered. If the court  
22 finds that the defendant is unable to pay, the court may establish or allow an appropriate super-  
23 vising authority to establish a payment schedule, taking into consideration the financial resources  
24 of the defendant and the burden that payment of restitution will impose, with due regard to the  
25 other obligations of the defendant. The supervising authority shall be authorized to modify any  
26 payment schedule established under this section.

27 (b) As used in this subsection, "supervising authority" means any state or local agency that is  
28 authorized to supervise the defendant.

29 [(5)] **(6)** If the defendant objects to the imposition, amount or distribution of the restitution, the  
30 court shall allow the defendant to be heard on such issue at the time of sentencing or at the time  
31 the court determines the amount of restitution.

32 **(7) Restitution is independent of and may be awarded in addition to a compensatory fine**  
33 **awarded under ORS 137.101.**

34 **SECTION 2b.** ORS 144.275 is amended to read:

35 144.275. Whenever the State Board of Parole and Post-Prison Supervision orders the release on  
36 parole of an inmate who has been ordered to pay compensatory fines pursuant to ORS 137.101 or  
37 to make restitution pursuant to ORS 137.106, but with respect to whom payment of all or a portion  
38 of the fine or restitution was suspended until the release of the inmate from imprisonment, the board  
39 may establish a schedule by which payment of the compensatory fine or restitution shall be resumed.  
40 In fixing the schedule and supervising the paroled inmate's performance thereunder, the board shall  
41 consider the factors specified in ORS 137.106 [(4)] **(5)**. The board shall provide to the sentencing  
42 court a copy of the schedule and any modifications thereof.

43 **SECTION 2c.** ORS 419A.004 is amended to read:

44 419A.004. As used in this chapter and ORS chapters 419B and 419C, unless the context requires  
45 otherwise:

1 (1) "CASA Volunteer Program" means a program approved or sanctioned by the juvenile court  
2 to recruit, train and supervise volunteer persons to serve as court appointed special advocates.

3 (2) "Child care center" means a residential facility for wards or youth offenders that is licensed  
4 under the provisions of ORS 418.240.

5 (3) "Community service" has the meaning given that term in ORS 137.126.

6 (4) "Conflict of interest" means a person appointed to a local citizen review board who has a  
7 personal or pecuniary interest in a case being reviewed by that board.

8 (5) "Counselor" means a juvenile department counselor or a county juvenile probation officer.

9 (6) "Court" means the juvenile court.

10 (7) "Court appointed special advocate" or "CASA" means a person appointed by the court pur-  
11 suant to a CASA Volunteer Program to act as special advocate pursuant to ORS 419A.170.

12 (8) "Court facility" has the meaning given that term in ORS 166.360.

13 (9) "Department" means the Department of Human Services.

14 (10) "Detention" or "detention facility" means a facility established under ORS 419A.010 to  
15 419A.020 and 419A.050 to 419A.063 for the detention of children, wards, youths or youth offenders  
16 pursuant to a judicial commitment or order.

17 (11) "Director" means the director of a juvenile department established under ORS 419A.010 to  
18 419A.020 and 419A.050 to 419A.063.

19 (12) "Guardian" means guardian of the person and not guardian of the estate.

20 (13) "Indian child" means any unmarried person less than 18 years of age who is:

21 (a) A member of an Indian tribe; or

22 (b) Eligible for membership in an Indian tribe and is the biological child of a member of an In-  
23 dian tribe.

24 (14) "Juvenile court" means the court having jurisdiction of juvenile matters in the several  
25 counties of this state.

26 (15) "Local citizen review board" means the board specified by ORS 419A.090 and 419A.092.

27 (16) "Parent" means the biological or adoptive mother and the legal father of the child, ward,  
28 youth or youth offender. As used in this subsection, "legal father" means:

29 (a) A man who has adopted the child, ward, youth or youth offender or whose paternity has been  
30 established or declared under ORS 109.070 or 416.400 to 416.465 or by a juvenile court; and

31 (b) In cases in which the Indian Child Welfare Act applies, a man who is a father under appli-  
32 cable tribal law.

33 (17) "Permanent foster care" means an out-of-home placement in which there is a long-term  
34 contractual foster care agreement between the foster parents and the department that is approved  
35 by the juvenile court and in which the foster parents commit to raise a ward in substitute care or  
36 youth offender until the age of majority.

37 (18) "Planned permanent living arrangement" means an out-of-home placement other than by  
38 adoption, placement with a relative or placement with a legal guardian that is consistent with the  
39 case plan and in the best interests of the ward.

40 (19) "Public building" has the meaning given that term in ORS 166.360.

41 (20) "Reasonable time" means a period of time that is reasonable given a child or ward's emo-  
42 tional and developmental needs and ability to form and maintain lasting attachments.

43 (21) "Records" means any information in written form, pictures, photographs, charts, graphs,  
44 recordings or documents pertaining to a case.

45 (22) "Resides" or "residence," when used in reference to the residence of a child, ward, youth

1 or youth offender, means the place where the child, ward, youth or youth offender is actually living  
2 or the jurisdiction in which wardship or jurisdiction has been established.

3 (23) "Restitution" has the meaning given that term in ORS 137.103 **(3)(a)**.

4 (24) "Serious physical injury" means:

5 (a) A serious physical injury as defined in ORS 161.015; or

6 (b) A physical injury that:

7 (A) Has a permanent or protracted significant effect on a child's daily activities;

8 (B) Results in substantial and recurring pain; or

9 (C) In the case of a child under 10 years of age, is a broken bone.

10 (25) "Shelter care" means a home or other facility suitable for the safekeeping of a child, ward,  
11 youth or youth offender who is taken into temporary custody pending investigation and disposition.

12 (26) "Short-term detention facility" means a facility established under ORS 419A.050 (3) for  
13 holding children, youths and youth offenders pending further placement.

14 (27) "Sibling" means one of two or more children or wards related:

15 (a) By blood or adoption through a common legal parent; or

16 (b) Through the marriage of the children's or wards' legal or biological parents.

17 (28) "Substitute care" means an out-of-home placement directly supervised by the department  
18 or other agency, including placement in a foster family home, group home or other child caring in-  
19 stitution or facility. "Substitute care" does not include care in:

20 (a) A detention facility, forestry camp or youth correction facility;

21 (b) A family home that the court has approved as a ward's permanent placement, when a private  
22 child caring agency has been appointed guardian of the ward and when the ward's care is entirely  
23 privately financed; or

24 (c) In-home placement subject to conditions or limitations.

25 (29) "Surrogate" means a person appointed by the court to protect the right of the child, ward,  
26 youth or youth offender to receive procedural safeguards with respect to the provision of free ap-  
27 propriate public education.

28 (30) "Tribal court" means a court with jurisdiction over child custody proceedings and that is  
29 either a Court of Indian Offenses, a court established and operated under the code of custom of an  
30 Indian tribe or any other administrative body of a tribe that is vested with authority over child  
31 custody proceedings.

32 (31) "Victim" means any person determined by the district attorney, the juvenile department or  
33 the court to have suffered direct financial, psychological or physical harm as a result of the act that  
34 has brought the youth or youth offender before the juvenile court. When the victim is a minor,  
35 "victim" includes the legal guardian of the minor. The youth or youth offender may not be consid-  
36 ered the victim. When the victim of the crime cannot be determined, the people of Oregon, as re-  
37 presented by the district attorney, are considered the victims.

38 (32) "Violent felony" means any offense that, if committed by an adult, would constitute a felony  
39 and:

40 (a) Involves actual or threatened serious physical injury to a victim; or

41 (b) Is a sexual offense. As used in this paragraph, "sexual offense" has the meaning given the  
42 term "sex crime" in ORS 181.594.

43 (33) "Ward" means a person within the jurisdiction of the juvenile court under ORS 419B.100.

44 (34) "Young person" means a person who has been found responsible except for insanity under  
45 ORS 419C.411 and placed under the jurisdiction of the Psychiatric Security Review Board.

1 (35) "Youth" means a person under 18 years of age who is alleged to have committed an act that  
2 is a violation, or, if done by an adult would constitute a violation, of a law or ordinance of the  
3 United States or a state, county or city.

4 (36) "Youth care center" has the meaning given that term in ORS 420.855.

5 (37) "Youth offender" means a person who has been found to be within the jurisdiction of the  
6 juvenile court under ORS 419C.005 for an act committed when the person was under 18 years of age.

7 **SECTION 3.** ORS 137.295 is amended to read:

8 137.295. (1) When a defendant convicted of a crime or violation in the circuit, justice or munic-  
9 ipal court, or allowed diversion in such a case, makes a payment of money to be credited against  
10 monetary obligations imposed as a result of that conviction or diversion, the clerk shall distribute  
11 the payment as provided in this section.

12 (2) There are four categories of monetary obligations. The categories are as follows:

13 (a) Category 1 consists of compensatory fines under ORS 137.101.

14 (b) Category 2 consists of restitution as defined in ORS 137.103 and restitution under ORS  
15 419C.450 and a monetary obligation imposed under ORS 811.706.

16 (c) Category 3 consists of the unitary assessment imposed under ORS 137.290, costs imposed  
17 under ORS 151.505 or 161.665 and those fines, costs, forfeited security amounts and other monetary  
18 obligations payable to the state or to the General Fund of the state in criminal and quasi-criminal  
19 cases for which moneys the law does not expressly provide other disposition.

20 (d) Category 4 consists of monetary obligations imposed upon the defendant as a result of the  
21 conviction, but which do not fall under category 1, category 2 or category 3 of the obligation cate-  
22 gories. These include, but are not limited to, fines and other monetary obligations that the law ex-  
23 pressly directs be paid to an agency, person or political subdivision of the state, and any other  
24 obligation to reimburse for payment of a reward under ORS 131.897. Notwithstanding paragraph (c)  
25 of this subsection, the portion of assessments collected as required by ORS 137.290 (2)(c) and (d)  
26 shall be considered category 4 obligations.

27 (3) As long as there remains unpaid any obligation under category 1, the clerk shall credit to-  
28 ward category 1 all of each payment received.

29 (4) After the total obligation has been credited under category 1, then as long as there remains  
30 unpaid any obligation under both categories 2 and 3, the clerk shall credit toward each such cate-  
31 gory 50 percent of each payment received.

32 (5)(a) The clerk shall monthly transfer the moneys credited under category 1 and under category  
33 2 to the victims for whose benefit moneys under that category were ordered paid. If there are mul-  
34 tiple victims for whose benefit moneys have been ordered paid under category 2, the clerk shall first  
35 transfer moneys credited under category 2 to the victim, as defined in ORS 137.103 (4)(a). When the  
36 moneys due the victim, as defined in ORS 137.103 (4)(a), have been fully paid, the clerk shall transfer  
37 moneys credited under category 2 to the Criminal Injuries Compensation Account if moneys have  
38 been ordered paid to the account under category 2. When the moneys due the account have been  
39 fully paid, the clerk shall transfer moneys credited under category 2 to any other victims, as defined  
40 in ORS 137.103 (4)(b) or (d), for whose benefit moneys under that category were ordered paid in  
41 proportion to the amounts ordered. **When all moneys due the victims have been fully paid, the**  
42 **clerk shall transfer any moneys credited under category 2 that are ordered paid under ORS**  
43 **137.106 (4) to the Department of Justice Protection and Education Revolving Account created**  
44 **pursuant to ORS 180.095.**

45 (b) The clerk of a circuit court shall monthly transfer the moneys credited under category 3 as

1 directed by the State Court Administrator for deposit in the State Treasury to the credit of the  
2 Criminal Fine and Assessment Account established under ORS 137.300. The clerk of a justice or  
3 municipal court shall monthly transfer the moneys credited under category 3 to the Department of  
4 Revenue as provided in ORS 305.830.

5 (6) When the entire amount owing for purposes of either category 2 or category 3 has been  
6 credited, further payments by the defendant shall be credited by the clerk entirely to the unpaid  
7 balance of whichever of those categories remains unpaid, until both category 2 and category 3 have  
8 been entirely paid.

9 (7) When category 1, category 2 and category 3 have been entirely paid and any obligation re-  
10 mains owing under category 4, the clerk shall credit further payments by the defendant to the ob-  
11 ligations under category 4 and shall monthly transfer the moneys so received to the appropriate  
12 recipient, giving first priority to counties and cities entitled to revenues generated by prosecutions  
13 in justice and municipal courts and giving last priority to persons entitled to moneys as reimburse-  
14 ment for reward under ORS 131.897. The clerk shall monthly transfer the portion of assessments  
15 collected as required by ORS 137.290 (2)(c) and (d) to the county for administration of substance  
16 abuse treatment programs described in ORS 430.420.

17 (8) Notwithstanding subsection (5) of this section, the clerk of a circuit court shall monthly  
18 transfer the moneys attributable to parking violations to the State Treasurer for deposit in the  
19 General Fund.

20 (9) The clerk of a justice or municipal court must make the transfers required by this section  
21 not later than the last day of the month immediately following the month in which a payment is  
22 made.

26 **SECTION 4.** ORS 196.890 is amended to read:

27 196.890. Any person who violates any provision of ORS 196.600 to 196.905 or any rule, order or  
28 permit adopted or issued under ORS 196.600 to 196.905 shall be subject to a:

29 (1) Civil penalty in an amount to be determined by the Director of the Department of State  
30 Lands of not more than \$10,000 per day of violation[.]; **or**

40 account shall consist of transfers of moneys authorized by the Legislative Assembly from the State  
41 Wildlife Fund and gifts and grants of moneys from whatever source for the purpose of paying the  
42 expense of maintaining fish hatcheries operated by the department.

43 (4) The Migratory Waterfowl Subaccount is established in the Fish and Wildlife Account. All  
44 moneys received by the commission from the sale of art works and prints related to the migratory  
45 waterfowl stamp shall be deposited in the subaccount. Moneys in the subaccount may be expended

1 only for activities that promote the propagation, conservation and recreational uses of migratory  
2 waterfowl and for activities related to the design, production, issuance and arrangements for sale  
3 of the migratory waterfowl stamps and related art works and prints. Expenditures of moneys in the  
4 subaccount may be made within this state, in other states or in foreign countries, in such amounts  
5 as the commission determines appropriate. Expenditures in other states and foreign countries shall  
6 be on such terms and conditions as the commission determines will benefit most directly the mi-  
7 gratory waterfowl resources of this state.

8 (5) The Halibut Research Subaccount is established in the Fish and Wildlife Account. Based on  
9 the annual number of recreational halibut anglers, a portion of the moneys derived from the sale  
10 of the salmon, steelhead trout, sturgeon and halibut tag pursuant to ORS 497.121 shall be credited  
11 to the subaccount. Moneys in the subaccount may be expended only for halibut population studies  
12 and other research.

13 (6) The Upland Bird Subaccount is established in the Fish and Wildlife Account. All moneys  
14 received by the State Fish and Wildlife Commission from the sale of upland bird stamps, from the  
15 sale of any art works and prints related to the upland bird stamp and from private hunting preserve  
16 permit fees shall be deposited in the subaccount. Moneys in the subaccount may be expended only  
17 for promoting the propagation and conservation of upland birds and the acquisition, development,  
18 management, enhancement, sale or exchange of upland bird habitat, and for activities related to the  
19 design, production, issuance and arrangements for sale of the upland bird stamps and related art  
20 works and prints. Expenditures of moneys in the subaccount shall be made for the benefit of pro-  
21 grams within this state in such amounts and at such times as the commission determines appropriate  
22 to most directly benefit the upland bird resources of the state.

23 (7)(a) The Fish and Wildlife Deferred Maintenance Subaccount is established in the Fish and  
24 Wildlife Account. Interest earnings on moneys in the subaccount shall be credited to the subaccount.  
25 The subaccount shall consist of moneys authorized by the Legislative Assembly from the State  
26 Wildlife Fund and moneys obtained by gift, grant, bequest or donation from any other public or  
27 private source.

28 (b) The principal in the subaccount may be utilized only as provided in paragraph (c) of this  
29 subsection. Interest earnings on the moneys in the subaccount may be expended only for the main-  
30 tenance of fish hatcheries and State Department of Fish and Wildlife facilities other than adminis-  
31 trative facilities located in Salem.

32 (c) The department may borrow funds from the principal of the subaccount to maintain adequate  
33 cash flow requirements. However, moneys borrowed from the principal must be repaid to the sub-  
34 account:

35 (A) Within six months from the date on which the moneys were borrowed.

36 (B) With interest at the standard rate that the State Treasurer charges to state agencies for  
37 other loans. Interest paid under this subparagraph shall be paid to the subaccount.

38 (d) For purposes of this subsection, "principal" means moneys authorized by the Legislative  
39 Assembly for transfer to the subaccount from the State Wildlife Fund, including any assignment of  
40 earnings on moneys in the fund and other moneys obtained by gift, grant, bequest or donation de-  
41 posited into the subaccount.

42 (8) The Access and Habitat Board Subaccount is established in the Fish and Wildlife Account.  
43 The subaccount shall consist of moneys transferred to the subaccount pursuant to ORS 496.242.  
44 Moneys in the subaccount may be used for the purposes specified in ORS 496.242.

45 (9) The Marine Shellfish Subaccount is established in the Fish and Wildlife Account. Interest



1 earnings on moneys in the subaccount shall be credited to the subaccount. All moneys received by  
2 the commission from the sale of resident and nonresident shellfish licenses pursuant to ORS 497.121  
3 shall be deposited in the subaccount. Moneys in the subaccount shall be used for the protection and  
4 enhancement of shellfish for recreational purposes, including shellfish sanitation costs and the cost  
5 of enforcement of wildlife laws pertaining to the taking of shellfish. The State Fish and Wildlife  
6 Director, or a designee, the Director of Agriculture, or a designee, and the Superintendent of State  
7 Police, or a designee, shall jointly make a recommendation to the Governor for inclusion in the  
8 Governor's budget beginning July 1 of each odd-numbered year.

9 (10)(a) The Mountain Sheep Subaccount is established in the Fish and Wildlife Account, con-  
10 sisting of moneys collected under ORS 497.112 (2)(a) to (c).

11 (b) All moneys in the subaccount shall be used for the propagation and conservation of mountain  
12 sheep, for research, development, management, enhancement and sale or exchange of mountain  
13 sheep habitat and for programs within the state that in the discretion of the commission most di-  
14 rectly benefit mountain sheep resources of this state.

15 (11)(a) The Antelope Subaccount is established in the Fish and Wildlife Account, consisting of  
16 moneys collected under ORS 497.112 (2)(a) to (c).

17 (b) All moneys in the subaccount shall be used for the propagation and conservation of antelope,  
18 for research, development, management, enhancement and sale or exchange of antelope habitat and  
19 for programs within the state that in the discretion of the commission most directly benefit antelope  
20 resources of this state.

21 (12)(a) The Mountain Goat Subaccount is established in the Fish and Wildlife Account, consist-  
22 ing of moneys collected under ORS 497.112 (2)(a) to (c).

23 (b) All moneys in the subaccount shall be used for the propagation and conservation of mountain  
24 goats for research, development, management, enhancement and sale or exchange of mountain goat  
25 habitat and for programs within the state that in the discretion of the commission most directly  
26 benefit mountain goat resources of this state.

27 (13)(a) The commission shall keep a record of all moneys deposited in the Fish and Wildlife  
28 Account. The record shall indicate by separate cumulative accounts the sources from which the  
29 moneys are derived and the individual activity or programs against which each withdrawal is  
30 charged.

31 (b) Using the record created pursuant to paragraph (a) of this subsection, the commission shall  
32 report, in the budget documents submitted to the Legislative Assembly, on the application of in-  
33 vestment and interest earnings to the maintenance of fish hatcheries and other State Department  
34 of Fish and Wildlife facilities.

38 **SECTION 33.** ORS 561.280 is amended to read:

39 561.280. In addition to the other remedies provided by law, the State Department of Agriculture  
40 may apply to the circuit court for, and such court shall have jurisdiction upon a summary hearing  
41 and for cause shown to grant, a temporary or permanent injunction restraining any person from  
42 violating any provision of a law under the jurisdiction of the department. **The department may**  
43 **not be required to furnish a bond in such proceeding. Any action authorized by this section**  
44 **must be tried in the circuit court of the county in which the violation occurs or in Marion**  
45 **County. The State Board of Agriculture, the department, the Director of Agriculture and the**

1 **employees and duly authorized representatives of the department may not be held liable for**  
2 **any damages a defendant may sustain as a result of an injunction, restraining order or other**  
3 **order issued under this section.**

5 568.933. (1) In addition to any other liability or penalty provided by law, the State Department  
6 of Agriculture may impose a civil penalty on a landowner of lands within an agricultural or rural

9 (2) The department may not impose a civil penalty on a landowner for a first violation under this  
10 section unless the department:

11 (a) Has notified the landowner of the violation in a writing that describes, with reasonable  
12 specificity, the factual basis for the department's determination that a violation has occurred; and

13 (b) Has prescribed a reasonable time for the landowner to correct the violation that may not  
14 exceed 30 days after the first notice of a violation, unless the violation requires more than 30 days  
15 to correct, in which case the department shall specify a reasonable period of time to correct the  
16 violation in a plan of correction issued to the landowner.

17 (3) A civil penalty imposed under this section may not exceed:

18 (a) \$2,500 for a first violation; or

19 (b) \$10,000 for a second or subsequent violation.

20 (4) For purposes of this section, each day of a violation continuing after any period of time of  
21 correction set by the department is a separate violation unless the department finds that a different  
22 period of time is more appropriate to describe a specific violation event.

23 (5) The landowner to whom a notice of violation or a notice of civil penalty is addressed shall  
24 have 30 days from the date of receipt of the notice in which to make written application for a  
25 hearing before the department.

26 (6) In imposing a penalty under this section, the department shall consider the following factors:

27 (a) The past history of the landowner incurring a penalty in taking all feasible steps or proce-  
28 dures necessary or appropriate to correct a violation.

29 (b) Any prior violations of rules, regulations or statutes pertaining to a water quality manage-  
30 ment plan.

31 (c) The gravity and magnitude of the violation.

32 (d) Whether the violation was repeated or continuous.

33 (e) Whether the cause of the violation was an unavoidable accident, negligence or an intentional  
34 act.

35 (f) The violator's efforts to correct the violation.

36 (g) The immediacy and extent to which the violation threatens the public health or safety.

37 (7) A notice of violation or period to comply shall not be required under subsection (2) of this  
38 section if:

39 (a) The violation is intentional; or

40 (b) The landowner has received a previous notice of the same or similar violation.

41 **(8) When the State Department of Agriculture brings a civil action pursuant to ORS**  
42 **561.280 to enjoin the violation of any rules adopted under ORS 561.191 or 568.912, in lieu of**  
43 **imposing civil penalties under this section, the State Department of Agriculture may recover**  
44 **a penalty in such civil action in an amount equal to the amount of civil penalty that would**  
45 **be recovered as provided in this section.**

1            [(8)] **(9)(a) Except as provided in paragraph (b) of this subsection**, the department shall de-  
 2        posit any civil penalty recovered under this section into a special subaccount in the Department of  
 3        Agriculture Service Fund. Moneys in the subaccount are continuously appropriated to the depart-  
 4        ment to be used for educational programs on water quality management and to provide funding for

 12       standards, if the latter penalty is imposed on the same person and is based on the same violation.
