

Senate Bill 947

Sponsored by Senator HASS; Senators EDWARDS, MORSE (at the request of Oregon Business Association)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Designates United States Senator, Representative in Congress, Governor, Secretary of State, State Treasurer, Attorney General, state Senator, state Representative and any state, county, city or district office as voter choice offices. Excludes nonpartisan offices.

Allows voters at primary election to vote for any candidate for voter choice office, without regard to political party affiliation, or lack of affiliation, of voter or candidate. Specifies that two candidates for voter choice office receiving highest number of votes at primary election are nominated for office at general election. Provides that when one candidate for voter choice office receives majority of votes at primary election, name of that candidate alone is printed on general election ballot.

Allows political parties to file party rule with Secretary of State describing qualifications candidate must satisfy to be listed on ballot as party member. Allows party to notify chief elections officer that candidate for voter choice office is ineligible to be listed on ballot as party member.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 254.056 is amended to read:

10 254.056. (1) The general election shall be held on the first Tuesday after the first Monday in
11 November of each even-numbered year. Except as provided in ORS 254.650, at the general election
12 officers of the state and subdivisions of the state, members of Congress and electors of President
13 and Vice President of the United States as are to be elected in that year shall be elected.

14 (2) The primary election shall be held on the third Tuesday in May of each even-numbered year.
15 At the primary election [*precinct committeepersons shall be elected and major political party candi-*
16 *dates shall be nominated for offices to be filled at the general election held in that year.*]:

17 (a) **Precinct committeepersons shall be elected by members of major political parties;**

18 (b) **Nonpartisan candidates shall be nominated for offices to be filled at the general**
19 **election held in that year or elected by all electors, as provided in ORS 249.088;**

20 (c) **Voter choice office candidates shall be nominated by all electors, as described in ORS**
21 **chapter 249, for offices to be filled at the general election held in that year;**

22 (d) **In a year in which a President and Vice President of the United States are to be**
23 **elected, major political party candidates for the offices of President and Vice President of the**
24 **United States shall be nominated to the general election ballot by members of their respec-**
25 **tive political parties; and**

1 **(e) An elector may vote for any candidate for a voter choice office, without regard to the**
 2 **political party affiliation, or lack of political party affiliation, of the elector or the candidate.**

3 **SECTION 2.** ORS 249.088 is amended to read:

4 249.088. (1) [*Unless otherwise provided by a home rule charter, at the nominating election held on*
 5 *the date of the primary election, two candidates shall be nominated for the nonpartisan office.*] **Subject**
 6 **to subsections (3) and (4) of this section and the provisions of a home rule charter, for non-**
 7 **partisan offices, the two candidates receiving the highest number of votes at the primary**
 8 **election shall be nominated to the general election.**

9 **(2) Subject to subsection (5) of this section and the provisions of a home rule charter, for**
 10 **voter choice offices, the two candidates receiving the highest number of votes at the primary**
 11 **election shall be nominated to the general election.**

12 **(3) [However,] Except as provided in subsection (4) of this section,** when a candidate[, *other*
 13 *than a candidate for the office of sheriff, a candidate for the office of county clerk, a candidate for the*
 14 *office of county treasurer or a candidate to fill a vacancy,]* **for nonpartisan office** receives a majority
 15 of the votes cast for the office at the [*nominating*] **primary** election, that candidate is elected.

16 [(2)] **(4)** When a candidate for the office of sheriff, [*the office of*] county clerk[, *the office of*] **or**
 17 county treasurer or a candidate to fill a vacancy receives a majority of votes cast for the office at
 18 the nominating election, that candidate alone is nominated.

19 **(5) When a candidate for voter choice office receives a majority of the votes cast for the**
 20 **office at the primary election, that candidate's name shall be the only one printed for that**
 21 **office on the ballot for the general election.**

22 **SECTION 3.** ORS 249.002, as amended by section 2, chapter 18, Oregon Laws 2010, is amended
 23 to read:

24 249.002. As used in this chapter:

25 (1) "Candidate" means an individual whose name is or is expected to be printed on the official
 26 ballot.

27 (2) "County clerk" means the county clerk or the county official in charge of elections.

28 (3) "Elector" means an individual qualified to vote under section 2, Article II, Oregon Consti-
 29 tution.

30 (4) "Judge" means judge of the Supreme Court, Court of Appeals, circuit court or the Oregon
 31 Tax Court, or any county judge who exercises judicial functions.

32 (5) "Member" means an individual who is registered as being affiliated with the political party.

33 (6) "Minor political party" means a political party that has qualified as a minor political party
 34 under ORS 248.008.

35 (7) "Nonpartisan office" means the office of judge, Superintendent of Public Instruction, Com-
 36 missioner of the Bureau of Labor and Industries, any elected office of a metropolitan service district
 37 under ORS chapter 268, justice of the peace, county clerk, county assessor, county surveyor, county
 38 treasurer, sheriff, district attorney or any office designated nonpartisan by a home rule charter.

39 (8) "Prospective petition" means the information, except signatures and other identification of
 40 petition signers, required to be contained in a completed petition.

41 (9) "Public office" means any national, state, county, city or district office or position, except
 42 a political party office, filled by the electors.

43 (10) "State office" means Governor, Secretary of State, State Treasurer, Attorney General,
 44 Commissioner of the Bureau of Labor and Industries, Superintendent of Public Instruction, judge,
 45 state Senator, state Representative or district attorney.

1 **(11) “Voter choice office” means the office of United States Senator, Representative in**
 2 **Congress, Governor, Secretary of State, State Treasurer, Attorney General, state Senator**
 3 **or state Representative or any state, county, city or district office that is not:**

4 **(a) A nonpartisan office; or**

5 **(b) An office for which nominations to the general election by political parties are oth-**
 6 **erwise authorized by law.**

7 **SECTION 4.** ORS 254.005, as amended by section 3, chapter 18, Oregon Laws 2010, is amended
 8 to read:

9 254.005. As used in this chapter:

10 (1) “Ballot” means any material on which votes may be cast for candidates or measures. In the
 11 case of a recall election, “ballot” includes material posted in a voting compartment or delivered to
 12 an elector by mail.

13 (2) “Chief elections officer” means the:

14 (a) Secretary of State, regarding a candidate for a state office or an office to be voted on in the
 15 state at large or in a congressional district, or a measure to be voted on in the state at large.

16 (b) County clerk, regarding a candidate for a county office, or a measure to be voted on in a
 17 county only.

18 (c) City clerk, auditor or recorder, regarding a candidate for a city office, or a measure to be
 19 voted on in a city only.

20 (3) “County clerk” means the county clerk or the county official in charge of elections.

21 (4) “Elector” means an individual qualified to vote under section 2, Article II, Oregon Consti-
 22 tution.

23 (5) “Major political party” means a political party that has qualified as a major political party
 24 under ORS 248.006.

25 (6) “Measure” includes any of the following submitted to the people for their approval or re-
 26 jection at an election:

27 (a) A proposed law.

28 (b) An Act or part of an Act of the Legislative Assembly.

29 (c) A revision of or amendment to the Oregon Constitution.

30 (d) Local, special or municipal legislation.

31 (e) A proposition or question.

32 (7) “Minor political party” means a political party that has qualified as a minor political party
 33 under ORS 248.008.

34 (8) “Nonpartisan office” means the office of judge of the Supreme Court, Court of Appeals, cir-
 35 cuit court or the Oregon Tax Court, Superintendent of Public Instruction, Commissioner of the Bu-
 36 reau of Labor and Industries, any elected office of a metropolitan service district under ORS chapter
 37 268, justice of the peace, county clerk, county assessor, county surveyor, county treasurer, county
 38 judge who exercises judicial functions, sheriff, district attorney or any office designated nonpartisan
 39 by a home rule charter.

40 (9) “Prospective petition” means the information, except signatures and other identification of
 41 petition signers, required to be contained in a completed petition.

42 (10) “Regular district election” means the election held each year for the purpose of electing
 43 members of a district board as defined in ORS 255.005 (2).

44 (11) “Vote tally system” means one or more pieces of equipment necessary to examine and tally
 45 automatically the marked ballots.

1 **(12) “Voter choice office” means the office of United States Senator, Representative in**
 2 **Congress, Governor, Secretary of State, State Treasurer, Attorney General, state Senator**
 3 **or state Representative or any state, county, city or district office that is not:**

4 **(a) A nonpartisan office; or**

5 **(b) An office for which nominations to the general election by political parties are oth-**
 6 **erwise authorized by law.**

7 [(12)] **(13) “Voting machine” means any device that will record every vote cast on candidates**
 8 **and measures and that will either internally or externally total all votes cast on that device.**

9 **SECTION 5.** ORS 248.006 is amended to read:

10 248.006. (1) An affiliation of electors becomes a major political party in this state [*and is quali-*
 11 *fied to make nominations at a primary election*] when a number of electors equal to at least five
 12 percent of the number of electors registered in this state are registered as members of the party not
 13 later than the 275th day before the date of a primary election. An affiliation of electors satisfying
 14 the requirements of this subsection shall be subject to the provisions of ORS 248.007 on the date the
 15 Secretary of State determines the registration requirements are satisfied.

16 (2) The number of electors described in subsection (1) of this section shall be calculated based
 17 on the number of electors registered in this state and eligible to vote, as reported on the official
 18 abstracts of the election, at the general election immediately preceding the deadline specified in
 19 subsection (1) of this section.

20 (3) After an affiliation of electors becomes a major political party under subsection (1) of this
 21 section, in order to maintain status as a major political party subject to ORS 248.007, the party must
 22 satisfy the registration requirement of subsection (1) of this section not later than the 275th day
 23 before each primary election.

24 (4) An affiliation of electors ceases to be a major political party if the registration requirements
 25 of subsection (1) of this section are not satisfied by the 275th day before each primary election. The
 26 affiliation of electors ceases to be a major political party on the date the Secretary of State deter-
 27 mines that the registration requirement is not satisfied.

28 (5) When an affiliation of electors has not satisfied the registration requirement of subsection
 29 (1) of this section for the first time, at the request of a representative of the affiliation of electors,
 30 the Secretary of State shall determine not less than once each month whether at least five percent
 31 of the number of eligible electors registered in this state are registered as members of the party.
 32 After an affiliation of electors has qualified as a major political party, the Secretary of State shall
 33 determine on the 274th day before each primary election whether the major political party has sat-
 34 isfied the registration requirements described in subsection (3) of this section.

35 **SECTION 6.** ORS 248.007 is amended to read:

36 248.007. (1) Subject to ORS 248.005, a major political party may organize and select delegates
 37 to national party conventions in any manner.

38 (2) The provisions of ORS 248.012 to 248.315 do not apply to a major political party if the party
 39 has notified the Secretary of State as provided in subsection (5) of this section that the party does
 40 not intend to be subject to the provisions of ORS 248.012 to 248.315. References to precinct com-
 41 mitteepersons in any provisions of ORS chapters 246 to 260 do not apply to a party described in this
 42 subsection.

43 (3) ORS 248.012 to 248.315 apply only to a major political party that has notified the Secretary
 44 of State as provided in subsection (5) of this section that the political party intends to be subject
 45 to the provisions of ORS 248.012 to 248.315. References to precinct committeepersons in any pro-

1 visions of ORS chapters 246 to 260 shall apply to a party described in this subsection. If a major
 2 political party fails to notify the Secretary of State under this subsection, the party shall be con-
 3 sidered subject to the provisions of ORS 248.012 to 248.315.

4 (4) A major political party shall notify the Secretary of State as provided in subsection (5) of this
 5 section if the party does not intend to be subject to the provisions of ORS 248.012 to 248.315 except
 6 that the party intends to elect precinct committeepersons. If a party notifies the Secretary of State
 7 under this subsection, the party shall elect precinct committeepersons only as provided in ORS
 8 248.015 and shall elect precinct committeepersons in the same manner in all precincts in this state.

9 (5) Not later than the 274th day before the date of the primary election, a major political party
 10 shall notify the Secretary of State in writing whether or not the party intends to be subject to the
 11 provisions of ORS 248.012 to 248.315 or whether the party intends to elect precinct committeeper-
 12 sons under subsection (4) of this section. If the major political party does not intend to be subject
 13 to the provisions of ORS 248.012 to 248.315 or intends to elect precinct committeepersons under
 14 subsection (4) of this section, the party shall file with the Secretary of State, at the same time notice
 15 is given under this subsection, a copy of its organizational documents setting forth the manner in
 16 which its officers and managing committees are selected or any other manner in which it conducts
 17 its affairs.

18 (6) In each even-numbered year, a major political party shall file with the Secretary of State a
 19 statement indicating that the party is operating subject to ORS 248.012 to 248.315 or a copy of
 20 current organizational documents setting forth the manner in which its officers and managing com-
 21 mittees are selected or any other manner in which it conducts its affairs. Material described in this
 22 subsection shall be filed on the 274th day before the third Tuesday in May of each odd-numbered
 23 year.

24 *[(7) A major political party subject to the provisions of this section shall nominate candidates of*
 25 *the major political party, for other than political party office, at the primary election.]*

26 **SECTION 7.** ORS 248.008 is amended to read:

27 248.008. (1) An affiliation of electors becomes a minor political party in *[the state, a county or*
 28 *other electoral district,]* **this state**, qualified to make nominations for public office in *[that electoral*
 29 *district and in any other electoral district wholly contained within the electoral district]* **this state in**
 30 **years in which a President and Vice President of the United States are to be elected**, when
 31 either of the following events occurs:

32 (a) When the affiliation of electors has filed with the Secretary of State a petition with the
 33 signatures of at least a number of electors equal to one and one-half percent of the total votes cast
 34 in the *[electoral district]* **state** for all candidates for Governor at the most recent election at which
 35 a candidate for Governor was elected to a full term. The petition also must state the intention to
 36 form a new political party and give the designation of it. The petition must contain only original
 37 signatures and must be filed not later than two years following the date the prospective petition is
 38 filed. The circulator shall certify on each signature sheet that the circulator witnessed the signing
 39 of the signature sheet by each individual whose signature appears on the signature sheet and that
 40 the circulator believes each individual is an elector registered in the *[electoral district]* **state**. The
 41 Secretary of State shall verify whether the petition contains the required number of signatures of
 42 electors. The Secretary of State may not accept a petition for filing if it contains less than 100
 43 percent of the required number of signatures. The Secretary of State by rule shall designate a sta-
 44 tistical sampling technique to verify whether a petition contains the required number of signatures
 45 of electors. A petition may not be rejected for the reason that it contains less than the required

1 number of signatures unless two separate sampling processes both establish that the petition lacks
 2 the required number of signatures. The second sampling must contain a larger number of signatures
 3 than the first sampling. The Secretary of State may employ professional assistance to determine the
 4 sampling technique. The statistical sampling technique may be the same as that adopted under ORS
 5 250.105. Before circulating the petition, the chief sponsor of the petition must file with the Secretary
 6 of State a signed copy of the prospective petition. The chief sponsor must include with the pro-
 7 spective petition a statement declaring whether one or more persons will be paid money or other
 8 valuable consideration for obtaining signatures of electors on the petition. After the prospective
 9 petition is filed, the chief sponsor must notify the filing officer not later than the 10th day after the
 10 chief sponsor first has knowledge or should have had knowledge that:

11 (A) Any person is being paid for obtaining signatures, when the statement included with the
 12 prospective petition declared that no such person would be paid.

13 (B) No person is being paid for obtaining signatures, when the statement included with the
 14 prospective petition declared that one or more such persons would be paid.

15 (b) When the affiliation of electors has polled for [*any one of its candidates for any public office*
 16 *in the electoral district*] **its candidate for President of the United States** at least one percent of
 17 the total votes cast in the [*electoral district*] **state** for all candidates for[:]

18 [(A)] presidential elector at the last general election at which candidates for President and Vice
 19 President of the United States were listed on the ballot[; or].

20 [(B) *Any single state office to be voted upon in the state at large for which nominations by political*
 21 *parties are permitted by law at the most recent election at which a candidate for the office was elected*
 22 *to a full term.*]

23 (2) After satisfying either requirement of subsection (1) of this section, the minor political party
 24 may nominate candidates for election at the next general election **at which a President and Vice**
 25 **President of the United States are to be elected.**

26 (3) A filing officer may not accept a certificate of nomination of a candidate nominated by a
 27 minor political party for a subsequent general election **at which a President and Vice President**
 28 **of the United States are to be elected** unless the minor political party has satisfied the require-
 29 ments of subsection (4)(a) or (b) of this section.

30 (4) After a minor political party qualifies to nominate candidates [*for a general election*] under
 31 subsection (1) of this section, in order to maintain status as a minor political party for a subsequent
 32 general election:

33 (a)(A) Following each general election **held in a year when a President and Vice President**
 34 **of the United States are to be elected**, at any time during the period beginning on the date of the
 35 next primary election **held in a year when a President and Vice President of the United States**
 36 **are to be elected** and ending on the 90th day before the next general election, a number of electors
 37 equal to at least one-tenth of one percent of the total votes cast in the state [*or electoral district*]
 38 for all candidates for Governor at the most recent election at which a candidate for Governor was
 39 elected to a full term must be registered as members of the party; and

40 (B) A candidate or candidates of the party must poll a number of votes described in subsection
 41 (1)(b) of this section at each subsequent general election; or

42 (b) Following each general election, at any time during the period beginning on the date of the
 43 next primary election **held in a year when a President and Vice President of the United States**
 44 **are to be elected** and ending on the 90th day before the next general election, a number of electors
 45 equal to at least one-half of one percent of the total number of registered electors in this state must

1 be registered as members of the party.

2 (5) An affiliation of electors that fails to maintain its status as a minor political party, as de-
3 scribed in subsection (4) of this section, ceases to be a minor political party on the 90th day before
4 the date of the next general election.

5 (6) During the period beginning on the date of the primary election **held in a year when a**
6 **President and Vice President of the United States are to be elected** and ending on the 90th day
7 before the date of the general election, the Secretary of State shall determine not less than once
8 each month whether the registration requirements of subsection (4) of this section have been satis-
9 fied. If the minor political party changes its name, only those electors who register on or after the
10 effective date of the name change as members of the party under the new party name shall be
11 counted as members of the party under this subsection.

12 (7) An affiliation of electors or a minor political party may not satisfy the one percent require-
13 ment referred to in subsection (1)(b) of this section by nominating a candidate who is the nominee
14 of another political party at the same election.

15 (8) For purposes of this section, “subsequent general election” means any general election that
16 is held after the first general election following qualification as a minor political party under sub-
17 section (1) of this section.

18 **SECTION 8.** ORS 249.016 is amended to read:

19 249.016. A candidate [*of a major political party for public*] **for voter choice** office or a candidate
20 for nonpartisan office shall be nominated only in the manner provided in ORS 249.016 to 249.205.

21 **SECTION 9.** ORS 249.020 is amended to read:

22 249.020. (1) An eligible elector may become a candidate for nonpartisan office, or for [*the nomi-*
23 *nation to an office by the major political party of which the elector is a member*] **voter choice**
24 **office**, by filing a nominating petition or a declaration of candidacy.

25 (2) At the time of filing, a declaration of candidacy shall be accompanied by the filing fee
26 specified in ORS 249.056.

27 (3) At the time of filing, a nominating petition shall contain the signature sheets described under
28 ORS 249.064.

29 **SECTION 10.** ORS 249.031 is amended to read:

30 249.031. (1) Except as provided in subsection (2) of this section, a nominating petition or decla-
31 ration of candidacy shall contain:

32 (a) The name by which the candidate is commonly known. A candidate may use a nickname in
33 parentheses in connection with the candidate’s full name.

34 (b) Address information as required by the Secretary of State by rule.

35 (c) The office and department or position number, if any, for which the candidate seeks nomi-
36 nation.

37 (d) If the candidate is seeking [*the nomination of a major political party*] **nomination to a voter**
38 **choice office, and the candidate is a member of a major or minor political party**, the name of
39 the major **or minor** political party of which the candidate [*will have been a member, subject to the*
40 *exceptions stated in ORS 249.046, during at least 180 days before the deadline for filing a nominating*
41 *petition or declaration of candidacy*] **is a member.**

42 (e) **If the candidate is seeking nomination to a voter choice office and the candidate is**
43 **not a member of a political party, a statement that the candidate is nonaffiliated.**

44 [(e)] (f) A statement that the candidate is willing to accept the nomination or election or, re-
45 garding a candidate for precinct committeeperson, that the candidate accepts the office if elected.

1 *[(f)]* **(g)** A statement that the candidate will qualify if elected.

2 *[(g) If the candidate is seeking the nomination of a major political party, a statement that the*
 3 *candidate, if not nominated, will not accept the nomination or endorsement of any political party other*
 4 *than the one of which the candidate is a member on the date the petition or declaration is filed.]*

5 (h) The signature of the candidate.

6 (i) A statement of the candidate's occupation, educational and occupational background and
 7 prior governmental experience.

8 (2) Subsection (1)(i) of this section does not apply to a candidate for election as a precinct
 9 committeeperson.

10 (3) A declaration of candidacy shall include a statement that the required fee is included with
 11 the declaration.

12 (4) If required by the national rules of the major political party, the declaration of a candidate
 13 for election as a precinct committeeperson shall include the name of the individual the candidate
 14 supports for President of the United States or "uncommitted" or "no preference."

15 **SECTION 11.** ORS 249.042 is amended to read:

16 249.042. When an elector files with the appropriate filing officer the statement and prospective
 17 petition under ORS 249.061, or a declaration of candidacy, it is conclusive evidence that the elector
 18 is a candidate for nomination or election *[by the elector's political party or]* to the **voter choice or**
 19 nonpartisan office stated in the petition or declaration.

20 **SECTION 12.** ORS 249.046 is amended to read:

21 249.046. **(1)** If a candidate has not been a member of the major political party for at least 180
 22 days before the deadline for filing a nominating petition or declaration of candidacy, the candidate
 23 *[shall]* **is not [be]** entitled to receive the nomination of that major political party.

24 **(2)** If a *[candidate's]* **candidate is registered as a member of a political party and the** reg-
 25 **istration of the candidate** becomes inactive, the inactive status *[shall]* **does** not constitute a lapse
 26 of membership in the party if, immediately before the registration became inactive, the candidate
 27 was a member of the party and was not a member of any other political party within the 180 days
 28 preceding the deadline for filing a nominating petition or declaration of candidacy.

29 **(3)** The requirement that the candidate be qualified by length of membership does not apply to
 30 any candidate whose 18th birthday falls within the period of 180 days or to a write-in candidate.

31 **(4) This section does not apply to a candidate for a voter choice office.**

32 **SECTION 13.** ORS 249.064 is amended to read:

33 249.064. *[(1) A nominating petition of a candidate seeking the nomination of a major political party*
 34 *shall contain a statement that each elector whose signature appears on the petition is a member of the*
 35 *same major political party as is the candidate.]*

36 *[(2)]* **(1)** A nominating petition of any candidate shall contain the number of signatures of elec-
 37 tors required by ORS *[249.068 or]* 249.072 and the residence or mailing address and name or number
 38 of the precinct, if known, of each elector whose signature appears.

39 *[(3)]* **(2)** Pursuant to ORS 249.008, the county clerks shall certify the signatures contained in the
 40 nominating petition for genuineness.

41 **SECTION 14.** ORS 249.072 is amended to read:

42 249.072. **(1)** *[If the nonpartisan office is to be voted for in the state at large, the]* **A** nominating
 43 petition **for an office to be voted for in the state at large or for a candidate for Representative**
 44 **in Congress** shall contain at least 1,000 signatures of electors, or a number of signatures *[of*
 45 *electors]* equal to at least one percent of the vote cast in the state **or congressional district, as**

1 **the case may be**, for all candidates for Governor at the most recent election at which a candidate

14 general election; and

15 (c) The Secretary of State shall order a special election as provided in ORS 254.655.

16 (2) The candidates listed on the ballot at the special election shall be:

17 (a) The candidates who were listed on the general election ballot, other than the candidate
18 whose nomination became vacant; and

19 (b) The candidate selected to fill the vacancy in the nomination as provided in ORS [*249.190*
20 *or*] 249.205.

21 (3) As used in this section "state office" means the office of Governor, Secretary of State, State
22 Treasurer, Attorney General, state Senator or state Representative.

23 **SECTION 43.** ORS 260.112 is amended to read:

24 260.112. (1)(a) A candidate or a treasurer of a political committee who expects neither the ag-
25 gregate contributions to be received nor the aggregate expenditures to be made by or on behalf of
26 the candidate or political committee to exceed \$2,000 in total amount during the calendar year shall
27 file a certificate to that effect with the Secretary of State. The candidate or treasurer shall make
28 the certificate according to the best of the knowledge or belief of the candidate or treasurer. A
29 candidate or treasurer filing a certificate under this section is not required to file statements under
30 ORS 260.057.

31 (b) A treasurer of a petition committee organized under ORS 260.118 who expects neither the
32 aggregate contributions to be received nor the aggregate expenditures to be made by a chief
33 petitioner or the treasurer to exceed \$2,000 in total amount during the calendar year shall file a
34 certificate to that effect with the Secretary of State. The treasurer shall make the certificate ac-
35 cording to the best of the knowledge or belief of the treasurer. A treasurer filing a certificate under
36 this section is not required to file statements under ORS 260.118.

37 (2) A certificate described in subsection (1) of this section shall be filed:

38 (a) By a candidate, not sooner than the date on which the candidate files a declaration of can-
39 didacy or nominating petition, accepts a nomination or is nominated to fill a vacancy in a nomi-
40 nation [*or in a partisan elective office*], and not later than seven calendar days after the candidate
41 receives a contribution or makes an expenditure.

42 (b) By a treasurer of a political committee, not sooner than the date that the political committee
43 files a statement of organization under ORS 260.042, and not later than seven calendar days after
44 the political committee receives a contribution or makes an expenditure.

45 (c) By a treasurer of a petition committee, not sooner than the date that a chief petitioner or

1 the treasurer files a statement of organization under ORS 260.118, and not later than seven calendar
 2 days after a chief petitioner or the treasurer receives a contribution or makes an expenditure.

3 (3) A candidate, political committee or petition committee under this section must keep contri-
 4 bution and expenditure records during the calendar year.

5 (4) If at any time following the filing of a certificate under this section and during the calendar
 6 year either the aggregate contributions or aggregate expenditures exceed \$2,000, the candidate or
 7 treasurer shall do all of the following:

8 (a) File a statement under ORS 260.057 or 260.118 within seven calendar days after either the
 9 aggregate contributions or aggregate expenditures exceed \$2,000. The statement must reflect all
 10 contributions received and expenditures made by or on behalf of the candidate, political committee
 11 or petition committee to that date, beginning January 1 of the calendar year.

12 (b) If necessary, file additional statements under ORS 260.057 or 260.118.

13 (5) This section does not apply to a candidate for federal office.

14 (6) As used in this section, "contribution" and "expenditure" include a contribution or expendi-
 15 ture to or on behalf of an initiative, referendum or recall petition.

16 **SECTION 44.** ORS 253.690, as amended by section 5, chapter 9, Oregon Laws 2010, is amended
 17 to read:

18 253.690. (1) A long term absent elector described in ORS 253.510 may cast a ballot using a fac-
 19 simile machine as provided in this section. Notwithstanding ORS 254.470 [(8)] (9), a ballot cast under
 20 this section shall be counted only if the ballot:

21 (a) Is received in the office of the county clerk not later than 8 p.m. on the day of the election;

22 (b) Is accompanied by a return identification envelope containing the signature of the elector
 23 and a signed waiver described in subsection (2) of this section; and

24 (c) The signature is verified as provided in subsection (3) of this section.

25 (2) Each elector who casts a ballot under this section shall complete and submit using a fac-
 26 simile machine a waiver described in this subsection. The elector shall attest to the information
 27 supplied on the waiver by signing the completed waiver. The Secretary of State by rule shall design
 28 the form of the waiver, which shall include all of the following:

29 (a) Space for the elector to provide the elector's full name, residence or mailing address, a phone
 30 or facsimile number where the elector may be contacted and any other necessary information.

31 (b) A waiver in substantially the following form:

 38 (c) A statement to notify the elector that the elector's ballot will not be counted unless the
 39 elector has complied with the provisions of this section.

40 (d) Space for the elector to provide the elector's signature to attest to the information supplied.

41 (3) The county clerk shall verify the signature of each elector on the return identification en-
 42 velope transmitted by facsimile machine under this section with the signature on the elector's reg-
 43 istration card, according to the procedure provided by rules adopted by the Secretary of State.

44 (4) The Secretary of State shall adopt rules to administer this section and to ensure the secrecy
 45 of ballots cast using a facsimile machine to the greatest extent possible.

1 **SECTION 45.** ORS 260.695, as amended by section 1, chapter 35, Oregon Laws 2010, is amended
2 to read:

3 260.695. (1)(a) If a person prints or circulates an imitation of the ballot or sample ballot:

4 (A) The imitation ballot or sample ballot and the back of any return envelope enclosed with the
5 ballot or sample ballot shall state the following: “THIS IS NOT A REAL BALLOT. DO NOT USE
6 TO VOTE.” The statement on the imitation ballot or sample ballot shall be in bold print that is at
7 least two times as large as the majority of the text on the ballot or sample ballot or 20-point type,
8 whichever is larger. The statement on the back of a return envelope shall be in bold print that is
9 at least 36-point type.

10 (B) The word “UNOFFICIAL” must be superimposed on the imitation ballot or sample ballot so
11 that the word extends diagonally across the ballot from one margin of the text to the other. The
12 superimposed word may be printed in lighter ink than other text on the ballot or sample ballot.

13 (b) For purposes of this subsection, an imitation of the ballot or sample ballot includes an imi-
14 tation of a portion of the ballot or sample ballot.

15 (2) A person may not do any electioneering, including circulating any cards or handbills, or so-
16 liciting of signatures to any petition, within any building in which any state or local government
17 elections office designated for the deposit of ballots under ORS 254.470 is located, or within 100 feet
18 measured radially from any entrance to the building. A person may not do any electioneering by
19 public address system located more than 100 feet from an entrance to the building if the person is
20 capable of being understood within 100 feet of the building. The electioneering need not relate to
21 the election being conducted. This subsection applies during the period beginning on the date that
22 ballots are mailed to electors as provided in ORS 254.470 and ending on election day at 8 p.m. or
23 when all persons waiting in line at the building who began the act of voting as described in ORS
24 254.470 [(10)] (11) by 8 p.m. have finished voting.

25 (3) A person may not obstruct an entrance of a building in which ballots are issued or a place
26 designated for the deposit of ballots under ORS 254.470 or any voting booth maintained under ORS
27 254.474 is located. This subsection applies during the period beginning on the date that ballots are
28 mailed to electors as provided in ORS 254.470 and ending on election day at 8 p.m. or when all
29 persons waiting in line at the building or location who began the act of voting as described in ORS
30 254.470 [(10)] (11) by 8 p.m. have finished voting.

31 (4) A person may not vote or offer to vote in any election knowing the person is not entitled
32 to vote.

33 (5) A person may not make a false statement about the person’s inability to mark a ballot.

34 (6) A person, except an elections official in performance of duties or another person providing
35 assistance to an elector as described in ORS 254.445, may not ask a person at any place designated
36 for the deposit of ballots under ORS 254.470 or at any location described in ORS 254.472 or 254.474
37 for whom that person intends to vote, or examine or attempt to examine the person’s ballot.

38 (7) A person may not show the person’s own marked ballot to another person to reveal how it
39 was marked.

40 (8) An elections official, other than in the performance of duties, may not disclose to any person
41 any information by which it can be ascertained for whom any elector has voted.

42 (9) A person, except an elections official in performance of duties, may not do anything to a
43 ballot to permit identification of the person who voted.

44 (10) An elector may not willfully leave at any place designated for the deposit of ballots under
45 ORS 254.470 or at any location described in ORS 254.472 or 254.474 anything that will show how the

1 elector's ballot was marked.

2 (11) A person, except an elections official in performance of duties, may not remove a ballot
3 from any place designated for the deposit of ballots under ORS 254.470 or any location described in
4 ORS 254.472 or 254.474.

5 (12) A person, except an elections official in performance of duties or a person authorized by
6 that official, may not willfully deface, remove, alter or destroy a posted election notice.

7 (13) A person, except an elections official in performance of duties, may not willfully remove,
8 alter or destroy election equipment or supplies, or break the seal or open any sealed package con-
9 taining election supplies.

10 (14) A person, except an elections official in performance of duties, may not provide elections
11 advice or attempt to collect voted ballots within any building in which any state or local govern-
12 ment elections office designated for the deposit of ballots under ORS 254.470 is located, or within
13 100 feet measured radially from any entrance to the building.

14 (15) A person, except an elections official in performance of duties, may not establish a location
15 to collect ballots voted by electors unless:

16 (a) The person prominently displays at the location a sign stating: "NOT AN OFFICIAL BAL-
17 LOT DROP SITE"; and

18 (b) The sign is printed in all capital letters in bold 50-point type.

19 **SECTION 46.** ORS 249.215 is amended to read:

20 249.215. (1) If a vacancy occurs in a state office before the 61st day before the first general
21 election to be held during that term of office, the remaining two years of the term of the state office
22 shall be filled by the electors at that general election.

23 (2) The remaining two years of the term of the state office shall commence on the second
24 Monday in January following the general election. Any appointment made to fill the vacancy shall
25 expire when a successor to the office is elected and qualified.

26 (3) Candidates for the remaining two years of the term of the state office under this section shall
27 be nominated as provided in this chapter except [*as follows:*]

28 [*(a) A major political party or a minor political party, by party rule, or an assembly of electors*
29 *or individual electors, may select a nominee; and]*

30 [*(b)*] **that** the Secretary of State shall accept certificates of nomination and notifications of
31 nominees filed with the secretary pursuant to a schedule for filing set by the secretary, but in any
32 case not later than the 62nd day before the first general election.

33 (4) As used in this section, "state office" means the office of Governor, Secretary of State, State
34 Treasurer, Attorney General, Commissioner of the Bureau of Labor and Industries and Superinten-
35 dent of Public Instruction.
