Senate Joint Memorial 11

Sponsored by Senator GEORGE (at the request of Overseas American Academy, American Citizens Abroad, Alliance of American Organizations in Iberia and American Chamber of Commerce in the Philippines) (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Urges President and Congress to end double taxation on United States citizens living abroad.

JOINT MEMORIAL

- 2 To the President of the United States and the Senate and the House of Representatives of the United
- 3 States of America, in Congress assembled:

We, your memorialists, the Seventy-sixth Legislative Assembly of the State of Oregon, in legislative session assembled, respectfully represent as follows:

6 Whereas the United States, the world's most economically powerful nation, also has the world's 7 largest and most chronic international trade deficit; and

8 Whereas the United States Government Accountability Office and the President's Export Coun-9 cil have issued several reports since double taxation on Americans living abroad was first intro-10 duced in the United States in 1962 that concluded that this unique form of double taxation was not 11 only going to continue hurting United States exports efforts but also was going to lead to ever 12 greater losses of jobs at home and abroad; and

Whereas since 1976 the United States has had trade deficits that have reached the cumulative sum of more than 7.5 trillion dollars, with this deficit continuing to grow at a rate of more than 1.5 billion dollars per day; and

16 Whereas the United States now has the smallest percentage of its population living abroad of 17 any member country of the Organisation for Economic Co-operation and Development; and

18 Whereas the United States Government Accountability Office and the President's Export Coun-19 cil have already recommended on several occasions that getting rid of this uniquely American dou-20 ble taxation innovation would be a great benefit for United States trade and for job creation for

21 Americans at home and abroad; and

22 Whereas President Barack Obama has pledged to try to double the amount of United States 23 exports during the next five years; and

Whereas President Barack Obama also made a campaign pledge in 2008 to Americans living overseas that he would give them back a level playing field in world markets; now, therefore,

26 Be It Resolved by the Legislative Assembly of the State of Oregon:

(1) That we, the members of the Seventy-sixth Legislative Assembly, urge the President andCongress that:

(a) The current United States practice of subjecting Americans living overseas to an uncom petitive double taxation obligation, based upon United States citizenship, should be abandoned;

31 (b) Americans living overseas should be allowed once again to have full competitive equality

with citizens of every other trading nation of the world in all of the market places of the world; and
(c) The legislative work necessary to eliminate this self-destructive, citizenship-based tax should
begin at the earliest possible opportunity to facilitate the President's noble objectives to increase
United States exports, create new jobs and strengthen the economy within the next five years.
(2) A copy of this memorial shall be sent to the President of the United States, to the Senate
Majority Leader, to the Speaker of the House of Representatives and to each member of the Oregon
Congressional Delegation.
