3 Delete lines 6 through 27 and delete pages 2 through 4 and insert:

6 Superintendent of Public Instruction shall collect the following

12 “(e) Investigative costs incurred by the department when the de-
13 partment determines that the career school has violated ORS 345.010
14 to 345.450 or any applicable rule.

15 “(3) In addition to any fees collected by the superintendent, the
16 superintendent may charge the fee established by rule under ORS
17 181.534 for a nationwide criminal records check.

18 “(4) All fees collected under this section shall be paid to the credit of the
19 department. Such moneys are continuously appropriated to the department
20 and shall be used for the administration of the licensing program under ORS
21 345.010 to 345.450.

22 “**SECTION 2.** ORS 345.080, as amended by section 1 of this 2011 Act, is
23 amended to read:

24 “345.080. (1) Before issuing any licenses under ORS 345.010 to 345.450, the
25 Superintendent of Public Instruction shall collect [*the following*
26 *nonrefundable, annual license fees:*] **a nonrefundable annual license fee**
27 **established by the State Board of Education by rule.**

6 **“SECTION 3. (1) The amendments to ORS 345.080 by section 2 of this
7 2011 Act become operative on July 1, 2013.**

8 **“(2) Until the State Board of Education first adopts rules pursuant
9 to ORS 345.080 as amended by section 2 of this 2011 Act, the Super-
10 intendent of Public Instruction may collect annual license fees estab-
11 lished by ORS 345.080 as amended by section 1 of this 2011 Act.**

12 **“SECTION 4. This 2011 Act being necessary for the immediate
13 preservation of the public peace, health and safety, an emergency is
14 declared to exist, and this 2011 Act takes effect July 1, 2011.”.**
