

**PROPOSED AMENDMENTS TO  
A-ENGROSSED SENATE BILL 250**

1 On page 1 of the printed A-engrossed bill, line 4, after “334.177” insert “,  
2 334.217”.

3 On page 10, line 6, after the period insert “Prior to calculating the State  
4 School Fund grant for each education service district, the superintendent  
5 shall calculate the anticipated amount of administrative costs that will be  
6 incurred for that fiscal year by the Office of Regional Educational Services  
7 established in section 35 of this 2011 Act and shall retain that amount for  
8 the purpose of paying those costs.”.

9 On page 11, line 35, after the period insert “Prior to calculating the State  
10 School Fund grant for each education service district, the superintendent  
11 shall calculate the anticipated amount of administrative costs that will be  
12 incurred for that fiscal year by the Office of Regional Educational Services  
13 established in section 35 of this 2011 Act and shall retain that amount for  
14 the purpose of paying those costs.”.

15 On page 24, after line 39, insert:

16 **“SECTION 33. (1) The Regional Education Services Advisory Board**  
17 **is established. The duties of the board are to:**

18 **“(a) Advise the Director of the Office of Regional Educational Ser-**  
19 **vices for the purpose of assisting the director in fulfilling the statutory**  
20 **requirements imposed by section 35 of this 2011 Act;**

21 **“(b) Provide to the Director of the Office of Regional Educational**  
22 **Services recommendations for changes in statute or rule for the pur-**

1 pose of assisting the director in fulfilling the statutory requirements  
2 imposed on the Office of Regional Educational Services by section 35  
3 of this 2011 Act; and

4 “(c) Assist the Superintendent of Public Instruction in selecting the  
5 Director of the Office of Regional Educational Services, including de-  
6 veloping or modifying a proposed position description, screening can-  
7 didates and making a recommendation for the position.

8 “(2) The board shall consist of nine members appointed by the  
9 Governor and confirmed by the Senate in the manner provided by ORS  
10 171.562 and 171.565. The term of office of each member is four years,  
11 but a member serves at the pleasure of the Governor.

12 “(3) The Governor shall appoint the members of the board from  
13 among the school district superintendents of this state in a manner  
14 that ensures the representation of school districts of a variety of sizes  
15 and geographic locations.

16 “(4) Members of the board may not receive compensation for their  
17 services, but shall be paid for their necessary and actual expenses in  
18 accordance with ORS 292.495.

19 “SECTION 34. Notwithstanding the term of office specified by sec-  
20 tion 33 of this 2011 Act, of the members first appointed to the Regional  
21 Education Services Advisory Board:

22 “(1) Two shall serve for a term ending July 1, 2012.

23 “(2) Two shall serve for a term ending July 1, 2013.

24 “(3) Two shall serve for a term ending July 1, 2014.

25 “(4) Three shall serve for a term ending July 1, 2015.

26 “SECTION 35. (1) The Office of Regional Educational Services is  
27 established for the purposes of coordinating the efforts of and provid-  
28 ing leadership for regional educational service delivery systems. The  
29 office shall function under the direction and control of the State Board  
30 of Education.

1       **“(2)(a) The Director of the Office of Regional Educational Services**  
2 **shall serve as the administrative officer of the Office of Regional Ed-**  
3 **ucational Services. The Superintendent of Public Instruction shall se-**  
4 **lect the director after considering the recommendation made by the**  
5 **Regional Education Services Advisory Board established in section 33**  
6 **of this 2011 Act.**

7       **“(b) The director shall perform the duties, powers and functions of**  
8 **the office:**

9       **“(A) Under the supervision and subject to the direction of the Su-**  
10 **perintendent of Public Instruction; and**

11       **“(B) In cooperation with the Regional Education Services Advisory**  
12 **Board.**

13       **“(3) The Office of Regional Educational Services shall:**

14       **“(a) Establish best practice policies and conduct an ongoing analy-**  
15 **sis of the effectiveness of education service districts, including deter-**  
16 **mining the direct cost of services to school districts that are assessed**  
17 **by education service districts.**

18       **“(b) Establish benchmarks for education service districts that allow**  
19 **the education service districts to make improvements in the operation**  
20 **of the education service districts and to demonstrate that improve-**  
21 **ments are being made in the operation of education service districts.**

22       **“(c) Conduct ongoing evaluations of the systems and procedures of**  
23 **education service districts.**

24       **“(d) Ensure that each education service district has an annual audit**  
25 **of the accounts of the education service district prepared in accord-**  
26 **ance with the Municipal Audit Law, as provided in ORS 297.405 to**  
27 **297.555 and 297.990, and review the audit.**

28       **“(e) Request a performance audit of an education service district if**  
29 **the office has reason to believe that an education service district is**  
30 **nonstandard as provided by ORS 334.217.**

1       “(f) Recommend to the Superintendent of Public Instruction any  
2 sanctions to impose on an education service district that are consist-  
3 ent with ORS 334.217 and recommend any statutory changes required  
4 to impose effective sanctions on education service districts.

5       “(g) Recommend to the Superintendent of Public Instruction and  
6 the State Board of Education any statutory or rule changes that may  
7 improve the operations or administration of education service dis-  
8 tricts.

9       “(h) Recommend to the board of directors of an education service  
10 district or to the superintendent of an education service district any  
11 changes that may improve the operations or administration of the  
12 education service district.

13       “(i) Recommend to the Superintendent of Public Instruction and  
14 the State Board of Education any changes in education service district  
15 boundaries that may reduce costs and increase the quality of services  
16 provided by education service districts.

17       “(j) Recommend to the board of directors of an education service  
18 district or to the superintendent of an education district any changes  
19 in service delivery regions that may reduce costs and increase the  
20 quality of services provided by the education service district.

21       “(k) Provide training and related support for boards of directors of  
22 education service districts and superintendents of education service  
23 districts.

24       “(L) Gather information regarding the cost of services within edu-  
25 cation service districts and across education service districts, identify  
26 unusually high cost services and provide the gathered information to  
27 education service districts, the Superintendent of Public Instruction  
28 and the State Board of Education.

29       “(4) The State Board of Education, in collaboration with the Su-  
30 perintendent of Public Instruction and the Director of the Office of

1 **Regional Educational Services, may adopt any rules necessary for the**  
2 **purposes of this section.**

3 **“SECTION 36.** ORS 334.217 is amended to read:

4 “334.217. (1) The State Board of Education by rule shall establish stan-  
5 dards to determine the adequacy of services and facilities provided by the  
6 education service districts. In establishing such standards, the state board  
7 shall consider the most economic method of providing services and facilities,  
8 the quality of the services and facilities according to the best educational  
9 standards, and the needs of the students.

10 “(2) When the Superintendent of Public Instruction determines pursuant  
11 to rule that an education service district is nonstandard, the district desig-  
12 nated nonstandard shall file a plan to meet standards over a specified period  
13 of time. The Superintendent **of Public Instruction** may accept, reject or  
14 modify the plan and order the nonstandard district to comply with the plan  
15 as approved by the superintendent. Once a plan is approved, the district shall  
16 be conditionally standard until all deficiencies are corrected. If a district  
17 corrects all deficiencies, the district shall be designated as standard. The  
18 district shall have 180 days from the date the plan is accepted to make all  
19 corrections. After that time, the Superintendent **of Public Instruction** may  
20 impose sanctions on the district if the district has not made the necessary  
21 corrections.

22 “(3) The state board shall establish by rule appropriate sanctions for  
23 noncompliance. The sanctions may include:

24 “(a) Mandatory merger of the nonstandard education service district with  
25 a contiguous education service district that is standard[.];

26 “(b) The sanctions described in ORS 342.173, if applicable[ *or*];

27 “(c) The withholding of funds from the State School Fund[.];

28 “(d) **The removal of the superintendent of the education service**  
29 **district;**

30 “(e) **The temporary governance of the education service district by**

1 **the state board; or**

2 **“(f) Dissolution of the education service district.”.**
