**PROPOSED AMENDMENTS TO
HOUSE BILL 2541**

1 On page 1 of the printed bill, line 2, after "ORS" insert "105.645,".

2 Delete lines 4 through 7 and insert "118.171, 118.225, 118.260, 118.280,
3 118.300, 118.350, 118.525, 129.250, 305.490 and 314.415; repealing ORS 118.009,
4 118.019, 118.220, 118.240, 118.470, 118.810, 118.820, 118.830, 118.840, 118.855,
5 118.860, 118.865, 118.870, 118.875 and 118.880 and section 3, chapter 806,
6 Oregon Laws 2003; and prescribing an effective date."

7 Delete lines 9 through 27 and delete pages 2 through 23 and insert:

8 **"SECTION 1.** ORS 118.005 is amended to read:

9 "118.005. As used in ORS 118.005 to 118.840, unless the context requires
10 otherwise:

11 "(1) 'Beneficiary' means the recipient of a beneficial interest in property
12 or the income therefrom transferred in a manner taxable under ORS 118.005
13 to 118.840.

14 "(2) 'Department' means the Department of Revenue.

15 "(3) 'Director' means the Director of the Department of Revenue.

16 "(4) 'Executor' means the executor, administrator, personal representative,
17 fiduciary, or custodian of property of the decedent, or, if there is no executor,
18 administrator, fiduciary or custodian appointed, qualified and acting, then
19 any person who is in the actual or constructive possession of any property
20 includable in the estate of the decedent for [*inheritance*] estate tax purposes
21 whether or not such estate is subject to administration.

22 "(5) 'Federal taxable estate' means the taxable estate as determined

1 **under subtitle B, chapter 11 of the Internal Revenue Code.**

2 “[~~(5)~~] (6) ‘Gross estate’ has the meaning given that term in section 2031
3 of the Internal Revenue Code.

4 “[~~(6)~~] (6) ‘Nonresident decedent’ means an individual who is domiciled outside
5 of Oregon at the time of death.]

6 **“(7) ‘Oregon taxable estate’ means the federal taxable estate with
7 the adjustments provided by ORS 118.010 (3).**

8 “[~~(7)~~] (8) ‘Passes’ includes any case where for the purposes of ORS 118.005
9 to 118.840 a taxable transfer takes place or is deemed to take place.

10 “[~~(8)~~] (9) ‘Personal representative’ means personal representative as de-
11 fined in ORS 111.005.

12 “[~~(9)~~] (9) ‘Resident decedent’ means an individual who is domiciled in Oregon
13 at the time of death.]

14 “[~~(10)~~] (10) ‘Transfer’ or ‘transfer of property’ means a transfer that is subject
15 to the federal estate tax imposed under subtitle B, chapter 11 of the Internal
16 Revenue Code.]

17 **“SECTION 2.** ORS 118.007 is amended to read:

18 “118.007. Any term used in ORS 118.005 to 118.840 has the same meaning
19 as when used in a comparable context in the laws of the federal Internal
20 Revenue Code relating to federal estate taxes, unless a different meaning is
21 clearly required or the term is specifically defined in ORS 118.005 to 118.840.
22 Any reference in ORS 118.005 to 118.840 to the Internal Revenue Code means
23 the federal Internal Revenue Code as amended and in effect on December 31,
24 [2000] 2010, except where the Legislative Assembly has specifically provided
25 otherwise.

26 **“SECTION 3.** ORS 118.010 is amended to read:

27 “118.010. *[(1) A tax is imposed upon a transfer of property and any interest
28 therein, within the jurisdiction of the state, whether belonging to the inhabit-
29 ants of this state or not, which passes to or vests in any person or persons, or
30 any body or bodies politic or corporate, in trust or otherwise, or by reason*

1 *whereof any person or body politic or corporate shall become beneficially enti-*
2 *led, in possession or expectation, to any property or interest therein or income*
3 *thereof.]*

4 *“(2) The tax imposed under this section shall equal the maximum amount*
5 *of the state death tax credit allowable against the federal estate tax under*
6 *section 2011 of the Internal Revenue Code.]*

7 **“(1) As used in this section:**

8 **“(a) ‘Nonresident decedent’ means an individual who is domiciled**
9 **outside of Oregon on the date the individual dies.**

10 **“(b) ‘Resident decedent’ means an individual who is domiciled in**
11 **Oregon on the date the individual dies.**

12 **“(2) A tax is imposed upon a transfer of the property of each:**

13 **“(a) Resident decedent; and**

14 **“(b) Nonresident decedent whose estate includes any interest in:**

15 **“(A) Real property located in Oregon; or**

16 **“(B) Tangible personal property located in Oregon.**

17 **“(3) The Oregon taxable estate to be used for purposes of computing**
18 **the tax imposed under this section shall be the federal taxable estate:**

19 **“(a) Increased by:**

20 **“(A) The deduction for state estate, inheritance, legacy or suc-**
21 **cession taxes allowable under section 2058 of the Internal Revenue**
22 **Code; and**

23 **“(B) If the decedent is a surviving spouse owning the property at**
24 **death, the value of the following property unless included in the fed-**
25 **eral taxable estate:**

26 **“(i) Property for which a deduction for Oregon special marital**
27 **property under ORS 118.016 was previously allowed; or**

28 **“(ii) Property for which a separate Oregon election under section**
29 **2056 or 2056A of the Internal Revenue Code was previously allowed; and**

30 **“(b) Reduced by:**

1 “(A) The value on the date of the decedent’s death of all Oregon
2 special marital property under ORS 118.013; and

3 “(B) Any other applicable exclusions or deductions.

4 “(4) The tax imposed under this section shall be calculated by ap-
5 plying the rates in the following table. If the Oregon taxable estate is
6 at least the amount in column 1, but less than the amount in column
7 2, the tax is the amount in column 3, increased by the excess above
8 the amount in column 1 multiplied by the percentage in column 4:

22 “[(3)] (5) In the case of a resident decedent owning [*property outside of the*
23 *jurisdiction of this state at the time of death*], **on the date of the decedent’s**
24 **death, real property located outside Oregon or tangible personal prop-**
25 **erty located outside Oregon,** the tax imposed under this section shall be
26 the amount determined under subsection [(2)] (4) of this section multiplied
27 by a ratio. The numerator of the ratio shall be the sum of the [*appraised*]
28 value of the decedent’s real property located in Oregon, tangible personal
29 property located in Oregon and intangible personal property [*located both in*
30 *and outside of Oregon*]. **The numerator may not include any intangible**

1 **personal property subject to a tax imposed, as a result of the death**
2 **of the decedent, by another state or country.** The denominator of the
3 ratio shall be the total *[appraised]* value of the decedent's gross estate.

4 “*[(4)(a)] (6)* In the case of a nonresident decedent owning *[property within*
5 *the jurisdiction of this state at the time of death]*, **on the date of the**
6 **decedent's death, real property located in Oregon or tangible personal**
7 **property located in Oregon,** the tax imposed under this section shall be the
8 amount determined under subsection *[(2)] (4)* of this section multiplied by a
9 ratio. The numerator of the ratio shall be the sum of the *[appraised]* value
10 of the decedent's real property located in Oregon[,] **and** tangible personal
11 property located in Oregon *[and intangible personal property located in*
12 *Oregon]*. The denominator shall be the total *[appraised]* value of the
13 decedent's gross estate.

14 “*[(b) Intangible personal property of a nonresident decedent shall not be*
15 *included in the numerator of the ratio used to determine the tax under this*
16 *subsection if a similar exemption is made by the laws of the state or country*
17 *of the decedent's residence in favor of residents of this state.]*

18 “*[(5) In the case of decedents dying before January 1, 2003, if federal estate*
19 *tax credits other than the state death tax credit result in no federal estate tax,*
20 *no tax shall be imposed under this section.]*

21 “*[(6)] (7)* Payment, in whole or in part, of *[inheritance and]* estate taxes
22 from funds of an estate or trust on any benefit subject to tax under ORS
23 118.005 to 118.840 is not to be considered *[as]* a further taxable benefit, when
24 such payment is directed by **the** decedent's will or by a trust agreement.

25 “*[(7)] (8)(a)* If the federal taxable estate is determined by making an
26 election under section *[2032 or 2056] 2031(c), 2032, 2032A, 2056 or 2056A* of
27 the Internal Revenue Code or another provision of the Internal Revenue
28 Code, or if a federal estate tax return is not required under the Internal
29 Revenue Code, *[the Department of Revenue may adopt rules providing for a*
30 *separate election for state inheritance tax purposes.]* **an executor may make**

1 separate elections for state estate tax purposes under that same pro-
2 vision.

3 “(b) An executor may make elections under ORS 118.013 and 118.140
4 and section 2056 of the Internal Revenue Code for state estate tax
5 purposes.

6 “(c) Elections described in this subsection are irrevocable.

7 **“SECTION 4.** ORS 118.013 is amended to read:

8 “118.013. *[(1) For purposes of computing the tax imposed under ORS*
9 *118.010, the taxable estate to be used for computing the maximum amount of*
10 *the state death tax credit allowable under section 2011 of the Internal Revenue*
11 *Code shall be the taxable estate determined for federal estate tax purposes,*
12 *reduced by the value on the date of death of the decedent of all Oregon special*
13 *marital property in the estate.]*

14 **(1) As used in this section and ORS 118.016, ‘permissible**
15 **distributee’ has the meaning given that term in ORS 130.010.**

16 “(2) Oregon special marital property consists of any trust or other prop-
17 erty interest, or a portion of a trust or property interest:

18 “(a) In which principal or income may be accumulated or distributed to
19 or for the benefit of only the surviving spouse of the decedent during the
20 lifetime of the surviving spouse;

21 “(b) In which a person may not transfer or exercise a power to appoint
22 any part of the trust or other property interest to a person other than the
23 surviving spouse during the lifetime of the surviving spouse; and

24 “(c) For which the executor of the estate of the decedent has made the
25 election described in ORS 118.016 (1).

26 “(3) If a trust or other property interest would qualify as Oregon special
27 marital property under subsection (2) of this section except that the trust
28 or other property interest allows principal or income to be distributed to
29 other persons in addition to the surviving spouse, the executor may elect to
30 set aside a share of the trust or other property interest as a separate share

1 of the trust or property interest or as a separate trust, which shall qualify
2 as Oregon special marital property if:

3 “(a) The executor makes the election described in ORS 118.016 (1);

4 “(b) Each [*beneficiary who is living at the time the election is made and*
5 *who may be entitled to a distribution from the share during the lifetime of the*
6 *surviving spouse*] **permissible distributee** makes the election described in
7 ORS 118.016 (2);

8 “(c) The surviving spouse makes the election described in ORS 118.016 (2);
9 and

10 “(d) All [*elections*] **statements of election** are attached to the
11 [*inheritance*] **estate** tax return filed with respect to the estate of the
12 decedent, or are filed or maintained as records as otherwise prescribed by the
13 Department of Revenue by rule.

14 “**SECTION 5.** ORS 118.016 is amended to read:

15 “118.016. (1) The executor of an estate containing property that the execu-
16 tor seeks to qualify as Oregon special marital property under ORS 118.013
17 shall make an election under this subsection in order for the property to be
18 Oregon special marital property. The election shall be made:

19 “(a) By attaching a statement to the [*inheritance*] **estate** tax return for
20 the estate of the decedent that identifies the trust or other property interest
21 that constitutes Oregon special marital property and that affirms that the
22 identified property meets the requirements of Oregon special marital prop-
23 erty under ORS 118.013 and will be administered as required under ORS
24 118.013; or

25 “(b) In such other manner as the Department of Revenue prescribes by
26 rule.

27 “(2) For a trust or other property interest described in ORS 118.013 (3),
28 in order for any portion of the trust or other property interest to be Oregon
29 special marital property, in addition to the election of the executor described
30 in subsection (1) of this section, the surviving spouse and each [*beneficiary*

14 *might be entitled to a distribution during my lifetime*]. I agree that all other
15 terms, conditions and provisions that apply to the _____ (name
16 of trust or other property interest) shall apply to the Oregon special marital
17 property to which this election applies, and that upon my death, any re-
18 maining Oregon special marital property shall be distributed as otherwise
19 provided in the trust or other property interest.

“(3) Elections made under this section are irrevocable.”

1 “(4) The custodial parent or court appointed guardian of a [*minor benefi-*
2 *ciary*] **permissible distributee who is a minor, or any person who is**
3 **authorized under ORS 130.110**, may sign the election on behalf of the [*mi-*
4 *nor beneficiary*] **permissible distributee** and the unborn lineal descendants
5 of the [*minor beneficiary*] **permissible distributee**.

6 “**SECTION 6.** ORS 118.100 is amended to read:

7 “118.100. (1) The tax provided for in ORS 118.010 shall **take effect at and**
8 **accrue upon the death of the decedent. A return shall be filed and the**
9 **tax shall** be paid to the Department of Revenue on the date the federal es-
10 tate tax is payable **or, if no federal estate tax return is required, no**
11 **later than nine months following the date of death of the decedent. If**
12 [*interest is paid on federal estate tax installments resulting in a reduction of*
13 *the federal estate tax, and*] the department determines, pursuant to an
14 amended return or refund claim, that the amount of tax imposed by ORS
15 118.010 is less than the amount theretofore paid, the excess tax shall be re-
16 funded by the department with interest at the rate established by ORS
17 305.220 for each month or fraction thereof during a period beginning **45 days**
18 **after the due date of the return or** on the date the amended return or
19 refund claim is filed, **whichever is later, and ending at [to]** the time the
20 refund is made.

21 “(2) If the amount of federal estate tax reported on a [*United States*]
22 **federal** estate tax return is changed or corrected by the Internal Revenue
23 Service or other competent authority, resulting in a change in the [*maximum*
24 *state death tax credit allowable under the federal estate tax law*] **Oregon**
25 **taxable estate**, the executor shall report the change or correction in federal
26 estate tax to the department. If the federal change or correction results in
27 a reduction of the [*allowable state death tax credit*] **Oregon taxable estate**,
28 the report of the change or correction shall be treated by the department as
29 a claim for refund pursuant to ORS 305.270 and, notwithstanding the limi-
30 tations of ORS 305.270, shall be deemed timely if filed with the department

1 within two years after the federal correction was made. If the change or
2 correction results in an increase in the [*state death tax credit allowable on*
3 *the federal estate tax return*] **Oregon taxable estate**, the department may
4 issue a notice of deficiency within two years after the federal change or
5 correction was made or within two years after receiving a report of the fed-
6 eral change or correction, whichever is the later. Any executor filing an
7 amended federal estate tax return shall also file an amended return with the
8 department within 90 days thereafter.

9 “(3)(a) In the case of an estate that contains property that is valued under
10 section 2032A of the Internal Revenue Code for federal estate tax purposes
11 (relating to the valuation of certain farm or other property) and that ceases
12 to qualify for valuation under section 2032A, an additional tax under ORS
13 118.005 to 118.840 shall be imposed[. *The additional tax shall equal the*
14 *amount of any increase in the state death tax credit allowable under section*
15 *2011 of the Internal Revenue Code that is*] **in the amount** attributable to the
16 change in the value of the estate resulting from the imposition of additional
17 federal estate tax under section 2032A.

18 “(b) The department shall be notified of the disqualification of the prop-
19 erty from valuation under section 2032A in the same time and manner as the
20 federal Internal Revenue Service is notified of the disqualification.

21 “(c) The period for assessment of the tax imposed under this subsection,
22 including any penalty or interest, shall be two years from the date on which
23 the department receives the notice described in paragraph (b) of this sub-
24 section.

25 “(d) The other provisions of ORS 118.005 to 118.840 and ORS chapter 305
26 shall apply to the additional tax imposed under this subsection in the same
27 manner in which those provisions apply to the tax imposed under ORS
28 118.010.

29 “(4) For purposes of this section, a change or correction of a [*United*
30 *States*] **federal** estate tax return is deemed to be made on the date of the

1 federal audit report.

2 “(5) The executor shall, upon request of the department, supply a copy
3 of the [United States] federal estate tax return which the executor has filed
4 or may file with the federal government, or a copy of any federal agent’s
5 report upon any audit or adjustment of the [United States] federal estate tax
6 return.

7 “(6) The executor shall explain, on the return, how the reported
8 values were determined and attach copies of any appraisals.

9 “SECTION 7. ORS 118.140 is amended to read:

10 “118.140. [(1) As used in this section, ‘natural resource property’ means real
11 property as defined in ORS 307.010 that at the decedent’s death:]

12 “[(a) Is in farm use, as defined in ORS 308A.056, or is used as one or more
13 farm use homesites, as defined in ORS 308A.250, related to that real property;
14 or]

15 “[(b) Is used as forestland, as defined in ORS 321.201, or is used as one
16 or more forestland homesites, as defined in ORS 308A.250, related to that real
17 property, not to exceed 5,000 acres.]

18 “[(2)(a) A credit against the taxes otherwise due under ORS 118.005 to
19 118.840 shall be allowed based upon the value of the following property:]

20 “[(A) Natural resource property.]

21 “[(B) If the decedent or a person described in subsection (3)(c) of this sec-
22 tion was licensed under ORS chapter 508, property that is:]

23 “[(i) Used in the conduct of a fishing business as defined in section
24 1301(b)(4) of the Internal Revenue Code, including boats, gear, equipment,
25 vessel licenses and permits and commercial fishing licenses and permits; or]

26 “[(ii) Used to process and sell the catch of a commercial fishing business
27 in fresh, canned or smoked form directly to consumers, including a restaurant
28 with seating capacity of less than 15 seats at which catch from the fishing
29 business is prepared and sold.]

30 “[(C) Tangible and intangible personal property devoted to use as a farm

1 or used for farm or forestry purposes, including:]

2 “[(i) Timber, trees and improvements;]

3 “[(ii) Crops, both growing and stored; and]

4 “[(iii) Forestry and farming equipment.]

5 “[(D) Working capital of a farm, natural resource-based business or fishing
6 business owned by the decedent at the decedent’s death.]

7 “[(b) A taxpayer may:]

8 “[(A) Elect not to claim the credit allowed under this section;]

9 “[(B) Elect to claim less than the full amount of the credit allowed under
10 this section; or]

11 “[(C) Elect to claim the credit only for the value of certain assets.]

12 “[(c) If the value of property for which the credit allowed under this section
13 is claimed is at least the amount in column 1, but less than the amount in
14 column 2, the credit is the amount in column 3, increased by the excess above
15 the amount in column 1 multiplied by the percentage in column 4:]

16 “(1) As used in this section:

17 “(a) ‘Adjusted gross estate’ means the value of the gross estate re-
18 duced by the sum of the amounts allowable under sections 2053 and
19 2054 of the Internal Revenue Code.

20 “(b) ‘Family member’ means a member of the family, as defined in
21 section 2032A of the Internal Revenue Code, of the decedent.

22 “(c) ‘Farm business’ means a business operated for the primary
23 purpose of obtaining a profit in money by:

24 “(A) Raising, harvesting or selling fruit or crops;

25 “(B) Feeding, breeding, managing or selling livestock, poultry, fur-
26 bearing animals or bees, or the produce thereof;

27 “(C) Dairying and selling dairy products;

28 “(D) Breeding, stabling or training equines;

29 “(E) Propagating, cultivating, maintaining or harvesting aquatic
30 species, birds or animal species to the extent allowed by the rules

1 adopted by the State Fish and Wildlife Commission;

2 “(F) Raising nursery stock;

3 “(G) Practicing animal husbandry; or

4 “(H) Raising other agricultural or horticultural products.

5 “(d) ‘Farm use’ has the meaning given that term in ORS 308A.056.

6 “(e) ‘Fishing business’ has the meaning given that term in section
7 1301(b)(4) of the Internal Revenue Code.

8 “(f) ‘Forestland’ has the meaning given that term in ORS 321.201.

9 “(g) ‘Forestry business’ means a business operated for the primary
10 purpose of obtaining a profit in money by the planting, cultivating,
11 caring for, preparing, harvesting or cutting of timber or trees for
12 market.

13 “(h) ‘Homesite’ has the meaning given that term in ORS 308A.250.

14 “(i) ‘Natural resource property’ means the following property, if on
15 the date of the decedent’s death the property is owned by the decedent
16 and used in the operation of a farm business, forestry business or
17 fishing business owned by the decedent:

18 “(A) Real property used as forestland or as forestland homesites,
19 not to exceed 5,000 acres, or that is in farm use.

20 “(B) Timber or trees.

21 “(C) Crops, fruit or other horticultural products, both growing and
22 stored.

23 “(D) Forestry business or farm business equipment.

24 “(E) Livestock, poultry, fur-bearing animals, bees, dairying ani-
25 mals, equines, aquatic species, birds or other animal species, including
26 stored products or by-products.

27 “(F) Nursery stock as defined in ORS 571.005.

28 “(G) Boats, gear, equipment, vessel licenses or permits, commercial
29 fishing licenses or permits and other real or personal property used in
30 the operation of a fishing business.

1 **“(H) Real or personal property used to process and sell the catch**
2 **of a fishing business in fresh, canned or smoked form directly to con-**
3 **sumers, including a restaurant with seating capacity of fewer than 15**
4 **seats at which catch from the fishing business is prepared and sold.**

5 **“(I) An operating allowance.**

6 **“(J) Any other tangible and intangible personal property used in the**
7 **operation of a farm business, forestry business or fishing business.**

8 **“(j) ‘Operating allowance’ means cash or a cash equivalent that is**
9 **spent, maintained, used or available for the operation of a farm busi-**
10 **ness, forestry business or fishing business and not spent or used for**
11 **any other purpose.**

12 **“(k) ‘Qualified beneficiary’ has the meaning given that term in ORS**
13 **130.010.**

14 **“(L) ‘Real property’ means real property, as defined in ORS 307.010,**
15 **that is in this state.**

16 **“(2)(a) An estate shall be allowed a credit for the value of natural**
17 **resource property claimed. Any operating allowance claimed under**
18 **this section may not exceed the lesser of \$1 million or 15 percent of**
19 **the total value of natural resource property claimed, not including the**
20 **operating allowance.**

21 **“(b) The credit allowed under this section shall be computed by**
22 **multiplying the tax that would be payable under this chapter absent**
23 **the credit by a ratio, the numerator of which is an amount equal to**
24 **the lesser of the amount of natural resource property claimed under**
25 **this section or \$7.5 million, and the denominator of which is an**
26 **amount equal to the total adjusted gross estate.**

27 **“(c) An executor may:**

28 **“(A) Elect not to claim the credit allowed under this section;**

29 **“(B) Elect to claim less than the full amount of the credit allowed**
30 **under this section; or**

1 “(C) **Elect to claim the credit only for the value of certain assets.**

2 “(3) Except as provided in subsections [(4) and (5)] (4), (7) and (8) of this
3 section, a credit is allowed under this section only if:

4 “(a) The total adjusted gross estate does not exceed \$15 million;

5 “(b) The total value of [*property for which the credit established under this*
6 *section is allowable*] **natural resource property in the estate** is at least
7 50 percent of the total adjusted gross estate;

8 “(c) The **natural resource** property is transferred to a [*member of the*
9 *family, as that term is defined in section 2032A of the Internal Revenue Code,*
10 *or the registered domestic partner, of the decedent*] **family member**; and

11 “(d) During an aggregate period of five out of the eight years ending on
12 the date of the decedent’s death, the decedent[, *a member of the decedent’s*
13 *family or the decedent’s registered domestic partner owned the property and*
14 *the property was devoted to use as a farm or used for farm or forest*
15 *purposes*] **or a family member operated a farm business, forestry busi-**
16 **ness or fishing business and the property for which a credit is claimed**
17 **under this section is part of the business.**

18 “(4) Property that otherwise meets the requirements of this section shall
19 be allowed a credit under this section if:

20 “(a) The property is the subject of a net cash lease to or from the
21 decedent or a [*transferee described in subsection (3)(c) of this section*] **quali-**
22 **fied beneficiary who is a family member**; [*or*]

23 “(b) The property is held in trust for a [*person described in subsection*
24 *(3)(c) of this section.*] **qualified beneficiary who is a family member**; or

25 “(c) **The property replaces natural resource property, and the re-**
26 **placement property would otherwise meet the definition of natural**
27 **resource property except that it was acquired after the date of the**
28 **decedent’s death but before the estate tax return is filed. In order to**
29 **qualify under this paragraph, real property must be replaced with real**
30 **property.**

1 **“(5) A credit is allowed under this section for the following real**
2 **property only if the real property was owned by the decedent or a**
3 **family member during an aggregate period of five out of the eight**
4 **years ending on the date of the decedent’s death and used in a business**
5 **described in subsection (3)(d) of this section:**

6 **“(a) Real property used as forestland or as forestland homesites,**
7 **not to exceed 5,000 acres.**

8 **“(b) Real property used in farm use.**

9 **“(6) A credit is allowed under this section for property used in the**
10 **operation of a fishing business only if the decedent or a family mem-**
11 **ber, during an aggregate period of five out of the eight years ending**
12 **on the date of the decedent’s death:**

13 **“(a) Owned a vessel used in taking food fish or shellfish for com-**
14 **mercial purposes as defined in ORS 506.006;**

15 **“(b) Held a boat license as provided in ORS 508.260;**

16 **“(c) Held a commercial fishing license under ORS 508.235; and**

17 **“(d) Held one or more restricted fisheries permits as provided in**
18 **ORS chapter 508 or an equivalent restricted vessel permit system un-**
19 **der the laws of another state.**

20 **“(7) For the purpose of meeting the requirements of subsection (5)**
21 **of this section, in determining the period of time during which the**
22 **decedent or a family member owned real property received in exchange**
23 **under section 1031 of the Internal Revenue Code or acquired in an in-**
24 **voluntary conversion under section 1033 of the Internal Revenue Code,**
25 **the period during which the decedent or a family member owned the**
26 **exchanged or acquired real property, if the exchanged or acquired real**
27 **property was used in the farm business or forestry business, may be**
28 **included.**

29 **“[(5)] (8) Property that otherwise meets the requirements of this section**
30 **and that is owned indirectly by the decedent or a [member of the family de-**

1 scribed in subsection (3)(c) of this section, or the registered domestic partner,
2 of the decedent shall qualify for a credit] **family member qualifies for a**
3 **credit** under this section if the property is owned through an interest in a
4 limited liability company or in a corporation, partnership or trust as the
5 terms corporation, partnership or trust are used in section 2032A(g) of the
6 Internal Revenue Code. In order to qualify [for a credit] under this sub-
7 section, at least one [member of the family, or the registered domestic partner,
8 of the decedent] **family member** must materially participate in the business
9 after the transfer. For purposes of this subsection, 'materially participate'
10 means to engage in active management, as defined in section 2032A of the
11 Internal Revenue Code, of [natural resource property or a] **the farm busi-**
12 **ness, forestry business or** fishing business. The Department of Revenue
13 may adopt rules to administer this subsection consistent with this definition.

14 *"[(6) Property that otherwise meets the requirements of this section and is*
15 *involuntarily converted, as that term is used in section 1033 of the Internal*
16 *Revenue Code, shall qualify for a credit under this section if the proceeds of*
17 *conversion are used to acquire replacement property, the cost of which equals*
18 *or exceeds the amount realized on the conversion. The replacement property*
19 *must also meet the requirements of this section.]*

20 *"[(7)(a) An additional tax under ORS 118.005 to 118.840 shall be imposed*
21 *if property for which a credit is allowed under this section is not used in*
22 *commercial fishing operations or as natural resource property for at least five*
23 *out of the eight calendar years following the decedent's death or is disposed*
24 *of by the transferee other than by disposition to another member of the family,*
25 *or the registered domestic partner, of the decedent or to another entity eligible*
26 *for the credit allowed under this section. Property that otherwise meets the*
27 *requirements of this section and is conveyed after the decedent's death as a*
28 *qualified conservation contribution, as that term is defined in section 170(h)*
29 *of the Internal Revenue Code, shall continue to qualify for a credit under this*
30 *section.]*

1 “(9)(a) A disposition shall occur and an additional tax under ORS
2 118.005 to 118.840 shall be imposed if the natural resource property for
3 which a credit is allowed under this section is not used in the opera-
4 tion of a farm business, forestry business or fishing business for at
5 least five out of the eight calendar years following the decedent’s
6 death or is transferred to a person other than a family member or
7 another entity eligible for the credit allowed under this section.

8 “(b) The use of cash or other assets for which a credit is claimed
9 under this section for the payment of federal estate taxes or state
10 inheritance or estate taxes shall be a disposition and an additional tax
11 shall be imposed under this subsection.

12 “(c) The conveyance after the decedent’s death of property that
13 otherwise meets the requirements of this section and is conveyed as
14 a qualified conservation contribution, as defined in section 170(h) of
15 the Internal Revenue Code, is not a disposition requiring payment of
16 additional tax under this subsection.

17 “(d) Natural resource property may be replaced with real property
18 or personal property after the credit is claimed and not result in a
19 disposition subject to an additional tax if the replacement property is
20 used in the operation of the farm business, forestry business or fishing
21 business. Real property for which a credit is claimed under this section
22 may be replaced only with real property that would otherwise qualify
23 as natural resource property and that replacement must be made
24 within one year to avoid a disposition and additional tax, except that
25 a replacement of property that is involuntarily converted under sec-
26 tion 1033 of the Internal Revenue Code must occur within two years.

27 “[(b)] (e) The additional tax liability shall be the amount of [*the credit*
28 *allowed on*] additional tax that would have been imposed, had the dis-
29 qualified property not been included in the numerator of the ratio in
30 subsection (2)(b) of this section, multiplied by ((five minus the number of

1 years the property was used as natural resource property) divided by five).
2 The additional tax liability [*shall be*] is the responsibility of the owner of
3 the property at the time of the disposition or disqualifying event **and is due**
4 **within six months after the date on which the disposition or event**
5 **occurs. The Department of Revenue may establish by rule procedures**
6 **for reporting the additional tax due, consistent with ORS chapter 305.**

7 “[(c)] (f) Prior to the transfer of property under this section, the executor
8 shall notify the transferee of the potential for tax consequences to the
9 transferee if the transferee fails to meet the conditions of paragraph (a) of
10 this subsection. The transferee’s written acknowledgment of this notice shall
11 be attached to the [*inheritance*] **estate tax return.**

12 “[8) *The department shall adopt rules consistent with those adopted under*
13 *the Internal Revenue Code to administer this section.*]

14 “(10) **The executor shall identify property for which a credit under**
15 **this section is claimed, by asset, on a form prescribed by the depart-**
16 **ment and filed with the estate tax return. Transferees of property for**
17 **which a credit under this section has been claimed shall file a report**
18 **with the department on a form prescribed by the department. This**
19 **report shall be filed annually until the requirements of subsection**
20 **(9)(a) of this section are met and shall require tracking of each asset**
21 **for which the credit has been claimed, with confirmation that each**
22 **asset falls into one of the following categories:**

23 “(a) **The asset is still used in the operation of a farm business,**
24 **forestry business or fishing business;**

25 “(b) **The asset has been replaced with property that meets the re-**
26 **quirements of subsection (9)(d) of this section; or**

28 **of this section, resulting in additional tax.**

30 “118.160. (1) Except as provided in subsection (2) of this section:

1 “(a) An inheritance tax return is not required with respect to the estates
2 of decedents [*dying*] **who die** on or after January 1, 1987, and before January
3 1, 2003, unless a federal estate tax return is required to be filed; [*and*]

4 “(b) An inheritance tax return is not required with respect to the estates
5 of decedents [*dying*] **who die** on or after:

6 “(A) January 1, 2003, and before January 1, 2004, unless the value of the
7 gross estate is \$700,000 or more;

8 “(B) January 1, 2004, and before January 1, 2005, unless the value of the
9 gross estate is \$850,000 or more;

10 “(C) January 1, 2005, and before January 1, 2006, unless the value of the
11 gross estate is \$950,000 or more; or

12 “(D) January 1, 2006, **and before January 1, 2012**, unless the value of the
13 gross estate is \$1 million or more[.]; **and**

14 **“(c) An estate tax return is not required with respect to the estates
15 of decedents who die on or after January 1, 2012, unless the value of
16 the gross estate is \$1 million or more.**

17 “(2) In every estate, whether or not subject to administration and whether
18 or not a federal estate tax return is required to be filed, the executor shall
19 at such times and in such manner as required by rules of the Department
20 of Revenue, file with the department a return in a form provided by the de-
21 partment setting forth a list and description of all transfers of property, in
22 trust or otherwise, made by the decedent in the lifetime of the decedent as
23 a division or distribution of the estate of the decedent [*made within the*
24 *three-year period ending on the date of death or intended to take effect at or*
25 *after death*] and any further data that the department requires to determine
26 [*inheritance*] **estate tax** under this chapter.

27 **“SECTION 9.** ORS 118.171 is amended to read:

28 “118.171. The provisions of ORS chapter 305 as to the audit and exam-
29 ination of reports and returns, determination of deficiencies, assessments,
30 claims for refund, conferences and appeals to the Oregon Tax Court, and the

1 procedures relating thereto, shall apply to the determination of
2 [*inheritance*] estate taxes under this chapter, except where the context re-
3 quires otherwise.

4 **“SECTION 10.** ORS 118.225 is amended to read:

5 “118.225. (1) Upon application of the executor and the securing of all
6 taxes that are payable by bond, deposit or other good collateral acceptable
7 to the Department of Revenue, the department may extend the time for pay-
8 ment of any part of the amount imposed by ORS 118.005 to 118.840.

9 “(2) The extension under this section shall be for a period not in excess
10 of 14 years from the date prescribed by ORS [*118.220*] **118.100** for payment
11 of the tax.

12 “(3) Under rules prescribed by the department, the department may extend
13 the time for the payment of any deficiency of a tax imposed by ORS 118.005
14 to 118.840 for a reasonable period not to exceed four years from the date

17 “118.260. (1) If no return has been filed as required by this chapter, there
18 shall be added to the amount of tax required to be shown on the return a

21 months after the due date, there shall be added to the amount of tax required
22 to be shown as tax on the return a failure to file penalty of 20 percent of

11 "(d) All disbursements made during the period covered by the account.
12 Vouchers for disbursements must accompany the account, unless otherwise
13 provided by order or rule of the court, or unless the personal representative
14 is a trust company that has complied with ORS 709.030, but that personal
15 representative shall:

16 "(A) Maintain the vouchers for a period of not less than one year fol-
17 lowing the date on which the order approving the final account is entered;

18 "(B) Permit interested persons to inspect the vouchers and receive copies
19 thereof at their own expense at the place of business of the personal repre-
20 sentative during the personal representative's normal business hours at any
21 time prior to the end of the one-year period following the date on which the
22 order approving the final account is entered; and

23 "(C) Include in each annual account and in the final account a statement
24 that the vouchers are not filed with the account but are maintained by the
25 personal representative and may be inspected and copied as provided in
26 subparagraph (B) of this paragraph.

27 "(e) The money and property of the estate on hand.

28 "(f) Such other information as the personal representative considers nec-
29 essary to show the condition of the affairs of the estate or as the court may
30 require.

1 “(g) A declaration under penalty of perjury in the form required by ORCP
2 1 E.

3 “(3) When the estate is ready for final settlement and distribution, the
4 account must also include:

5 “(a) A statement that all Oregon income **taxes**, inheritance **or estate**
6 **taxes** and personal property taxes, if any, have been paid, or if not so paid,
7 that payment of those taxes has been secured by bond, deposit or otherwise,
8 and that all required tax returns have been filed.

9 “(b) A petition for a judgment authorizing the personal representative to
10 distribute the estate to the persons and in the portions specified therein.

11 “(4) If the distributees consent thereto in writing and all creditors of the
12 estate have been paid in full other than creditors owed administrative ex-
13 penses that require court approval, the personal representative, in lieu of the
14 final account otherwise required by this section, may file a statement that
15 includes the following:

16 “(a) The period of time covered by the statement.

17 “(b) A statement that all creditors have been paid in full other than
18 creditors owed administrative expenses that require court approval.

19 “(c) The statement and petition referred to in subsection (3) of this sec-
20 tion.

21 “(d) A declaration under penalty of perjury in the form required by ORCP
22 1 E.

23 “(5) Notice of time for filing objections to the statement described in
24 subsection (4) of this section is not required.

25 “(6) The Chief Justice of the Supreme Court may by rule specify the form
26 and contents of accounts that must be filed by a personal representative.

27 “**SECTION 20.** ORS 116.173 is amended to read:

28 “116.173. (1) Upon application to the court a personal representative is
29 entitled to receive compensation for services as provided in this section. If
30 there is more than one personal representative acting concurrently, the

1 compensation shall not be increased, but may be divided among them as they
2 agree or as the court may order. The compensation is a commission upon the
3 whole estate, as follows:

4 “(a) Upon the property subject to the jurisdiction of the court, including
5 income and realized gains:

6 “(A) Seven percent of any sum not exceeding \$1,000.

7 “(B) Four percent of all above \$1,000 and not exceeding \$10,000.

8 “(C) Three percent of all above \$10,000 and not exceeding \$50,000.

9 “(D) Two percent of all above \$50,000.

10 “(b) One percent of the property, exclusive of life insurance proceeds, not
11 subject to the jurisdiction of the court but reportable for Oregon inheritance
12 **or estate** tax or federal estate tax purposes.

13 “(2) In all cases, further compensation as is just and reasonable may be
14 allowed by the court for any extraordinary and unusual services not ordi-
15 narily required of a personal representative in the performance of duties as
16 a personal representative.

17 “(3) When a decedent by will has made special provision for the compen-
18 sation of a personal representative, the personal representative is not enti-
19 tled to any other compensation for services unless prior to appointment the
20 personal representative signs and files with the clerk of the court a written
21 renunciation of the compensation provided by the will.

22 **“SECTION 21.** ORS 116.303 is amended to read:

23 “116.303. As used in ORS 116.303 to 116.383:

24 “(1) ‘Estate’ means the gross estate of a decedent as determined for the
25 purpose of federal estate tax and the [*inheritance*] **estate** tax payable to this
26 state under ORS 118.005 to 118.840.

27 “(2) ‘Person’ means any individual, partnership, association, joint stock
28 company, corporation, government, political subdivision, governmental
29 agency or local governmental agency.

30 “(3) ‘Person interested in the estate’ means any person entitled to receive,

1 or who has received, from a decedent or by reason of the death of a decedent
2 any property or interest therein included in the decedent's estate. It includes
3 a personal representative, guardian, conservator or trustee.

4 “(4) ‘State’ means any state, territory or possession of the United States,
5 the District of Columbia or the Commonwealth of Puerto Rico.

6 “(5) ‘Tax’ means the federal estate tax and the [*inheritance*] **estate** tax
7 payable to this state under ORS 118.005 to 118.840, and interest and penalties
8 imposed in addition to the tax.

9 **“SECTION 22.** ORS 116.343 is amended to read:

10 “116.343. (1) In making an apportionment, allowances shall be made for
11 any exemptions granted, any classification made of persons interested in the
12 estate and any deductions and credits allowed by the law imposing the tax.

13 “(2) Any exemption or deduction allowed by reason of the relationship of
14 any person to the decedent or by reason of the purpose of the gift inures to
15 the benefit of the person bearing that relationship or receiving the gift, ex-
16 cept that when an interest is subject to a prior present interest that is not
17 allowable as a deduction, the tax apportionable against the present interest
18 shall be paid from principal.

19 “(3) Any deduction for property previously taxed and any credit for gift
20 taxes or [*death*] **estate** taxes of a foreign country paid by the decedent or
21 the estate of the decedent inures to the proportionate benefit of all persons
22 liable to apportionment.

23 “(4) Any credit for inheritance, succession or estate taxes or taxes in the
24 nature thereof in respect to property or interests includable in the estate
25 inures to the benefit of the persons or interests chargeable with the payment
26 thereof to the extent that, or in proportion as, the credit reduces the tax.

27 “(5) To the extent that property passing to or in trust for a surviving
28 spouse or any charitable, public or similar gift or bequest does not constitute
29 an allowable deduction for purposes of the tax solely by reason of an
30 inheritance tax or other death tax imposed upon and deductible from the

1 property, the property shall not be included in the computation provided for
2 in ORS 116.313, and to that extent no apportionment shall be made against
3 the property. This subsection does not apply to any case in which the result
4 will be to deprive the estate of a deduction otherwise allowable under section
5 2053 (d) of the Internal Revenue Code (26 U.S.C. 2053 (d)) relating to de-
6 duction for state [*death*] **estate** taxes on transfers for public, charitable or
7 religious uses.

8 **“SECTION 23.** ORS 129.250 is amended to read:

9 “129.250. After a decedent dies, in the case of an estate, or after an income
10 interest in a trust ends, the following rules apply:

11 “(1) A fiduciary of an estate or of a terminating income interest shall
12 determine the amount of net income and net principal receipts received from
13 property specifically given to a beneficiary under the rules in ORS 129.270
14 to 129.425 that apply to trustees and the rules in subsection (5) of this sec-
15 tion. The fiduciary shall distribute the net income and net principal receipts
16 to the beneficiary who is to receive the specific property.

17 “(2) A fiduciary shall determine the remaining net income of a decedent’s
18 estate or a terminating income interest under the rules in ORS 129.270 to
19 129.425 that apply to trustees and by:

20 “(a) Including in net income all income from property used to discharge
21 liabilities;

22 “(b) Paying from income or principal, in the fiduciary’s discretion, fees
23 of attorneys, accountants and fiduciaries, court costs and other expenses of
24 administration and interest on [*death*] **estate** taxes, but the fiduciary may
25 pay those expenses from income of property passing to a trust for which the
26 fiduciary claims an estate tax marital or charitable deduction only to the
27 extent that the payment of those expenses from income will not cause the
28 reduction or loss of the deduction; and

29 “(c) Paying from principal all other disbursements made or incurred in
30 connection with the settlement of a decedent’s estate or the winding up of

1 a terminating income interest, including debts, funeral expenses, disposition
2 of remains, family allowances, and [death] **estate** taxes and related penalties
3 that are apportioned to the estate or terminating income interest by the will,
4 the terms of the trust or applicable law.

5 “(3) A fiduciary shall distribute to a beneficiary who receives a pecuniary
6 amount outright the interest or any other amount provided by the will, the
7 terms of the trust or applicable law from net income determined under sub-
8 section (2) of this section or from principal to the extent that net income is
9 insufficient. If a beneficiary is to receive a pecuniary amount outright from
10 a trust after an income interest ends and no interest or other amount is
11 provided for by the terms of the trust or applicable law, the fiduciary shall
12 distribute the interest or other amount to which the beneficiary would be
13 entitled under applicable law if the pecuniary amount were required to be
14 paid under a will.

15 “(4) A fiduciary shall distribute the net income remaining after distrib-
16 utions required by subsection (3) of this section in the manner described in
17 ORS 129.255 to all other beneficiaries, including a beneficiary who receives
18 a pecuniary amount in trust, even if the beneficiary holds an unqualified
19 power to withdraw assets from the trust or other presently exercisable gen-
20 eral power of appointment over the trust.

21 “(5) A fiduciary may not reduce principal or income receipts from prop-
22 erty described in subsection (1) of this section because of a payment de-
23 scribed in ORS 129.400 or 129.405 to the extent that the will, the terms of the
24 trust or applicable law requires the fiduciary to make the payment from as-
25 sets other than the property or to the extent that the fiduciary recovers or
26 expects to recover the payment from a third party. The net income and
27 principal receipts from the property are determined by including all of the
28 amounts the fiduciary receives or pays with respect to the property, whether
29 those amounts accrued or became due before, on or after the date of a
30 decedent's death or an income interest's terminating event, and by making

1 a reasonable provision for amounts that the fiduciary believes the estate or
2 terminating income interest may become obligated to pay after the property
3 is distributed.

4 **“SECTION 24.** ORS 305.490 is amended to read:

5 “305.490. (1) Plaintiffs or petitioners filing a complaint or petition in the
6 tax court shall pay a filing fee at the time of filing for each complaint or
7 petition as follows:

8 “(a) For a complaint or petition in the magistrate division, \$25.

9 “(b) For a complaint or petition in the regular division, \$50.

10 “(c) If a complaint or petition is specially designated under ORS 305.501
11 for hearing in the regular division, a fee of \$50.

12 “(2) Neither the State of Oregon, nor any county, school district, munic-
13 ipal corporation or other public corporation therein, nor any officer of any
14 such public political division or corporation, appearing in the representative
15 capacity of the officer of any public political division or corporation, shall
16 be required to pay the fee prescribed under this section. The party entitled
17 to costs and disbursements on such appeal shall recover from the opponent
18 of the party the amount so paid upon order of the court, as in equity suits
19 in the circuit court.

20 “(3)(a) If, in any proceeding before the tax court judge involving taxes
21 upon or measured by net income in which an individual taxpayer is a party,
22 or involving inheritance **or estate** taxes, the court grants a refund claimed
23 by the executor or taxpayer or denies in part or wholly an additional as-
24 sessment of taxes claimed by the Department of Revenue to be due from the
25 estate or taxpayer, the court may allow the taxpayer, in addition to costs
26 and disbursements, the following:

27 “(A) Reasonable attorney fees for the proceeding under this subsection
28 and for the prior proceeding in the matter, if any, before the magistrate; and

29 “(B) Reasonable expenses as determined by the court. Expenses include
30 accountant fees and fees of other experts incurred by the executor or indi-

1 vidual taxpayer in preparing for and conducting the proceeding before the
2 tax court judge and the prior proceeding in the matter, if any, before the
3 magistrate.

4 “(b) Payment of attorney fees or reasonable expenses under this sub-
5 section shall be made by the Department of Revenue in the manner provided
6 by ORS 305.790.

7 “(4)(a) If, in any proceeding before the tax court judge involving ad
8 valorem property taxation, exemptions, special assessments or omitted prop-
9 erty, the court finds in favor of the taxpayer, the court may allow the tax-
10 payer, in addition to costs and disbursements, the following:

11 “(A) Reasonable attorney fees for the proceeding under this subsection
12 and for the prior proceeding in the matter, if any, before the magistrate; and

13 “(B) Reasonable expenses as determined by the court. Expenses include
14 fees of experts incurred by the individual taxpayer in preparing for and
15 conducting the proceeding before the tax court judge and the prior proceed-
16 ing in the matter, if any, before the magistrate.

17 “(b) Payment of attorney fees or reasonable expenses under this sub-
18 section shall be made by the Department of Revenue in the manner provided
19 by ORS 305.790.

20 “(5) All fees and other moneys received or collected by the clerk by virtue
21 of the office of the clerk shall be paid over to the State Treasurer and shall
22 be held by the clerk in the General Fund as miscellaneous receipts.

23 “**SECTION 25.** ORS 314.415 is amended to read:

24 “314.415. (1) If the Department of Revenue determines pursuant to ORS
25 305.270 that the amount of the tax due is less than the amount theretofore
26 paid, the excess shall be refunded by the department with interest at the rate
27 established under ORS 305.220, for each month or fraction of a month during
28 a period beginning 45 days after the due date of the return or the date the
29 tax was paid, **or, in the case of a return filed under ORS 118.100, the**
30 **date that the return is filed**, whichever is the later, to the time the refund

1 is made.

2 “(2)(a) The department may not allow or make a refund after three years
3 from the time the return was filed, or two years from the time the tax (or
4 a portion of the tax) was paid, whichever period expires later, unless before
5 the expiration of this period a claim for refund is filed by the taxpayer in
6 compliance with ORS 305.270. In any case, if the original return is not filed
7 within three years of the due date, excluding extensions, of the return, the
8 department may allow or make a refund only of amounts paid within two
9 years from the date of the filing of the claim for refund. If a refund is dis-
10 allowed for the tax year during which excess tax was paid for any reason set
11 forth in this subsection, the department may not allow the excess as a credit
12 against any tax occurring on a return filed for a subsequent year.

13 “(b) The department may not make a refund if the tax owed after offsets
14 for all amounts owed the state, or a county pursuant to a judgment obtained
15 under ORS 169.151, is less than \$1.

16 “(c) If a taxpayer would qualify under section 6511(h) of the Internal
17 Revenue Code for a suspension of the running of the periods specified for
18 filing a claim for refund of federal income tax, the period specified in para-
19 graph (a) of this subsection shall also be suspended.

20 “(d) The department may not pay an employee interest on a refund of a
21 tax withheld by an employer if the interest would be for any period prior to
22 the time the employee files a personal income tax return for the tax year
23 involved or for any period prior to the day that is 45 days after the date
24 when the employee’s annual return for that year was filed or was due,
25 whichever is later.

26 “(e) The department may not pay interest on a refund of estimated tax
27 paid under ORS 314.505 to 314.525 or 316.557 to 316.589 if the interest would
28 be for any period prior to the time the taxpayer files a tax return for the tax
29 year involved or for any period prior to the day that is 45 days after the date
30 when the tax return for that year was filed or was due, whichever is later.

1 “(f) The amount of the refund, exclusive of interest on the refund, may
2 not exceed the portion of the tax paid during the period preceding the filing
3 of the claim or, if no claim is filed, then during the period preceding the
4 allowance of the refund during which a claim might have been filed. Where
5 there has been an overpayment of any tax imposed, the amount of the over-
6 payment and interest on the overpayment shall be credited against any tax,
7 penalty or interest then due from the taxpayer, and only the balance shall
8 be refunded.

9 “(g) Except as provided in ORS 305.265 (12), if, pursuant to a notice of
10 deficiency or assessment, the taxpayer pays the amount specified in the no-
11 tice, or any part thereof, and if, upon appeal, the Oregon Tax Court or the
12 Oregon Supreme Court orders that all or any part of the deficiency amount
13 specified in the notice and paid by the taxpayer be refunded, the amount so
14 ordered to be refunded shall bear interest at the rate established for refunds
15 in ORS 305.220. Interest shall be computed from the date of payment to the
16 department. Nothing in this subsection shall require that interest be paid
17 upon any amount for any period for which interest upon the same amount
18 for the same period is required to be paid under ORS 305.419.

19 “(3)(a) Notwithstanding any provision to the contrary in ORS 305.265 or
20 305.270 or subsection (1) or (2) of this section, if, prior to the expiration of
21 the period prescribed in subsection (2) of this section, the department and
22 the taxpayer consent in writing to the refund of tax after the expiration of
23 the period prescribed:

24 “(A) The department shall make the refund prior to the expiration of the
25 period agreed upon; and

26 “(B) The department may not make or allow a refund after the expiration
27 of the period agreed upon unless a claim for refund is filed by the taxpayer
28 before the expiration of the period agreed upon in compliance with the
29 manner prescribed by the department. The period so agreed upon may be
30 extended by subsequent agreements in writing made before the expiration of

1 the period previously agreed upon.

2 “(b) The department may consent to extend the period during which a
3 refund may be made only if the taxpayer has consented to the assessment
4 of additional tax, if additional taxes are determined upon audit, after the
5 expiration of the applicable period prescribed in ORS 314.410 (1) to (3).

6 “(4)(a) If the claim for credit or refund relates to an overpayment on ac-
7 count of the deductibility by the taxpayer, or by a partnership, of the
8 worthlessness of a share of stock in a corporation, of the right to subscribe
9 for or to receive a share of stock in a corporation, or of a debt, in lieu of
10 the three-year period of limitation prescribed in subsection (2) of this section,
11 the period shall be seven years from the date prescribed by law for the filing
12 of the return for the year with respect to which the claim is made.

13 “(b) If the claim described in paragraph (a) of this subsection is made
14 after the expiration of the three-year period prescribed in subsection (2) of
15 this section, the department may not allow interest with respect to any
16 credit or refund determined to be due upon the claim for the period begin-
17 ning at the close of the three-year period prescribed in subsection (2) of this
18 section and ending at the expiration of six months after the date on which
19 the claim is filed.

20 “(5)(a) If the claim for credit or refund relates to an overpayment attrib-
21 utable to a net operating loss carryback or a net capital loss carryback, in
22 lieu of the three-year period of limitation prescribed in subsection (2) of this
23 section, the period shall be the period that ends three years after the time
24 prescribed by law for filing the return (including extensions) for the taxable
25 year of the net operating loss or net capital loss that results in such
26 carryback. In the case of such a claim, the amount of the credit or refund
27 may exceed the portion of the tax paid within the period provided in sub-
28 section (1), (2) or (3) of this section, whichever is applicable, to the extent
29 of the amount of the overpayment attributable to the carryback. If the al-
30 lowance of a credit or refund of an overpayment of tax attributable to a net

1 operating loss carryback or a net capital loss carryback is otherwise pre-
2 vented by the operation of any law or rule of law other than ORS 305.150,
3 relating to closing agreements, the credit or refund may be allowed or made
4 if the claim for credit or refund is filed within the period provided in this
5 subsection. To the extent that the carryback was not an issue in any pro-
6 ceeding in which the determination of a court, including the Oregon Tax
7 Court, has become final, the claimed credit or refund applicable to that
8 carryback may be allowed or made under this subsection.

9 “(b) For purposes of subsection (1) or (2) of this section, if any overpay-
10 ment of tax results from a carryback of a net operating loss or net capital
11 loss, the overpayment shall be deemed not to have been made prior to the
12 later of:

13 “(A) The due date of the return for the taxable year in which such net
14 operating loss or net capital loss arises;

15 “(B) The date the return for the year in which the net operating loss or
16 net capital loss arises is filed; or

17 “(C) The date of filing of the return for the year to which the net oper-
18 ating loss or net capital loss is carried back.

19 “(6) Notwithstanding any provision to the contrary in ORS 305.265 or
20 305.270 or this section, if the taxpayer has agreed with the United States
21 Commissioner of Internal Revenue for an extension, or a renewal of an ex-
22 tension, of the period for proposing and assessing deficiencies in federal in-
23 come tax for any year, the period within which a claim for credit or refund
24 may be filed or credit or refund allowed or made if no claim is filed shall
25 be the period provided within subsections (1) to (5) of this section or six
26 months after the date of the expiration of the agreed period for assessing
27 deficiency in federal income tax, whichever period expires later.

28 “(7) If a joint return is filed, the department may make separate refunds
29 at the request of either spouse. The separate refunds shall bear the same
30 proportion to the total refund as the adjusted gross income of each spouse

1 bears to the adjusted gross income of both spouses, or as otherwise deter-
2 mined by the department.

3 “(8) If a taxpayer entitled to a refund under subsection (1) of this section
4 dies, the department may issue a draft for payment of such refund under the
5 terms and conditions set out in ORS 293.490 to 293.500 exercising the same
6 powers and subject to the same restrictions pursuant to which the State
7 Treasurer is authorized to pay the amounts of warrants, checks or orders
8 under those statutes.

9 **“SECTION 26. Sections 27 and 28 of this 2011 Act are added to and
10 made a part of ORS 118.005 to 118.840.**

11 **“SECTION 27. When the Department of Revenue and the taxing
12 official of one or more other states each claims that the state of that
13 official respectively was the domicile of the decedent for the purpose
14 of estate taxes or claims taxing authority over the same property in
15 an estate, the department may negotiate, and enter into an agree-
16 ment, with the taxing official of the other state and with the executor
17 to accept payment of estate tax, together with any interest and pen-
18 alties. The department may enter into binding arbitration or into a
19 compromise agreement with respect to disputed liability for estate
20 taxes with each taxing official and with the executor.**

21 **“SECTION 28. (1) At any time within three years after the date that
22 an estate tax return is filed, the Department of Revenue may give
23 notice of deficiency as prescribed in ORS 305.265.**

24 **“(2) If the department finds that the value of the gross estate has
25 been undervalued on the estate tax return by an amount greater than
26 25 percent, notice of deficiency may given at any time within five years
27 after the date that the return is filed.**

28 **“(3) The limitations to the giving of notice of a deficiency provided
29 in this section do not apply to a deficiency resulting from a false or
30 fraudulent estate tax return or in a case where no return has been**

1 filed.

2 **"SECTION 29. ORS 118.009, 118.019, 118.220, 118.240, 118.470, 118.810,**
3 **118.820, 118.830, 118.840, 118.855, 118.860, 118.865, 118.870, 118.875 and**
4 **118.880 and section 3, chapter 806, Oregon Laws 2003, are repealed.**

5 **"SECTION 30. Sections 27 and 28 of this 2011 Act, the amendments**
6 **to ORS 105.645, 111.025, 114.075, 116.083, 116.173, 116.303, 116.343, 118.005,**
7 **118.007, 118.010, 118.013, 118.016, 118.100, 118.140, 118.160, 118.171, 118.225,**
8 **118.260, 118.280, 118.300, 118.350, 118.525, 129.250, 305.490 and 314.415 by**
9 **sections 1 to 25 of this 2011 Act and the repeal of ORS 118.009, 118.019,**
10 **118.220, 118.240, 118.470, 118.810, 118.820, 118.830, 118.840, 118.855, 118.860,**
11 **118.865, 118.870, 118.875 and 118.880 and section 3, chapter 806, Oregon**

14 **"SECTION 31. This 2011 Act takes effect on the 91st day after the**
