- 4 118.019, 118.220, 118.240, 118.470, 118.810, 118.820, 118.830, 118.840, 118.855,
- 5 118.860, 118.865, 118.870, 118.875 and 118.880 and section 3, chapter 806,
- 6 Oregon Laws 2003; and prescribing an effective date.”.

- 8 **“SECTION 1.** ORS 118.005 is amended to read:
- 9 “118.005. As used in ORS 118.005 to 118.840, unless the context requires
- 10 otherwise:
- 11 “(1) ‘Beneficiary’ means the recipient of a beneficial interest in property
- 12 or the income therefrom transferred in a manner taxable under ORS 118.005
- 13 to 118.840.
- 14 “(2) ‘Department’ means the Department of Revenue.
- 15 “(3) ‘Director’ means the Director of the Department of Revenue.
- 16 “(4) ‘Executor’ means the executor, administrator, personal representative,
- 17 fiduciary, or custodian of property of the decedent, or, if there is no executor,
- 18 administrator, fiduciary or custodian appointed, qualified and acting, then
- 19 any person who is in the actual or constructive possession of any property
- 20 includable in the estate of the decedent for [*inheritance*] **estate** tax purposes
- 21 whether or not such estate is subject to administration.
- 22 “(5) ‘Federal taxable estate’ means the taxable estate as determined

1 **under subtitle B, chapter 11 of the Internal Revenue Code.**

2 “[5] (6) ‘Gross estate’ has the meaning given that term in section 2031  
3 of the Internal Revenue Code.

4 “[6] ‘Nonresident decedent’ means an individual who is domiciled outside  
5 of Oregon at the time of death.]

6 **“(7) ‘Oregon taxable estate’ means the federal taxable estate with  
7 the adjustments provided by ORS 118.010 (3).**

8 “[7] (8) ‘Passes’ includes any case where for the purposes of ORS 118.005  
9 to 118.840 a taxable transfer takes place or is deemed to take place.

10 “[8] (9) ‘Personal representative’ means personal representative as de-  
11 fined in ORS 111.005.

12 “[9] ‘Resident decedent’ means an individual who is domiciled in Oregon  
13 at the time of death.]

14 “[10] ‘Transfer’ or ‘transfer of property’ means a transfer that is subject  
15 to the federal estate tax imposed under subtitle B, chapter 11 of the Internal  
16 Revenue Code.]

17 **“SECTION 2.** ORS 118.007 is amended to read:

18 “118.007. Any term used in ORS 118.005 to 118.840 has the same meaning  
19 as when used in a comparable context in the laws of the federal Internal  
20 Revenue Code relating to federal estate taxes, unless a different meaning is  
21 clearly required or the term is specifically defined in ORS 118.005 to 118.840.  
22 Any reference in ORS 118.005 to 118.840 to the Internal Revenue Code means  
23 the federal Internal Revenue Code as amended and in effect on December 31,  
24 [2000] **2010**, except where the Legislative Assembly has specifically provided  
25 otherwise.

26 **“SECTION 3.** ORS 118.010 is amended to read:

27 “118.010. [(1) A tax is imposed upon a transfer of property and any interest  
28 therein, within the jurisdiction of the state, whether belonging to the inhabit-  
29 ants of this state or not, which passes to or vests in any person or persons, or  
30 any body or bodies politic or corporate, in trust or otherwise, or by reason

1 *whereof any person or body politic or corporate shall become beneficially enti-*  
2 *tled, in possession or expectation, to any property or interest therein or income*  
3 *thereof.]*

4 *“(2) The tax imposed under this section shall equal the maximum amount*  
5 *of the state death tax credit allowable against the federal estate tax under*  
6 *section 2011 of the Internal Revenue Code.]*

7 **“(1) As used in this section:**

8 **“(a) ‘Nonresident decedent’ means an individual who is domiciled**  
9 **outside of Oregon on the date the individual dies.**

10 **“(b) ‘Resident decedent’ means an individual who is domiciled in**  
11 **Oregon on the date the individual dies.**

12 **“(2) A tax is imposed upon a transfer of the property of each:**

13 **“(a) Resident decedent; and**

14 **“(b) Nonresident decedent whose estate includes any interest in:**

15 **“(A) Real property located in Oregon; or**

16 **“(B) Tangible personal property located in Oregon.**

17 **“(3) The Oregon taxable estate to be used for purposes of computing**  
18 **the tax imposed under this section shall be the federal taxable estate:**

19 **“(a) Increased by:**

20 **“(A) The deduction for state estate, inheritance, legacy or suc-**  
21 **cession taxes allowable under section 2058 of the Internal Revenue**  
22 **Code; and**

23 **“(B) If the decedent is a surviving spouse owning the property at**  
24 **death, the value of the following property unless included in the fed-**  
25 **eral taxable estate:**

26 **“(i) Property for which a deduction for Oregon special marital**  
27 **property under ORS 118.016 was previously allowed; or**

28 **“(ii) Property for which a separate Oregon election under section**  
29 **2056 or 2056A of the Internal Revenue Code was previously allowed; and**

30 **“(b) Reduced by:**

1       “(A) The value on the date of the decedent’s death of all Oregon  
2 special marital property under ORS 118.013;

3       “(B) \$1.5 million; and

4       “(C) Any other applicable exclusions or deductions.

5       “(4) The tax imposed under this section shall be calculated by ap-  
6 plying the rates in the following table. If the Oregon taxable estate is  
7 at least the amount in column 1, but less than the amount in column  
8 2, the tax is the amount in column 3, increased by the excess above  
9 the amount in column 1 multiplied by the percentage in column 4:

23       “[(3)] (5) In the case of a resident decedent owning [*property outside of the*  
24 *jurisdiction of this state at the time of death*], on the date of the decedent’s  
25 death, real property located outside Oregon or tangible personal prop-  
26 erty located outside Oregon, the tax imposed under this section shall be  
27 the amount determined under subsection [(2)] (4) of this section multiplied  
28 by a ratio. The numerator of the ratio shall be the sum of the [*appraised*]  
29 value of the decedent’s real property located in Oregon, tangible personal  
30 property located in Oregon and intangible personal property [*located both in*

1 *and outside of Oregon*]. **The numerator may not include any intangible**  
2 **personal property subject to a tax imposed, as a result of the death**  
3 **of the decedent, by another state or country.** The denominator of the  
4 ratio shall be the total [*appraised*] value of the decedent's gross estate.

5 “[*(4)(a)*] **(6)** In the case of a nonresident decedent owning [*property within*  
6 *the jurisdiction of this state at the time of death*], **on the date of the**  
7 **decedent's death, real property located in Oregon or tangible personal**  
8 **property located in Oregon,** the tax imposed under this section shall be the  
9 amount determined under subsection [*(2)*] **(4)** of this section multiplied by a  
10 ratio. The numerator of the ratio shall be the sum of the [*appraised*] value  
11 of the decedent's real property located in Oregon[,] **and** tangible personal  
12 property located in Oregon [*and intangible personal property located in*  
13 *Oregon*]. The denominator shall be the total [*appraised*] value of the  
14 decedent's gross estate.

15 “[*(b)*] *Intangible personal property of a nonresident decedent shall not be*  
16 *included in the numerator of the ratio used to determine the tax under this*  
17 *subsection if a similar exemption is made by the laws of the state or country*  
18 *of the decedent's residence in favor of residents of this state.*]

19 “[*(5)*] *In the case of decedents dying before January 1, 2003, if federal estate*  
20 *tax credits other than the state death tax credit result in no federal estate tax,*  
21 *no tax shall be imposed under this section.*]

22 “[*(6)*] **(7)** Payment, in whole or in part, of [*inheritance and*] estate taxes  
23 from funds of an estate or trust on any benefit subject to tax under ORS  
24 118.005 to 118.840 is not to be considered [*as*] a further taxable benefit, when  
25 such payment is directed by **the** decedent's will or by a trust agreement.

26 “[*(7)*] **(8)(a)** If the federal taxable estate is determined by making an  
27 election under section [*2032 or 2056*] **2031(c), 2032, 2032A, 2056 or 2056A** of  
28 the Internal Revenue Code or another provision of the Internal Revenue  
29 Code, or if a federal estate tax return is not required under the Internal  
30 Revenue Code, [*the Department of Revenue may adopt rules providing for a*

1 *separate election for state inheritance tax purposes.] an executor may make*  
2 **separate elections for state estate tax purposes under that same pro-**  
3 **vision.**

4 **“(b) An executor may make elections under ORS 118.013 and 118.140**  
5 **and section 2056 of the Internal Revenue Code for state estate tax**  
6 **purposes.**

7 **“(c) Elections described in this subsection are irrevocable.**

8 **“SECTION 4.** ORS 118.013 is amended to read:

9 *“118.013. [(1) For purposes of computing the tax imposed under ORS*  
10 *118.010, the taxable estate to be used for computing the maximum amount of*  
11 *the state death tax credit allowable under section 2011 of the Internal Revenue*  
12 *Code shall be the taxable estate determined for federal estate tax purposes,*  
13 *reduced by the value on the date of death of the decedent of all Oregon special*  
14 *marital property in the estate.]*

15 **(1) As used in this section and ORS 118.016, ‘permissible**  
16 **distributee’ has the meaning given that term in ORS 130.010.**

17 **“(2) Oregon special marital property consists of any trust or other prop-**  
18 **erty interest, or a portion of a trust or property interest:**

19 **“(a) In which principal or income may be accumulated or distributed to**  
20 **or for the benefit of only the surviving spouse of the decedent during the**  
21 **lifetime of the surviving spouse;**

22 **“(b) In which a person may not transfer or exercise a power to appoint**  
23 **any part of the trust or other property interest to a person other than the**  
24 **surviving spouse during the lifetime of the surviving spouse; and**

25 **“(c) For which the executor of the estate of the decedent has made the**  
26 **election described in ORS 118.016 (1).**

27 **“(3) If a trust or other property interest would qualify as Oregon special**  
28 **marital property under subsection (2) of this section except that the trust**  
29 **or other property interest allows principal or income to be distributed to**  
30 **other persons in addition to the surviving spouse, the executor may elect to**

1 set aside a share of the trust or other property interest as a separate share  
2 of the trust or property interest or as a separate trust, which shall qualify  
3 as Oregon special marital property if:

4 “(a) The executor makes the election described in ORS 118.016 (1);

5 “(b) Each [*beneficiary who is living at the time the election is made and*  
6 *who may be entitled to a distribution from the share during the lifetime of the*  
7 *surviving spouse*] **permissible distributee** makes the election described in  
8 ORS 118.016 (2);

9 “(c) The surviving spouse makes the election described in ORS 118.016 (2);  
10 and

11 “(d) All [*elections*] **statements of election** are attached to the  
12 [*inheritance*] **estate** tax return filed with respect to the estate of the  
13 decedent, or are filed or maintained as records as otherwise prescribed by the  
14 Department of Revenue by rule.

15 “**SECTION 5.** ORS 118.016 is amended to read:

16 “118.016. (1) The executor of an estate containing property that the exec-  
17 utor seeks to qualify as Oregon special marital property under ORS 118.013  
18 shall make an election under this subsection in order for the property to be  
19 Oregon special marital property. The election shall be made:

20 “(a) By attaching a statement to the [*inheritance*] **estate** tax return for  
21 the estate of the decedent that identifies the trust or other property interest  
22 that constitutes Oregon special marital property and that affirms that the  
23 identified property meets the requirements of Oregon special marital prop-  
24 erty under ORS 118.013 and will be administered as required under ORS  
25 118.013; or

26 “(b) In such other manner as the Department of Revenue prescribes by  
27 rule.

28 “(2) For a trust or other property interest described in ORS 118.013 (3),  
29 in order for any portion of the trust or other property interest to be Oregon  
30 special marital property, in addition to the election of the executor described

1 in subsection (1) of this section, the surviving spouse and each [*beneficiary*  
2 *who is living at the time of the election and*] **permissible distributee** who  
3 may be eligible for a distribution from the trust or other property interest  
4 [*during the lifetime of the surviving spouse*] shall make an election and **pro-**  
5 **vide** written consent that is in substantially the following form:

7 **CONSENT TO ESTABLISHMENT OF**  
8 **OREGON SPECIAL MARITAL PROPERTY**

9

10 (a) **ELECTION TO BE SIGNED BY ALL [*BENEFICIARIES*] PERMISS-**  
11 **SIBLE DISTRIBUTEES EXCEPT THE SURVIVING SPOUSE:** Each of the  
12 undersigned acknowledge and consent to a portion of the \_\_\_\_\_  
13 (name of trust or other property interest) being set aside as a separate share  
14 or trust in order to qualify for the Oregon special marital property election  
15 in accordance with ORS 118.013, for the primary purpose of reducing or  
16 eliminating the Oregon [*inheritance*] **estate** tax due on the estate  
17 of \_\_\_\_\_ (name of decedent). The undersigned together with the  
18 surviving spouse constitute all of the persons living on the date of this  
19 election who may be entitled to a distribution during the lifetime of the  
20 surviving spouse from the \_\_\_\_\_ (name of trust or other property  
21 interest). Each of the undersigned, both on behalf of the undersigned and on  
22 behalf of the unborn lineal descendants of the undersigned, irrevocably  
23 agrees to release all rights to [*distributions from*] **any current interest in**  
24 the Oregon special marital property during the lifetime of the surviving  
25 spouse. Each of the undersigned agrees that all other provisions of the  
26 \_\_\_\_\_ (name of trust or other property interest) shall remain in effect  
27 and that, upon the death of the surviving spouse, any remaining Oregon  
28 special marital property shall be distributed as otherwise provided in the  
29 trust or other property interest.

19 maining Oregon special marital property shall be distributed as otherwise  
20 provided in the trust or other property interest.

1       “(3) Elections made under this section are irrevocable.

2       “(4) The custodial parent or court appointed guardian of a [*minor benefi-*  
3 *ciary*] **permissible distributee who is a minor, or any person who is**  
4 **authorized under ORS 130.110**, may sign the election on behalf of the [*mi-*  
5 *nor beneficiary*] **permissible distributee** and the unborn lineal descendants  
6 of the [*minor beneficiary*] **permissible distributee**.

7       “**SECTION 6.** ORS 118.100 is amended to read:

8       “118.100. (1) The tax provided for in ORS 118.010 shall **take effect at and**  
9 **accrue upon the death of the decedent. A return shall be filed and the**  
10 **tax shall** be paid to the Department of Revenue on the date the federal es-  
11 tate tax is payable **or, if no federal estate tax return is required, no**  
12 **later than nine months following the date of death of the decedent.** If  
13 [*interest is paid on federal estate tax installments resulting in a reduction of*  
14 *the federal estate tax, and*] the department determines, pursuant to an  
15 amended return or refund claim, that the amount of tax imposed by ORS  
16 118.010 is less than the amount theretofore paid, the excess tax shall be re-  
17 funded by the department with interest at the rate established by ORS  
18 305.220 for each month or fraction thereof during a period beginning **45 days**  
19 **after the due date of the return or** on the date the amended return or  
20 refund claim is filed, **whichever is later, and ending at** [*to*] the time the  
21 refund is made.

22       “(2) If the amount of federal estate tax reported on a [*United States*]  
23 **federal** estate tax return is changed or corrected by the Internal Revenue  
24 Service or other competent authority, resulting in a change in the [*maximum*  
25 *state death tax credit allowable under the federal estate tax law*] **Oregon**  
26 **taxable estate**, the executor shall report the change or correction in federal  
27 estate tax to the department. If the federal change or correction results in  
28 a reduction of the [*allowable state death tax credit*] **Oregon taxable estate**,  
29 the report of the change or correction shall be treated by the department as  
30 a claim for refund pursuant to ORS 305.270 and, notwithstanding the limi-

1 tations of ORS 305.270, shall be deemed timely if filed with the department  
2 within two years after the federal correction was made. If the change or  
3 correction results in an increase in the [*state death tax credit allowable on*  
4 *the federal estate tax return*] **Oregon taxable estate**, the department may  
5 issue a notice of deficiency within two years after the federal change or  
6 correction was made or within two years after receiving a report of the fed-  
7 eral change or correction, whichever is the later. Any executor filing an  
8 amended federal estate tax return shall also file an amended return with the  
9 department within 90 days thereafter.

10 “(3)(a) In the case of an estate that contains property that is valued under  
11 section 2032A of the Internal Revenue Code for federal estate tax purposes  
12 (relating to the valuation of certain farm or other property) and that ceases  
13 to qualify for valuation under section 2032A, an additional tax under ORS  
14 118.005 to 118.840 shall be imposed[. *The additional tax shall equal the*  
15 *amount of any increase in the state death tax credit allowable under section*  
16 *2011 of the Internal Revenue Code that is*] **in the amount** attributable to the  
17 change in the value of the estate resulting from the imposition of additional  
18 federal estate tax under section 2032A.

19 “(b) The department shall be notified of the disqualification of the prop-  
20 erty from valuation under section 2032A in the same time and manner as the  
21 federal Internal Revenue Service is notified of the disqualification.

22 “(c) The period for assessment of the tax imposed under this subsection,  
23 including any penalty or interest, shall be two years from the date on which  
24 the department receives the notice described in paragraph (b) of this sub-  
25 section.

26 “(d) The other provisions of ORS 118.005 to 118.840 and ORS chapter 305  
27 shall apply to the additional tax imposed under this subsection in the same  
28 manner in which those provisions apply to the tax imposed under ORS  
29 118.010.

30 “(4) For purposes of this section, a change or correction of a [*United*

1 States] **federal** estate tax return is deemed to be made on the date of the  
2 federal audit report.

3 “(5) The executor shall, upon request of the department, supply a copy  
4 of the [United States] **federal** estate tax return which the executor has filed  
5 or may file with the federal government, or a copy of any federal agent’s  
6 report upon any audit or adjustment of the [United States] **federal** estate tax  
7 return.

8 “(6) **The executor shall explain, on the return, how the reported**  
9 **values were determined and attach copies of any appraisals.**

10 “**SECTION 7.** ORS 118.140 is amended to read:

11 “118.140. [(1) As used in this section, ‘natural resource property’ means real  
12 property as defined in ORS 307.010 that at the decedent’s death:]

13 “[a) Is in farm use, as defined in ORS 308A.056, or is used as one or more  
14 farm use homesites, as defined in ORS 308A.250, related to that real property;  
15 or]

16 “[b) Is used as forestland, as defined in ORS 321.201, or is used as one  
17 or more forestland homesites, as defined in ORS 308A.250, related to that real  
18 property, not to exceed 5,000 acres.]

19 “[(2)(a) A credit against the taxes otherwise due under ORS 118.005 to  
20 118.840 shall be allowed based upon the value of the following property:]

21 “[A) Natural resource property.]

22 “[B) If the decedent or a person described in subsection (3)(c) of this sec-  
23 tion was licensed under ORS chapter 508, property that is:]

24 “[i) Used in the conduct of a fishing business as defined in section  
25 1301(b)(4) of the Internal Revenue Code, including boats, gear, equipment,  
26 vessel licenses and permits and commercial fishing licenses and permits; or]

27 “[ii) Used to process and sell the catch of a commercial fishing business  
28 in fresh, canned or smoked form directly to consumers, including a restaurant  
29 with seating capacity of less than 15 seats at which catch from the fishing  
30 business is prepared and sold.]

1       “(C) Tangible and intangible personal property devoted to use as a farm  
2 or used for farm or forestry purposes, including:]

3       “[(i) Timber, trees and improvements;]

4       “[(ii) Crops, both growing and stored; and]

5       “[(iii) Forestry and farming equipment.]

6       “[(D) Working capital of a farm, natural resource-based business or fishing  
7 business owned by the decedent at the decedent’s death.]

8       “[(b) A taxpayer may:]

9       “[(A) Elect not to claim the credit allowed under this section;]

10       “[(B) Elect to claim less than the full amount of the credit allowed under  
11 this section; or]

12       “[(C) Elect to claim the credit only for the value of certain assets.]

13       “[(c) If the value of property for which the credit allowed under this section  
14 is claimed is at least the amount in column 1, but less than the amount in  
15 column 2, the credit is the amount in column 3, increased by the excess above  
16 the amount in column 1 multiplied by the percentage in column 4:]

17 “(1) As used in this section:

18 “(a) ‘Adjusted gross estate’ means the value of the gross estate re-  
19 duced by the sum of the amounts allowable under sections 2053 and  
20 2054 of the Internal Revenue Code.

21 “(b) ‘Family member’ means a member of the family, as defined in  
22 section 2032A of the Internal Revenue Code, of the decedent.

23 “(c) ‘Farm business’ means a business operated for the primary  
24 purpose of obtaining a profit in money by:

25 “(A) Raising, harvesting or selling fruit or crops;

26 “(B) Feeding, breeding, managing or selling livestock, poultry, fur-  
27 bearing animals or bees, or the produce thereof;

28 “(C) Dairying and selling dairy products;

29 “(D) Breeding, stabling or training equines;

30 “(E) Propagating, cultivating, maintaining or harvesting aquatic

1 species, birds or animal species to the extent allowed by the rules  
2 adopted by the State Fish and Wildlife Commission;

3 “(F) Raising nursery stock;

4 “(G) Practicing animal husbandry; or

5 “(H) Raising other agricultural or horticultural products.

6 “(d) ‘Farm use’ has the meaning given that term in ORS 308A.056.

7 “(e) ‘Fishing business’ has the meaning given that term in section  
8 1301(b)(4) of the Internal Revenue Code.

9 “(f) ‘Forestland’ has the meaning given that term in ORS 321.201.

10 “(g) ‘Forestry business’ means a business operated for the primary  
11 purpose of obtaining a profit in money by the planting, cultivating,  
12 caring for, preparing, harvesting or cutting of timber or trees for  
13 market.

14 “(h) ‘Homesite’ has the meaning given that term in ORS 308A.250.

15 “(i) ‘Natural resource property’ means the following property, if on  
16 the date of the decedent’s death the property is owned by the decedent  
17 and used in the operation of a farm business, forestry business or  
18 fishing business owned by the decedent:

19 “(A) Real property used as forestland or as forestland homesites,  
20 not to exceed 5,000 acres, or that is in farm use.

21 “(B) Timber or trees.

22 “(C) Crops, fruit or other horticultural products, both growing and  
23 stored.

24 “(D) Forestry business or farm business equipment.

25 “(E) Livestock, poultry, fur-bearing animals, bees, dairying ani-  
26 mals, equines, aquatic species, birds or other animal species, including  
27 stored products or by-products.

28 “(F) Nursery stock as defined in ORS 571.005.

29 “(G) Boats, gear, equipment, vessel licenses or permits, commercial  
30 fishing licenses or permits and other real or personal property used in

1 the operation of a fishing business.

2 “(H) Real or personal property used to process and sell the catch  
3 of a fishing business in fresh, canned or smoked form directly to con-  
4 sumers, including a restaurant with seating capacity of fewer than 15  
5 seats at which catch from the fishing business is prepared and sold.

6 “(I) An operating allowance.

7 “(J) Any other tangible and intangible personal property used in the  
8 operation of a farm business, forestry business or fishing business.

9 “(j) ‘Operating allowance’ means cash or a cash equivalent that is  
10 spent, maintained, used or available for the operation of a farm busi-  
11 ness, forestry business or fishing business and not spent or used for  
12 any other purpose.

13 “(k) ‘Qualified beneficiary’ has the meaning given that term in ORS  
14 130.010.

15 “(L) ‘Real property’ means real property, as defined in ORS 307.010,  
16 that is in this state.

17 “(2)(a) An estate shall be allowed a credit for the value of natural  
18 resource property claimed. Any operating allowance claimed under  
19 this section may not exceed the lesser of \$1.5 million or 20 percent of  
20 the total value of natural resource property claimed, not including the  
21 operating allowance.

22 “(b) The credit allowed under this section shall be computed by  
23 multiplying the tax that would be payable under this chapter absent  
24 the credit by a ratio, the numerator of which is an amount equal to  
25 the lesser of the amount of natural resource property claimed under  
26 this section or \$6 million, and the denominator of which is an amount  
27 equal to the total adjusted gross estate.

28 “(c) An executor may:

29 “(A) Elect not to claim the credit allowed under this section;

30 “(B) Elect to claim less than the full amount of the credit allowed

3 **“(3) Except as provided in subsections [(4) and (5)] (4), (7) and (8) of this**  
4 **section, a credit is allowed under this section only if:**

5 **“(a) The total adjusted gross estate does not exceed \$15 million;**

6 **“(b) The total value of [property for which the credit established under this**  
7 **section is allowable] natural resource property in the estate is at least**  
8 **50 percent of the total adjusted gross estate;**

9 **“(c) The natural resource property is transferred to a [member of the**  
10 **family, as that term is defined in section 2032A of the Internal Revenue Code,**  
11 **or the registered domestic partner, of the decedent] family member; and**

12 **“(d) During an aggregate period of five out of the eight years ending on**  
13 **the date of the decedent’s death, the decedent[, a member of the decedent’s**  
14 **family or the decedent’s registered domestic partner owned the property and**  
15 **the property was devoted to use as a farm or used for farm or forest**  
16 **purposes] or a family member operated a farm business, forestry busi-**  
17 **ness or fishing business and the property for which a credit is claimed**  
18 **under this section is part of the business.**

19 **“(4) Property that otherwise meets the requirements of this section shall**  
20 **be allowed a credit under this section if:**

21 **“(a) The property is the subject of a net cash lease to or from the**  
22 **decedent or a [transferee described in subsection (3)(c) of this section] quali-**  
23 **fied beneficiary who is a family member; [or]**

24 **“(b) The property is held in trust for a [person described in subsection**  
25 **(3)(c) of this section.] qualified beneficiary who is a family member; or**

26 **“(c) The property replaces natural resource property, and the re-**  
27 **placement property would otherwise meet the definition of natural**  
28 **resource property except that it was acquired after the date of the**  
29 **decedent’s death but before the estate tax return is filed. In order to**  
30 **qualify under this paragraph, real property must be replaced with real**

1 property.

2 “(5) A credit is allowed under this section for the following real  
3 property only if the real property was owned by the decedent or a  
4 family member during an aggregate period of five out of the eight  
5 years ending on the date of the decedent’s death and used in a business  
6 described in subsection (3)(d) of this section:

7 “(a) Real property used as forestland or as forestland homesites,  
8 not to exceed 5,000 acres.

9 “(b) Real property used in farm use.

10 “(6) A credit is allowed under this section for property used in the  
11 operation of a fishing business only if the decedent or a family mem-  
12 ber, during an aggregate period of five out of the eight years ending  
13 on the date of the decedent’s death:

14 “(a) Owned a vessel used in taking food fish or shellfish for com-  
15 mercial purposes as defined in ORS 506.006;

16 “(b) Held a boat license as provided in ORS 508.260;

17 “(c) Held a commercial fishing license under ORS 508.235; and

18 “(d) Held one or more restricted fisheries permits as provided in  
19 ORS chapter 508 or an equivalent restricted vessel permit system un-  
20 der the laws of another state.

21 “(7) For the purpose of meeting the requirements of subsection (5)  
22 of this section, in determining the period of time during which the  
23 decedent or a family member owned real property received in exchange  
24 under section 1031 of the Internal Revenue Code or acquired in an in-  
25 voluntary conversion under section 1033 of the Internal Revenue Code,  
26 the period during which the decedent or a family member owned the  
27 exchanged or acquired real property, if the exchanged or acquired real  
28 property was used in the farm business or forestry business, may be  
29 included.

30 “[5] (8) Property that otherwise meets the requirements of this section

1 and that is owned indirectly by the decedent or a [*member of the family de-*  
2 *scribed in subsection (3)(c) of this section, or the registered domestic partner,*  
3 *of the decedent shall qualify for a credit*] **family member qualifies for a**  
4 **credit** under this section if the property is owned through an interest in a  
5 limited liability company or in a corporation, partnership or trust as the

18 *conversion are used to acquire replacement property, the cost of which equals*

21 “[7)(a) *An additional tax under ORS 118.005 to 118.840 shall be imposed*  
22 *if property for which a credit is allowed under this section is not used in*  
23 *commercial fishing operations or as natural resource property for at least five*  
24 *out of the eight calendar years following the decedent’s death or is disposed*  
25 *of by the transferee other than by disposition to another member of the family,*

3 of decedents [*dying*] **who die** on or after January 1, 1987, and before January  
4 1, 2003, unless a federal estate tax return is required to be filed; [*and*]

5 "(b) An inheritance tax return is not required with respect to the estates  
6 of decedents [*dying*] **who die** on or after:

7 "(A) January 1, 2003, and before January 1, 2004, unless the value of the  
8 gross estate is \$700,000 or more;

9 "(B) January 1, 2004, and before January 1, 2005, unless the value of the

6 “(a) A statement that all Oregon income **taxes**, inheritance **or estate**  
7 **taxes** and personal property taxes, if any, have been paid, or if not so paid,  
8 that payment of those taxes has been secured by bond, deposit or otherwise,  
9 and that all required tax returns have been filed.

10 “(b) A petition for a judgment authorizing the personal representative to  
11 distribute the estate to the persons and in the portions specified therein.

12 “(4) If the distributees consent thereto in writing and all creditors of the  
13 estate have been paid in full other than creditors owed administrative ex-  
14 penses that require court approval, the personal representative, in lieu of the  
15 final account otherwise required by this section, may file a statement that  
16 includes the following:

17 “(a) The period of time covered by the statement.

18 “(b) A statement that all creditors have been paid in full other than  
19 creditors owed administrative expenses that require court approval.

14 property specifically given to a beneficiary under the rules in ORS 129.270  
15 to 129.425 that apply to trustees and the rules in subsection (5) of this sec-  
16 tion. The fiduciary shall distribute the net income and net principal receipts  
17 to the beneficiary who is to receive the specific property.

27 fiduciary claims an estate tax marital or charitable deduction only to the  
28 extent that the payment of those expenses from income will not cause the

30 “(c) Paying from principal all other disbursements made or incurred in

1 connection with the settlement of a decedent's estate or the winding up of  
2 a terminating income interest, including debts, funeral expenses, disposition  
3 of remains, family allowances, and [death] estate taxes and related penalties  
4 that are apportioned to the estate or terminating income interest by the will,  
5 the terms of the trust or applicable law.

6 “(3) A fiduciary shall distribute to a beneficiary who receives a pecuniary  
7 amount outright the interest or any other amount provided by the will, the  
8 terms of the trust or applicable law from net income determined under sub-  
9 section (2) of this section or from principal to the extent that net income is  
10 insufficient. If a beneficiary is to receive a pecuniary amount outright from  
11 a trust after an income interest ends and no interest or other amount is  
12 provided for by the terms of the trust or applicable law, the fiduciary shall  
13 distribute the interest or other amount to which the beneficiary would be  
14 entitled under applicable law if the pecuniary amount were required to be

9 valorem property taxation, exemptions, special assessments or omitted prop-  
10 erty, the court finds in favor of the taxpayer, the court may allow the tax-  
11 payer, in addition to costs and disbursements, the following:

12 “(A) Reasonable attorney fees for the proceeding under this subsection  
13 and for the prior proceeding in the matter, if any, before the magistrate; and

14 “(B) Reasonable expenses as determined by the court. Expenses include  
15 fees of experts incurred by the individual taxpayer in preparing for and

23 the time the employee files a personal income tax return for the tax year

1 when the tax return for that year was filed or was due, whichever is later.

2 “(f) The amount of the refund, exclusive of interest on the refund, may  
3 not exceed the portion of the tax paid during the period preceding the filing  
4 of the claim or, if no claim is filed, then during the period preceding the  
5 allowance of the refund during which a claim might have been filed. Where  
6 there has been an overpayment of any tax imposed, the amount of the over-  
7 payment and interest on the overpayment shall be credited against any tax,  
8 penalty or interest then due from the taxpayer, and only the balance shall  
9 be refunded.

10 “(g) Except as provided in ORS 305.265 (12), if, pursuant to a notice of  
11 deficiency or assessment, the taxpayer pays the amount specified in the no-

25 “(A) The department shall make the refund prior to the expiration of the  
26 period agreed upon; and

27 “(B) The department may not make or allow a refund after the expiration  
28 of the period agreed upon unless a claim for refund is filed by the taxpayer  
29 before the expiration of the period agreed upon in compliance with the  
30 manner prescribed by the department. The period so agreed upon may be

1 extended by subsequent agreements in writing made before the expiration of  
2 the period previously agreed upon.

3 “(b) The department may consent to extend the period during which a  
4 refund may be made only if the taxpayer has consented to the assessment  
5 of additional tax, if additional taxes are determined upon audit, after the  
6 expiration of the applicable period prescribed in ORS 314.410 (1) to (3).

7 “(4)(a) If the claim for credit or refund relates to an overpayment on ac-  
8 count of the deductibility by the taxpayer, or by a partnership, of the  
9 worthlessness of a share of stock in a corporation, of the right to subscribe  
10 for or to receive a share of stock in a corporation, or of a debt, in lieu of  
11 the three-year period of limitation prescribed in subsection (2) of this section,  
12 the period shall be seven years from the date prescribed by law for the filing  
13 of the return for the year with respect to which the claim is made.

14 “(b) If the claim described in paragraph (a) of this subsection is made  
15 after the expiration of the three-year period prescribed in subsection (2) of  
16 this section, the department may not allow interest with respect to any  
17 credit or refund determined to be due upon the claim for the period begin-  
18 ning at the close of the three-year period prescribed in subsection (2) of this  
19 section and ending at the expiration of six months after the date on which  
20 the claim is filed.

21 “(5)(a) If the claim for credit or refund relates to an overpayment attrib-  
22 utable to a net operating loss carryback or a net capital loss carryback, in  
23 lieu of the three-year period of limitation prescribed in subsection (2) of this  
24 section, the period shall be the period that ends three years after the time  
25 prescribed by law for filing the return (including extensions) for the taxable  
26 year of the net operating loss or net capital loss that results in such  
27 carryback. In the case of such a claim, the amount of the credit or refund  
28 may exceed the portion of the tax paid within the period provided in sub-  
29 section (1), (2) or (3) of this section, whichever is applicable, to the extent  
30 of the amount of the overpayment attributable to the carryback. If the al-



1 lowance of a credit or refund of an overpayment of tax attributable to a net  
2 operating loss carryback or a net capital loss carryback is otherwise pre-  
3 vented by the operation of any law or rule of law other than ORS 305.150,  
4 relating to closing agreements, the credit or refund may be allowed or made  
5 if the claim for credit or refund is filed within the period provided in this  
6 subsection. To the extent that the carryback was not an issue in any pro-

8 Court, has become final, the claimed credit or refund applicable to that

15 operating loss or net capital loss arises;

16 “(B) The date the return for the year in which the net operating loss or  
17 net capital loss arises is filed; or

18 “(C) The date of filing of the return for the year to which the net oper-  
19 ating loss or net capital loss is carried back.

20 “(6) Notwithstanding any provision to the contrary in ORS 305.265 or  
21 305.270 or this section, if the taxpayer has agreed with the United States  
22 Commissioner of Internal Revenue for an extension, or a renewal of an ex-  
23 tension, of the period for proposing and assessing deficiencies in federal in-  
24 come tax for any year, the period within which a claim for credit or refund  
25 may be filed or credit or refund allowed or made if no claim is filed shall  
26 be the period provided within subsections (1) to (5) of this section or six  
27 months after the date of the expiration of the agreed period for assessing  
28 deficiency in federal income tax, whichever period expires later.

29 “(7) If a joint return is filed, the department may make separate refunds  
30 at the request of either spouse. The separate refunds shall bear the same

1 proportion to the total refund as the adjusted gross income of each spouse

11 **made a part of ORS 118.005 to 118.840.**

12 **“SECTION 27. When the Department of Revenue and the taxing**  
13 **official of one or more other states each claims that the state of that**  
14 **official respectively was the domicile of the decedent for the purpose**  
15 **of estate taxes or claims taxing authority over the same property in**  
16 **an estate, the department may negotiate, and enter into an agree-**  
17 **ment, with the taxing official of the other state and with the executor**  
18 **to accept payment of estate tax, together with any interest and pen-**  
19 **alties. The department may enter into binding arbitration or into a**  
20 **compromise agreement with respect to disputed liability for estate**  
21 **taxes with each taxing official and with the executor.**

22 **“SECTION 28. (1) At any time within three years after the date that**  
23 **an estate tax return is filed, the Department of Revenue may give**  
24 **notice of deficiency as prescribed in ORS 305.265.**

25 **“(2) If the department finds that the value of the gross estate has**  
26 **been undervalued on the estate tax return by an amount greater than**  
27 **25 percent, notice of deficiency may given at any time within five years**  
28 **after the date that the return is filed.**

29 **“(3) The limitations to the giving of notice of a deficiency provided**  
30 **in this section do not apply to a deficiency resulting from a false or**

1 fraudulent estate tax return or in a case where no return has been  
2 filed.

3 **“SECTION 29.** For decedents who die on or after January 1, 2011,  
4 and before the effective date of this 2011 Act:

5 **“(1)** A return is not due under ORS 118.005 to 118.840 until the later  
6 of the date required under ORS 118.100 or two months after the effec-  
7 tive date of this 2011 Act.

8 **“(2)** Taxes imposed by ORS 118.005 to 118.840 are due and payable  
9 by the date provided in subsection (1) of this section for filing of the  
10 return.

11 **“(3)** If the amendments to statutes by sections 1 to 15 and 25 of this  
12 2011 Act result in:

13 **“(a)** An increase in the taxes due under ORS 118.005 to 118.840, the  
14 executor shall file an amended return accompanied by payment of the  
15 additional tax due.

16 **“(b)** A decrease in the taxes due under ORS 118.005 to 118.840, the  
17 executor may file an amended return claiming a refund.

18 **“(4)** If a deficiency is assessed under ORS 118.005 to 118.840, and the  
19 deficiency or any portion thereof is attributable to any retroactive  
20 treatment under the amendments to statutes by sections 1 to 15 and  
21 25 of this 2011 Act, any interest or penalty assessed under ORS chapter  
22 118, 305, 314, 315, 316, 317 or 318 with respect to the deficiency or por-  
23 tion thereof will not accrue until 60 days after the date provided for  
24 the filing of the return.

25 **“(5)** If a refund of the tax imposed under ORS 118.005 to 118.840 is  
26 due, and the refund or any portion thereof is due on account of any  
27 retroactive treatment under the amendments to statutes by sections  
28 1 to 15 and 25 of this 2011 Act, then notwithstanding ORS 305.270 or  
29 314.415, the refund or portion thereof shall be paid without interest.

30 **“SECTION 30.** ORS 118.009, 118.019, 118.220, 118.240, 118.470, 118.810,

1 118.820, 118.830, 118.840, 118.855, 118.860, 118.865, 118.870, 118.875 and  
2 118.880 and section 3, chapter 806, Oregon Laws 2003, are repealed.

3 **SECTION 31.** (1) Sections 27 to 29 of this 2011 Act, the amendments  
4 to ORS 111.025, 114.075, 116.083, 116.173, 116.303, 116.343, 118.005, 118.007,  
5 118.010, 118.013, 118.016, 118.100, 118.140, 118.160, 118.171, 118.225, 118.260,  
6 118.280, 118.300, 118.350, 118.525, 129.250, 305.490 and 314.415 by sections  
7 1 to 15 and 17 to 25 of this 2011 Act and the repeal of ORS 118.009,  
8 118.019, 118.220, 118.240, 118.470, 118.810, 118.820, 118.830, 118.840, 118.855,  
9 118.860, 118.865, 118.870, 118.875 and 118.880 and section 3, chapter 806,  
10 Oregon Laws 2003, by section 30 of this 2011 Act apply to estates of  
11 decedents who die on or after January 1, 2011.

12 **(2)** The amendments to ORS 105.645 by section 16 of this 2011 Act  
13 apply to estates of decedents who die on or after January 1, 2010.

14 **SECTION 32.** This 2011 Act takes effect on the 91st day after the  
15 date on which the 2011 regular session of the Seventy-sixth Legislative  
16 Assembly adjourns sine die.”
