- SB 1503  
CARRIED OVER FROM THE 2/6//2012 AGENDA: Requires health care worker to provide health care employer with evidence that worker received annual seasonal influenza vaccination or written declaration that worker declines vaccination.
- SB 1504  
CARRIED OVER FROM THE 2/6/2012 AGENDA: Exempts insurer from requirement to send notice of cancellation of health benefit plan if cancellation is due to nonpayment of premium.
- SB 1506 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM 2/6/2012 AGENDA: Creates Central Oregon Psychiatric Prescribing Program as pilot program to allow reimbursement of mental health drug costs using capitation payment methodology.
- SB 1577 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM 2/6/2012 AGENDA: Requires state agencies to participate in Oregon Prescription Drug Program subject to exceptions.

Provides legislative approval of Oregon Health Authority proposals for coordinated care organizations and Oregon Health Insurance Exchange Corporation business plan for health insurance exchange by repealing provisions of law enacted to require legislative approval.
