HB 4142

FIRST PUBLIC HEARING: Requires contracting agency to apply certain preferences in awarding contracts related to certain goods manufactured from recycled materials.

HB 4144 **

**Subsequent Referral(s) to Ways and Means

FIRST PUBLIC HEARING. Requires contracting agency, in determining lowest bid for procurement, to make certain additions and deductions based on health and retirement benefits paid for workers who are residents of this state, based on fuel consumption and carbon generation and based on personal income taxes paid by employing workers who are residents of this state.

Public Hearing

HB 4103 **

**Subsequent Referral(s) to Revenue

FIRST PUBLIC HEARING. Creates income tax credit for capital improvements to business facilities or homes that are commenced prior to May 30, 2012, or effective date of Act, whichever is later.

HB 4133

FIRST PUBLIC HEARING. Requires financial institutions that disperse government benefits through debit cards to provide certain information about fees imposed for use of debit cards.

Work Session

HB 4092

Allows licensed distillery or trade association representing distilleries to obtain license for special event at which multiple distilleries may permit tastings and conduct limited sales.

HB 4035

Amends provisions of Oregon law to conform to changes in Uniform Commercial Code, to clarify meaning of name of debtor, to permit filing of information statement, to adopt official filing forms, to specify priority of competing secured claims and to address related matters.
