FIRST PUBLIC HEARING: Authorizes local government to conditionally approve siting of photovoltaic solar energy facility when site certificate is not required and facility is on farmland that is not high-value farmland but is within area zoned for exclusive farm use.

HB 4101 **

FIRST PUBLIC HEARING: Directs Water Resources Department to aggressively pursue development of Columbia River Basin water resources.

HB 4166 **

FIRST PUBLIC HEARING: Allows State Department of Energy to require applicants seeking tax credit certification to demonstrate whether efficiency standards of energy conservation projects are eligible for certification under certain forest product stewardship systems.
