  - One, non-voting member, appointed by the Speaker of the House (REP. DOHERTY)
  - One, non-voting member, appointed by the Senate President (SEN. DINGFELDER)
- Members shall have a background that demonstrates a commitment to Oregon's culture
- Members are entitled to compensation and expenses

**DUTIES AND AUTHORITY:** ORS 359.413, ORS 359.416

- The board shall meet at least once every three months
- Oversees management of Trust for Cultural Development Account
- Provides direction to the Administrator of the Art Program for the coordination, administration, and evaluation of the Cultural Development Grant Program, Community Cultural Participation Grant Program, and funds received by core partner agencies
- Rulemaking authority
