  - o One lawyer with experience in juvenile law practice (ALBA)

- The work is divided between an adult panel and a juvenile panel, with each panel directing the care and treatment of those persons
- The board's jurisdiction is equal to the maximum sentence provided for the crime
- The board's primary purpose is to protect the public through the on-going review of the progress of those placed under its jurisdiction
- The board has authority to commit a person to the state hospital, conditionally release a person from the hospital to community-based program, revoke conditional release, or discharge person
