Wells— Partial four- year term: March 1, 2012 – July 31, 2015

**STATUTORY QUALIFICATIONS:** ORS 327.500, 327.502

- Eleven members, no more than five members that are school district employees at the time of appointment (District employees are: BAUTISTA, BOLY, CURTIS, GEROT, MCNAMARA, RASMUSSEN, RUSSELL, TROMBA) Other members are: BACKLUND, LUNDQUIST, MASSEY, WELLS)
- Governor selects chair and vice-chair
- Eligible for reappointment; serve at the pleasure of the Governor

**DUTIES AND AUTHORITY:** ORS 327.506

- Determine each biennium the amount of moneys sufficient to ensure that the state's system of K-12 public education meets quality goals established in ORS 329.007, 329.015, 329.025, 329.035, 329.045, 329.065, 329.465, 329.475 and 329.487
- Identify best practices that lead to high student performance and the cost of implementing those practices
- Issue a report to the Governor and the Legislative Assembly prior to August 1<sup>st</sup> of each even-numbered year that identifies:
  - Current practices in the state's K-12 public education system, the costs of continuing those practices and the expected student performance under those practices
  - Best practices for meeting the quality goals, the costs of implementing those practices and the expected student performance under those practices
  - At least two alternatives, which may include different approaches or phased implementation, for meeting quality goals
