- Nine-members appointed by the Governor
- Three public members (**DUNCAN, FERRIS, MARKGRAF**) one to serve as chair.  
Public members not to have had, during preceding 5 years or during tenure, any interest in ownership, operation or management of tugs, cargo or passenger or freight vessels, or in any organization or association related to commercial ocean-going vessels engaged in commercial maritime industry, or hold any maritime pilot license
- Three licensed maritime pilots, licensed for than three years, actively engaged in piloting; and residents of this state
  - One member to be a Columbia River bar licensee (**RIGGS**)
  - One member to be a Columbia River licensee (**McINTYRE**)
  - One member to be a Coos Bay or Yaquina Bay licensee (**WOODS, Coos Bay**)
- Three members, for at least 3 immediately preceding years and during tenure, involved in activities of operating commercial ocean-going vessels (**BADAWI, KRUG, PAPACHRISTOPOULOS**)

**DUTIES AND AUTHORITY:** ORS 776.115, 776.118, 776.300, 776.311, 776.375

- Provide for efficient and competent pilotage with primary consideration to be public safety
- License pilot organizations and pilots; regulate and limit number of pilots and trainees
- Fix at reasonable and just rates pilotage fees, extra fees for vessels in distress, extraordinary pilotage service fees, etc
- Establish and fix boundaries of pilotage grounds
- Set meetings, at least one each calendar year
