

House Bill 4003

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Agriculture and Natural Resources)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Allows State Department of Agriculture to adopt rules to establish license fees for certain food-related establishments and occupations. Imposes limitations on timing and amount of fees established by rule. Applies to fees charged for licensing periods beginning on or after July 1, 2013. Continues existing statutory fees until adoption of fees by rule.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 603.025 is amended to read:

7 603.025. (1) A person may not sell, offer to sell or expose for sale meat products or engage in
8 any other activity described or identified in subsection (4) of this section without first obtaining and
9 maintaining a license [*therefor*] **for that activity** from the State Department of Agriculture. All such
10 licenses shall expire on June 30 next following the date of issuance or on such date as may be
11 specified by department rule. Renewal applications must be postmarked before the expiration date
12 to be timely.

13 (2) Application for a license required by this section shall be made to the department on forms
14 prescribed by the department[, *which*] **and** shall contain any information the department deems
15 necessary. The license is personal and nontransferable, with a separate license required for each
16 establishment location. A new license is required each time there is a change in ownership, legal
17 entity or establishment location.

18 (3) In addition to other license requirements of this section, if an applicant for a license under
19 subsection (4)(c) of this section has an average weekly dollar value of meat animal purchases that
20 exceeds \$10,000, the applicant shall submit with the application a surety bond with one or more
21 corporate sureties authorized to do business in this state, or an irrevocable letter of credit issued
22 by an insured institution, as defined in ORS 706.008. The bond or letter of credit shall be in an
23 amount equal to twice the average daily value of meat animal purchases during the preceding cal-
24 endar year, or the amount of \$20,000, whichever amount is greater. The department shall prescribe
25 the form for [*and approve*] the bond or letter of credit.[, *which shall*] **A bond or letter of credit is**
26 **subject to department approval and must** be conditioned upon faithful performance by the
27 licensee of all obligations to the producers of meat animals arising from the sale of meat animals
28 by producers to the licensee.

29 (4) Each of the following activities [*shall*] **must** be licensed, and the fee established by the de-
30 partment paid with the **license** application [*therefor*]:

1 (a) Operation of a meat seller establishment. A license under this section allows only the meat
2 products preparation described in ORS 603.010 (8).

3 (b) Operation of a nonslaughtering processing establishment. A license under this section allows
4 selling meat products at the same location without obtaining the license described in paragraph (a)
5 of this subsection.

6 (c) Operation of a slaughterhouse. A license under this section allows selling meat products at
7 the same location without obtaining the license described in paragraph (a) of this subsection.

8 (d) Operation of a custom slaughtering establishment or custom processing establishment. A li-
9 cense under this section does not allow selling meat products without first obtaining and maintain-
10 ing the license described in paragraph (a) of this subsection.

11 (e) Operation of a slaughterhouse, custom slaughtering establishment or custom processing es-
12 tablishment wherein only poultry or rabbits are slaughtered or prepared. A license under this sec-
13 tion allows selling only poultry or rabbit products at the same location without obtaining the license
14 described in paragraph (a) of this subsection.

15 (5) The license required by this section shall be displayed at all times in a conspicuous manner
16 at the address shown on the license.

17 *[(6) Except as provided in subsection (7) of this section, the license fees for establishments under*
18 *this section are:]*

19 *[(a) \$216 if the establishment's annual gross dollar volume of sales and services is not more than*
20 *\$50,000;]*

21 *[(b) \$271 if the establishment's annual gross dollar volume of sales and services is more than*
22 *\$50,000 and not more than \$500,000;]*

23 *[(c) \$325 if the establishment's annual gross dollar volume of sales and services is more than*
24 *\$500,000 and not more than \$1 million;]*

25 *[(d) \$487 if the establishment's annual gross dollar volume of sales and services is more than \$1*
26 *million and not more than \$5 million;]*

27 *[(e) \$541 if the establishment's annual gross dollar volume of sales and services is more than \$5*
28 *million and not more than \$10 million; or]*

29 *[(f) \$704 if the establishment's annual gross dollar volume of sales and services is more than \$10*
30 *million.]*

31 *[(7) If the establishment sells only prepackaged meats packaged at a facility inspected by the United*
32 *States Department of Agriculture, the following license fee amounts shall apply instead of the fee es-*
33 *tablished in subsection (6)(a) of this section:]*

34 *[(a) \$108 if the establishment's annual gross dollar volume of sales and services is not more than*
35 *\$5,000; or]*

36 *[(b) \$162 if the establishment's annual gross dollar volume of sales and services is more than*
37 *\$5,000 and not more than \$50,000.]*

38 **[(8)] (6) The department may adopt rules establishing license fee schedules for establish-**
39 **ments licensed under this section. The department may determine the license fee for an es-**
40 **tablishment based upon the annual gross dollar volume of sales and services by the applicant.**

41 In establishing the amount of the license fee for an establishment, the State Department of Agri-
42 culture shall use the annual gross dollar volume of sales and services by that establishment within
43 Oregon during the prior calendar year or, if the establishment maintains sales and service records
44 on a fiscal basis, the prior fiscal year. If the establishment applying for an original license or for a
45 renewal license cannot provide the annual gross dollar volume of sales and services for a full cal-

1 endar year, the department shall base the fee on estimated annual gross sales and services by the
 2 establishment. If an establishment whose previous year's fee was determined using an estimated
 3 gross sales and services figure applies for renewal of that license, the fee for the previous license
 4 year shall be adjusted to reflect the actual annual gross dollar volume of sales and services by the
 5 establishment.

6 **(7) Except as provided in this subsection, the department may not adopt a rule under this**
 7 **section to establish a license fee that is more than three percent higher than the license fee**
 8 **charged during the preceding year for an establishment of the same type and having the**
 9 **same volume of gross sales and services. When adopting a rule establishing a license fee,**
 10 **notwithstanding the three percent limit, the department may round the fee amount to the**
 11 **next higher whole dollar amount. Fee schedules adopted under this section may not change**
 12 **the amount of the same license fee more frequently than once each year.**

13 **SECTION 2. (1) Notwithstanding the amendments to ORS 603.025 by section 1 of this 2012**
 14 **Act, the license fee amounts authorized by ORS 603.025 as set forth in the 2011 Edition of**
 15 **Oregon Revised Statutes and in effect on the effective date of this 2012 Act shall remain in**
 16 **effect until superseded by license fees established by State Department of Agriculture rules.**

17 **(2) The department shall adopt initial rules establishing license fees under ORS 603.025**
 18 **to take effect no later than July 1, 2013. For the purpose of adopting initial rules establishing**
 19 **license fees under ORS 603.025, the license fees authorized by ORS 603.025 as set forth in the**
 20 **2011 Edition of Oregon Revised Statutes and in effect on the effective date of this 2012 Act**
 21 **are deemed to be the license fees charged during the year preceding adoption of the rule.**

22 **SECTION 3. ORS 616.706 is amended to read:**

23 616.706. (1) Except as otherwise provided in ORS 616.695 to 616.755, a person may not operate
 24 a food establishment without first obtaining and thereafter maintaining a license under this section.
 25 A person shall make an application for a license to the State Department of Agriculture on forms
 26 prescribed by the department. Each license shall expire on June 30 next following the date of issu-
 27 ance or on such date as may be specified by department rule.

28 (2) The department may, subject to the applicable provisions of ORS chapter 183, suspend, re-
 29 voke or refuse to issue a license if the licensee has violated any of the provisions of ORS 616.695
 30 to 616.755 or rules adopted under ORS 616.695 to 616.755.

31 (3) A license is personal to the applicant and may not be transferred. A new license is necessary
 32 if the business entity of the licensee is changed, or if the membership of a partnership is changed,
 33 irrespective of whether or not the business name is changed.

34 (4) The license shall cover all operations of the person licensed, under one entity or ownership.
 35 With prior approval of the department, the location of a licensed food establishment, or any part
 36 of a licensed food establishment, may be moved without the requirement of a new license if there
 37 is no change in the ownership or business entity.

38 (5) The license shall be posted in a conspicuous place in the main office of the food establish-
 39 ment. Duplicate copies of the license shall be conspicuously posted in branch offices, warehouses
 40 and other places owned or operated by the licensee at locations other than the main office. A license
 41 is automatically canceled if the food establishment ceases or discontinues operations or business.

42 *[(6) The license fee for a food establishment that is part of a domestic kitchen is \$189.]*

43 *[(7) The license fees for a food establishment other than an establishment that is part of a domestic*
 44 *kitchen, or other than a retail food store or a warehouse, are:]*

45 *[(a) \$325 if the gross sales of an applicant's covered operations are not more than \$50,000;]*

1 **[(b) \$460 if the gross sales of an applicant's covered operations are more than \$50,000 and not more**
 2 **than \$500,000;]**

3 **[(c) \$541 if the gross sales of an applicant's covered operations are more than \$500,000 and not**
 4 **more than \$1 million;]**

5 **[(d) \$704 if the gross sales of an applicant's covered operations are more than \$1 million and not**
 6 **more than \$5 million;]**

7 **[(e) \$812 if the gross sales of an applicant's covered operations are more than \$5 million and not**
 8 **more than \$10 million; or]**

9 **[(f) \$920 if the gross sales of an applicant's covered operations are more than \$10 million.]**

10 **[(8) The food establishment license fees for a retail food store, as defined by the department by rule,**
 11 **are:]**

12 **[(a) \$135 if the gross sales of an applicant's covered operations are not more than \$50,000;]**

13 **[(b) \$271 if the gross sales of an applicant's covered operations are more than \$50,000 and not more**
 14 **than \$500,000;]**

15 **[(c) \$325 if the gross sales of an applicant's covered operations are more than \$500,000 and not**
 16 **more than \$1 million;]**

17 **[(d) \$487 if the gross sales of an applicant's covered operations are more than \$1 million and not**
 18 **more than \$5 million;]**

19 **[(e) \$595 if the gross sales of an applicant's covered operations are more than \$5 million and not**
 20 **more than \$10 million; or]**

21 **[(f) \$704 if the gross sales of an applicant's covered operations are more than \$10 million.]**

22 **[(9) The food establishment license fees for a warehouse, as defined by the department by rule,**
 23 **are:]**

24 **[(a) \$108 if the gross sales of an applicant's covered operations are not more than \$50,000;]**

25 **[(b) \$135 if the gross sales of an applicant's covered operations are more than \$50,000 and not more**
 26 **than \$10 million; or]**

27 **[(c) \$162 if the gross sales of an applicant's covered operations are more than \$10 million.]**

28 **(6) The department may adopt rules establishing license fee schedules for a food estab-**
 29 **lishment:**

30 **(a) That is part of a domestic kitchen;**

31 **(b) That is a retail food store;**

32 **(c) That is a warehouse; or**

33 **(d) That is other than part of a domestic kitchen, retail food store or warehouse.**

34 **[(10)] (7) The department may determine the license fee for a food establishment de-**
 35 **scribed in subsection (6)(b) to (d) of this section based upon the gross sales by the applicant.**

36 In establishing the amount of *[the license fee for]* **a license fee based upon gross sales by** an ap-
 37 plicant, the department shall use the annual gross dollar volume of sales of covered operations by
 38 that applicant within Oregon during the prior calendar year or, if the applicant maintains sales re-
 39 cords on a fiscal basis, the prior fiscal year. If the applicant applying for an original license or for
 40 a renewal license cannot provide the annual gross dollar volume of sales of covered operations for
 41 a full calendar year, the department shall base the fee on estimated annual gross sales of covered
 42 operations by the applicant. If an applicant whose previous year's fee was determined using an es-
 43 timated gross sales of covered operations figure applies for renewal of that license, the fee for the
 44 previous license year shall be adjusted to reflect the actual gross dollar volume of sales of covered
 45 operations by the applicant.

1 (8) Except as provided in this subsection, the department may not adopt a rule under this
 2 section to establish a license fee that is more than three percent higher than the license fee
 3 charged during the preceding year for a food establishment of the same type and having the
 4 same volume of gross sales. When adopting a rule establishing a license fee, notwithstanding
 5 the three percent limit, the department may round the fee amount to the next higher whole
 6 dollar amount. License fee schedules adopted under this section may not change the amount
 7 of the same license fee more frequently than once each year.

8 **SECTION 4.** (1) Notwithstanding the amendments to ORS 616.706 by section 3 of this 2012
 9 Act, the license fee amounts authorized by ORS 616.706 as set forth in the 2011 Edition of
 10 Oregon Revised Statutes and in effect on the effective date of this 2012 Act shall remain in
 11 effect until superseded by license fees established by State Department of Agriculture rules.

12 (2) The department shall adopt initial rules establishing license fees under ORS 616.706
 13 to take effect no later than July 1, 2013. For the purpose of adopting initial rules establishing
 14 license fees under ORS 616.706, the license fees authorized by ORS 616.706 as set forth in the
 15 2011 Edition of Oregon Revised Statutes and in effect on the effective date of this 2012 Act
 16 are deemed to be the license fees charged during the year preceding adoption of the rule.

17 **SECTION 5.** ORS 619.031 is amended to read:

18 619.031. (1) A person may not operate an animal food slaughtering establishment or processing
 19 establishment without first obtaining a license *[therefor]* **for the establishment** from the State De-
 20 partment of Agriculture.

21 *[(2) The license fees for an animal food slaughtering establishment or processing establishment*
 22 *are:]*

23 *[(a) \$216 if the establishment's annual gross dollar volume of sales and services is not more than*
 24 *\$50,000;]*

25 *[(b) \$271 if the establishment's annual gross dollar volume of sales and services is more than*
 26 *\$50,000 and not more than \$500,000;]*

27 *[(c) \$325 if the establishment's annual gross dollar volume of sales and services is more than*
 28 *\$500,000 and not more than \$1 million;]*

29 *[(d) \$487 if the establishment's annual gross dollar volume of sales and services is more than \$1*
 30 *million and not more than \$5 million;]*

31 *[(e) \$541 if the establishment's annual gross dollar volume of sales and services is more than \$5*
 32 *million and not more than \$10 million; or]*

33 *[(f) \$704 if the establishment's annual gross dollar volume of sales and services is more than \$10*
 34 *million.]*

35 **[(3)] (2) The department may adopt rules establishing license fee schedules for establish-**
 36 **ments licensed under this section. The department may determine the license fee for an es-**
 37 **tablissement based upon the annual gross dollar volume of sales and services by the applicant.**

38 In establishing the amount of the license fee for an applicant, the department shall use the annual
 39 gross dollar volume of sales and services by that applicant within Oregon during the prior calendar
 40 year or, if the applicant maintains sales and service records on a fiscal basis, the prior fiscal year.
 41 If the applicant applying for an original license or for a renewal license cannot provide the annual
 42 gross dollar volume of sales and services for a full calendar year, the department shall base the fee
 43 on estimated annual gross sales and services by the applicant. If an applicant whose previous year's
 44 fee was determined using an estimated gross sales and services figure applies for renewal of that
 45 license, the fee for the previous license year shall be adjusted to reflect the actual gross dollar

1 volume of sales and services by the applicant. The license shall expire on June 30 next following the
2 date of issuance or on such date as may be specified by department rule.

3 **(3) Except as provided in this subsection, the department may not adopt a rule to es-**
4 **tablish a license fee that is more than three percent higher than the license fee charged**
5 **during the preceding year for an establishment of the same type and having the same volume**
6 **of gross sales and services. When adopting a rule establishing a license fee, notwithstanding**
7 **the three percent limit, the department may round the fee amount to the next higher whole**
8 **dollar amount. Fee schedules adopted under this section may not change the amount of the**
9 **same license fee more frequently than once each year.**

10 (4) The provisions of ORS 603.025 (2) and (5), 603.034 (1) and (2), 603.045 (7) and 603.075 shall
11 apply to animal food slaughtering establishments or processing establishments. Except as provided
12 in this subsection, the remainder of the provisions of ORS chapter 603 do not apply to such estab-
13 lishments.

14 (5) Notwithstanding subsection (1) of this section, a person licensed by the department under
15 ORS chapter 603 to slaughter meat animals and subject to federal meat inspection, or a person li-
16 censed by the department under ORS chapter 603 to slaughter only poultry and rabbits and subject
17 to federal poultry inspection, or a person licensed by the department under ORS chapter 603 as a
18 nonslaughtering processor may, without being required to obtain an additional license, also sell or
19 dispose of meat products as animal food provided that such licensees also comply with the provisions
20 of subsection (6) of this section, ORS 619.010 to 619.026 and 619.036 to 619.066.

21 (6) In accordance with the provisions of ORS chapter 183, the department may promulgate rules
22 necessary to carry out and enforce any procedures or measures to protect the health of the animals
23 that are fed or intended to be fed the meat products sold or disposed of by animal food slaughtering
24 establishments or processing establishments, and to protect the health of other animals in this state.
25 In addition to the provisions of ORS 619.046, for the purposes of this section the department shall
26 take into consideration:

27 (a) The provisions of ORS chapter 596.

28 (b) The procedures necessary to ensure that meat products that are only fit for or destined for
29 animal consumption are not sold for human consumption.

30 (7) A person licensed as provided by this section:

31 (a) May not sell, hold or offer for sale any carcass of a meat animal or part thereof that is unfit
32 for or unwholesome as animal food.

33 (b) May not sell, hold or offer for sale a carcass of a meat animal or part thereof for human
34 consumption.

35 (c) Shall keep complete and accurate records of the meat animals purchased for slaughter, in-
36 cluding but not limited to their description, brands if any, date of purchase and the name and ad-
37 dress of the person from whom the animals were purchased.

38 (d) Shall keep complete and accurate records of the sale of all meat animal carcasses or parts
39 [thereof] **of meat animal carcasses**, including the name and address of the purchaser.

40 (e) Shall comply with the provisions of ORS 619.026.

41 **SECTION 6. (1) Notwithstanding the amendments to ORS 619.031 by section 5 of this 2012**
42 **Act, the license fee amounts authorized by ORS 619.031 as set forth in the 2011 Edition of**
43 **Oregon Revised Statutes and in effect on the effective date of this 2012 Act shall remain in**
44 **effect until superseded by license fees established by State Department of Agriculture rules.**

45 **(2) The department shall adopt initial rules establishing license fees under ORS 619.031**

1 **to take effect no later than July 1, 2013. For the purpose of adopting initial rules establishing**
 2 **licensing fees under ORS 619.031, the license fees authorized by ORS 619.031 as set forth in**
 3 **the 2011 Edition of Oregon Revised Statutes and in effect on the effective date of this 2012**
 4 **Act are deemed to be the license fees charged during the year preceding adoption of the rule.**

5 **SECTION 7.** ORS 621.072 is amended to read:

6 621.072. (1) The State Department of Agriculture shall issue a license to use a grade designation
 7 to any person who:

8 (a) Makes written application for a license on forms provided by the department;

9 (b) Pays the designated license fee;

10 (c) Is engaged in the business of producing or distributing fluid milk; and

11 (d) Meets the requirements of the particular grade designation for which application is made.

12 (2) If a person carries on the activities of a producer and a producer-distributor, the person must
 13 obtain a separate license for each of those activities. If a producer-distributor manufactures products
 14 from both grade A fluid milk and grade B fluid milk at the same premises, the producer-distributor
 15 must obtain separate licenses for grade A product manufacturing activity and grade B product
 16 manufacturing activity.

17 (3) Licenses issued under this section shall be personal and not transferable.

18 (4) Each milk hauler, milk receiver or other person who grades fluid milk as fit or unfit for
 19 processing as fluid milk due to quality, odor, flavor or wholesomeness must first obtain a license
 20 from the department authorizing that person to sample and grade fluid milk. Each applicant for a
 21 milk sampler's and grader's license shall, by written examination, demonstrate an adequate knowl-
 22 edge of milk sanitation as it relates to the sampling, grading and handling of fluid milk and cream
 23 for analysis. The department shall give examinations for licenses at such times and places as ap-
 24 pears to be necessary and practicable.

25 (5) Before and after issuing a license to a person as a producer, producer-distributor, distributor
 26 or nonprocessing distributor of fluid milk, the department shall, as it deems necessary, inspect the
 27 physical facilities of the applicant's dairy, milk processing plant or distribution center and investi-
 28 gate other factors the department determines may relate to the production, processing or distrib-
 29 ution of fluid milk. The physical facilities must conform to the production, processing or distribution
 30 requirements for the fluid milk grade designation sought or held.

31 (6) Each license issued under this section expires on June 30 next following the date of its is-
 32 suance unless sooner revoked and may be renewed upon application of the licensee. Each applica-
 33 tion for a license or annual renewal *[thereof]* **of a license** shall be accompanied by a license fee.

34 *[(7) The department shall establish license fee schedules for milk samplers and graders in accord-*
 35 *ance with ORS chapter 183. A fee may not be less than \$25 or more than \$50.]*

36 *[(8) The license fees for producer-distributors, distributors and nonprocessing distributors are:]*

37 *[(a) \$135 if the applicant's annual gross dollar volume of sales and services is not more than*
 38 *\$50,000;]*

39 *[(b) \$189 if an applicant's annual gross dollar volume of sales and services is more than \$50,000*
 40 *and not more than \$500,000;]*

41 *[(c) \$325 if an applicant's annual gross dollar volume of sales and services is more than \$500,000*
 42 *and not more than \$1 million;]*

43 *[(d) \$487 if an applicant's annual gross dollar volume of sales and services is more than \$1 million*
 44 *and not more than \$5 million;]*

45 *[(e) \$649 if an applicant's annual gross dollar volume of sales and services is more than \$5 million*

1 *and not more than \$10 million; or]*

2 *[(f) \$812 if an applicant's annual gross dollar volume of sales and services is more than \$10*
3 *million.]*

4 *[(9) The license fees for producers are:]*

5 *[(a) \$135 if the applicant's annual gross sales are not more than \$50,000;]*

6 *[(b) \$189 if an applicant's annual gross sales are more than \$50,000 and not more than \$500,000;]*

7 *[(c) \$325 if an applicant's annual gross sales are more than \$500,000 and not more than \$1*
8 *million;]*

9 *[(d) \$487 if an applicant's annual gross sales are more than \$1 million and not more than \$5*
10 *million;]*

11 *[(e) \$649 if an applicant's annual gross sales are more than \$5 million and not more than \$10*
12 *million; or]*

13 *[(f) \$812 if an applicant's annual gross sales are more than \$10 million.]*

14 **(7) The department may adopt rules establishing license fee schedules for:**

15 **(a) Milk samplers and graders;**

16 **(b) Producer-distributors, distributors and nonprocessing distributors; and**

17 **(c) Producers.**

18 **[(10)] (8) The department may determine the license fee for a producer-distributor, dis-**
19 **tributor or nonprocessing distributor based upon the annual gross dollar volume of sales and**
20 **services by the applicant.** In establishing the amount of the license fee for an applicant under this
21 *[section]* **subsection**, the department shall use the annual gross dollar volume of sales and services
22 by that applicant within Oregon during the prior calendar year or, if the applicant maintains sales
23 and service records on a fiscal basis, the prior fiscal year. If the applicant applying for an original
24 license or for a renewal license cannot provide the annual gross dollar volume of sales and services
25 for a full calendar year, the department shall base the fee on estimated annual gross sales and ser-
26 vices by the applicant. If an applicant whose previous year's fee was determined using an estimated
27 gross sales and services figure applies for renewal of that license, the fee for the previous license
28 year shall be adjusted to reflect the actual gross dollar volume of sales and services by the appli-
29 cant.

30 **(9) The department may determine the license fee for a producer based upon the annual**
31 **gross sales by the applicant. In establishing the amount of the license fee for an applicant**
32 **under this subsection, the department shall use the annual gross sales by that applicant**
33 **within Oregon during the prior calendar year or, if the applicant maintains sales records on**
34 **a fiscal basis, the prior fiscal year. If the applicant applying for an original license or for a**
35 **renewal license cannot provide the annual gross sales for a full calendar year, the depart-**
36 **ment shall base the fee on estimated annual gross sales by the applicant. If an applicant**
37 **whose previous year's fee was determined using an estimated gross sales figure applies for**

42 on June 30 next following its issuance or on such date as may be specified by department rule. Dairy
43 products plant licenses are personal and are not transferable.

44 (3) Each dairy products plant shall submit a separate fee established by the department for each
45 mobile milk tanker. The fee does not apply to a mobile milk tanker owned and operated by a dairy

1 products plant while transporting dairy products from the dairy products plant to wholesale or retail
2 outlets for those products.

3 (4) The department may adopt rules establishing license fee schedules for:

4 (a) Mobile milk tankers; and

5 (b) Dairy products plants.

6 (5) The department may determine the license fee for a dairy products plant based upon the
7 annual gross dollar volume of sales and services by the applicant. In establishing the amount of the
8 license fee for an applicant, the department shall use the annual gross dollar volume of sales and
9 services by that applicant within Oregon during the prior calendar year or, if the applicant main-
10 tains sales and service records on a fiscal basis, the prior fiscal year. If the applicant applying for
11 an original license or for a renewal license cannot provide the annual gross dollar volume of sales
12 or services for a full calendar year, the department shall base the fee on estimated annual gross
13 sales and services by the applicant. If an applicant whose previous year's fee was determined using
14 an estimated gross sales and services figure applies for renewal of that license, the fee for the pre-
15 vious license year shall be adjusted to reflect the actual gross dollar volume of sales and services
16 by the applicant.

17 (6) *[Except as provided in this subsection, the department may not adopt a rule under this section*
18 *to establish a license fee that is more than three percent higher than the fee charged during the pre-*
19 *ceding year for an equivalent mobile milk tanker or for a dairy products plant having the same volume*
20 *of gross sales and services. When adopting a rule establishing a license fee, notwithstanding the three*
21 *percent limit, the department may round the fee amount to the next higher whole dollar amount.]* Fee
22 schedules adopted under this section may not change the amount of the same license fee more fre-
23 quently than once each year.

24 **SECTION 41.** ORS 625.180, as amended by section 11 of this 2012 Act, is amended to read:

25 625.180. (1) Every bakery or bakery distributor doing business in this state shall pay a license
26 fee.

27 (2) The State Department of Agriculture may adopt rules establishing license fee schedules for:

28 (a) A bakery distributor;

29 (b) A domestic kitchen bakery; and

30 (c) A bakery other than a domestic kitchen bakery.

31 (3) The department may determine the license fee for a bakery or bakery distributor based upon
32 the annual gross sales by the applicant. In establishing the amount of the license fee for a bakery
33 or bakery distributor, the department shall use the annual gross sales by that bakery or distributor
34 within Oregon during the prior calendar year or, if the bakery or distributor maintains sales records
35 on a fiscal basis, the prior fiscal year. If the bakery or distributor applying for an original license
36 or for a renewal license cannot provide the annual gross sales for a full calendar year, the depart-
37 ment shall base the fee on estimated annual gross sales by the bakery or distributor. If a bakery
38 or distributor whose previous year's fee was determined using an estimated gross sales figure applies
39 for renewal of that license, the fee for the previous license year shall be adjusted to reflect the ac-
40 tual gross sales by the bakery or distributor.

41 (4) *[Except as provided in this subsection, the department may not adopt a rule under this section*
42 *to establish a license fee that is more than three percent higher than the license fee charged during the*
43 *preceding year for a bakery distributor having the same volume of gross sales or for a bakery of the*
44 *same type and having the same volume of gross sales. When adopting a rule establishing a license fee,*
45 *notwithstanding the three percent limit, the department may round the fee amount to the next higher*

1 *whole dollar amount.*] Fee schedules adopted under this section may not change the amount of the
2 same license fee more frequently than once each year.

3 **SECTION 42.** ORS 628.240, as amended by section 13 of this 2012 Act, is amended to read:

4 628.240. (1) An applicant for a refrigerated locker plant license shall pay a license fee to the
5 State Department of Agriculture. The department may adopt rules establishing a license fee for a
6 refrigerated locker plant. [*Except as provided in this subsection, the department may not adopt a rule*
7 *under this section to establish a license fee that is more than three percent higher than the fee charged*
8 *during the preceding year. When adopting a rule establishing a license fee, notwithstanding the three*
9 *percent limit, the department may round the fee amount to the next higher whole dollar amount.*] The
10 department may not change the amount of the refrigerated locker plant license fee more frequently
11 than once each year.

12 (2) If the license is issued after January 1 but before June 30 of the same year, the license fee
13 shall be one-half of the fee established by the department by rule under subsection (1) of this section.

14 (3) All fees received by the department under ORS 628.210 to 628.370 shall be deposited in the
15 Department of Agriculture Service Fund and are continuously appropriated to the department for
16 the purpose of administering and enforcing those sections.

17 **SECTION 43.** ORS 632.720, as amended by section 15 of this 2012 Act, is amended to read:

18 632.720. An applicant for an egg handler's license shall pay an annual license fee to the State
19 Department of Agriculture with each application. The department may adopt rules establishing a
20 license fee for an egg handler. [*Except as provided in this section, the department may not adopt a rule*
21 *under this section to establish a license fee that is more than three percent higher than the fee charged*
22 *during the preceding year. When adopting a rule establishing a license fee, notwithstanding the three*
23 *percent limit, the department may round the fee amount to the next higher whole dollar amount.*] The
24 department may not change the amount of the egg handler's license fee more frequently than once
25 each year.

26 **SECTION 44.** ORS 635.030, as amended by section 17 of this 2012 Act, is amended to read:

27 635.030. (1) Any person desiring to or who does engage in the business of a nonalcoholic
28 beverage manufacturer shall apply to the State Department of Agriculture for a license for each
29 plant operated by such person. The application shall be in such form and contain such information
30 as the department may prescribe.

31 (2) The department may adopt rules establishing license fee schedules for nonalcoholic beverage
32 manufacturers. The department may determine the license fee for a manufacturer based upon the
33 annual gross sales by the manufacturer. In establishing the amount of the license fee for a man-
34 ufacturer, the department shall use the annual gross sales by that manufacturer within Oregon
35 during the prior calendar year or, if the manufacturer maintains sales records on a fiscal basis, the
36 prior fiscal year. If the manufacturer applying for an original license or for a renewal license cannot
37 provide the annual gross sales for a full calendar year, the department shall base the fee on esti-
38 mated annual gross sales by the manufacturer. If a manufacturer whose previous year's fee was de-
39 termined using an estimated gross sales figure applies for renewal of that license, the fee for the
40 previous license year shall be adjusted to reflect the actual gross sales by the manufacturer.

41 (3) [*Except as provided in this subsection, the department may not adopt a rule under this section*
42 *to establish a license fee that is more than three percent higher than the license fee charged during the*
43 *preceding year for a manufacturer having the same volume of gross sales. When adopting a rule es-*
44 *tablishing a license fee, notwithstanding the three percent limit, the department may round the fee*
45 *amount to the next higher whole dollar amount.*] Fee schedules adopted under this section may not

1 increase the amount of the same license fee more frequently than once each year.

2 (4) Licenses issued under this section shall expire on June 30 next following the date of issuance
3 or on such date as may be specified by department rule. The department shall collect a license fee
4 for each license and for each renewal of a license. The fee shall be remitted by the department to
5 the State Treasurer. The State Treasurer shall place all moneys received under this section in the
6 Department of Agriculture Service Fund. Moneys from fees imposed under this section are contin-
7 uously appropriated to the department for the purpose of administering and enforcing the provisions
8 of this chapter.
