

House Bill 4175

Sponsored by COMMITTEE ON RULES

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Permits certain counties to use federal forest reserve moneys in county road funds for law enforcement purposes if sufficient amount of federal moneys is received by county.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to county road funds; creating new provisions; amending section 4, chapter 894, Oregon
3 Laws 2007; repealing section 4, chapter 894, Oregon Laws 2007; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** Section 4, chapter 894, Oregon Laws 2007, as amended by section 1, chapter 556,
6 Oregon Laws 2011, is amended to read:

7 **Sec. 4.** (1) Notwithstanding ORS 294.060 and 368.705, moneys described in ORS 294.060 (1) that
8 are received by Douglas County and deposited into its road fund may be expended for the patrolling
9 of Douglas County roads by Douglas County law enforcement officials.

10 (2) Notwithstanding ORS 294.060 and 368.705, moneys described in ORS 294.060 (1) that are re-
11 ceived by Lane County and deposited into its road fund may be expended for the patrolling of Lane
12 County roads by Lane County law enforcement officials.

13 **(3) Except as provided in subsections (1) and (2) of this section and notwithstanding ORS**
14 **294.060 and 368.705, moneys described in ORS 294.060 (1) that are received by a county and**
15 **deposited into the county's road fund may be expended for the patrolling of roads within the**
16 **county by county law enforcement officials only if the average amount of moneys received**
17 **by the county under ORS 293.560 (1) over the 10 years immediately preceding the current**
18 **fiscal year is greater than 10 percent of the moneys deposited into the county's general fund**
19 **for the same 10-year period.**

20 *[(3) This section is repealed on January 2, 2016.]*

21 *[(4) This section applies to moneys described in subsections (1) and (2) of this section that are re-*
22 *ceived before, on or after September 27, 2007.]*

23 **SECTION 2.** The amendments to section 4, chapter 894, Oregon Laws 2007, by section 1
24 of this 2012 Act, apply to moneys received by a county before, on or after the effective date
25 of this 2012 Act.

26 **SECTION 3.** Section 4, chapter 894, Oregon Laws 2007, as amended by section 1, chapter
27 556, Oregon Laws 2011, and section 1 of this 2012 Act, is repealed on January 2, 2016.

28 **SECTION 4.** This 2012 Act being necessary for the immediate preservation of the public
29 peace, health and safety, an emergency is declared to exist, and this 2012 Act takes effect
30 on its passage.
