SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires beneficiary or beneficiary's agent under residential trust deed to send notice of mediation and enter into mediation with grantor for purpose of agreeing to foreclosure avoidance measure. Specifies form and content of notice of mediation, date by which notice must be sent and method of service.

Specifies duties of beneficiary or beneficiary's agent with respect to mediation. Requires beneficiary or beneficiary's agent to record certificate of compliance from mediation service provider in order to proceed with foreclosure of trust deed.

Permits grantor that is at risk of default to request mediation with beneficiary or beneficiary's agent.

Establishes Foreclosure Avoidance Mediation Fund. Continuously appropriates moneys in fund to Attorney General for purposes of paying expenses of coordinating mediation program and related expenses.

Requires trustee to notify certain persons if [*trustee*] **person** postpones trustee's sale.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to foreclosures of residential trust deeds; creating new provisions; amending ORS 86.705,
3 86.735, 86.740, 86.742 and 86.755; appropriating money; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Sections 2, 3 and 4 of this 2012 Act are added to and made a part of ORS**
6 **86.705 to 86.795.**

7 **SECTION 2. (1) As used in this section and section 3 of this 2012 Act, "foreclosure**
8 **avoidance measure" means an agreement between a beneficiary and a grantor that uses one**
9 **or more of the following methods to modify an obligation that is secured by a trust deed:**

10 (a) **The beneficiary defers or forbears from collecting one or more payments due on the**
11 **obligation.**

12 (b) **The beneficiary modifies, temporarily or permanently, the payment terms or other**
13 **terms of the obligation.**

14 (c) **The beneficiary accepts a deed in lieu of foreclosure from the grantor.**

15 (d) **The grantor conducts a short sale.**

16 (e) **The beneficiary provides the grantor with other assistance that enables the grantor**
17 **to avoid a foreclosure.**

18 (2)(a) **Except as provided in paragraph (d) of this subsection, a beneficiary that seeks to**
19 **foreclose a residential trust deed under ORS 86.735 shall enter into mediation with the**
20 **grantor for the purpose of negotiating a foreclosure avoidance measure in accordance with**

1 the provisions of this section.

2 (b) The Attorney General shall:

3 (A) Appoint a mediation service provider to coordinate a mediation program and shall
4 enter into an agreement to pay the mediation service provider for the mediation service
5 provider's services from the Foreclosure Avoidance Mediation Fund established in section 4
6 of this 2012 Act. The appointment and the agreement are not subject to ORS chapter 279A
7 or 279B.

8 (B) Prescribe qualifications, training and experience requirements for mediators by rule.

9 (C) Set the schedule of fees for the mediation by rule.

10 (c) The beneficiary and the grantor shall share the cost of the mediation, except that the
11 grantor's portion of the cost may not exceed \$200.

12 (d) The requirement to enter into mediation with a grantor does not apply to a benefi-
13 cary:

14 (A) If the beneficiary provides to the Attorney General a sworn affidavit that states that,
15 during a period of one year that includes and precedes the date on which a notice of sale
16 was given under ORS 86.740 with respect to the trust deed the beneficiary seeks to foreclose,
17 the trustee or beneficiary or an affiliate of the trustee or beneficiary has not commenced
18 more than a total of 250 actions to foreclose a residential trust deed by advertisement and
19 sale under ORS 86.735 or a residential mortgage by suit under ORS 88.010; or

20 (B) If the grantor fails to confirm that the grantor will enter into mediation by the date
21 specified under subsection (3)(c) of this section.

22 (3) Within 30 days after the date on which the beneficiary caused a notice of mediation
23 to be served or mailed as provided in ORS 86.740, the mediation service provider shall send
24 a notice to the grantor and the beneficiary that:

25 (a) Schedules a date, time and location for the mediation. The date must be not earlier
26 than 45 days and not later than 90 days after the date on which the notice of mediation was
27 served or mailed as provided in ORS 86.740.

28 (b) Identifies and provides contact information for the mediation service provider.

29 (c) Specifies a date at least 15 days before the scheduled date of the mediation by which
30 the grantor must contact the mediation service provider to confirm that the grantor will
31 enter into mediation. The notice must state that the mediation service provider will deem
32 the grantor to have declined to enter into mediation if the grantor fails to confirm by the
33 specified date.

34 (d) Lists the costs of the mediation and specifies the portion of the costs for which the
35 grantor is responsible.

36 (e) Provides any other information that the Attorney General requires by rule.

37 (4)(a) If the grantor confirms by the date specified under subsection (3)(c) of this section
38 that the grantor will enter into mediation, the beneficiary or the beneficiary's agent shall
39 appear at the time and the location identified in the mediation service provider's notice un-
40 der subsection (3) of this section with the documentation described in paragraph (b) of this
41 subsection.

42 (b) The beneficiary or the beneficiary's agent must appear at the location for the medi-
43 ation with:

44 (A) The grantor's complete payment history for the obligation that is secured by the
45 residential trust deed that the beneficiary seeks to foreclose;

1 **(B) Evidence that the beneficiary is the real party in interest with respect to the obli-**
2 **gation, including but not limited to:**

3 **(i) A true copy of the original debt instrument that is the basis for the right the benefi-**
4 **ciary claims to foreclose the trust deed; and**

5 **(ii) Documents that show the chain of title for the property that is subject to the resi-**
6 **dential trust deed from the date of the original loan for which the beneficiary seeks fore-**
7 **closure to the date of the notices given under ORS 86.740, including conveyances,**
8 **endorsements and assignments of the residential trust deed, the note and the security in-**
9 **strument, whether recorded or unrecorded;**

10 **(C) A copy of the authorization from the beneficiary to the beneficiary's agent, if the**
11 **beneficiary's agent appears at the mediation;**

12 **(D) A copy of any of the following documents that apply to the note or obligation that is**
13 **secured by the trust deed:**

14 **(i) A servicing agreement the beneficiary entered into with another person; or**

15 **(ii) An agreement by means of which the beneficiary pledged as collateral for a security**
16 **the beneficiary issued or sold all or a portion of the ownership interest in the note or other**
17 **obligation; and**

18 **(E) Other documentation the Attorney General specifies by rule.**

19 **(c) The beneficiary or the beneficiary's agent that enters into mediation with the grantor**
20 **must have or be able to obtain, before the initial mediation session concludes, authority to**
21 **accept or reject a proposal for a foreclosure avoidance measure and authority to enter with**
22 **the grantor into an agreement for a foreclosure avoidance measure.**

23 **(5)(a) The beneficiary or the beneficiary's agent must enter into mediation in accordance**
24 **with mediation guidelines the Attorney General establishes by rule.**

25 **(b) If the beneficiary or the beneficiary's agent agrees with the grantor on a foreclosure**
26 **avoidance measure, the beneficiary or beneficiary's agent and the grantor shall set forth the**
27 **terms of the foreclosure avoidance measure in a written agreement, a copy of which the**
28 **beneficiary or beneficiary's agent shall provide to the Attorney General. The beneficiary may**
29 **elect to pay the grantor's portion of the cost of the mediation or the grantor and the bene-**
30 **fiary may agree to include the cost of the mediation as part of and in accordance with any**
31 **payment plan that is part of the foreclosure avoidance measure.**

32 **(c) If the beneficiary or the beneficiary's agent and the grantor do not agree on a fore-**
33 **closure avoidance measure, the mediation service provider shall notify the Attorney General**
34 **that the mediation did not result in an agreement.**

35 **(6)(a) At the conclusion of the mediation, if the beneficiary has complied with the re-**
36 **quirements of subsections (4) and (5) of this section, the mediation service provider shall**
37 **provide the beneficiary or the beneficiary's agent with a certificate of compliance in a form**
38 **and with contents that the Attorney General specifies by rule. The certificate must state**
39 **that the beneficiary has complied with the requirements of this section.**

40 **(b) If the grantor does not confirm by the date specified under subsection (3)(c) of this**
41 **section that the grantor will enter into mediation, the mediation service provider shall pro-**
42 **vide the beneficiary or the beneficiary's agent with a certificate of compliance in a form and**
43 **with contents that the Attorney General specifies by rule. The certificate must state that**
44 **the grantor declined to enter into mediation with the beneficiary.**

45 **(c) The mediation service provider shall provide a copy of the certificate the mediation**

1 service provider issues under paragraph (a) or (b) of this subsection to the grantor and to
2 the Attorney General.

3 (7)(a) A grantor that is at risk of default before the beneficiary or the trustee has filed
4 a notice of default for recording under ORS 86.735 may notify the beneficiary or trustee in
5 the trust deed or the beneficiary's or trustee's agent that the grantor wants to enter into
6 mediation. Within 10 days after receiving the request, the beneficiary or trustee or the
7 beneficiary's or trustee's agent shall respond to the grantor's request and shall notify the
8 Attorney General and the mediation service provider identified in subsection (2)(b) of this
9 section. The response to the grantor must include contact information for the Attorney
10 General and the mediation service provider.

11 (b) A grantor that requests mediation under paragraph (a) of this subsection may also
12 notify the Attorney General and the mediation service provider of the request. The Attorney
13 General shall post on the Department of Justice website contact information for the medi-
14 ation service provider and an address or method by which the grantor may notify the At-
15 torney General.

16 (c) Within 10 days after receiving notice of the request under paragraph (a) of this sub-
17 section, the mediation service provider shall send a notice to the grantor and the beneficiary
18 that, except with respect to the date by which the mediation service provider must send the
19 notice, is otherwise in accordance with the provisions of subsection (3) of this section.

20 (d) A beneficiary or beneficiary's agent that receives a request under paragraph (a) of
21 this subsection is subject to the same duties as are described in subsections (2), (4) and (5)
22 of this section.

23 **SECTION 3.** The notice of mediation required under ORS 86.740 (1)(b) must be in a form
24 and with the contents the Attorney General specifies by rule and must:

25 (1) List the name, address, telephone number and other contact information for the
26 grantor or other person named in the residential trust deed.

27 (2) Specify the account number or other means by which the beneficiary or trustee or
28 an agent of the beneficiary or trustee identifies the obligation that is secured by the resi-
29 dential trust deed.

30 (3) Provide the address, telephone number and other contact information for:

31 (a) The beneficiary or an agent of the beneficiary that the beneficiary authorizes to ne-
32 gotiate on the beneficiary's behalf;

33 (b) The Oregon State Bar's Lawyer Referral Service;

34 (c) Service agencies or other providers that offer free or low-cost legal services from a
35 list of agencies or providers that the Attorney General adopts by rule; and

36 (d) A list of not-for-profit housing counselors approved by the United States Department
37 of Housing and Urban Development or an agency of this state.

38 (4) State that section 2 of this 2012 Act requires the beneficiary to enter into mediation
39 with the grantor for the purpose of negotiating a foreclosure avoidance measure.

40 (5) List the documents the grantor must bring to the mediation. The Attorney General
41 by rule shall specify the documents the grantor must bring.

42 (6) State that the grantor may choose to have an attorney or a housing counselor ap-
43 proved by the United States Department of Housing and Urban Development represent the
44 grantor at the mediation.

45 (7) State the costs of the mediation and specify the maximum cost for which the grantor

1 will be responsible.

2 (8) State that the mediation and mediation communications, as defined in ORS 36.110, are
3 confidential in accordance with and to the extent provided in ORS 36.220 to 36.238.

4 (9) State that within 30 days after the date of the notice a mediation service provider
5 will send another notice to the grantor with a date, time and location for the mediation and
6 with the other information specified in section 2 (3) of this 2012 Act.

7 **SECTION 4.** (1) The Foreclosure Avoidance Mediation Fund is established in the State
8 Treasury, separate and distinct from the General Fund. The fund consists of moneys the
9 Attorney General collects or receives for the purpose of paying the expenses of coordinating
10 a mediation program under section 2 of this 2012 Act and related expenses. The moneys in
11 the fund are continuously appropriated to the Attorney General for the purposes of paying
12 the expenses of coordinating the mediation program and related expenses.

13 (2) The Attorney General may receive moneys for the purposes set forth in subsection
14 (1) of this section from any public or private source.

15 (3)(a) Except as provided in paragraph (b) of this subsection, a trustee or beneficiary that
16 files a notice of default under ORS 86.735 shall pay to the county clerk that records the no-
17 tice \$100 in addition to and not in lieu of any fee that the county clerk charges for recording
18 the notice of default. The county clerk at the end of each month shall forward the proceeds
19 of the \$100 charge to the Attorney General for deposit into the fund described in subsection
20 (1) of this section.

21 (b) A trustee or beneficiary is not subject to the \$100 charge described in paragraph (a)
22 of this subsection if the trustee or beneficiary provides to the county clerk a sworn affidavit
23 that states that, during a period of one year that includes and precedes the date on which
24 the trustee or beneficiary presents the notice of default for recording, the trustee or bene-
25 ficiary or an affiliate of the trustee or beneficiary has not commenced more than a total of
26 250 actions to foreclose a residential trust deed by advertisement and sale under ORS 86.735
27 or a residential mortgage by suit under ORS 88.010.

28 **SECTION 5.** ORS 86.705 is amended to read:

29 86.705. As used in ORS 86.705 to 86.795:

30 (1) "Affordable housing covenant" has the meaning given that term in ORS 456.270.

31 (2) "Beneficiary" means a person named or otherwise designated in a trust deed as the person
32 for whose benefit a trust deed is given, or the person's successor in interest, and who is not the
33 trustee unless the beneficiary is qualified to be a trustee under ORS 86.790 (1)(d).

34 (3) "Eligible covenant holder" has the meaning given that term in ORS 456.270.

35 (4) "Grantor" means the person that conveys an interest in real property by a trust deed as
36 security for the performance of an obligation.

37 (5) "Residential trust deed" means a trust deed on property upon which are situated four or
38 fewer residential units, one of which the grantor, the grantor's spouse or the grantor's minor or
39 dependent child occupies as a principal residence at the time a [*trust deed foreclosure is*
40 *commenced*] **default on the obligation secured by the trust deed first occurs.**

41 (6) "Residential unit" means an improvement designed for residential use.

42 (7) "Trust deed" means a deed executed in conformity with ORS 86.705 to 86.795 that conveys
43 an interest in real property to a trustee in trust to secure the performance of an obligation the
44 grantor or other person named in the deed owes to a beneficiary.

45 (8) "Trustee" means a person, other than the beneficiary, to whom a trust deed conveys an in-

1 terest in real property, or the person's successor in interest, or an employee of the beneficiary, if
2 the employee is qualified to be a trustee under ORS 86.790.

3 **SECTION 6.** ORS 86.735 is amended to read:

4 86.735. *[The]* **A** trustee may foreclose a trust deed by advertisement and sale in the manner
5 provided in ORS 86.740 to 86.755 if:

6 (1) The trust deed, any assignments of the trust deed by the trustee or the beneficiary and any
7 appointment of a successor trustee are recorded in the mortgage records in the counties in which
8 the property described in the deed is situated; *[and]*

9 (2) There is a default by the grantor or other person *[owing]* **that owes** an obligation, the per-
10 formance of which is secured by the trust deed, or by *[their]* **the grantor's or other person's** suc-
11 cessors in interest with respect to *[any]* **a** provision in the deed *[which]* **that** authorizes sale in the
12 event of default of *[such]* **the** provision; *[and]*

13 (3) The trustee or beneficiary has filed for record in the county clerk's office in each county
14 where the trust property, or some part of *[it]* **the trust property**, is situated, a notice of default
15 containing the information required by ORS 86.745 and containing the trustee's or beneficiary's
16 election to sell the property to satisfy the obligation; *[and]*

17 **(4) The beneficiary or the beneficiary's agent has filed for recording in the official records**
18 **of the county or counties in which the property that is subject to the residential trust deed**
19 **is located the certificate of compliance the beneficiary received under section 2 of this 2012**
20 **Act, if the beneficiary must enter into mediation with the grantor under section 2 (2)(a) of**
21 **this 2012 Act; and**

22 *[(4)]* **(5) [No] An** action has **not** been *[instituted]* **commenced** to recover the debt or any part
23 of *[it]* **the debt** then remaining secured by the trust deed, or, if *[such]* **an** action has been
24 *[instituted]* **commenced**, the action has been dismissed, except that:

25 (a) Subject to ORS 86.010 and the procedural requirements of ORCP 79 and 80, an action may
26 be *[instituted]* **commenced** to appoint a receiver or to obtain a temporary restraining order during
27 foreclosure of a trust deed by advertisement and sale, except that a receiver *[shall]* **may** not be
28 appointed with respect to a single-family residence *[which is occupied as the principal residence of]*
29 **that** the grantor, the grantor's spouse or the grantor's minor or dependent child **occupies as a**
30 **principal residence.**

31 (b) An action may be commenced *[for the judicial or nonjudicial foreclosure of]* **to foreclose,**
32 **judicially or nonjudicially,** the same trust deed as to any other property covered *[thereby]* **by the**
33 **trust deed,** or any other trust deeds, mortgages, security agreements or other consensual or
34 nonconsensual security interests or liens *[securing]* **that secure** repayment of the debt.

35 **SECTION 7.** ORS 86.740 is amended to read:

36 86.740. (1)(a) **Except as provided in paragraph (b) of this subsection,** subsequent to recording
37 notice of default as provided in ORS 86.735 and at least 120 days before the day the trustee conducts
38 the sale, notice of the sale *[shall]* **with the contents described in ORS 86.745 must** be served
39 pursuant to ORCP 7 D(2) and 7 D(3) or mailed by both first class and certified mail with return re-
40 ceipt requested[.].

41 **(b) If the sale is for the purpose of foreclosing a residential trust deed, the notice of sale**
42 **must be served or mailed in the manner provided in paragraph (a) of this subsection at least**
43 **180 days before the date of the sale. A separate notice of mediation, in the form and with the**
44 **contents described in section 3 of this 2012 Act, must accompany the notice of sale if the**
45 **beneficiary in the trust deed must enter into mediation with the grantor under section 2**

1 **(2)(a) of this 2012 Act.**

2 **(2) The notices described in subsection (1) of this section must be served or mailed** to the
3 last-known address of the following persons or *[their]* **the** legal representatives **of the persons**, if
4 any:

5 (a) The grantor in the trust deed.

6 (b) Any successor in interest to the grantor whose interest appears of record, or of whose in-
7 terest the trustee or the beneficiary has actual notice.

8 (c) Any person, including the Department of Revenue or *[any other]* **another** state agency,
9 *[having]* **that has** a lien or interest subsequent to the trust deed if the lien or interest appears of
10 record or the beneficiary has actual notice of the lien or interest.

11 (d) *[Any]* **A** person *[requesting]* **that requests** notice as provided in ORS 86.785.

12 **(e) The mediation service provider that the Attorney General appoints under section 2**
13 **(2)(b) of this 2012 Act, if the notices are served or mailed under subsection (1)(b) of this**
14 **section.**

15 *[(2)]* **(3)** A notice served by mail under subsection (1) of this section is effective when the notice
16 is mailed.

17 *[(3)(a)]* **(4)(a)** The disability, insanity or death of *[any]* **a** person to whom *[notice of sale]* **the**
18 **notices required under this section** must be given *[under this section]* does not delay or impair in
19 any way the trustee's right under a trust deed to foreclose under the deed. If the disability, insanity
20 or death occurs *[prior to the recording of]* **before the** notice of default **is recorded**, the *[notice*
21 *shall]* **notices required under this section must** be given instead to the guardian, the conservator
22 of the estate of the person or the administrator or personal representative of the person¹, *as the case*
23 *may be,* in the manner and by the time set forth in this section.

24 (b) If the disability, insanity or death of *[any]* **a** person to whom *[notice of sale]* **the notices**
25 **required under this section** must be given *[under this section]* occurs on or after the *[recording*
26 *of]* notice of default **is recorded**, the trustee shall, if and when the trustee has knowledge of the
27 disability, insanity or death, promptly give the guardian, **the** conservator of the estate or the ad-
28 ministrator or personal representative¹, *as the case may be, the notice provided in ORS 86.745. This*
29 *notice shall be given* **required notices by sending the notices** by first class and certified mail with
30 return receipt requested¹, to the last-known address of the guardian, conservator or administrator
31 or personal representative.

32 (c) *[In the event]* **If** there is no administrator or personal representative of the estate of the
33 person to whom *[notice of sale must be given]* **the notices required** under this section **must be**
34 **given**, the *[notice]* **notices** may be given instead to the heirs at law or devisees of the deceased
35 person in the manner and by the time set forth in this section.

36 *[(4)]* **(5)** If the owner of real property subject to foreclosure dies and the real property is also
37 subject to a transfer on death deed, as provided by ORS 93.948 to 93.979, *[notice of sale]* **the notices**
38 **required under this section** must be given *[under this section]* to the beneficiary designated under
39 the transfer on death deed.

40 **SECTION 8.** ORS 86.742 is amended to read:

41 86.742. (1) If the trustee fails to give notice of the sale to *[any]* **a** person entitled to notice under
42 ORS 86.740 *[(1)(c)]* **(2)(c)**, and *[such]* **the** person did not have actual notice of the sale at least 25
43 days *[prior to]* **before** the date **on which** the trustee conducted the sale, *[such]* **the** omitted person
44 *[shall have]* **has** the same rights *[possessed by]* **that** the holder of a junior lien or interest who was
45 omitted as a party defendant in a judicial foreclosure proceeding **possesses**, and the purchaser at

1 the trustee's sale or the purchaser's heirs, assigns or transferees, *[shall have]* **have** the same rights
2 *[possessed by]* **that** a purchaser at a sheriff's sale following a judicial foreclosure **possesses**.

3 (2) The omitted person may also commence an action against the trustee in the circuit court in
4 the county where the real property is located. In an action against the trustee, the omitted person
5 *[shall be]* **is** entitled to damages *[upon proof]* **if the omitted person proves** that:

6 (a) The trustee did not give notice of the sale to the omitted person in the manner required by
7 ORS 86.740 *[(1)(c)]* **(2)(c)** and 86.750;

8 (b) A search of the record under the name of the grantor as *[it]* **the grantor's name** appears
9 on the trust deed, or **as** the name of the grantor's successor in interest **appears**, would have re-
10 vealed the omitted person's interest;

11 (c) The omitted person could and would have cured the default under ORS 86.753; and

12 (d) The omitted person sustained actual damages as a result of *[such]* **the** person's loss of the
13 opportunity to cure the default under ORS 86.753 (1).

14 (3) In an action against the trustee under subsection (2) of this section, *[any]* **a** defendant or
15 third party defendant may move for dismissal on the ground that the omitted person would not or
16 could not have cured the default and reinstated the trust deed if the omitted person had received
17 the notice required by ORS 86.740 *[(1)(c)]* **(2)(c)**. The court shall hold a hearing on *[such]* **the** motion
18 *[prior to any]* **before a** hearing on *[any]* **a** motion for summary judgment, and *[prior to trial of]* **be-**
19 **fore trying** the action. The court shall deny the motion only if the omitted person produces affida-
20 vits or other evidence sufficient for a reasonable jury to find, applying a standard of clear and
21 convincing evidence, that the omitted person had the financial ability to cure the default under ORS
22 86.753 *[prior to]* **before** the date of the trustee's sale, and that the omitted person would have done
23 so had the omitted person received the notice required by ORS 86.740 *[(1)(c)]* **(2)(c)**. If the court
24 grants the motion to dismiss *[it]*, **the court** shall award attorney fees *[pursuant to]* **under** subsection
25 (5) of this section.

26 (4) In *[any]* **an** action against the trustee or *[any other]* **another** party under this section the
27 omitted person shall plead that the omitted person did not have actual knowledge of the sale at least
28 25 days prior to the date the trustee conducted the sale, but thereafter the defendant *[shall have]*
29 **has** the burden of proving that the omitted person did have *[such]* notice.

30 (5) In *[all suits]* **an action** brought under this section, the applicable court may, upon entering
31 judgment, allow to the prevailing party as a part of the costs a reasonable amount for attorney fees
32 at trial and on appeal.

32 A bona fide tenant is a residential tenant who is not the borrower (property owner), or a child,
33 spouse or parent of the borrower, and whose rental agreement:

- 34 • Is the result of an arm's-length transaction;
- 35 • Requires the payment of rent that is not substantially less than fair market rent for the
36 property, unless the rent is reduced or subsidized due to a federal, state or local subsidy; and
- 37 • Was entered into prior to the date of the foreclosure sale.

38 IMPORTANT:

39 YOU SHOULD CONTACT THE NEW OWNER OR THE OWNER'S REPRESENTATIVE AT
40 THE ADDRESS LISTED ON THIS NOTICE AS SOON AS POSSIBLE TO LET THE NEW OWNER
41 KNOW IF YOU ARE A BONA FIDE TENANT. YOU SHOULD PROVIDE WRITTEN EVIDENCE
42 OF THE EXISTENCE OF YOUR RENTAL AGREEMENT, ESPECIALLY IF YOU HAVE A FIXED
43 TERM RENTAL AGREEMENT OR LEASE WITH MORE THAN 30 DAYS LEFT. Written evidence
44 of your rental agreement can be a copy of your lease or rental agreement, or other documentation
45 of the existence of your rental agreement. Keep your original documents and a record of any infor-

1 mation you give to the new owner.

2 YOUR TENANCY
3 BETWEEN NOW
4 AND THE MOVE-OUT DATE

5 The new owner may be willing to allow you to stay as a tenant instead of requiring you to move
6 out after 30 or 60 days. You should contact the new owner if you would like to stay. If the new
7 owner accepts rent from you, signs a new residential rental agreement with you or does not notify
8 you in writing within 30 days after the date of the foreclosure sale that you must move out, the new
9 owner becomes your new landlord and must maintain the property. Otherwise:

- 10 • You do not owe rent;
11 • The new owner is not your landlord and is not responsible for maintaining the property; and
12 • You must move out by the date the new owner specifies in a notice to you.

13 The new owner may offer to pay your moving expenses and any other costs or amounts you and
14 the new owner agree on in exchange for your agreement to leave the premises in less than 30 or
15 60 days. You should speak with a lawyer to fully understand your rights before making any decisions
16 regarding your tenancy.

17 IT IS UNLAWFUL FOR ANY PERSON TO TRY TO FORCE YOU TO LEAVE YOUR
18 DWELLING UNIT WITHOUT FIRST GIVING YOU WRITTEN NOTICE AND GOING TO COURT
19 TO EVICT YOU. FOR MORE INFORMATION ABOUT YOUR RIGHTS, YOU SHOULD CONSULT
20 A LAWYER. If you believe you need legal assistance, contact the Oregon State Bar and ask for the
21 lawyer referral service. Contact information for the Oregon State Bar is included with this notice.
22 If you do not have enough money to pay a lawyer and are otherwise eligible, you may be able to
23 receive legal assistance for free. Information about whom to contact for free legal assistance is in-
24 cluded with this notice.

27 (6)(a) Except as provided in paragraph (b) or (c) of this subsection, the purchaser at the trustee's
28 sale is entitled to possession of the property on the 10th day after the sale. A person that remains
29 in possession after the 10th day under any interest, except an interest prior to the trust deed, or
30 an interest the grantor or a successor of the grantor created voluntarily, is a tenant at sufferance.
31 The purchaser may obtain possession of the property from a tenant at sufferance by following the
32 procedures set forth in ORS 105.105 to 105.168 or other applicable judicial procedure.

33 (b) Except as provided in paragraph (c) of this subsection, at any time after the trustee's sale
34 the purchaser may follow the procedures set forth in ORS 105.105 to 105.168 or other applicable
35 judicial procedure to obtain possession of the property from a person that holds possession under
36 an interest that the grantor or a successor of the grantor created voluntarily if, not earlier than 30
37 days before the date first set for the sale, the person was served with not less than 30 days' written
38 notice of the requirement to surrender or deliver possession of the property.

39 (c) If the property purchased at the trustee's sale includes a dwelling unit that is subject to ORS
40 chapter 90 and an individual occupies the unit under a bona fide tenancy, the purchaser may obtain
41 possession by following the procedures set forth in ORS 105.105 to 105.168 and by using the com-
42 plaint form provided in ORS 105.124 or 105.126:

43 (A) At least 60 days after service of a written termination notice, if the bona fide tenancy is a
44 fixed term tenancy as defined in ORS 90.100; or

45 (B) At least 30 days after service of a written termination notice if the bona fide tenancy is:

1 (i) A fixed term tenancy and the purchaser intends to occupy, as the purchaser's primary resi-
2 dence, the dwelling unit that is subject to the fixed term tenancy; or

3 (ii) A month-to-month tenancy or week-to-week tenancy, as those terms are defined in ORS
4 90.100.

5 (d) If a purchaser gives a 30-day written termination notice pursuant to paragraph (c) of this
6 subsection, the purchaser may include in the notice a request that a tenant with a fixed term
7 tenancy provide written evidence of the existence of the tenancy to the purchaser at an address
8 described in the notice. Written evidence includes a copy of the rental agreement or another docu-
9 ment that shows the existence of the fixed term tenancy. Failure of the tenant to provide the re-
10 quested written evidence before the purchaser files an action for possession based on a 30-day
11 notice:

12 (A) Does not prevent the tenant from asserting the existence of the fixed term tenancy as a
13 defense to the action.

14 (B) Prevents the tenant from recovering prevailing party attorney fees or costs and disburse-
15 ments pursuant to subsection (11)(b) of this section. The 30-day notice must describe the provisions
16 of this paragraph.

17 (e) A purchaser may not commence a proceeding under ORS 105.105 to 105.168 that is authorized
18 under this subsection before the later of:

19 (A) The 10th day after the trustee's sale;

20 (B) The date specified in a written notice of the requirement to surrender or deliver possession
21 of the property if the notice is required by and is given to the person in accordance with paragraph
22 (b) of this subsection;

23 (C) The date specified in a written notice of the purchaser's intent to terminate a tenancy if the
24 notice is required by and is given to the person in accordance with paragraph (c) of this subsection;
25 or

26 (D) The date on which the term of a fixed term tenancy ends, if the property is a dwelling unit
27 and the purchaser has not terminated the tenancy in accordance with paragraph (c) of this sub-
28 section.

29 (f) A purchaser seeking to obtain possession pursuant to ORS 105.105 to 105.168 must attach
30 proof of service of a written termination notice required by paragraph (c) of this subsection to the
31 pleadings.

32 (g) In an action to obtain possession, violation of the procedures required by subsection (5) of
33 this section or paragraph (c) of this subsection is a defense for a bona fide tenant seeking to retain
34 possession.

35 (h) As used in this subsection, "bona fide tenancy" means tenancy of a dwelling unit that is
36 subject to ORS chapter 90 that results from an arm's-length transaction that occurred before the
37 date of a foreclosure sale in which:

38 (A) The mortgagor or the child, spouse or parent of the mortgagor under the contract is not the
39 tenant; and

40 (B) The rent required is not substantially less than fair market rent for the dwelling unit, unless
41 the rent is reduced or subsidized due to a federal, state or local subsidy.

42 (7) A purchaser shall serve a notice under subsection (6) of this section by one or more of the
43 following methods:

44 (a) Personal delivery to the tenant.

45 (b) First class mail to the tenant at the dwelling unit.

1 (c) First class mail to the tenant at the dwelling unit and attachment of a second notice copy.
2 The second notice copy must be attached in a secure manner to the main entrance to the portion
3 of the premises in the possession of the tenant.

4 (8) If the notice under subsection (6) of this section is served by mail pursuant to subsection
5 (7)(b) of this section, the minimum period for compliance must be extended by three days and the
6 notice must include the extension in the period stated in the notice.

7 (9)(a) Notwithstanding the provisions of subsection (6)(c) of this section and except as provided
8 in paragraph (b) of this subsection, the purchaser is not a landlord subject to the provisions of ORS
9 chapter 90 unless the purchaser:

10 (A) Accepts rent from the individual who possesses the property under a tenancy described in
11 subsection (6)(c) of this section;

12 (B) Enters into a new rental agreement with the individual who possesses the property under
13 a tenancy described in subsection (6)(c) of this section; or

14 (C) Fails to terminate the tenancy as provided in subsection (6)(c) of this section within 30 days
15 after the date of the sale.

16 (b) The purchaser may act as a landlord for purposes of terminating a tenancy in accordance
17 with the provisions of ORS 90.396.

18 (c) The purchaser is subject to the provisions of ORS 90.322, 90.375, 105.165, 659A.421 and
19 659A.425. The application of ORS 90.375 to a purchaser that does not become a landlord does not
20 impose an affirmative duty to pay for or provide services. For the purpose of damages pursuant to
21 this paragraph, "rent" refers to the amount paid by the tenant to the landlord for the right to oc-
22 cupy the unit before the foreclosure.

23 (10)(a) Except as provided in paragraph (b) of this subsection, the purchaser is not liable to the
24 individual who possesses the property under a tenancy described in subsection (6)(c) of this section
25 for:

26 (A) Damage to the property or diminution in rental value; or

27 (B) Returning a security deposit.

28 (b) A purchaser that is a landlord under the provisions of subsection (9)(a) of this section is li-
29 able to the individual who possesses the property under a tenancy described in subsection (6)(c) of
30 this section for:

31 (A) Damage to the property or diminution in rental value that occurs after the date of the
32 trustee's sale; or

33 (B) Returning a security deposit the individual pays after the date of the trustee's sale.

34 (11)(a) Except as provided in paragraph (b) of this subsection and notwithstanding an agreement
35 to the contrary, in an action or defense arising pursuant to subsection (6)(c), (d), (f) or (g), (7) or
36 (9)(c) of this section, reasonable attorney fees at trial and on appeal may be awarded to the pre-
37 vailing party together with costs and disbursements.

38 (b) If a tenant asserts a successful defense to an action for possession pursuant to subsection
39 (6)(c), (d), (f) or (g) of this section, the tenant is not entitled to prevailing party fees, attorney fees
40 or costs and disbursements if the purchaser:

41 (A) Did not know, and did not have reasonable cause to know, of the existence of a fixed term
42 tenancy when commencing the action for possession; and

43 (B) Promptly dismissed the action upon becoming aware of the existence of a fixed term tenancy.

44 (c) As used in this subsection, "prevailing party" means the party in whose favor final judgment
45 is rendered.

1 (12)(a) Notwithstanding subsection (2) of this section, except when a beneficiary has participated
2 in obtaining a stay, foreclosure proceedings that are stayed by order of the court, by proceedings
3 in bankruptcy or for any other lawful reason shall, after release from the stay, continue as if unin-
4 terrupted, if within 30 days after release the trustee sends amended notice of sale by registered or
5 certified mail to the last-known address of the persons listed in ORS 86.740 and 86.750 (1).

6 (b) In addition to the notice required under paragraph (a) of this subsection, the trustee shall
7 send amended notice of sale:

8 (A) By registered or certified mail to:

9 (i) The address provided by each person who was present at the time and place set for the sale
10 that was stayed; and

11 (ii) The address provided by each member of the Oregon State Bar who by registered or certified
12 mail requests the amended notice of sale and includes with the request the notice of default or an
13 identification number for the trustee's sale that would assist the trustee in identifying the property
14 subject to the trustee's sale and a self-addressed, stamped envelope measuring at least 8.5 by 11
15 inches in size; or

16 (B) By posting a true copy or a link to a true copy of the amended notice of sale on the trustee's
17 Internet website.

18 (13) The amended notice of sale must:

19 (a) Be given at least 20 days before the amended date of sale;

20 (b) Set an amended date of sale that may be the same as the original sale date, or date to which
21 the sale was postponed, provided the requirements of this subsection and ORS 86.740 and 86.750 are
22 satisfied;

23 (c) Specify the time and place for sale;

24 (d) Conform to the requirements of ORS 86.745; and

25 (e) State that the original sale proceedings were stayed and the date the stay terminated.

26 (14) If the publication of the notice of sale was not completed before the date the foreclosure
27 proceedings were stayed by order of the court, by proceedings in bankruptcy or for any other lawful
28 reason, after release from the stay, in addition to complying with the provisions of subsections (12)
29 and (13) of this section, the trustee shall complete the publication by publishing an amended notice
30 of sale that states that the notice has been amended following release from the stay and that con-
31 tains the amended date of sale. The amended notice must be published in a newspaper of general
32 circulation in each of the counties in which the property is situated once a week for four successive
33 weeks, except that the required number of publications must be reduced by the number of publica-
34 tions that were completed before the effective date of the stay. The last publication must be made
35 more than 20 days before the date the trustee conducts the sale.

36 **SECTION 11. (1) Sections 2, 3 and 4 of this 2012 Act and the amendments to ORS 86.705,**
37 **86.735, 86.740, 86.742 and 86.755 by sections 5 to 9 of this 2012 Act become operative 91 days**
38 **after the effective date of this 2012 Act.**

39 **(2) The Attorney General may take any action before the operative date specified in**
40 **subsection (1) of this section that is necessary to enable the Attorney General to exercise,**
41 **on and after the operative date specified in subsection (1) of this section, all of the duties,**
42 **functions and powers conferred on the Attorney General by sections 2, 3 and 4 of this 2012**
43 **Act and the amendments to ORS 86.740 by section 7 of this 2012 Act.**

44 **SECTION 12. Sections 2, 3 and 4 of this 2012 Act and the amendments to ORS 86.705,**
45 **86.735, 86.740, 86.742 and 86.755 by sections 5 to 10 of this 2012 Act apply to requests for me-**

1 **diation that a grantor sends and notices of sale and mediation that a trustee or beneficiary**
2 **or an agent of the trustee or beneficiary sends on or after the operative date specified in**
3 **section 11 of this 2012 Act.**

4 **SECTION 13. This 2012 Act being necessary for the immediate preservation of the public**
5 **peace, health and safety, an emergency is declared to exist, and this 2012 Act takes effect**
6 **on its passage.**
