SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Makes changes to membership and powers of Travel Information Council. Makes changes to policy of Oregon Motorist Information Act of 1971. Repeals provisions that sunset authority of council over rest areas. Increases, according to two-year schedule, number of rest areas over which council has managerial authority. [*Funds increase with certain moneys attributable to certain increases in fees and tax rates.*]

Allocates moneys from State Highway Fund to council to fund management of rest areas. Provides for suspension or reduction of allocation if specified revenue source for Department of Transportation is suspended or reduced.

Requires audit of council for moneys allocated to council prior to January 1, 2013.

Decreases, for biennium beginning July 1, 2011, limitation on expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and federal funds received as reimbursement from United States Department of Transportation, but excluding lottery funds and other federal funds, collected or received by Department of Transportation for rest area operation and maintenance.

Declares emergency, effective on passage.

7 **CHANGES TO MEMBERSHIP AND POWERS**
8 **OF TRAVEL INFORMATION COUNCIL**
9 **(Changes to Membership and General Powers)**

10
11 **SECTION 1.** ORS 377.835 is amended to read:

12 377.835. (1) The Travel Information Council is created as a semi-independent state agency.

13 (2) The Travel Information Council shall consist of 11 members. [*One shall be the chairperson*
14 *of the Oregon Transportation Commission or a person within the Department of Transportation desig-*
15 *nated by the chairperson and 10 appointed members as follows: Two members from among the lodging,*
16 *restaurant and recreation industries; one member from the vehicular service industry; one member from*
17 *the outdoor advertising industry; one member from the electrical sign industry; and five members from*
18 *the public at large. The public at-large members shall be appointed from among the residents of each*
19 *congressional district. None of the public at-large members shall have any financial interest in any*

1 restaurant, hotel, motel, recreational facility, garage, oil company or other vehicular service industry,
2 or in any advertising business other than shares of stock that are traded on a national stock
3 exchange.] **One shall be the chairperson of the Oregon Transportation Commission or a person**
4 **designated by the chairperson. The Governor shall appoint the other 10 members from the**
5 **public at large. The Governor shall appoint at least one member from each congressional**
6 **district. The Governor shall select members for their knowledge of, experience with or in-**
7 **terest in economic development, travel within Oregon, recreational opportunities in Oregon,**
8 **Oregon history or Oregon natural history.**

9 (3) *[The 10 appointed members shall be appointed by the Governor. Each shall be appointed to]*
10 **Each appointed member shall** serve for a term of four years *[but a]*, **but an appointed** member
11 may be removed at the pleasure of the Governor. Before the expiration of the term of *[a]* **an ap-**
12 **pointed** member, the Governor shall appoint a successor whose term begins on July 1 next follow-
13 ing. *[A]* **An appointed** member is eligible for reappointment. If there is a vacancy for any cause,
14 the Governor shall make an appointment to become effective immediately for the unexpired term.
15 *[Five shall be appointed biennially on July 2 in odd-numbered years.]*

16 (4) The council shall select one of its members as chairperson, another as vice chairperson and
17 a third as secretary. Six members shall constitute a quorum for the transaction of business. The
18 council shall meet quarterly at a time and place to be determined by the chairperson. The chair-
19 person or any three members of the council may call a special meeting upon not less than one
20 week's written notice to the other members. All members are entitled to expenses as provided by
21 ORS 292.495.

22 (5) The council may, in accordance with ORS chapter 183 and consistent with ORS 377.700 to
23 377.840, adopt, *[and from time to time]* amend and repeal rules relating to tourist oriented directional
24 signs, logo signs and motorist informational signs and all other matters necessary and appropriate
25 to carry out its responsibilities under ORS 377.700 to 377.840. The sign rules for protected areas in
26 effect on July 2, 1971, shall be continued in effect unless modified by the commission. All *[such]* rules
27 **adopted under this subsection** shall be consistent with federal laws and regulations relating to
28 highways. The Director of Transportation shall take appropriate action for the administration and
29 enforcement of orders issued and rules adopted under ORS 377.700 to 377.840, **except rules adopted**
30 **by the council under section 33, chapter 865, Oregon Laws 2009.**

31 (6) The commission may continue or amend any existing agreements and may enter into new
32 agreements with the United States or any agency thereof authorized to make agreements under
33 section 131, title 23, United States Code relating to the regulation, control and removal of signs
34 within or adjacent to the Interstate and Federal Aid Systems.

35 (7) The council shall be under the administrative control of a director who is appointed by and
36 who holds office at the pleasure of the council. The director of the *[Travel Information]* council may
37 appoint all subordinate officers and employees of the council and may prescribe their duties and fix
38 their compensation. The director of the *[Travel Information]* council may delegate to any subordi-
39 nate officer or employee any administrative duty, function or power imposed upon the council by
40 or pursuant to law.

42 **(Transitional Provisions Relating to Changes in Membership)**

44 **SECTION 2. (1) On May 1, 2012, the term of office of the current members of the Travel**
45 **Information Council shall cease and the Governor shall appoint new members to the council.**

1 **A member whose term of office has been terminated by this subsection is eligible for reap-**
2 **pointment to the council.**

3 **(2) Notwithstanding the term of office specified by ORS 377.835, of the members appointed**
4 **to the council on May 1, 2012, five shall serve for terms ending July 1, 2014, and five shall**
5 **serve for terms ending July 1, 2016.**

9 **SECTION 3. Section 4 of this 2012 Act is added to and made a part of ORS 377.700 to**
10 **377.840.**

11 **SECTION 4. The Travel Information Council created under ORS 377.835 may:**

13 **as the council determines is necessary to carry out its responsibilities under ORS 377.700 to**
14 **377.840; and**

15 **(2) Acquire, receive, hold, control, convey, sell, lease, lend, manage, operate, improve and**
16 **develop any and all property, real or personal, as the council determines is necessary to**
17 **carry out its responsibilities under ORS 377.700 to 377.840.**

20 **OREGON MOTORIST INFORMATION ACT OF 1971**

22 **SECTION 5. ORS 377.705 is amended to read:**

23 **377.705.** To promote the public safety; to preserve the recreational value of public travel on the
24 state's highways; to preserve the natural beauty and aesthetic features of such highways and adja-
25 cent areas; to provide information about and direct travelers to public accommodations, services for
26 the traveling public, campgrounds, parks, recreational areas[,] and points of scenic, historic, cultural
27 and educational interest, it is the policy of this state and the purpose of ORS 377.700 to 377.840 and
28 377.992:

29 **(1) To establish official information centers and motorist informational signs, including sign**
30 **plazas or travel plazas in appropriate locations [*for the convenient arrangement of those signs*].**

31 **(2) To provide for publication and distribution of official guidebooks and other publications.**

32 **(3) To prohibit the indiscriminate use of other outdoor advertising.**

33 **(4) To provide motorists, where feasible, [*a telephone emergency, information and reservation***
34 ***system for lodging*] **with information and access to communications systems for emergency****
35 **and travel-related purposes.**

1 **(7) The council may not use any moneys originating from a local transient lodging tax**

3 **of funding the management, maintenance, improvement and development of roadside rest**
4 **areas under this section.**

5 **SECTION 9.** ORS 366.490 is amended to read:

6 366.490. (1) The Department of Transportation shall establish by rule a permit program allowing
7 nonprofit organizations to provide free coffee or other nonalcoholic beverages and cookies at
8 roadside rest areas **managed by the department**. Cookies offered under the program must come
9 from a licensed facility. Rules adopted under this section may not restrict the program to any par-
10 ticular days of the year.

11 (2) An organization may apply for a permit to provide coffee, other beverages and cookies **at a**
12 **rest area managed by the department** by submitting a written request to an employee of the de-
13 partment designated by the department. The request shall specify the day on which the organization
14 wishes to offer the beverages and cookies and the specific rest area where they will be offered. The
15 request shall be submitted not more than 60 days prior to the date requested.

16 (3) The department shall issue a permit to the selected organization not less than 30 days in
17 advance of the date for which the permit is issued. If there is more than one request for the same
18 date and the same place, the department shall select one organization by random drawing and shall
19 issue the permit to that organization.

20 (4) The department may not issue more than one permit for the same time and place.

21 (5) An organization that receives a permit shall confine distribution of coffee, other beverages
22 or cookies to an area of the rest area designated in the permit or by the rest area attendant. The
23 organization may not obstruct access to any building or other structure in the rest area.

24 (6) An organization providing coffee, other beverages or cookies may receive donations.

25 (7) An organization may post signs identifying the organization and the activity, provided that
26 each sign is not more than 10 square feet in area and there are not more than two signs. The signs
27 may be placed only on vehicles used in connection with the provision of beverages and cookies or
28 located in the area designated for the activity.

29 (8) The department may revoke the permit of any organization that fails to comply with the
30 provisions of this section or with rules adopted by the department to implement the provisions.

31 **(9) Rules adopted by the department under this section do not apply to roadside rest**
32 **areas managed by the Travel Information Council pursuant to section 32, chapter 865,**
33 **Oregon Laws 2009.**

34 **SECTION 10.** Section 33, chapter 865, Oregon Laws 2009, is amended to read:

36 rule a permit program allowing nonprofit organizations to provide free coffee or other nonalcoholic
37 beverages and cookies at roadside rest areas [*the council is responsible for under section 32 of this*
38 *2009 Act*] **managed by the council pursuant to section 32, chapter 865, Oregon Laws 2009.**
39 Cookies offered under the program must come from a licensed facility. Rules adopted under this
40 section may not restrict the program to any particular days of the year.

41 (2) [*In lieu of applying to the Department of Transportation for a permit under ORS 366.490,*] An
42 organization may apply for a permit to provide coffee, other nonalcoholic beverages and cookies at
43 a rest area [*maintained*] **managed** by the council by submitting a written request to the council. The
44 request shall specify the day on which the organization wishes to offer the nonalcoholic beverages
45 and cookies and the specific rest area where they will be offered. The request shall be submitted

1 not less than 60 days prior to the date requested.

2 (3) The council shall issue a permit to the selected organization not less than 30 days in advance
3 of the date for which the permit is issued. If there is more than one request for the same date and
4 the same place, the council shall select one organization by random drawing and shall issue the
5 permit to that organization.

6 (4) The council may not issue more than one permit for the same time and place.

7 (5) An organization that receives a permit shall confine distribution of coffee, other nonalcoholic
8 beverages or cookies to an area of the rest area designated in the permit or by the rest area at-
9 tendant. The organization may not obstruct access to any building or other structure in the rest
10 area.

11 (6) An organization providing coffee, other nonalcoholic beverages or cookies may accept do-
12 nations at the rest area while providing coffee, other nonalcoholic beverages or cookies.

13 (7) An organization may post signs identifying the organization and the activity, provided that
14 each sign is not more than 10 square feet in area and there are not more than two signs. The signs
15 may be placed only on vehicles used in connection with the provision of nonalcoholic beverages and
16 cookies or located in the area designated for the activity.

17 (8) The council may revoke the permit of any organization that fails to comply with the pro-
18 visions of this section or with rules adopted by the council to implement the provisions of this sec-
19 tion.

7 tronic government portal, that are related to services provided by the Department of
8 Transportation; and

9 (b) Transferred by the Oregon Department of Administrative Services to the Department
10 of Transportation for deposit into the State Highway Fund.

11 (2)(a) The Oregon Transportation Commission may direct the Department of Transpor-
12 tation to suspend the allocation of funds to the Travel Information Council, or to propor-
13 tionally reduce the amount of the allocations to the council, under section 32 (5), chapter 865,
14 Oregon Laws 2009, if the collection of convenience fees is suspended or the amount of the
15 convenience fees collected by the Oregon Department of Administrative Services is reduced.

16 (b) If the allocation is suspended or reduced under paragraph (a) of this subsection, the
17 commission shall modify the intergovernmental agreement entered into by the Department
18 of Transportation and the council under section 32 (3), chapter 865, Oregon Laws 2009, to
19 suspend or reduce the council’s responsibility to manage, maintain, improve and develop
20 roadside rest areas under that agreement by an amount that is proportional to the suspen-
21 sion or reduction in funds.

23 **FINANCIAL AUDIT OF TRAVEL INFORMATION**
24 **COUNCIL FOR MONEYS ALLOCATED TO DATE**

26 **SECTION 18.** (1) The Secretary of State shall conduct a financial audit of and prepare
27 an audit report on the Travel Information Council, at the council’s expense, with respect to
28 moneys received by the council under ORS 366.752 and expended on the management, main-
29 tenance, improvement or development of rest areas under section 32, chapter 865, Oregon
30 Laws 2009, prior to the operative date specified in section 14 of this 2012 Act.

31 (2) The Secretary of State shall supply the Joint Legislative Audit Committee and the
32 Legislative Fiscal Officer with a copy of the audit report prepared by the Secretary of State
33 under subsection (1) of this section.

34 (3) The council shall report the findings of the financial audit to an interim legislative
35 committee related to transportation and an interim legislative committee related to the re-
36 view of government expenditures no later than December 31, 2012.

38 **DECREASE OF LIMITATION ON EXPENDITURES**

40 **SECTION 19.** Notwithstanding any other law limiting expenditures, the limitation on
41 expenditures established by section 2 (2), chapter 542, Oregon Laws 2011, for the biennium
42 beginning July 1, 2011, as the maximum limit for payment of expenses from fees, moneys or
43 other revenues, including Miscellaneous Receipts and federal funds received as reimburse-
44 ment from the United States Department of Transportation, but excluding lottery funds and
45 federal funds not described in this section, collected or received by the Department of

1 **Transportation, is decreased by \$691,963 for rest area operation and maintenance.**

11 **SECTION 21. This 2012 Act being necessary for the immediate preservation of the public**
12 **peace, health and safety, an emergency is declared to exist, and this 2012 Act takes effect**
13 **on its passage.**
