

# Senate Concurrent Resolution 209

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Recognizes and honors achievements of Terri Jean Frohnmayer.

## CONCURRENT RESOLUTION

2       Whereas Terri Jean Frohnmayer of Salem, Oregon, won the United States Golf Association's  
3 Senior Women's Amateur Championship on September 15, 2011, defeating heavily favored defending  
4 champion Mina Hardin of Fort Worth, Texas, and bringing the Senior Women's Amateur golf title  
5 to Oregon for the first time in the event's 49-year history; and

6       Whereas that victory marks the culmination of a long history of success playing the game of  
7 golf; and

8       Whereas Terri Jean Frohnmayer began playing golf when she was 13 years old at the urging  
9 of her mother, Shirley Thoreson, who enjoyed playing golf competitively; and

10       Whereas Terri Jean Frohnmayer, while attending Mount Si High School, played on the boys' golf  
11 team because the school did not have a girls' golf team at that time; and

12       Whereas Terri Jean Frohnmayer demonstrated great acumen for golf, playing in the 1973 United  
13 States Girls' Junior tournament, where she lost in the second round to future World Golf Hall of  
14 Fame member Betsy King, and winning the 1972 Washington State Women's Public Links tourna-  
15 ment and the 1974 Pacific Northwest Golf Association's Women's Amateur tournament; and

16       Whereas Terri Jean Frohnmayer's success playing golf led to her receiving scholarship offers  
17 from the University of Miami, Arizona State University and Rollins College in Winter Park, Florida;  
18 and

19       Whereas Terri Jean Frohnmayer, after choosing to attend Rollins College for its balanced ap-  
20 proach to athletics and academics, was a top performer for the Rollins College Women's Golf Team,  
21 which competed for the 1978 Association for Intercollegiate Athletics for Women Golf Championship;  
22 and

23       Whereas after college, Terri Jean Frohnmayer demonstrated the same vision and capacity for  
24 business and public service that she had demonstrated for golf; and

25       Whereas Terri Jean Frohnmayer at one time owned three car washes and a mail order company  
26 that sold automotive accessories; and

27       Whereas Terri Jean Frohnmayer has been a successful broker and real estate investor, con-  
28 tributing to the development of Center 50+ for the City of Salem, among other high-profile projects;  
29 and

30       Whereas Terri Jean Frohnmayer has served on a variety of boards and commissions, including

1 as president of the Salem Area Chamber of Commerce; and

2       Whereas after not picking up a golf club for 24 years, Terri Jean Frohnmayer, at the urging of  
3 her mother and her husband, Bill, returned to golf to see whether she could attain the same level  
4 of expertise she had achieved at college; and

5       Whereas Terri Jean Frohnmayer subsequently played in several tournaments, including the 2008,  
6 2009 and 2010 Pacific Northwest Golf Association's Senior Women's Amateur tournaments, winning  
7 the 2010 tournament by nine strokes; and

8       Whereas after Terri Jean Frohnmayer won the United States Golf Association's Senior Women's  
9 Amateur Championship, she was named the 2011 Senior Women's Player of the Year by the Pacific  
10 Northwest Golf Association and the 2011 Golfer of the Year by the Oregon Golf Association; and

11       Whereas the Marion County Board of Commissioners recognized the accomplishments of Terri  
12 Jean Frohnmayer by designating September 28, 2011, "Terri Frohnmayer Day" in recognition of her  
13 outstanding success as a golfer and generous contributions to community service; now, therefore,

14 **Be It Resolved by the Legislative Assembly of the State of Oregon:**

15       That we, the members of the Seventy-sixth Legislative Assembly, recognize and honor the  
16 achievements of Terri Jean Frohnmayer; and be it further

17       Resolved, That a copy of this resolution shall be presented to Terri Jean Frohnmayer.
