

**PROPOSED AMENDMENTS TO
SENATE BILL 1509**

1 On page 1 of the printed bill, line 2, after “ORS” delete the rest of the
2 line and delete lines 3 through 5 and insert “679.025, 680.020, 680.205, 687.011,
3 687.021, 687.071, 687.081 and 687.121; and declaring an emergency.”.

4 Delete lines 7 through 28 and delete pages 2 through 12.

5 On page 13, delete lines 1 through 7.

6 In line 11, delete “19” and insert “1” and delete “20” and insert “2”.

7 In line 13, delete “20” and insert “2”.

8 In line 40, delete “21” and insert “3”.

9 On page 14, line 33, delete “22” and insert “4”.

10 In line 38, after “is” insert a colon and begin a new paragraph and insert
11 “(A)” and delete the period and insert “; or

12 “(B) Exempt under rules adopted by the board pursuant to subsection (2)
13 of this section.”.

14 After line 44, insert:

15 “(2) The board may, by rule, exempt a massage facility from the prohibi-
16 tion in subsection (1) of this section if the license or temporary facility
17 permit is unnecessary for the regulation of the practice of massage therapy
18 or to protect the health and safety of the public.”.

19 In line 45, restore the bracketed material and delete the boldfaced mate-
20 rial.

21 On page 15, line 5, delete “23” and insert “5”.

22 In line 15, delete “20” and insert “2”.

1 In line 23, delete “20” and insert “2”.
2 In line 27, delete “24” and insert “6”.
3 On page 16, line 42, delete “25” and insert “7”.
4 On page 17, line 13, delete “26” and insert “8” and delete “20” and insert

11 **“PRACTICE OF DENTISTRY AND DENTAL HYGIENE**
12 **BY VOLUNTEERS**

13
14 **“SECTION 9.** ORS 679.025 is amended to read:

15 “679.025. (1) A person may not practice dentistry or purport to be a den-
16 tist without a valid license to practice dentistry issued by the Oregon Board
17 of Dentistry.

18 “(2) The requirements of this section do not apply to:

19 “(a) Dentists licensed in another state making a clinical presentation
20 sponsored by a bona fide dental society or association or an accredited dental
21 educational institution approved by the board.

22 “(b) Bona fide full-time students of dentistry who, during the period of
23 their enrollment and as a part of the course of study in an Oregon accredited
24 dental education program, engage in clinical studies on the premises of such
25 institution or in a clinical setting located off the premises of the institution
26 if the facility, the instructional staff and the course of study to be pursued
27 at the off-premises location meet minimum requirements prescribed by the
28 rules of the board and the clinical study is performed under the direct
29 supervision of a member of the faculty.

30 “(c) Bona fide full-time students of dentistry who, during the period of

1 their enrollment and as a part of the course of study in a dental education
2 program located outside of Oregon that is accredited by the Commission on
3 Dental Accreditation of the American Dental Association or its successor
4 agency, engage in community-based or clinical studies as an elective or re-
5 quired rotation in a clinical setting located in Oregon if the community-
6 based or clinical studies meet minimum requirements prescribed by the rules
7 of the board and are performed under the direct supervision of a member of
8 the faculty of the Oregon Health and Science University School of Dentistry.

9 “(d) Candidates who are preparing for a licensure examination to practice
10 dentistry and whose application has been accepted by the board or its agent,
11 if such clinical preparation is conducted in a clinic located on premises ap-
12 proved for that purpose by the board and if the procedures are limited to
13 examination only. This exception shall exist for a period not to exceed two
14 weeks immediately prior to a regularly scheduled licensure examination.

15 “(e) Dentists practicing in the discharge of official duties as employees
16 of the United States Government and any of its agencies.

17 “(f) Instructors of dentistry, whether full- or part-time, while exclusively
18 engaged in teaching activities and while employed in accredited dental edu-
19 cational institutions.

20 “(g) Dentists employed by public health agencies who are not engaged in
21 the direct delivery of clinical dental services to patients.

22 “(h) Persons licensed to practice medicine in the State of Oregon in the
23 regular discharge of their duties.

24 “(i) Persons qualified to perform services relating to general anesthesia
25 or sedation under the direct supervision of a licensed dentist.

26 “**(j) Dentists licensed in another state, while practicing dentistry**
27 **without compensation at the invitation of a dentist licensed under this**
28 **chapter. The dentist issuing the invitation must submit the name of**
29 **the visiting dentist to the board on a form approved by the board at**
30 **least 10 days before the dentist practices dentistry under this para-**

1 **graph. A dentist practicing dentistry without a license under this**
2 **paragraph may practice for no more than one period of five consec-**
3 **utive days in any 12 months.**

4 “[*j*] (k) Persons practicing dentistry upon themselves as the patient.

5 “[*k*] (L) Dental hygienists, dental assistants or dental technicians per-
6 forming services under the supervision of a licensed dentist in accordance
7 with the rules adopted by the board.

8 “[*L*] (m) A person licensed as a denturist under ORS 680.500 to 680.565
9 engaged in the practice of denture technology.

10 “[*m*] (n) An expanded practice dental hygienist who renders services
11 authorized by a permit issued by the board pursuant to ORS 680.200.

12 **“SECTION 10.** ORS 680.020 is amended to read:

13 “680.020. (1) It is unlawful for any person not otherwise authorized by law
14 to practice dental hygiene or purport to be a dental hygienist without a valid
15 license to practice dental hygiene issued by the Oregon Board of Dentistry.

16 “(2) The requirements of this section do not apply to:

17 “(a) Dental hygienists licensed in another state making a clinical pres-
18 entation sponsored by a bona fide dental or dental hygiene society or asso-
19 ciation or an accredited dental or dental hygiene education program
20 approved by the board.

21 “(b) Bona fide students of dental hygiene who engage in clinical studies
22 during the period of their enrollment and as a part of the course of study in
23 an Oregon dental hygiene education program. The program must be accred-
24 ited by the Commission on Dental Accreditation of the American Dental
25 Association, or its successor agency, if any, and approved by the board. The
26 clinical study may be conducted on the premises of the program or in a
27 clinical setting located off the premises. The facility, the instructional staff,
28 and the course of study at the off-premises location must meet minimum re-
29 quirements prescribed by the rules of the board, and the clinical study at the
30 off-premises location must be performed under the direct supervision of a

1 member of the faculty.

2 “(c) Bona fide students of dental hygiene who engage in community-based
3 or clinical studies as an elective or required rotation in a clinical setting
4 located in Oregon during the period of their enrollment and as a part of the
5 course of study in a dental hygiene education program located outside of
6 Oregon. The program must be accredited by the Commission on Dental Ac-
7 creditation of the American Dental Association or its successor agency. The
8 community-based or clinical studies must:

9 “(A) Meet minimum requirements prescribed by the rules of the board;
10 and

11 “(B) Be performed under the direct supervision of a member of the faculty
12 of the Oregon Health and Science University School of Dentistry or another
13 Oregon institution with an accredited dental hygiene education program ap-
14 proved by the board.

15 “(d) Students of dental hygiene or graduates of dental hygiene programs
16 who engage in clinical studies as part of a course of study or continuing
17 education course offered by an institution with a dental or dental hygiene
18 program. The program must be accredited by the Commission on Dental Ac-
19 creditation of the American Dental Association or its successor agency.

20 “(e) Candidates who are preparing for licensure examination to practice
21 dental hygiene and whose application has been accepted by the board or its
22 agent, if such clinical preparation is conducted in a clinic located on prem-
23 ises approved for that purpose by the board and if the procedures are limited
24 to examination only.

25 “(f) Dental hygienists practicing in the discharge of official duties as
26 employees of the United States Government and any of its agencies.

27 “(g) Instructors of dental hygiene, whether full- or part-time, while ex-
28 clusively engaged in teaching activities and while employed in accredited
29 dental hygiene educational programs.

30 “(h) Dental hygienists employed by public health agencies who are not

1 engaged in direct delivery of clinical dental hygiene services to patients.

2 “(i) Counselors and health assistants who have been trained in the ap-
3 plication of fluoride varnishes to the teeth of children and who apply
4 fluoride varnishes only to the teeth of children enrolled in or receiving ser-
5 vices from the Women, Infants and Children Program, the Oregon
6 prekindergarten program or a federal Head Start grant program.

7 “(j) **Dental hygienists licensed in another state, while practicing**
8 **dental hygiene without compensation at the invitation of a dentist li-**
9 **censed under ORS chapter 679 or a dental hygienist licensed under**
10 **ORS 680.010 to 680.205. The dentist or dental hygienist issuing the in-**
11 **invitation must submit the name of the visiting dental hygienist to the**
12 **board on a form approved by the board at least 10 days before the**
13 **dental hygienist practices dentistry under this paragraph. A dental**
14 **hygienist practicing dental hygiene without a license under this para-**
15 **graph may practice for no more than one period of five consecutive**
16 **days in any 12 months.**

18 **“EXPANDED PRACTICE DENTAL HYGIENISTS**

19

20 **“SECTION 11.** ORS 680.205 is amended to read:

21 “680.205. (1) An expanded practice dental hygienist may render all ser-
22 vices within the scope of practice of dental hygiene, as defined in ORS
23 679.010, without the supervision of a dentist and as authorized by the ex-
24 panded practice dental hygienist permit to:

25 “(a) Patients or residents of the following facilities or programs who, due
26 to age, infirmity or disability, are unable to receive regular dental hygiene
27 treatment:

28 “(A) Nursing homes as defined in ORS 678.710;

29 “(B) Adult foster homes as defined in ORS 443.705;

30 “(C) Residential care facilities as defined in ORS 443.400;

1 “(D) Adult congregate living facilities as defined in ORS 441.525;

2 “(E) Mental health residential programs administered by the Oregon
3 Health Authority;

4 “(F) Facilities for mentally ill persons, as those terms are defined in ORS
5 426.005;

6 “(G) Facilities for persons with developmental disabilities, as those terms
7 are defined in ORS 427.005;

8 “(H) Local correctional facilities and juvenile detention facilities as those
9 terms are defined in ORS 169.005, regional correctional facilities as defined
10 in ORS 169.620, youth correction facilities as defined in ORS 420.005, youth
11 care centers as defined in ORS 420.855, and Department of Corrections in-
12 stitutions as defined in ORS 421.005; or

13 “(I) Public and nonprofit community health clinics.

14 “(b) Adults who are homebound.

15 “(c) Students or enrollees of nursery schools and day care programs and
16 their siblings under 18 years of age, Job Corps and similar employment
17 training facilities, primary and secondary schools, including private schools
18 and public charter schools, and persons entitled to benefits under the
19 Women, Infants and Children Program.

20 “(d) Patients in hospitals, medical clinics, medical offices or offices oper-
21 ated or staffed by nurse practitioners, physician assistants or midwives.

22 “(e) Patients whose income is less than the federal poverty level.

23 “**(f) Residents of areas that are federally designated as health pro-**
24 **fessional shortage areas for dental care or areas in which dental pro-**
25 **viders would be eligible for the tax credit described in ORS 315.613.**

26 “[*f*] **(g) Other populations and locations** that the Oregon Board of
27 Dentistry determines are underserved or lack access to dental hygiene ser-
28 vices.

29 “(2) At least once each calendar year, an expanded practice dental
30 hygienist shall refer each patient or resident to a dentist who is available

1 to treat the patient or resident.

2 “(3) An expanded practice dental hygienist may render the services de-
3 scribed in paragraphs (a) to (d) of this subsection to the patients described
4 in subsection (1) of this section if the expanded practice dental hygienist has
5 entered into an agreement in a format approved by the board with a dentist
6 licensed under ORS chapter 679. The agreement must set forth the agreed-
7 upon scope of the dental hygienist’s practice with regard to:

8 “(a) Administering local anesthesia;

9 “(b) Administering temporary restorations without excavation;

10 “(c) Prescribing prophylactic antibiotics and nonsteroidal anti-
11 inflammatory drugs specified in the agreement; and

12 “(d) Overall dental risk assessment and referral parameters.

13 “(4) This section does not authorize an expanded practice dental hygienist
14 to administer nitrous oxide except under the indirect supervision of a dentist
15 licensed under ORS chapter 679.

16 “(5) An expanded practice dental hygienist may assess the need for and
17 appropriateness of sealants, apply sealants and write prescriptions for all
18 applications of fluoride in which fluoride is applied or supplied to patients.

19 “(6) An expanded practice dental hygienist must also procure all other
20 permits or certificates required by the board under ORS 679.250.”.
