**PROPOSED AMENDMENTS TO
HOUSE BILL 4082**

1 On page 1 of the printed bill, delete lines 3 through 5 and insert "409.185,
2 417.707, 417.710, 417.720, 417.725, 417.735, 417.775, 417.780, 417.785, 418.575,
3 418.580, 419A.004, 458.558 and 458.568; repealing 419A.170;".

4 On page 2, line 34, delete "sections 2 and 4" and insert "sections 2, 4 and
5 9".

6 In line 35, after "that" insert "is approved or sanctioned by a juvenile
7 court, has received accreditation from the National CASA Association
8 and".

9 On page 3, delete lines 4 through 9 and insert:

10 "(c) Oversee the provision of court appointed special advocate services
11 throughout this state in a uniform, consistent and cost-efficient manner by
12 ensuring that CASA Volunteer Programs:

13 "(A) Adopt policies, procedures, standards and guidelines regarding the
14 provision of court appointed special advocate services as directed by the
15 commission; and

16 "(B) Develop and provide training and education for court appointed
17 special advocates and employees and other volunteers in CASA Volunteer
18 Programs as directed by the commission."

19 In line 10, delete "(f)" and insert "(d)"

20 In line 11, delete "(g)" and insert "(e)".

21 In line 13, delete "(h)" and insert "(f)".

22 After line 28, insert:

1 “(3) Public agencies or private nonprofit organizations to whom the com-
2 mission has delegated responsibilities, or with whom the commission has
3 contracted, under this section shall provide biannual reports to the commis-
4 sion regarding:

5 “(a) The fulfillment of responsibilities that have been delegated or con-
6 tracted for; and

7 “(b) When applicable to responsibilities delegated or contracted for, the
8 achievement of the objectives in subsection (1)(c) to (f) of this section.”.

9 In line 29, delete “(3)” and insert “(4)”.

10 In line 33, delete “(1)(f)” and insert “(1)(d)”.

11 On page 5, delete lines 41 through 44 and insert:

12 **“SECTION 9. Each CASA Volunteer Program shall report**
13 **biannually to standing and interim committees of the Legislative As-**
14 **sembly related to the provision of court appointed special advocate**
15 **services. The report must include each program’s status with respect**
16 **to the statewide outcome or performance measures identified by the**
17 **Oregon Volunteers Commission for Voluntary Action and Service un-**
18 **der section 4 of this 2012 Act.**

19 **“SECTION 10. The Judicial Department, the Housing and Commu-**
20 **nity Services Department and the Oregon Volunteers Commission for**
21 **Voluntary Action and Service shall study the appropriate structure**
22 **and operation for funding and administration of the CASA Volunteer**
23 **Programs in this state and make recommendations to standing and**
24 **interim committees of the Legislative Assembly related to the pro-**
25 **vision of court appointed special advocate services no later than Sep-**
26 **tember 30, 2014.”.**

27 On page 20, line 20, after “that” insert “is approved or sanctioned by a
28 juvenile court, has received accreditation from the National CASA Associ-
29 ation and”.

30 On page 22, delete lines 37 through 45 and delete pages 23 through 43.

1 On page 44, delete lines 1 through 12.

2 In line 16, delete "53" and insert "32".

3 In line 22, delete "54" and insert "33".
