

**PROPOSED AMENDMENTS TO
HOUSE BILL 4063**

1 On page 3 of the printed bill, delete lines 41 through 45.

2 On page 4, delete lines 1 through 18 and insert:

3 **SECTION 7.** ORS 677.512 is amended to read:

4 “677.512. (1) A person seeking licensure as a physician assistant shall
5 complete an application form provided by the Oregon Medical Board and
6 submit the form to the board, accompanied by nonrefundable fees for the
7 application and for the license in amounts determined by rule of the board.

8 “(2) The board may issue a license to a physician assistant who:

9 “(a) Submits an application as required by the board by rule;

10 “(b) Pays the application fee established by the board by rule;

11 “(c) Has completed an educational program accredited by a nationally
12 recognized accreditation organization for physician assistant educational
13 programs;

14 “(d) Has passed the initial national examination required of physician
15 assistants to become nationally certified;

16 “(e) Is mentally and physically able to engage safely in practice as a
17 physician assistant;

18 “(f) Has not been disciplined by a physician assistant licensing board in
19 another state, unless the board considers the discipline and determines that
20 the person is competent to practice as a physician assistant; and

21 “(g) Is of good moral character as determined by the board.

22 “(3) The board may issue a license by reciprocity to a person who is li-

1 censed as a physician assistant in another state and meets the requirements
2 of subsection (2)(c) and (d) of this section.

3 “(4)(a) The board shall adopt necessary and proper rules to govern the
4 renewal of licenses issued under this section.

5 “(b) **If the board requires a licensee to complete continuing educa-**
6 **tion in order to renew a license issued under this section, the board**
7 **shall allow a licensee to meet those requirements by providing the**
8 **board with documentation of military training or experience that is**
9 **substantially equivalent to the continuing education required by the**
10 **board.”.**

11 On page 16, line 8, delete “department” and insert “Department of Public
12 Safety Standards and Training”.

13 In line 9, delete “board” and insert “department”.

14 On page 17, delete lines 30 through 34 and insert:

15 “**SECTION 31. (1) The amendments to ORS 181.875, 672.105, 672.118,**
16 **675.030, 675.240, 675.250, 678.442, 680.515, 680.520, 681.260, 681.264, 681.360,**
17 **684.040, 688.050, 688.455, 688.650, 688.720, 688.815, 688.819, 689.255, 689.490,**
18 **690.047, 692.045, 692.105, 703.080, 703.090, 703.415 and 807.040 by sections**
19 **1 to 6 and 8 to 30 of this 2012 Act apply to applications for licenses,**
20 **certificates and registrations submitted on or after the effective date**
21 **of this 2012 Act.**

22 “(2) **The amendments to ORS 677.512 by section 7 of this 2012 Act**
23 **apply to applications for renewal of a license submitted on or after the**
24 **effective date of this 2012 Act.”.**
