APPOINTMENT/CONFIRMATION AUTHORITY: ORS 777.925

TERM: Four year terms: November 22, 2013 – November 21, 2017

ECONOMIC INTEREST FILING (ORS 244.050): Not required.

STATUTORY QUALIFICATIONS: ORS 777.923 - 777.927

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Five commissioners (FARM, GARCIA, HANSEN, KRONSTEINER, OPITZ,)
- Electors registered in the port district and who have resided within the port for one year immediately preceding appointment; U.S. citizenry
- Removal for malfeasance after statement of charges, notice, court hearing or unexcused absence from regular or special meetings for 60 days

DUTIES AND AUTHORITY: ORS 777.065 to 777.135, 777.920 to 777.953

The power and authority given to the port is vested in the board of commissioners. The duties and authorities include:

- Full control over the bays, rivers and harbors within its limits, and between its limits and the sea
- Improving bays, rivers and harbors for the width and length and to the depth the port considers necessary or convenient for the use of shipping
- May borrow money, issue and sell general obligation bonds
- Exercise such powers as is usual and customary with similar bodies
- May initiate a proposal for annexation of territory that is not within another port
- Report biennially to Legislative Assembly.
