- No member shall have any pecuniary interest, other than an incidental interest which is disclosed and made a matter of public record at the time of appointments, in any corporation or other business entity doing business in the workers' compensation insurance industry.

**DUTIES AND AUTHORITY:** ORS 656.751

- Select chair and vice-chair
- Meet at least quarterly
- Establish policies for operation of SAIF consistent with law
- Report on activities to Governor and Legislative Assembly
