- One registered professional mechanical engineer (**DANCEY**)
- One officer or employee of the Department of Human Services (**PERRY**)
- One plumbing equipment supplier who otherwise qualifies by experience in the industry or one building official (**VILENDRE**)
- One member of the general public (**HEINICKE**)

DUTIES AND AUTHORITY: **ORS 693.120**

- Examine all persons applying for certificates to engage in the trade or business of plumbing or as journeyman plumbers
- Meet at least four times per year at time and place specified by Director of Department of Consumer and Business Services after consultation with board
- Establish fees
- Advise in formulating plumbing codes
