#### Public Hearing and Possible Work Session

- HB 2027  
FIRST PUBLIC HEARING: Requires State Department of Fish and Wildlife to develop and implement program to provide technical assistance to Oregon landowners, businesses and communities regarding nonlethal options to reduce conflict between humans and wildlife.
- HB 2697  
FIRST PUBLIC HEARING: Provides that person may return fish carcass to water from which person caught fish under certain circumstances.
- HB 3086  
FIRST PUBLIC HEARING: Provides that private entity that proposes action that affects core area habitat of sage grouse shall give State Department of Fish and Wildlife certain report.
- HB 3262  
FIRST PUBLIC HEARING: Requires State Fish and Wildlife Commission to issue permits for removal of certain crab pots.

#### Work Session

- HB 2252  
Allows State Fish and Wildlife Commission by rule to establish multiyear licenses.
- HB 2249  
Establishes Willamette River Basin Bonneville Power Administration Stewardship Fund.
- HB 2649  
Removes requirement that grant to purchase Oregon food products and to fund certain educational activities be allocated in specified percentage.
