Directs Oregon Business Development Department to develop and implement Beginning and Expanding Farmer Lo Program to assist beginning farmers with acquisition of agricultural land, agricultural improvements and depreciable agricultural property.

Establishes Willamette River Basin Bonneville Power Administration Stewardship Fund. HB 3199
