Public Hearing and Possible Work Session

- HB 2615
FIRST PUBLIC HEARING: Eliminates requirement to mark or brand floated or transported forest products and booming equipment.
- HB 2745
FIRST PUBLIC HEARING: Allows action to enjoin or restrain nuisance if place is used for certain activities involving animals.
- HB 2841
FIRST PUBLIC HEARING: Requires that at least 30 days before agencies give notice of intended action to adopt, amend or repeal rules pertaining to recreational or small scale mining, agencies shall perform certain consultation.
- HB 3408
FIRST PUBLIC HEARING: Deletes statutory preference for placing forfeited animal with person having prior contact with animal.
- HB 3452
FIRST PUBLIC HEARING: Describes circumstances in which gray wolves may be taken.

- HB 2032 ** **Subsequent Referral(s) to Ways and Means
Sets forth requirements for payments for off-site compensatory mitigation to Oregon Removal-Fill Mitigation Fund
- HB 2259 ** **Subsequent Referral(s) to Ways and Means
Increases certain fees charged by Water Resources Department.
- HB 2427
CARRIED OVER FROM THE 4/11/2013 AGENDA: Prohibits raising canola within Willamette Valley.
- HB 2624
Provides that county is exempt from applicability of statute banning use of dogs to hunt black bears or cougars and use of bait to hunt black bears if voters approve county measure proposed by initiative petition or referred to people by governing body of county.
- HB 3364 ** **Subsequent Referral(s) to Ways and Means
Amends list of state agencies and public universities required to adopt integrated pest management practices.

- HB 3395 ** **Subsequent Referral(s) to Ways and Means
Requires State Department of Fish and Wildlife to recommend rules to State Fish and Wildlife Commission regarding creation of pilot program that allows persons to use dogs to hunt or pursue cougars.
- HB 3437
Requires certain qualifications for appointment as member of State Fish and Wildlife Commission.
- HJM 2
Urges United States Secretary of Interior to allow enhanced management of cormorants by State of Oregon.
- HJR 16
Proposes amendment to Oregon Constitution establishing right to hunt, to fish, to trap and to harvest wildlife.
