- SB 199 A  
CARRIED OVER FROM 5/2/2013 AGENDA: Changes approval process for lease transferring all or part of existing water right for use as in-stream water right.
- SB 200 A  
CARRIED OVER FROM 5/2/2013 AGENDA: Allows record landowner holding certain water rights to apply for assignment of all or part of water right to owner of land to which water right pertains.

#### Work Session

- SB 25 A  
CARRIED OVER FROM 5/2/2013 AGENDA: Provides that State Marine Board has authority over certain charter boats carrying seven or more passengers.
- SB 26  
CARRIED OVER FROM 5/2/2013 AGENDA: Authorizes State Marine Board to make grants from funds received through federal Boating Infrastructure Grant Program.
- SB 31  
CARRIED OVER FROM 5/2/2013 AGENDA: Allows representatives of certain landowners to serve on forestland classification committees.
- SB 198 A  
CARRIED OVER FROM 5/2/2013 AGENDA: Provides that in certain cases court may order State Fish and Wildlife Commission to revoke licenses or permits issued under commercial fishing laws.
- SB 571  
CARRIED OVER FROM 5/2/2013 AGENDA: Adds State Marine Director, or designated representative, and one appointed member to Invasive Species Council.
