FIRST PUBLIC HEARING: Exempts employees of attorneys from licensure and other requirements relating to tax return preparation.

HB 2340

FIRST PUBLIC HEARING: Modifies provisions requiring public body to provide workers' compensation coverage for qualified emergency service volunteers.

HB 2478 \*\*

\*\*Subsequent Referral(s) to Tax Credits

FIRST PUBLIC HEARING: Extends sunset for tax credit for payments to employee and dependent scholarship programs.

HB 2655 \*\*

\*\*Subsequent Referral(s) to Ways and Means

FIRST PUBLIC HEARING: Establishes Task Force on Lowering Barriers to Entering a Profession for purpose of studying barriers to entering professions not related to health care.

HB 2070

FIRST PUBLIC HEARING: Requires banking institution board of directors to hold regular meeting at least once every two months.

##### Work Session

HB 2242

Allows use of alternate definition of "base year" only if use makes individual eligible for unemployment insurance benefits.
