HB 2448

CARRIED OVER FROM THE 2/22/2013 AGENDA: Requires issue subject to collective bargaining during term of collective bargaining agreement that is not resolved through negotiation or mediation to be resolved through binding arbitration.

HB 2688

FIRST PUBLIC HEARING: Changes from \$250 to \$1,000 value of chattel for which person that forecloses lien on chattel by sale must file statement of account with recording officer of county in which sale takes place.

HB 2909

FIRST PUBLIC HEARING: Renames Center for Research on Occupational and Environmental Toxicology to Oregon Institute of Occupational Health Sciences.

Work Session

HB 2061

Reduces amount of time that appraisal management company has to make payment to independent contractor appraiser for completion of appraisal or appraisal review assignment.

HB 2069

Authorizes Director of Department of Consumer and Business Services to order payment of temporary disability compensation for up to 21 months for certain injured workers actively engaged in vocational assistance training.

HB 2403

FOR PURPOSE OF REFERRING TO HOUSE JUDICIARY WITHOUT RECOMMENDATION: Modifies manner in which scrap metal business may purchase metal for recycling purposes.
