HB 2545

CARRIED OVER FROM THE 2/27/2013 AGENDA: Permits Commissioner of Bureau of Labor and Industries to debar from public works contract contractor or subcontractor that is limited liability company if member or manage of limited liability company fails to pay or post prevailing rate of wage, fails to pay subcontractor's employees wher contractor pays employees on subcontractor's behalf or falsifies information on contractor's or subcontractor's certified statements.

#### HB 2379

FIRST PUBLIC HEARING: Prohibits person that issues credit card or debit card or that provides service as payment card network from restricting or prohibiting merchant from disclosing amount of interchange transaction for network fee that merchant pays to person, specifying minimum dollar amount for which merchant will accept credit card or debit card as payment in retail transaction or offering other person discount for using payment method other than credit card or debit card in retail transaction.

#### HB 2383

FIRST PUBLIC HEARING: Prohibits merchant from requiring statement of account as condition for cardholder to obtain refund of amount in payment card transaction.

### HB 2683

FIRST PUBLIC HEARING: Authorizes employer to pay wages due employee through direct deposit into employee's account or by other means of electronic transfer.

#### HB 2698

FIRST PUBLIC HEARING: Eliminates sunset on provisions for training, qualifying and certifying specialized building inspectors.
