#### Public Hearing

HB 2692

FIRST PUBLIC HEARING: Directs school districts to consider competence of teachers when determining which teachers will be retained when school district reduces staff in certain circumstances.

HB 2669

FIRST PUBLIC HEARING: Extends certain employee protections to persons performing work for educational purposes.

HB 2915

FIRST PUBLIC HEARING: Eliminates requirement for religious corporation to hold annual meeting if sole member of religious corporation is corporation sole or individual that constitutes corporation sole, provided that religious corporation is incorporated under state laws and is of same church or religious denomination as corporation sole.

#### Work Session

HB 2066

Allows certain personal property to be used as pledge for pledge loan from pawnbroker.

HB 2383

Prohibits merchant from requiring statement of account as condition for cardholder to obtain refund of amount in payment card transaction.

HB 2418

Modifies definition of "supervisory employee" for purposes of public employee collective bargaining law.

HB 2449

Makes strikes or recognition of picket line of labor organization by assistant attorneys general unlawful.

HB 2478 \*\* \*\*Subsequent Referral(s) to Tax Credits  
Extends sunset for tax credit for payments to employee and dependent scholarship programs.

HB 2545  
Permits Commissioner of Bureau of Labor and Industries to debar from public works contract contractor or subcontractor that is limited liability company if member or manager of limited liability company fails to pay or pay prevailing rate of wage, fails to pay subcontractor's employees when contractor pays employees on subcontractor's behalf or falsifies information on contractor's or subcontractor's certified statements.

HB 2990 \*\* \*\*Subsequent Referral(s) to Revenue  
FOR PURPOSE OF REFERRING TO HOUSE REVENUE WITHOUT RECOMMENDATION: Requires person engaged in trade or business that makes payment for performance of construction services to make reports to payee and to Department of Revenue.
