HB 2706

CARRIED OVER FROM THE 3/27 AGENDA: Permits owner of self-service storage facility to charge late fee for failure to pay or late payment of rent due.

#### Public Hearing

HB 3435

FIRST PUBLIC HEARING: Increases number of locations for which distillery licensee may hold full on-premises sales license for alcoholic beverages.

HB 3388

FIRST PUBLIC HEARING: Prohibits talent agency from charging individual fee or requiring individual to pay any other compensation to talent agency in exchange for talent agency's offer or promise to procure, or actual services in procuring, work for individual in media-directed occupation, except that talent agency may agree in writing with individual for whom talent agency has procured work that individual will pay talent agency compensation as percentage of individual's earnings from work that talent agency...

HB 2923

FIRST PUBLIC HEARING: Extends exclusive remedy protections of workers' compensation statutes to partners, limited liability company partners, general partners, limited liability partners, and limited partners.

#### Work Session

HB 2683

Authorizes employer to pay wages due employee through direct deposit into employee's account or by other means electronic transfer.

**April 1, 2013**

- HB 2383  
Prohibits merchant from requiring statement of account as condition for cardholder to obtain refund of amount in payment card transaction.
- HB 2448  
Requires issue subject to collective bargaining during term of collective bargaining agreement that is not resolved through negotiation or mediation to be resolved through binding arbitration.
- HB 2903  
Requires certain employers to post in premises where employees are employed summary of statutes and rules relate to employment rights of victims of domestic violence, harassment, sexual assault or stalking.
- HB 2950  
Allows eligible employees to take family leave to deal with death of family member.
- HB 3361  
Defines "comparable" for purposes of arbitration between certain employees and Department of Corrections.
