#### Work Session

HB 2296

Permits creation of, or conversion of other business entity into, benefit company that has purpose of providing general public benefit and possible specific public benefit in addition to other purposes.

HB 2524

Limits exemption from construction contractor licensing requirement for financial institutions, real estate personnel and suppliers of workers.

HB 2669

Extends certain employee protections to persons performing work for educational purposes.

HB 2908 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires Interagency Compliance Network to conduct biennial review of usage of certain terms related to employment and to report findings to Legislative Assembly and appropriate interim legislative committee by September 15 of each even-numbered year.

HB 3076 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Bureau of Labor and Industries to study methods of resolving post-employment disputes and report to committee or interim committee of Legislative Assembly on or before September 1, 2014.

HB 3342

Prohibits public employer from assisting, promoting or deterring union organizing and from using public property to hold meeting with employee or supervisor if purpose of meeting is to assist, promote or deter union organizing.

#### **Public Hearing and Possible Work Session**

HB 2410

FIRST PUBLIC HEARING: Requires Department of Consumer and Business Services to request waiver from federal government of federal requirements for operation of small cranes mounted on boom trucks.

HB 3180

FIRST PUBLIC HEARING: Authorizes holder of off-premises sales license to store wine, cider and malt beverages at licensed premises for transport to other premises of holder licensed for off-premises sales.

HB 3473

FIRST PUBLIC HEARING: Prohibits public body from entering into public contract with contract price of more than \$50,000 to construct, reconstruct, renovate, alter, maintain or repair public improvement or public works unless iron, steel and manufactured goods intended for use in public improvement or public works are made within United States.

**Note: The following six bills are placed on this agenda in the event they do not move out of committee on 4/8.**

#### **Work Session**

HB 2469 \*\*

\*\*Subsequent Referral(s) to Tax Credits

Extends sunset for tax credit for pension income.

HB 2654

Prohibits employer from compelling employee or applicant for employment to provide access to personal social media account or to add employer to social media contact list.

HB 2692

Directs school districts to consider competence of teachers when determining which teachers will be retained when school district reduces staff in certain circumstances.

HB 2672

Establishes certain workplace protections for domestic workers.

HB 2214

NOTE: NO AMENDMENTS ARE UNDER CONSIDERATION: Exempts employees of attorneys from licensure and other requirements relating to tax return preparation.

HB 2950

Allows eligible employees to take family leave to deal with death of family member.
