HB 2672

CARRIED OVER FROM 4/10 AGENDA: Establishes certain workplace protections for domestic workers.

HB 2524

CARRIED OVER FROM 4/10 AGENDA: Limits exemption from construction contractor licensing requirement fo financial institutions, real estate personnel and suppliers of workers.

HB 2669

CARRIED OVER FROM 4/10 AGENDA: Extends certain employee protections to persons performing work for educational purposes.

- HB 2908 ** **Subsequent Referral(s) to Ways and Means CARRIED OVER FROM 4/10 AGENDA: Requires Interagency Compliance Network to conduct biennial review of usage of certain terms related to employment and to report findings to Legislative Assembly and appropriate interim legislative committee by September 15 of each even-numbered year.

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM 4/10 AGENDA: Directs Bureau of Labor and Industries to study methods of resolving post-employment disputes and report to committee or interim committee of Legislative Assembly on or before September 1, 2014.

HB 3342

CARRIED OVER FROM 4/10 AGENDA: Prohibits public employer from assisting, promoting or deterring union organizing and from using public property to hold meeting with employee or supervisor if purpose of meeting is to assist, promote or deter union organizing.

HB 3180

CARRIED OVER FROM 4/10 AGENDA: Authorizes holder of off-premises sales license to store wine, cider and malt beverages at licensed premises for transport to other premises of holder licensed for off-premises sales.

HB 3473

CARRIED OVER FROM 4/10 AGENDA: Prohibits public body from entering into public contract with contract price of more than \$50,000 to construct, reconstruct, renovate, alter, maintain or repair public improvement or publi works unless iron, steel and manufactured goods intended for use in public improvement or public works are made within United States.

HB 2702

Establishes process for Oregon Liquor Control Commission to adopt rule declaring alcohol impact area upon petitio by municipality.

HB 3256

Allows parties to good neighbor agreement to file agreement with Oregon Liquor Control Commission.

HB 3435

Increases number of locations for which distillery licensee may hold full on-premises sales license for alcoholic beverages.

HB 2977 **

**Subsequent Referral(s) to Ways and Means

Requires construction labor contractors to be licensed by Commissioner of Bureau of Labor and Industries.

HB 3142

Modifies definitions of "employ," "employee," "employer" and "wages" for purposes of statutes relating to hours, wages, wage claims, employment conditions, employment agencies, farm labor contractors and construction contractors.

HB 3436

Creates Oregon Retirement Savings Investment Board.

Public Hearing and Possible Work Session

HB 3470

FIRST PUBLIC HEARING: Allows brewery-public house licensee or winery licensee to operate mobile premises for purpose of dispensing securely covered containers of alcoholic beverages from parked premises.

HB 3307

FIRST PUBLIC HEARING: Requires employer who fails to provide meal period or rest period breaks in accordance with rules adopted by Commissioner of Bureau of Labor and Industries to pay additional one and one-ha hours of wages for each day employer is in violation of rules.
