# AGENDA (Cont.) April 15, 2013

#### HB 3307

CARRIED OVER FROM THE 4/12 AGENDA: Requires employer who fails to provide meal period or rest period breaks in accordance with rules adopted by Commissioner of Bureau of Labor and Industries to pay additional one and one-half hours of wages for each day employer is in violation of rules.

### HB 3342

CARRIED OVER FROM THE 4/12 AGENDA: Prohibits public employer from assisting, promoting or deterring union organizing and from using public property to hold meeting with employee or supervisor if purpose of meeting is to assist, promote or deter union organizing.

### HB 3436

CARRIED OVER FROM THE 4/12 AGENDA: Creates Oregon Retirement Savings Investment Board.

#### HB 3470

CARRIED OVER FROM THE 4/12 AGENDA: Allows brewery-public house licensee or winery licensee to operate mobile premises for purpose of dispensing securely covered containers of alcoholic beverages from parked premises.

## HB 3473

CARRIED OVER FROM THE 4/12 AGENDA: Prohibits public body from entering into public contract with contract price of more than \$50,000 to construct, reconstruct, renovate, alter, maintain or repair public improvement or public works unless iron, steel and manufactured goods intended for use in public improvement or public works are made within United States.

#### HB 2535

Requires workers' compensation premium rates for clients of temporary service provider to be based on client's experience rating.

# HB 2540

Allows Construction Contractors Board to revoke, suspend or refuse to issue license if board finds person has engaged in dishonesty by enabling evasion of certain obligations.

#### HB 3005

Authorizes person with legal estate in real property to evict person in possession of real property under lease or rent agreement for conduct that causes place to be nuisance.

HB 3263 \*\* \*\*Subsequent Referral(s) to Ways and Means Requires State of Oregon to grant paid leave to eligible employees who are victims of domestic violence, harassmer sexual assault or stalking.

## HB 3459 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes Office of Small Business Assistance in Office of Secretary of State for purpose of facilitating interactions between small businesses and state agencies with regulatory authority over small businesses.

## HB 2608

Requires, when parties utilize services of escrow agents, trust funds to be deposited in interest-bearing accounts.
