# **Work Session**

HB 2535

CARRIED OVER FROM THE 4/15 AGENDA: Requires workers' compensation premium rates for clients of temporary service provider to be based on client's experience rating.

# HB 2540

CARRIED OVER FROM THE 4/15 AGENDA: Allows Construction Contractors Board to revoke, suspend or refuse to issue license if board finds person has engaged in dishonesty by enabling evasion of certain obligations.

# HB 2608

CARRIED OVER FROM THE 4/15 AGENDA: Requires, when parties utilize services of escrow agents, trust funds to be deposited in interest-bearing accounts.

# HB 2669

CARRIED OVER FROM THE 4/15 AGENDA: Extends certain employee protections to persons performing work for educational purposes.

# HB 2672

CARRIED OVER FROM THE 4/15 AGENDA: Establishes certain workplace protections for domestic workers.

# HB 2977 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/15 AGENDA: Requires construction labor contractors to be licensed by Commissioner of Bureau of Labor and Industries.

# HB 3076 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/15 AGENDA: Directs Bureau of Labor and Industries to study methods of resolving post-employment disputes and report to committee or interim committee of Legislative Assembly on or before September 1, 2014.

# AGENDA (Cont.) April 17, 2013

# HB 3142

CARRIED OVER FROM THE 4/15 AGENDA: Modifies definitions of "employ," "employee," "employer" and "wages" for purposes of statutes relating to hours, wages, wage claims, employment conditions, employment agencies, farm labor contractors and construction contractors.

# HB 2702

CARRIED OVER FROM THE 4/15 AGENDA: Establishes process for Oregon Liquor Control Commission to adopt rule declaring alcohol impact area upon petition by municipality.

# HB 3342

CARRIED OVER FROM THE 4/15 AGENDA: Prohibits public employer from assisting, promoting or deterring union organizing and from using public property to hold meeting with employee or supervisor if purpose of meeting is to assist, promote or deter union organizing.

# HB 3473

CARRIED OVER FROM THE 4/15 AGENDA: Prohibits public body from entering into public contract with contract price of more than \$50,000 to construct, reconstruct, renovate, alter, maintain or repair public improvement or public works unless iron, steel and manufactured goods intended for use in public improvement or public works are made within United States.

#### HB 3263 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/15 AGENDA: Requires State of Oregon to grant paid leave to eligible employees who are victims of domestic violence, harassment, sexual assault or stalking.

# HB 3436

CARRIED OVER FROM THE 4/15 AGENDA: Creates Oregon Retirement Savings Investment Board.

# HB 2007

Deems establishment of lottery game retailer or applicant to be casino when 50 percent or more of net income of establishment is, or is projected to be, derived from sale of tickets or shares in lottery games.

# HB 2008

Allows city to order temporary cessation of alcoholic beverage sales or other operations at premises licensed for ful or limited on-premises sales or as brewery-public house upon reasonable belief that continued sales or operation are immediate threat to public safety.

# HB 2613

Provides that forms of live or historical racing possibly resulting in wagering pool being carried forward to future race are forms of mutuel wagering.

#### HB 2614 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Increases share of moneys retained by Oregon Racing Commission from payments received by commission from gross receipts of mutuel wagering recorded by totalizator system.

#### HB 2923

Extends exclusive remedy protections of workers' compensation statutes to partners, limited liability company partners, general partners, limited liability partners, and limited partners.

#### HB 3042

Prohibits discrimination against members of certain protected classes in payment of wages for work of comparable character that requires comparable skills to perform.

# AGENDA (Cont.) April 17, 2013

### HB 3315 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires that Director of the Employment Department's investigations of contractors performing reforestation work on federal forestland include investigation of contractor compliance with federal employment eligibility verification law.

# HB 3347

Prohibits motor vehicle manufacturer, distributor or importer from coercing or requiring dealer to construct new dealer facility or materially alter or remodel existing dealer facility within 10 years after date on which dealer previously constructed, materially altered or remodeled existing dealer facility if existing dealer facility complies w manufacturer's, distributor's or importer's approved brand image standards or plans that existed at time dealer facility was constructed.

#### HB 3095

Prohibits public body from deeming franchisee employee of franchisor unless public body determines, with support of substantial evidence, that franchisor exercises more control over franchisee than is customary among franchisor a franchisee relationships in relevant market and than is necessary to preserve goodwill associated with trademark tha franchisor licensed to franchisee.

#### HB 3141

Excludes certain direct sales from definition of "employment" for purposes of unemployment insurance taxation.

#### HB 3390

Requires covered employer to implement paid sick leave for eligible employees.
