HB 3070

CARRIED OVER FROM THE 03/28/2013 AGENDA: FIRST PUBLIC HEARING: Requires disclosure of shipping and handling charges in sale or advertisement of consumer good.

HB 2662

CARRIED OVER FROM THE 03/28/2013 AGENDA: Prohibits owner of foreclosed residential real property from neglecting foreclosed residential real property during period of vacancy.

HB 2295 **

**Subsequent Referral(s) to Ways and Means

FIRST PUBLIC HEARING: Appropriates moneys to Oregon Progress Board for purposes of performing functions of board.

HB 2600

FIRST PUBLIC HEARING: Provides that record of financing statement sufficiently provides name of debtor who individual when record provides individual name, or surname and first personal name, of debtor.

HB 3013

FIRST PUBLIC HEARING: Excludes real estate appraisals submitted to housing authority or obtained by Housing and Community Services Department from public records disclosure exemption.

HB 3169 **

**Subsequent Referral(s) to Ways and Means

FIRST PUBLIC HEARING: Revises requirement that contracting agency dedicate certain amount of contract price toward including green energy technology in public building.

HB 2207

Requires payment of state payroll to be made through direct electronic deposit.

HB 2536

Modifies laws relating to transfers of structured settlement payment rights.

AGENDA (Cont.)
April 2, 2013

- HB 2821
Modifies amount of reimbursement due personal injury protection provider when total benefits exceed damages.
- HB 2822
Disallows publication of notice of sale of real property by Internet posting without additional publication in newspaper of general circulation.
- HB 2824
Clarifies that tower does not need to contact owner of parking facility or owner's agent at time of tow before towing motor vehicle from facility if sign warning that parking is prohibited is posted or if motor vehicle is parked next to red or yellow curb.
- HB 2856
Exempts from mortgage loan originator licensing requirements individual who, as seller during any 12-month period offers or negotiates terms for not more than three residential mortgage loans as security for purchase money obligations, unless United States Department of Housing and Urban Development determines otherwise.
- HB 2929
Provides penalty of \$500 for trustee's failure to give notice of trustee's sale postponement in accordance with requirements.
- HB 3159
Directs Oregon Transportation Commission to set maximum rates for towing and related services when tower tows motor vehicle without consent or authorization of owner or operator.
